APPLICATION FORM FOR HORSEFEED COUPONS  
AGRICULTURAL HORSES

To be sent to the Feeding Stuffs Department of your County Agricultural Executive Committee by the middle of the month prior to that for which rations are required.

- (2) I have no home-grown oats or other feeding stuffs suitable for horsefeed available, nor is it possible for me to grow any, on my holding.
- (3) I am not receiving ration documents for any of the above horses from the LOCAL FOOD OFFICE or from any other source.
- (4) ALTERNATIVELY, I require feeding stuffs coupons for the above number of horses for the months of.....(early winter months only) until I have been able to thresh my oats. I hereby undertake to sell to an approved buyer, after threshing, a quantity of oats not less than the total amount of horsefeed obtained against these coupons.

I declare that my working horses are essential to my farm and that the statements made, and the particulars given, are to the best of my knowledge and belief correct.

Farmers are reminded that the requirements of working horses must be the first charge on the resources of the farm and every possible step should be taken to provide the full requirements for Horses from Home Grown feeding stuffs. Horsefeed coupons can only be allowed where it has not been possible to grow sufficient food.
