DISEASES OF ANIMALS ACTS.

RABIES.

LONDON, MIDDLESEX, AND DISTRICT (MUZZLING AND CONTROL OF DOGS) ORDER OF 1919.

OUTBREAK OF RABIES.—The Board of Agriculture have now given notice that the following Areas have been added to the Scheduled District (see my Circular C.D. 249).

No Dog must be moved out of the Scheduled District unless it is accompanied by a licence of the Board of Agriculture authorising such movement.

Stationmasters, Agents, Booking Clerks, and all concerned must warn any person desiring to take or send a Dog by railway into the Scheduled District that such animal cannot be removed from the Scheduled District except by licence and under conditions requiring quarantine.

Dog tickets must not be issued for Dogs accompanying passengers through the Scheduled District from a place outside the Scheduled District to another place outside the Scheduled District, unless the Board of Agriculture licence authorising such movement is presented at Sending Station, and if such licence is tendered Sender must be informed that the Dog must be efficiently muzzled with an effective **wire cage muzzle** before it can be accepted.

The Board of Agriculture will, however, allow the movement of a Dog by railway through the Scheduled District from a place outside the District to another place outside the District without unnecessary delay, and without the Dog being re-booked within the Scheduled District, under the following conditions, and same must be strictly carried out:—

- (1) Through bookings must be in operation from Sending Station to Destination Station.
- (2) The Dog **must not** accompany a passenger, but must be consigned in the ordinary way, and be in charge of the Railway Companies' Officials during the whole of the journey from Sending Station to Destination Station.
- (3) Such Dog must be efficiently muzzled with an effective **wire cage muzzle**, or
- (4) Confined in a suitable hamper, crate, box, or other receptacle, so constructed as to render it impossible for such a Dog to bite any person or animal.

SCHEDULED DISTRICT.

An Area comprising:—

In the Administrative County of Essex:—

The Borough of Maldon.

The Petty Sessional Divisions of Beacontree, Epping, Ongar, Brentwood, Romford, Orsett, Rochford, Chelmsford (including the Borough of Chelmsford, but excluding the Parishes of Great Waltham, Little Waltham, Great Leighs, Little Leighs, and Boreham), and Dengie; and

The Parish of Margaret Roding, and the detached part of the Parish of Great Totham.

In the Administrative County of Kent:—

The Boroughs of Bromley, Chatham, Gillingham, Gravesend, and Tunbridge Wells, and the City of Rochester; and

The Petty Sessional Divisions of Bromley, Dartford, Rochester, Malling, Sevenoaks (including its detached parts), Tonbridge, and Tunbridge Wells (including its detached part); and

In the Administrative County of Surrey:—

The Petty Sessional Division of Godstone.

And also comprising:—

The County Boroughs of East Ham, West Ham, and Southend-on-Sea.

EAST KENT (MUZZLING AND CONTROL OF DOGS) ORDER OF 1919.

OUTBREAK OF RABIES.—The Board of Agriculture and Fisheries have notified that the following is a Scheduled District.

Dogs are only allowed to be moved under the conditions set out in the Instructions given above relating to the London Middlesex District.

The Regulations apply forthwith, and must be strictly adhered to.

SCHEDULED DISTRICT.

A District comprising:—

In the Administrative County of Kent:—

The Boroughs of Dover, Folkestone, Maidstone, Margate, Ramsgate, Queenborough, Faversham, Sandwich (including the Parish of Sarre), Deal, Hythe, New Romney, Lydd, and Tenterden; and

The Petty Sessional Divisions (including any detached parts thereof) of Sittingbourne, Bearsted, Faversham, Home, Thanet, Ramsgate, Wingham, Deal, Elham, Romney Marsh, Ashford, and Cranbrook;

And also comprising:—

The City and County Borough of Canterbury.

MONMOUTHSHIRE AND DISTRICT (CONTROL OF DOGS) ORDER OF 1919.

Add to Scheduled District (C.D. 247).

In the Administrative County of Glamorgan:—

An Area comprising the Borough of Neath, and the Petty Sessional Divisions of Neath, Pontardawe, Gower, and Swansea (including its detached part).

And also comprising the County Borough of Swansea.

SWINE FEVER.

NORFOLK (C.) ... Swine Fever Infected Area, Circular C.D. 247 has been **revoked**.
