# EUROPE SAYS NO TO COSMETIC

# TESTS ON ANIMALS

The campaign to end cosmetic tests on animals took a dramatic step forward on February 12th when the European Parliament voted in favour of banning these cruel experiments.

This latest move has been hailed as a major victory by Britain's leading anti-vivisection society, the British Union for the Abolition of Vivisection.

The BUAV has led the international campaign

co-ordinating the highly successful European Coalition to End Cosmetic Tests on Animals involving animal protection societies throughout Europe. Despite strong Parliamentary support there is likely to be resistance to the proposals from the European Commission and Council of Ministers, but campaigners are determined to press forward for a complete ban.

In the UK a Parliamentary Early Day Motion, initiated by the BUAV has been tabled by MPs from all the main political parties. This calls on the UK Government to support a ban within the Council of Ministers. The BUAV and other animal groups will be urging their supporters and members of the public to write to their MP asking them to sign the EDM.

The UK Government has not yet indicated whether it will endorse the animal test ban proposals and its decision could well determine the fate of an estimated 200,000 animals used worldwide each year to test cosmetic products and ingredients. The BUAV is hopeful that it can be persuaded to take a compassionate lead.
