Who are HLS?

Huntingdon Life Sciences, based in Huntingdon, Cambridgeshire are Europe's largest contract animal testing laboratory. Beyond the razor wire and CCTV are 70,000 animals imprisoned in tiny cages. Born into vivisection, these animals will never see daylight. Cats, dogs, rodents, farm animals, to name just a few, have toxic chemicals forced down their throats or into their veins to enable large chemical and pharmaceutical companies to make a profit.

Why are HLS Different?

HLS have been exposed four times in the last four years. Each investigation revealed severe animal cruelty, law-breaking and incompetence. In 1997 Channel 4 filmed staff at HLS shaking and punching beagle puppies in the face. Since then it has been proved that staff have been drug taking on site, drunk whilst on their way to work and can't perform even the simplest of procedures. One monkey died because they had left a swab inside his body during procedure.

What do we want Marsh UK and ~~The Beckett Group~~ to do?

Without their services, HLS would have great difficulty operating as a legal business. Thus, they are directly helping support this cruel company.
