Bournemouth Rationing Scheme.

Leaflet for the Guidance of the Householder who fills up and signs the Application Form.

1. Please read **very carefully** all the instructions on the Application Form, and fill it up in ink and **strictly** as instructed. If the instructions are not correctly followed in every particular, your Ration Cards cannot be given you till a later date.
2. When the Form is correctly filled in, bring it, or send it by a responsible person on your behalf, to:—

Trinity Hall (behind Holy Trinity Church),
Off Old Christchurch Road, Bournemouth,

between 9.30 a.m. and 1 p.m., or 2.0 and 5.30 p.m., on either of the two days referred to below, when you will receive individual **Meat Cards** and **Butter and Margarine Cards** in exchange.

3. If the **surname** of the **Householder** begins with:—

A to C Come **Tuesday, February 26th** or **Monday, March 4th.**

D to H „ **Wednesday, February 27th,** or **Tuesday, March 5th.**

I to Q „ **Thursday, February 28th,** or **Thursday, March 7th.**

R to Z „ **Friday, March 1st,** or **Friday, March 8th.**

Only one person for each Application Form (the Householder or someone representing him or her) will be admitted into the Hall, but one person may bring several Forms. If you cannot call or send, **post** the Form correctly filled up to the

Food Control Office, BOURNEMOUTH,

and it will receive attention, but not until those sent to Trinity Hall as above have been dealt with.

4. The Committee appeal to the Public to do all in their power to help the work of issuing the Cards and specially not to ask questions of the clerical helpers about what to do with the Cards. This is fully explained on the Cards themselves.
5. After you get your Ration Cards, be very careful not to lose or destroy them. **They cannot be replaced** without the most serious **inconvenience and delay** to the holder.
