BOVRIL

The following indications are based upon clinical records which have been communicated to Bovril, Limited, by members of the Medical Profession.

ALCOHOLISM. The powerful sustaining and stimulating action of Bovril makes it of exceptional value in the treatment of alcoholism and drug addiction.

COLLAPSE. In cases of collapse due to exhaustion, pain or accident, Bovril is invaluable, owing to the ease with which it can be prepared, and the rapidity of its restorative action.

DIABETES. In modern treatment the free administration of Bovril prevents risks of poisoning by toxic acids produced by excess of fat and protein,

and the possibility of coma is largely reduced.

INFLUENZA. A teaspoonful of Bovril added to half a pint of hot milk constitutes a valuable restorative.

PERNICIOUS ANÆMIA. A combination of Bovril and Liver Extract and Fish Liver Oil, enables many patients to take the oil, who otherwise could not do so.

MALNUTRITION. Where the condition is due to weak digestion and faulty assimilation, a course of Bovril, taken shortly before or along with the principal meals of the day, will frequently effect a marked improvement.

POST-ANÆSTHESIA SICKNESS. A half-pint of Bovril, given $2\frac{1}{2}$ to $1\frac{1}{2}$ hours before the administration of an anæsthetic, usually obviates or greatly reduces post-operation sickness. Its employment for this purpose is now recommended by many surgeons and physicians.

PNEUMONIA. Clinical records emphasize the particular value of Bovril in maintaining the strength of the patient, warding off heart failure and repairing tissue waste.

TUBERCULOSIS. The outlook in tuberculosis depends largely upon the digestion. Patients who loathe other kinds of food take Bovril freely, and its systematic administration, by supplying protein in an easily assimilable form, increases constitutional resistance to the bacterial inroads.

UTERINE CONTRACTION. Bovril has proved to be of greater efficacy than tea in labour cases.
