Dear Sir,

Your letter of the 13th inst., duly to hand enclosing the postal order for 11/8 (70 piastres). I should be glad if you would buy the sign of the chair for me at 60 piastres and also the sign of the sailing vessel at one and a half Turkish Lire, and have them carefully packed for me in either one or two boxes and send them to me by parcel post if possible. If you will then let me know the cost of the same with postage, I will send you a bank draft for that amount.

I am afraid I am unable to judge of the MSS. on medicine unless I have the names of them translated into English, and the date when they were written, so I shall have to leave these until I come again to Constantinople.

Thank you for letting me know about the man with the instruments. I think the ones you referre were the Roman instruments belonging to the dealer in the Grand Bazaar. If so, he wants too much money for them; 400 francs is a great deal more than they are worth, but keep your eyes open for anything that you may see, and let me know when you find anything of interest.

Mr. Amoruso wishes to be remembered to you.

I hope you are having a busy and successful season, and thank you for the trouble you have taken.

I am in receipt of your estimate letter dated 2nd May, in answer to yours I have the pleasure to enclose herewith a postal Order to cover the sum of 20 piastres which I had equal to £ 0.11.8.

I have received the photographs, I gave them to the Hodjas and I kept one for me.

I went to the Egyptian Bazaar and I found, the Chair for 60, the selling was

The way how to use the Egg with the sugar
is as follows:-

You take the egg and sugar put it inside the
mortar till the egg and sugar become like powder, then
passed through a linen which is very thin like gaze
you have to double the peace of gaze in it and
put the powder of said egg & sugar at the top part
of said gaze and whatever comes out under the
gaze, they use it in Consule for the eyes when
there is blood in it.

Now Sir, I have a balance of pastres 70 to your
credit out of the £30.0.0. which money I left
it as a deposit for the purchase of 8 Coloured
vases yielded, if you remember asking me, about
those in a closed shop, on a/c of proceeding with the
proprietor, I saw the man & left with him the 70 ptes
soon that the things will be sold by the Municipality
I will try to buy them for you & send them to you,
otherwise I will send you the said 70 pastres back.

Now I must tell you that I have lost 4 days

to finish up everything, as for the rest you
know as agreed that I have to get from you

Dear Sir,

Your letter of the 22nd inst. duly to hand enclosing your accounts. I have received the freight notes of the despatch of the cases from Mr. Spadaro, and trust they will arrive safely before very long.

There is one item in your account which I do not quite understand. After you record the expense of taking the lantern to Mr. Ryan's house, 22 piastres, there is an item "plus the amount of piastres 85". Will you kindly let me know what this means, and what it was expended for as you do not say. I notice that you have a balance of 70 piastres in hand out of the £30, which you have left as a deposit for the purchase of the vases. If you are not able to obtain these, when they are sold will you kindly return me a money order for the amount.

Thanks for obtaining the egg with the sugar and the account of it. I hope you will keep a look out for any old objects of medicine or surgery or charms that you may see in the bazaars, and will let me know of them and the price asked. Will you try and obtain

for me the hanging sign of the little wooden ship that was suspended from the front of one of the drug shops in the Egyptian bazaar, if you can get it for a reasonable price, say 50 or 60 piastres. I should also like to have, if you can buy it, another sign that we saw hanging outside another shop of crescent and a star. Did you get the sign of the little wooden chair that was hanging from the front of the shop where you bought the counters? This sign is important, and I should like to have any of the others that you can get as they would be useful. If you would let me know how much these would cost, I would remit you the money direct.

I enclose herewith a draft for you for 10% commission on the amount you have expended in purchase. This amounts to 331 piastres, also a sum of 169 piastres to pay for your time, making 500 piastres in all which I trust will be satisfactory to you. Please sign the enclosed receipt and return it to me at your early convenience. I thank you very much for the trouble you have taken and for having obtained the things which I hope to see here very soon.

Dear Sir,

I have just arrived back in London, and have received your two letters.

First with respect to the medical instruments I bought from Mr. Levy in Pera; they were handed to Mr. Amoruso by the hotel porter, and I was under the impression that I had sent Mr. Amoruso with the money to pay him, and had marked it up, but I have no receipt from him, and I cannot say positively that he was paid. As there is a doubt on the matter, I am enclosing you a cheque for £1. English sterling, payable to Mr. Isaac Levy for the instruments, and should be glad if you would please hand it to him and get a receipt from him for the same, and forward it to me.

With reference to your second letter, I have by this post forwarded to Mr. Ryan at the British Embassy a further amount of £10. from which he will pay you the amount you expend on my account, including the transport to the ship, and the packing and insurance. I can pay the freight on their arrival here.

The list of the things you have bought is all right with the exception of the four big ostrich eggs at 400 piastres. I do not want these, as I already have some like them, and they are very dear at 400 piastres, so if you have not actually paid for them, please make the owner take them back.

I am sorry the proprietor cannot sell the cornices, but if you can find me some which are just as good at a reasonable price, say 600 or 700 piastres, please buy them and send them with the other objects.

When you have finished all the buying and have got the objects packed and sent off, please let me know, and I will remit you a commission for the trouble you have had. There are several other things I shall want you to buy for me in Constantinople. I want about six more of the large blue glass eye charms for the evil eye, you will remember there were plenty of them in the bazaar, and I paid about a piastre each for them. Also do not forget to try and get me some of the clay bowls of tinkamatoum from Lemnos. There ought to be some of these in the native drug shops in Stamboul. I trust you will be able to get everything packed up soon and that we shall receive them safely. Please inform me of the steam-ship company by which you forward the cases, and send the freight notes direct to me.
