I hope these lines will find you and yo<sup>r</sup> and all our friends in the County well. as blessed of our. and all my family so long as god please: for we have very great sickly times at London: since June came in. and are very fearful it will grow worse every week while summer weather continues. for the plague increases more and forward it falls very strangely in for Ditty and suburbs. 17 dyed one week. 43 next and last week 112 of the plague. and of all diseases 558 <sup>last week</sup> had more feared this week but will far exceed the last. it comes not out till thursday morning. Now knowing young persons are most apt to take infection. thought good to give you an account of it. to have your advice about John John. to know yo<sup>r</sup> mind whether you do not desire him home again. or judge it the best way to have him into the County again ~~and~~ till these sickly times be gone again. and let me know yo<sup>r</sup> mind if need if you think fit to let him continue at London. I shall be as careful of him as my self. but as I said before. you is in more danger to take infection from outdoor offices and if the sickness increase. we shall have nothing to do. for it will put a stopp to all business. If god in mercy to us all put not a stopp to it. pray remember me with love to yo<sup>r</sup> brother George sister your selves. Mr. Malt offer friends as you for home and send love to yo<sup>r</sup> self rest

I promise you in my last to wait upon yo<sup>r</sup> works at Hull if god enabled me on  
Wednesday or this day to know yo<sup>r</sup> further pleasure abt yo<sup>r</sup> Electing me Shrieve  
in or to yo<sup>r</sup> performance of 10<sup>th</sup> promise I got (not without some difficulty) hither  
to York last night & designed for Hull this day, but though both as to all these  
troubles I writ you of before I sett out they increased mightily upon me by  
riding so yt before I got to dcast I believ<sup>d</sup> I did win about a pint with some  
all cleave of the blood & y<sup>e</sup> Liked against all York whom I alighted & send him  
since, so yt truly I think it very unsafe & Hazardous to proceed in so long a  
journey, & this is not my servants only, but y<sup>e</sup> Judgm<sup>t</sup> of several here who  
see my Condition w<sup>th</sup> they are ready for yo<sup>r</sup> satisfactions in y<sup>e</sup> truth for to  
subscribe to, therefore I humbly Crave yo<sup>r</sup> Pardon, yt I cannot now perform my  
promise (Having an earnest desire to be at home) and yt you & yo<sup>r</sup> Honour<sup>d</sup> bench  
will take these things into yo<sup>r</sup> present Consideration, w<sup>ch</sup> such means for a new  
election as may quit me, Hoping yo<sup>r</sup> goodness & humanity will not suffer you  
to impose Impossibilities upon
