



The Mork of the Institute.

HYGIENE is the science which treats of the preservation of health; and the most eminent medical authorities have, for years, maintained that an enormous amount of sickness and a large number of deaths are due to ignorance of its elementary principles. Improved sanitation, as applied to the community, has done an infinite amount of good in stamping out epidemics, eradicating some of the most loathsome diseases and lowering the death rate, but beyond this, much must always depend upon the individual, who seldom appreciates and, in many cases, does not realise his immense responsibility to himself and to others. Intemperance is induced, food, as well as drink, is abused, infection is spread, children are born degenerate and the weak become a burden on the strong, as well as a positive danger to their neighbours, through callousness and want of knowledge. The work of the Institute is to remove this widespread and prevailing ignorance by promoting Hygiene and impressing its far-reaching influence on the well-being of the people.

THE PURITY and value of fresh air, water and food supplies; a better knowledge of dietetics and cooking, and the feeding and rearing of children; all that pertains to a healthy home and a healthy life as well as nursing and the needs of the invalid, are among a few of the subjects that take a prominent place in the work of the Institute and indicate the character and scope of its efforts. Conferences are also held from time to time to discuss and deal with matters of grave importance affecting the public health, while several popular exhibitions have been promoted, as object lessons, to illustrate the best methods and awaken the public interest, such as the Infants' Health Exhibition, inaugurated by H.R.H. The Duchess of Albany.

LECTURES by Medical and Scientific authorities, on subjects of educational value and general interest, are regularly given throughout the year, in the Lecture Hall of the Institute. These are invariably crowded, and among those which have been delivered are:

EXAMINATIONS for the Certificate and Diploma of the Institute, have been organized throughout the country, and these are now held at the following centres, viz., London, Liverpool, Leeds, Manchester, Birmingham, Bristol, Cardiff, Portsmouth, Newcastle, Huddersfield, Edinburgh, Glasgow, Aberdeen, Dublin and Belfast. Very great interest has been taken in these examinations, especially by school teachers, who have thus been induced to acquire much valuable knowledge and impart it to the young.

PROVINCIAL WORK—The Institute has established Branches in the Provinces and already two have been opened, viz., The Midland Counties' Branch, inaugurated by Sir William Bennett, K.C.V.O., at Birmingham University, in 1907, and the Northern Counties' Branch, inaugurated by Professor Sims Woodhead, M.D., at Armstrong College, Newcastle-on-Tyne, in 1908, of which The Viscount Ridley is President. The Educational work at these centres is on similar lines to that promoted by the Institute in London, but each branch has its own Council, and its own organization, although working in co-operation with the parent Society.

LABORATORY WORK.—One of the most important departments in the work of the Institute has been that devoted to securing a pure food supply, and the due appreciation of that which is serviceable and reliable in the home. A great deal of analytical and bacteriological investigation has been carried out, and a large number of articles have been examined in the Laboratories so as to test their qualities and claims. Many of these articles have been condemned as unfit for consumption or use; some have been found to be misrepresented, or with exaggerated statements on the label requiring modification; and only those have been passed and certificated by the Institute that were proved to be free from adulteration, and absolutely pure and reliable in every way. This has been of great value as a protection to the public, and it has also encouraged a higher standard of quality on the part of manufacturers.

EXHIBITIONS.—The permanent exhibition of hygienic products and appliances, opened by the late Sir Joseph Fayrer, Bart., in 1904, has been eminently useful and practical, and the medical profession and the public have alike benefitted by its inception. A great many exhibits are on view in the various sections, representing Foods, Beverages, Clothing, and Domestic Hygiene, as well as Medical, Surgical and Hospital requirements; and a special feature is that every article has been thoroughly tested and examined in the Laboratory, as to its claims and merits, before being passed for exhibition. This has proved of great service as a guide to the public, who receive reliable information from the Superintendent and a staff of demonstrators, as well as free admission, throughout the year.

Another, and similar, Exhibition-the first in the Provinces-has been established by the Institute at Birmingham as an additional centre of useful information.




Dear Sir,
