Your attention is, however, called to the fact that frequent changes are made in the prohibited list, details of which are duly announced both in the London Gazette and in the Board of Trade Journal.

I am to add that this letter must not be regarded as giving permission to manufacture goods in cases where that course is necessary under the Regulations of the Ministry of Munitions.
