**SURGEON W. B. ALLIN, M.B.**, served with the 8th Hussars, in the Khyber Division, during the second campaign.

**Surgeon-Major A. Anderson** was in medical charge of a battery of Horse Artillery in the Kandahar F.F. during the second campaign.

**Surgeon-Major Geo. Andrew, M.B.**, served during the first campaign with the Peshawar Valley F.F., and during the second campaign with the Khyber Division and Khyber Line Force.

**Surgeon-Major M. Anthony, M.D.**, served with the Khyber Line Force, and Khyber Brigade, in medical charge of the 1st Battn. 18th Regt., during the second campaign.

**Surgeon-Major G. Ashton, M.B.**

**Surgeon-Major C. A. Atkins** was in medical charge of the 72nd Highlanders throughout the second campaign, being present at the night attack on the rear-guard at Zaidabad, the action of Charasiab (horse shot), the operations around Kabul and defence of Sherpur in Dec., 1879, including the Deh Mozang gorge, the assault and capture of the Asmai Heights (mentioned in despatches), and the final repulse of the enemy, taking part in the advance from Kabul to the relief of Kandahar, and being present at the battle of Kandahar. (Mentioned in despatches.)

**Surgeon-Major G. Atkinson, M.B.** (Deceased. See Biographical Division.)

**Surgeon-Major A. G. Bartley, M.D.**, served during the second campaign with the N. Afghanistan F.F.

**Surgeon J. M. Beamish, M.D.**, served during the first campaign in medical charge of the 1st Division Siege Train, Kandahar F.F., at Dadar and in the Bolan Pass.

**Surgeon-Major J. F. Beattie, M.D.**

**Surgeon-Major T. Bennett.**

**Surgeon-Major W. F. Bennett, M.D.**, served during the second campaign with the Kabul and Kabul-Kandahar Field Forces, taking part in the advance from Kabul to the relief of Kandahar, and being present at the battle of Kandahar.

**Surgeon-Major R. H. Bolton.** (Deceased. See Biographical Division.)

**Hon. Brigade Surgeon J. Bonnyman, M.D. (retired)**, served with the Kandahar F.F. during the second campaign.

**Surgeon I. Boulger** served with the 85th L.I., in the Kuram F.F., during the second campaign.

**Surgeon-Major J. Bourke (retired)** served with the Kabul F.F. during the second campaign, was in charge of the new Ambulance Corps during the advance on and occupation of Kabul by Sir F. Roberts, and at the action of Charasiab. (Mentioned in despatches.)

**Surgeon-Major W. C. Boyd** served with the Kabul F.F. during the second campaign, being present at the operations round Kabul and defence of Sherpur in Dec., 1879.

**Surgeon-Major R. M. Bradford.**

**Surgeon W. H. Briggs** served with the N. Afghanistan F.F. during the second campaign.

**Surgeon John Brodie, M.B.**, served in the first campaign with the 67th Regt. during a severe epidemic of typhoid fever in the Kuram Valley in 1879; in the second campaign took part in the



advance of the Kuram Division Kabul F.F. on Kabul, and was present at the action of Charasiab; was in medical charge of the 67th Regt. during the operations round Kabul and defence of Sherpur in Dec., 1879; accompanied the advance from Kabul to the relief of Kandahar (in charge of a section of the Field Hospital), and was present at the battle of Kandahar. (Thanked by Col. Parker and the officers and men of the 92nd Highlanders for aid rendered to the wounded under fire.)

*Surgeon-Major John Fitz G. Brodie* served during the first campaign, first in medical charge of D/2, R.A., taking part in the advance on and occupation of Kandahar, and afterwards, from 16 Feb., 1879, till the return of the battery to India, in medical charge of I/1, R.A.

*Surgeon A. W. Browne* served with the N. Afghanistan F.F. during the second campaign.

*Surgeon-Major R. F. Buchanan* served with the Kuram Valley F.F. during the first campaign.

*Surgeon W. A. Burgess* served with the Kandahar F.F. during the first campaign.

*Surgeon-Major W. F. Burnett* served with the Khyber Line Force, in medical charge of the 1st Battn. 25th K.O.Bs., during the second campaign.

*Surgeon J. T. Carey, M.B.*, served with the Kuram Valley F.F. during the first campaign, being present at the assault and capture of the Peiwar Kotal. (Mentioned in despatches.)

*Surgeon A. W. Carleton, M.B.*, accompanied Sir D. Stewart's Division in the advance from Kandahar on Ghazni and into the Logar Valley, being present at the battle of Ahmad Khel and the action of Arzu.

*Brigade Surgeon R. W. Carter* served with General Phayre's Division in S. Afghanistan, in medical charge of the 63rd Regt., during the second campaign.

*Surgeon S. H. Carter, M.B.*, arrived at Kandahar, 2 March, 1879, in medical charge of drafts for the 2/60th and 70th Foot, and remained there till 29 March, 1880; accompanied Sir D. Stewart's Division in the advance from Kandahar on Ghazni, and was present at the battle of Ahmad Khel and the action of Arzu; was with General Hill's force in the Logar valley during the operations in May, June, and July, 1880; and eventually returned to India by the Khyber route on the evacuation of Kabul.

*Brigade Surgeon W. Cattell* was in medical charge of the 10th Hussars throughout the first campaign, being present at the taking of Ali Musjid and action of Futtehabad.

*Surgeon H. Charlesworth* served with the 1st Battn. 5th Fusiliers, on the Khyber Line, during both campaigns.

*Surgeon-Major M. Cogan* served in Southern Afghanistan with General Phayre's Division during the second campaign, organizing the Principal Base European Hospital at Kandahar. (Mentioned in reports, and thanked by Governor-General in Council.)

*Surgeon P. Connolly.*

*Surgeon-Major H. Cornish.* (Killed in action. See Biographical Division.) *MAJUBI HILL 1881*

*Surgeon H. Cotton* served with the N. Afghanistan F.F. during the second campaign.

*Hon. Brigade Surgeon W. Creagh* (retired).

*Surgeon-Major W. Creyk, M.B.*, served with the N. Afghanistan F.F., in medical charge of I/A, R.H.A., during the second campaign.

*Surgeon-Major J. d'Altera* during the first campaign organized a Dépôt Hospital at Multan for European troops at the front in Southern Afghanistan; and during the second campaign, served with the Kuram F.F.

*Surgeon-Major G. S. Davie, M.D.*, served with the Peshawar Valley F.F. during the first campaign. (Mentioned in despatches.)

*Surgeon-Major F. A. Davy, M.D.*, served with the Khyber Line Force during the second campaign.

*Surgeon-Major R. W. Davies* was in medical charge of the Carabineers from Oct., 1879, till Sept., 1880, taking part in the affair at Ali Boghan, 13 Jan., 1880, and the expeditions into the Lughman Valley and against the Wazir Kugianis, under General Bright.

*Surgeon P. J. Dempsey, M.D.*, served with the S. Afghanistan F.F. during the second campaign.

*Surgeon W. Donovan* served during the second campaign with the 3rd Brigade, Kuram Division Kabul F.F., and subsequently with the Kuram Force, till the withdrawal of the troops to India, taking part, in medical charge of the 85th L.I., in the Zaimusht expedition, and being present at the storming and destruction of Zawa.

*Surgeon J. C. Dorman, M.B.*, served during the first campaign with the Quetta Division, and during the second campaign, with the Kuram F.F., being present at the fighting at Ali Khel and the Shutargardan.

*Surgeon-Major W. E. Dudley* served with General Phayre's Division in Southern Afghanistan during the second campaign, in medical charge of the 78th Highlanders.

*Surgeon-Major R. C. Eaton* served in medical charge of the 1st Battn. Royal Irish, in the 1st Section Khyber Line Force, during the second campaign.



*Surgeon-Major J. D. Edge, M.D.*, served with the Kandahar F.F. during the second campaign.

*Brigade Surgeon J. Ekin, M.B.*, served during the second campaign with the Kabul and Kabul-Kandahar Field Forces, taking part in the advance from Kabul to the relief of Kandahar, and being present at the battle of Kandahar. (Mentioned in despatches.)

*Surgeon I. B. Emerson.*

*Surgeon-Major E. J. H. Evatt, M.D.*, served throughout the first campaign with the 1st Division Peshawar Valley F.F., being present, in charge of the advanced section of the Field Hospital, at the taking of Ali Musjid and the forcing of the Khyber Pass; establishing a Field Hospital at Daka; accompanying, as Senior Medical Officer with General Tytler's Column, the expedition into the Bazar Valley; advancing with the Division to Gandamak; and eventually taking part, in charge of a Field Hospital, in the return-march of the troops to India in June, 1879. (Mentioned in despatches for "indefatigable care of the wounded," and thanked in Orders.) In the second campaign had charge of a Field Hospital with General C. Gough's Brigade, and took part in the advance to the relief of Sherpur; established the Bala Hissar General Hospital; accompanied General Ross's force towards Ghazni; and eventually returned to India on the evacuation of Kabul.

*Brigade Surgeon J. G. Faught* served with the N. Afghanistan F.F. during the second campaign.

*Surgeon E. H. Fenn* served in the second campaign in charge of 6/8, R.A., being present at the affairs at Zaidabad, 25 and 26 April, 1880, taking part in the advance from Kabul to the relief of Kandahar, and being present at the battle of Kandahar. (Mentioned in despatches.)

*Surgeon-Major A. J. Ferguson* served during the second campaign with the Khyber Line Force, being present at the operations in the Mazina Valley. (Mentioned in despatches.)

*Surgeon-Major J. Ferguson* served with the Khyber Line Reserve during the second campaign.

*Surgeon-Major R. P. Ferguson* served during the first campaign with the 2nd Division Peshawar Valley F.F.

*Surgeon-Major N. Ffolliott.*

*Surgeon-Major W. Ffolliott* served throughout the first campaign with the 2nd Division Peshawar Valley F.F., being in charge of the Divisional Field Hospital at Landi Kotal. In the second campaign advanced to Kabul with the 9th Lancers, and remained there, in charge of the Ambulance Corps, till Dec., 1879, when he returned to India in charge of a convoy of sick and wounded.

*Surgeon John Findlay, M.B.*, served during the second campaign with the Kandahar F.F., being in Kandahar throughout the siege. As Assistant to Surgeon-Major Waghorn, treated the wounded who were brought in from the fields of Maiwand and Deh Khwaja, and was present at the battle of Kandahar.

*Surgeon-Major J. E. Fishbourne* served throughout the first campaign with the Peshawar Valley F.F., first in charge of the 2nd Division Field Hospital at Jamrud, and afterwards of the 1st Division Field Hospital at Jalalabad. Served with the 4th Battn. Rifle Brigade, and had charge of the Field Hospital of the Bannu Column Mahsud Waziri Expeditionary Force, during the advance into Waziristan in May, 1881.

*Surgeon J. W. H. Flanagan* served with the Kandahar F.F. during the second campaign.

*Surgeon-Major Joseph Fleming, M.D.*, served in medical charge of the 67th Regt. from Dec., 1878, till Sept., 1879, and subsequently in charge of the 2nd Battn. 8th Regt., and all the troops at the Peiwar Kotal, till 28 Dec., 1879, when he was ordered to India. Subsequently proceeded to Kabul, and from April to July, 1880, served there in charge of a section of the Field Hospital, and as Brigade Surgeon, 1st Brigade, 2nd Division, N.A.F.F. In July, 1880, returned to India in charge of the Divisional Field Hospital, and of all the sick and wounded from Kabul and of the Ghazni F.F., prior to the evacuation.

*Surgeon-Major S. Flood (retired).*

*Surgeon-Major E. Footner, M.B.*, served with the Kandahar F.F. in medical charge of the 70th Regt., during the first campaign.

*Surgeon-Major P. T. Frazer* served during the first campaign with the 1st Division Peshawar Valley F.F., being present at the forcing of the Khyber Pass.

*Surgeon T. J. Gallwey, M.D.*

*Surgeon-Major A. G. Gaye* served with the Southern Afghanistan F.F., under General Phayre, in 1880.

*Deputy Surgeon-General J. Gibbons, C.B.* (For services see "Staff.")

*Surgeon-Major G. J. Gibson, M.D.*, served in medical charge of the 2nd Battn. 8th Regt., throughout the first campaign, being present at the assault and capture of the Peiwar Kotal. (Mentioned in despatches.)

*Surgeon-Major H. C. Gillespie, M.D.*

*Surgeon-Major B. T. Giraud, M.D.*, served in medical charge of the 2nd Battn. 7th Fusiliers



throughout the period of its service in the war, being present at the defence of Kandahar, the sortie to Deh Khwaja, and the battle of Kandahar. (Mentioned in despatches.)

*Surgeon J. A. Gormley, M.D.*, served with the 6th Dragoon Guards, in the Khyber Division, during the second campaign.

*Surgeon-Major H. R. Greene.*

*Surgeon J. J. Greene, M.B.*

*Surgeon-Major J. Greig, M.B. (retired.)*

*Surgeon-Major G. C. Gribbon, M.B.*, served during the first campaign in medical charge of the 1st Battalion 25th King's Own Borderers, with the Peshawar Valley F.F., taking part in the Bazar Valley expedition.

*Surgeon W. L. Gubbins, M.B.*, served with the 2nd Division Peshawar Valley F.F., throughout the first campaign, in medical charge of the Divisional Staff, and during part of the time in medical charge of the 1/5th Fusiliers, taking part, with the battalion, in the first of the Bazar Valley expeditions. In the second campaign served in charge of a detachment of the 5th Fusiliers, with the Kuram F.F. from Nov., 1879, till Jan., 1880, when he was transferred to the Khyber Line Force, and held medical charge of the Head-quarters Staff till invalided to England, in June 1880, from illness contracted in the field. Took part in the affair at Kam Daka, Jan., 1880, and the Hissarak expedition, April, 1880. In addition to his other appointment, held the post of Secretary to the Principal Medical Officer, and was also Sanitary Officer to the Khyber Line Force.

*Brigade-Surgeon A. Guthrie M.D.* (For services see Staff.)

*Surgeon-Major A. R. Hall* served with the S. Afghanistan F.F. during the second campaign.

*Deputy Surgeon-General J. A. Hanbury, M.B., C.B.* (For services see "Staff.")

*Surgeon-Major W. M. Harman, M.B.*, served with the Kuram F.F. during the second campaign.

*Surgeon-Major C. H. Harvey, M.D.*, served with the Kandahar F.F. during the second campaign, being present in Kandahar throughout the siege. (Mentioned in despatches.)

*Deputy Surgeon-General H. B. Hassard, C.B.* (For services see "Staff.")

*Surgeon A. E. Hayes.*

*Deputy Surgeon-General J. Hendley, C.B.* (For services see "Staff.")

*Surgeon-Major W. G. R. Hinds, M.D.*, served with the 1st Division Kandahar F.F. from Feb. till Nov., 1880, being present at Kandahar throughout the siege. Was in medical charge, first of the 66th Regt., and afterwards of No. 1 Field Hospital.

*Surgeon R. D. Hodson* served with the Kandahar F.F. during the second campaign.

*Surgeon-Major E. Hopkins.*

*Surgeon-Major F. Howard, M.D.*, served with the Peshawar Valley F.F. during the first campaign.

*Surgeon John Hoysted* served during the second campaign, from 19 Dec., 1879, till 26 May, 1880, with the Division operating on the Khyber line, being present, with Col. Boisragon's Column, at the defeat of the Mohmands at Kam Daka in Jan., 1880, and taking part in the Lughman Valley and Hissarak expeditions under General Bright. Was in temporary medical charge of the 1/25th, K.O.Bs., and subsequently in medical charge of C/3, R.A., and I/A, R.H.A., returning with the latter to India.

*Surgeon-Major T. N. Hoysted* served with the Kuram Valley F.F. during the first campaign, being present at the assault and capture of the Peiwar Kotal.

*Surgeon G. A. Hughes, M.B.*, served with the Royal Artillery in the second campaign.

*Surgeon-Major J. H. Hunter.*

*Surgeon-Major R. Jackson* served in medical charge of the 2nd Battn. 8th Regt. at Peiwar Kotal during the year 1880. Was the senior Medical Officer present, and had charge of the Depot Field Hospital.

*Surgeon-Major T. W. Jackson, M.B.*, served with the Kandahar F.F. during the second campaign.

*Surgeon-Major H. Jagoe, M.B.*, served with the Kandahar F.F. during the second campaign.

*Surgeon-Major J. H. Jeffcoat* served with the Peshawar Valley F.F., in medical charge of the 10th Hussars, during the first campaign.

*Surgeon P. G. Jevors* served with the 1st and 2nd Divisions Peshawar Valley F.F. from Dec., 1878, till the conclusion of the first campaign, taking part in medical charge of 11/9, R.A., in the advance through the Khyber and the first Bazar Valley expedition. During the second campaign, served from Jan. till July, 1880, with the Kuram F.F., in medical charge of the 4th Battn. Rifle Brigade.

*Surgeon P. H. Johnston, M.D.*, served with the Kuram F.F. during the second campaign. Was attached to No. 1 Mountain Battery in the Zaimusht expedition, and was present at the storming and capture of Zawa.

*Hon. Brigade-Surgeon M. G. Jones (retired)* served with the Peshawar Valley F.F. during the first campaign, accompanying the retirement from Gandamak on the conclusion of hostilities. (Mentioned in despatches.)



*Surgeon A. C. Keith, M.B.* (Deceased. See Biographical Division.)

*Surgeon-Major R. Keith, M.D.*

*Surgeon E. W. Kelsall* served with the Kandahar F.F. during the second campaign, being present in Kandahar throughout the siege. (Mentioned in despatches.)

*Surgeon-Major H. Kelsall.* (Deceased. See Biographical Division.)

*Surgeon W. W. Kenny, M.B.*, served with the Khyber Line Force during the second campaign, being attached for duty to the 2nd Battn. 14th Regt.

*Surgeon H. C. Kirkpatrick, M.D.*, served with the N. Afghanistan F.F. during the second campaign.

*Surgeon-Major M. Knox.*

*Surgeon-Major J. Langdon.*

*Surgeon G. T. Langridge* served during the first campaign in medical charge of the detached squadron 9th Lancers in the Kuram Valley, subsequently accompanying it, during the second campaign, in the advance on Kabul, and being present at the affair at Jagi Thana, the action of Charasiab, the skirmishes on the 7th and 8th Oct., 1879, and the cavalry pursuit on the 9th. Was afterwards attached to the 92nd Highlanders, and took part in the operations round Kabul and defence of Sherpur in Dec., 1879, and the expeditions into the Maidan district.

*Surgeon W. J. Le Grand, M.D.*

*Surgeon-Major R. Lewer, M.D.*, served in medical charge of the 9th Lancers, on the Khyber line, during the first campaign, from 13 March, to 7 June, 1879, and during the second campaign from 11 Oct., 1879, and as Sanitary Officer to the Kabul F.F. from 11 Nov., 1879, till the conclusion of hostilities, being present at the operations round Kabul and the defence of Sherpur in Dec., 1879. (Brought to special notice for good service.) As Acting Brigade Surgeon of the Cavalry Brigade, took part in the advance from Kabul to the relief of Kandahar, and was present at the battle of Kandahar. (Mentioned in despatches.)

*Surgeon-Major A. Long* served with the S. Afghanistan F.F. during the second campaign.

*Surgeon-Major E. L. Low, M.B.*, served uninterruptedly during both campaigns, from 21 Nov., 1878, till 23 Jan., 1880, in medical charge of F/A, R.H.A., taking part in the assault and capture of the Peiwar Kotal, the advance over the Shutargardan Pass, the action of Charasiab, the action of Killa Kazi (in which four guns of the Battery had to be temporarily abandoned), the recovery of the four guns (being the only officer of the Battery present), and the subsequent operations round Kabul and defence of Sherpur in Dec., 1879.

*Surgeon-Major F. Lyons, M.D.*, served with the S. Afghanistan F.F. during the second campaign.

*Surgeon-Major J. J. McCarthy, M.D.*

*Surgeon J. A. McCracken, M.D.*, crossed the frontier with the 25th K.O.Bs., 16 Dec., 1879, and served during the war till the return of the troops to India: first in charge of Field Hospital of No. 2 Flying Column, Khyber Line Force, and afterwards as Chief Sanitary Officer on the Divisional Headquarters Staff of General Bright. Was also Secretary to the Principal Medical Officer of the Khyber Line Force.

*Surgeon-Major G. W. McNalty, M.D.*, served during the first campaign with the Peshawar Valley F.F., and during the second campaign with the Kabul and Kabul-Kandahar Field Forces, being present at the affair at Zaidabad, taking part in the advance from Kabul to the relief of Kandahar, and being present at the battle of Kandahar. (Mentioned in despatches.)

*Surgeon J. McNamara, M.D.*, served during the second campaign, from 10 Feb. till 11 Nov., 1880, in medical charge of C/2, R.A., being present in Kandahar throughout the siege, and taking part in the reconnaissance of 31 Aug., 1880. Accompanied, in medical charge, the force under Brigadier-General Brooke which went out, 28 July, 1880, to cover the retreat of the remnants of Brigadier-General Burrows' Brigade from Maiwand. (Mentioned in despatches.)

*Surgeon J. G. McNeece* served with the Kandahar F.F. during the second campaign.

*Surgeon P. J. McQuaid, M.D.*, served during the second campaign with Sir F. Roberts' Division, taking part in the advance on and occupation of Kabul, and being present at the action of Charasiab and the affairs round Kabul and defence of Sherpur in Dec., 1879, including the actions of Karez Mir and Killa Afshar.

*Surgeon-Major W. McWatters* served with the Khyber Line Force, in medical charge of the 1st Battn. 17th Regt. during the second campaign.

*Brigade-Surgeon W. G. N. Manley, V.C.*, served with the Kandahar F.F. during the first campaign. (Mentioned in despatches.)

*Surgeon-Major E. C. Markey* served during the first campaign with Sir D. Stewart's Division, taking part in the advance on and occupation of Kandahar, and being present at the action of Takht-i-pul. Served during the second campaign with the Kabul and Kabul-Kandahar Field Forces, taking part in



the advance from Kabul to the relief of Kandahar and being present at the battle of Kandahar. Subsequently accompanied the Marri Expeditionary force. (Twice mentioned in despatches.)

*Brigade Surgeon C. Martin* was in medical charge of the Kuram Valley and Ali Khel Hospitals during the first campaign. (Mentioned in despatches.)

*Surgeon-Major J. Martin* served with the 1st Division Peshawar Valley F.F., in medical charge of the 81st Regt., during the first campaign, being present at the bombardment and capture of Ali Musjid. (Wounded.)

*Brigade Surgeon R. W. Meadows, M.B.*, served during the second campaign with the Kandahar, Ghazni, and Kabul Field Forces, taking part in the advance from Kandahar on Ghazni and into the Logar Valley, and the retirement from Kabul by the Khyber route to India, and being present at the battle of Ahmed Khel and the action of Arzu. (Mentioned in despatches.)

*Hon. Deputy Surgeon-General J. Meane (retired)* served with the Kuram Valley F.F. throughout the first campaign, in medical charge of the 72nd Highlanders, being present at the assault and capture of the Peiwar Kotal, the advance to Ali Khel, and the march through the Sapari defile. Was in charge of the Divisional Base Hospital at Kuram and the Peiwar Kotal; and was Senior Medical Officer British Forces throughout the campaign.

*Surgeon-Major A. Minto, M.B.*

*Surgeon O. F. Molloy.*

*Surgeon-Major J. H. Moore* served during both campaigns with the force under Sir D. Stewart, taking part in the original advance on and occupation of Kandahar and Kalat-i-Ghilzai, the advance from Kandahar on Ghazni and into the Logar Valley, and the retirement from Kabul by the Khyber route to India, and being present at the battle of Ahmad Khel and the action of Arzu. (Mentioned in despatches.)

*Surgeon J. J. La V. Morris, M.D.*, served in the first campaign with the Kuram Valley F.F., and in the second, with the Kabul F.F. Accompanied General Baker's Brigade into Kohistan in Jan., 1880, in charge of Field Hospital. Was in medical charge of the 92nd Highlanders at the second action of Charasiab. Afghanistan during both campaigns, in medical charge of 11/11, R.A., taking part in the advance on and occupation of Kandahar and Kalat-i-Ghilzai, and the second occupation of Kalat-i-Ghilzai, and being present at the action of Shahjui. *Surgeon-Major T. Murtagh* served with the S. Afghanistan F.F. during the second campaign.

*Surgeon-Major W. Nash, M.D.*, served with the 72nd Highlanders throughout the first campaign, being present at the assault and capture of the Peiwar Kotal, the reconnaissance to the Shutargardan, and the passage of the Sapari Pass. Was latterly in charge of the Divisional Field Hospital at Ali Khel. (Mentioned in Orders.)

*Brigade Surgeon N. Norris* served in medical charge of the 1st Batta. 5th Fusiliers throughout the period the regiment was employed in the second campaign.

the Halmand. Was present at the action of Girishk, and the battle of Maiwand, in which he was severely wounded while attending a disabled man in the front line of fire. Was in Kandahar throughout the siege. (Mentioned in despatches.)

*Surgeon-Major W. S. M. Price* served with the Peshawar Valley F.F. during the first campaign, being present at the operations in the Bazar Valley, and the affair at Deh Sarak.

*Surgeon W. J. R. Rainsford* served with the Khyber F.F. during the second campaign.

On the occurrence of the disaster at Maiwand, again volunteered for service, and proceeded in medical charge of the 78th Highlanders with General Phayre's Brigade, to Kandahar, returning with the regiment to India in Feb., 1881.

*Surgeon-Major T. Rudd, M.D.*, served with the Khyber Line Force during the second campaign.

*Surgeon G. M. Russell, M.B.*, served with the N. Afghanistan F.F. during the second campaign.

*Surgeon-Major W. F. Rutledge* served in medical charge of C/3, R.A., with the Peshawar Valley F.F. throughout the period it was employed in the first campaign and early part of the second, being present at the relief of the village of Kam Daka in April, 1879, and taking part in the advance of Brigadier-General C. Gough's Brigade to Gandamak. Was subsequently in medical charge of European and Native Field Hospital, and Superintendent of Sick Transport at Jalalabad. Proceeded to Kabul Feb., 1880, to take charge of sick transport of both divisions of the Field Force and of F/A, R.H.A.; and on the departure of that battery, superintended the transport of all the sick from Kabul to Gandamak, and equipped with transport both the Kabul-Kandahar F.F. and the force returning to India by the Khyber route. Returned in medical charge of the 2nd Battn. 9th Regt. to Gandamak, and from thence to Peshawar in charge of a section of the Field Hospital.

During March and April, 1879, was in temporary medical charge of the 4th Battn. Rifle Brigade, and accompanied the regiment in the demonstration from Jalalabad into the Lughman Valley. Returned by the Khyber route, on the evacuation of Kabul, to India, having charge of a section of the Field Hospital, and acting as Medical Store-keeper, in addition to discharging his regimental duties.

*Surgeon B. W. Wellings* served with the Southern Afghanistan F.F. during the second campaign.

*Surgeon-Major H. B. White* served with the Division under Sir F. Roberts during both campaigns; first in medical charge of a section of the Field Hospital at Ali Khel; afterwards in medical charge of G/3, R.A., in the Kuram Valley, subsequently accompanying the battery in the advance on and occupation of Kabul, being present at the action of Charasiab, and the operations round Kabul and defence of Sherpur in Dec., 1879, including the storming of the Tahkt-i-Shah and the Asmai Heights; and eventually, in medical charge of the 2nd Battn. 9th Regt., accompanying the battalion in the advance towards Ghazni, and being present with it at the affair at Zaidabad.
