Instructions Regarding Pay and Allowances for Civil Surgeons

FROM THE

United Kingdom, serving under War Office Contract.

N.B.—It must be distinctly understood that these instructions are merely intended as a guide. They are no authority for payment, and must not be quoted in any official document.

1. Civil Surgeons serving in Cape Colony are paid by the Chief Paymaster, Cape Town; in the Orange River Colony by the District Paymaster, Bloemfontein; in the Transvaal by the Chief Paymaster, Pretoria; and in Natal by the District Paymaster, Maritzburg. If a Civil Surgeon is sent for duty for any length of time from one Colony to another he must obtain from the Paymaster who has been paying him a Last Pay Certificate, which he must forward with his first claim to his new Paymaster.

2. Pay and allowances are paid monthly in arrear, and broken periods (*i.e.*, any period less than a month) cannot be paid unless the applicant is leaving the country or being transferred to another Paymaster.

3. The rates for Civil Surgeons are as follows, but the rates of some of the allowances are different in the other Colonies of South Africa, and the rates should therefore be obtained from the Paymasters mentioned in para. 1. The rates here given are for Cape Colony.

PAY.

£1 per diem, less income duty at 1s. 2d. in the £.

FIELD ALLOWANCE, 3s. 6d. per diem.

This allowance can only be drawn when under canvas, on trek, or when specially authorised in temporary shelter.

RATION ALLOWANCE, 1s. 8d. per diem.

Issuable when rations in kind are not drawn.

SERVANT'S ALLOWANCE, 1s. 6d. per diem.

If any person paid by the public is employed this allowance is not issuable, but if the Civil Surgeon has a horse he may employ *one* person paid by the public and claim the allowance for one servant. If rations are drawn for a civilian servant the allowance is 1s. only.

LODGING ALLOWANCE, 5s. 7½d. per diem.

This is the rate at present, but it is liable to reduction. This allowance can only be drawn where neither a public quarter nor a tent is available, and special authority must be obtained for its issue, application being made through the S.M.O. to the D.A.A.G., the district in which the Civil Surgeon is serving. This authority must be attached to the first claim.

FUEL AND LIGHT ALLOWANCE.

Summer 1s. 3½d., Winter (May to August), 2s. 6d. per diem.

The same remarks apply as to lodging allowance, with the addition that this allowance cannot be drawn if fuel or light is drawn in kind.

BICYCLE ALLOWANCE, 2s. per diem.

Is only issuable when the Civil Surgeon is not provided with a horse. Claims must be supported by certificates.

1. That the Civil Surgeon has a bicycle in his possession during the period of the claim.
2. That he has been effective during this period. Both these certificates should be signed by the claimant.
3. A certificate signed by the Army Service Corps Officer at the station, that no forage or allowance in lieu was drawn.

TRAVELLING CLAIMS AND DETENTION ALLOWANCE.

12s. 6d. is admissible for every night spent in a mail train, and an additional 3s. 6d. for day of arrival at destination. Detention allowance at the same rate (12s. 6d.) is admissible for every night of detention at places other than permanent stations for short periods when public quarters are not available. When detention follows a journey the 3s. 6d. is inadmissible. When detention exceeds 8 nights, including night of arrival, the rate drops to 7s. 6d., and claims require the approval of the G.O.C. of the district where the detention takes place.

N.B.—When travelling or detention allowance is drawn, field, and ration, or lodging (except in very exceptional circumstances), and fuel and light allowance cannot be claimed.

GRATUITY.

After one year's service civil surgeons are entitled to a gratuity of 61 day's pay. No special form is necessary for claiming it. It can be drawn in South Africa if the civil surgeon is remaining in the country. The claim must give date of original engagement, and declaration of intention to remain in South Africa, and should be sent through his S.M.O. to the P.M.O., South Africa. A further gratuity of a fortnight's pay for each three months' extension of service is issuable in the same manner as the above.

4. The pay and allowances must be claimed on the following Army Forms, which can be obtained from the Army Stationery Department, Darling Street, Cape Town, if none are at the hospital where the Civil Surgeon is serving.

1. PAY AND SERVANTS ALLOWANCE.—Army Form O. 1679.

The column headed "Period of Absence" must be invariably filled in. The receipt column must be signed by the claimant, as also one of the certificates on the 4th page re servants allowance; and the certificates, &c., on the centre page must be signed by the Commanding Officer.

FIELD ALLOWANCE.—Army Form O. 1628.

The receipt column must be signed by the Civil Surgeon. The O.C. must sign on the 4th page, and the certificate at the end of 4th page must be signed by the local Army Service Corps Officer, unless on trek with a Column, in which case "On trek with Column" must be written across these lines and signed by the Civil Surgeon.

RATION ALLOWANCE.—Army Form P. 1927.

Receipt column must be signed by claimant, and certificates by Commanding Officer and Army Service Corps Officer *must* be signed.

LODGING, FUEL, AND LIGHT.—Army Form P. 1934.

Receipt column must be signed by claimant, and the periods of absence carefully filled in, in the columns for that purpose. Certificates by Commanding Officers and Army Service Corps Officers must also be signed by them.

BICYCLE ALLOWANCE.—Army Form O. 1771.

In addition to the certificates mentioned, the claim must be received by the Civil Surgeon, signed by him as "Officer preferring the claim," and also signed by his Commanding Officer.

TRAVELLING AND DETENTION ALLOWANCE.—Army Form O. 1771.

The claim must be received by the claimant, and signed by him as "Officer preferring the claim," and signed by his Commanding Officer, and should be supported by a certified copy of the order, authorising the journey.

5. In conclusion, it cannot be too strongly impressed upon Civil Surgeons that it is to their own advantage to take the greatest care in making out their claims, as otherwise correspondence must ensue, which causes considerable delay before they can receive their pay and allowances.

1. The period of my service hereunder shall commence as from the day on which I shall embark from England, and shall continue until the expiration of 12 calendar months thereafter, or until my services are no longer required, whichever shall first happen.
2. My pay shall (subject as hereinafter appears) be twenty shillings a day for the said period.
3. In addition to such pay, I shall receive a free passage from England to South Africa, and (subject as hereinafter appears) a similar free passage from South Africa to England at the end of the said period; and I shall receive an advance of field allowance as for a Captain in the Army on proceeding abroad, and field allowance thereafter so long as I may remain on service in the field, the use of a Government horse, and a soldier or civilian servant, and rations while in the field.
4. During the said period I will devote my whole time and professional skill to my service hereunder, and will obey all orders given to me by Commissioned Military or Naval Officers, or by the Permanent Medical Officers of either of those services.

5. In case I shall complete my service hereunder to your satisfaction in all respects, I shall receive at the end of the said period a gratuity of two months' full pay, at the rate hereinbefore specified, but in case I shall in any manner misconduct myself, or shall be (otherwise than through illness or unavoidable accident) unfit in any respect for service hereunder, of which misconduct or unfitness you shall be sole judge, you shall be at liberty from and immediately after such misconduct or unfitness to discharge me from further service hereunder, and thereupon all pay and allowances hereunder shall cease, and I shall not be entitled to any free passage home or gratuity.



Temporary Appointments for Civil Surgeons in South Africa.

CONDITIONS.

Applicants must be qualified to practice medicine and surgery, and must be registered under the Medical Act now in force in the United Kingdom.

The period of service shall commence from date of embarkation from England, and shall continue until the expiration of 12 calendar months thereafter, or until his services are no longer required, whichever shall first happen.

The pay will (subject as hereinafter appears) be twenty shillings a day for the said period.

In addition to such pay, a free passage from England to South Africa, and (subject as hereinafter appears) a similar free passage from South Africa to England at the end of the said period will be provided, and there will also be given an advance of field allowance as for a Captain in the Army on proceeding abroad, and field allowance thereafter during service in the field, the use of a Government horse, and a soldier or civilian servant, and rations while in the field.

During the said period he must devote his whole time and professional skill to his service, and shall obey all orders given to him by Commissioned Military or Naval Officers, or by the Permanent Medical Officers of either of those services.

In case he shall complete his service to the satisfaction of the Secretary of State in all respects, he will receive at the end of the said period a gratuity of two months' full pay, at the rate hereinbefore specified, but in case he shall in any manner misconduct himself, or shall be (otherwise than through illness or unavoidable accident) unfit in any respect for service, of which misconduct or unfitness the Secretary of State shall be sole judge, the Military Authorities shall be at liberty from and immediately after such misconduct or unfitness, to discharge him from further service, and thereupon all pay and allowances will cease, and he will not be entitled to any free passage home or gratuity.


