Scutari, 9th Novr. 1854.

My dear Hall,

By this time you will have no doubt seen Dr. Spencer, who will give you all the news, etc. It appears this want of Lint and Linen etc. etc. has sent all the people of England mad, and I fear I shall now be quite stormed with supplies of all kinds from various quarters. Already I have got a parcel of Charpie from Smyrna sent with sut any address, and yesterday I had a communication from General Sir Ralph Darling at Brighton informing me that six cases containing the above mentioned articles and bandages were to be forwarded by H. M's Ship Miranda from the Ladies and xxx Gentlemen resident there, which of course I must acknowledge with thanks, but will mention at the same time that we were not so helpless as they imagined from the reports in the newspapers. I forward to you copy of an other extract from the "Sun" sent to me by the Director General and requesting that he may be furnished with all possible information in reference to the allegations contained therein, and to find out if possible the name of the writer, which will not be an easy matter to do, as I suspect it must have been a soldier in place of an officer. I may tell you that there was a great deal of confusion and irregularity in landing the sick and wounded on their arrival here from the vessel at the time alluded to, owing to the Admiral having sent his steamer on two different occasions alongside and put the sufferers on shore at an early hour in the morning contrary to my

wishes as wereak more than once expressed to the Commandant, until they had their dinners either on board or brought on shore cooked with the them, which was not the case on the two occasions I speak of, and probably this may have given rise to the remark, when disembarked, "they had neither tea, rations nor anything except \frac{1}{2} lbof Bread." I shall mention these particulars to Dr. Smith, with any other information collect respecting this paragraph in question.

Leutari Sept 28. - He have got to Scutari atlast, but Sthought we should not have brught any men at all, as the men keps during the voyage quickly dying of their wounds there were only 3 Largerns on bourd to duss and look after too men - my for, in not having sufficient hudical men to. attend the wounded soldiers, who risked their lives and bled for their country's honor. I never had my arm looked to by a Do from the day I received the wound tell yesterday, but thank God from previous expersence, I was able to look after it myself, and the wounds of others also, During our stay on bourd the ship many a bught man lost his lefe through the want of medical attendance, we through about 80 or 100 overboard coming down the Black Lea, but it is just as bad at Section, Me disembarked on the 96" and we have how neither tear vations, nor anything else except to bothead.

There was a draft of 300 man to have sailed today for the Crimea, but is was countermanded, There there are no more troops wanted in the Crimea, as Tebastopol is all but down, but I cannot vouch

for the buth of it.
