Translation of letter from Fl. Defays, Chemist, Chatelet, Belgium, dated 24th Jan. 1905, received here 26th Jan. 1905, addressed to Mr. Wellcome.

I have at home two bronze mortars 20 and 25 centimetres high which are not at all extraordinary as regards form, but which may be of interest to your exposition because of their origin. I think a great deal of them, but would consent to lend them to you. Here is their history:-

Towards the end of the 18th century, there was in Fleurus, province of Hainaut, a chemist named Pasquier, who was a great amateur collector of historic souvenirs. About 1793, the French revolutionists entered the little town as conquerors and set fire to the church. The bells melted in the steeple and as a souvenir of the episode, Pasquier had a mortar made for his pharmacy from a part of the débris. In 1819 after the famous of Waterloo, Pasquier like a great number of his fellow-citizens went to the field where Napoleon had fallen - Fleurus is only separated from Waterloo by about 3 leagues. He took some fragments of cannon as a souvenir of the field of battle, and had a second mortar made from them as a match for the other. His son Charles succeeded him and he after a few years left Fleurus and came to live in Chatelet. After having practised pharmacy for 50 years he retired in 1890 handing over his pharmacy to me and the two historic souvenirs of which he himself told me the story. Awaiting your reply, etc.

Translation of letter addressed to Mr. Wellcome by Angel de Diego, Valdemoro, Spain; dated Nov.1st, received Nov.6th, 1909.

I have received your favour of the 26th ult. and to correspond to your wishes, I am going to give you some details as regards the book in question.

The reading of this book causes a deep emotion, because many of the medicaments which are thought to be modern nowadays, were already known in those times in which medicine reached such a great splendour. Thus, for instance referring to Alums, it says:

9 ANS^o
NOV 1909

"Alums are useful to excrescences of the gums, and to the uvula and to purulent glands"

Therefore, they already knew the properties of this body. The same thing happens as regards ammonia of which they knew the property of curing drunkenness.

The said book was written by Dioscorides Anazarbeo, called "the freckled" and of whom Pliny and Suidas have mentioned, the latter writes saying:-

"Dioscorides Anazarbeo, Physician called the freckled owing to the freckles he had on his face, lived with Cleopatra and Anthony and wrote XXIII medicinal books very celebrated by the universal world".

It was translated into Castilian by Dr. Laguna who was Dr. to Pope Jules III and the edition made was very short in number, and this is so indeed, that notwithstanding the enquiries I have made both in the State Libraries as in private libraries, I have not been able to find another copy. Undoubtedly owing to the ignorance in those days they would throw it away without understanding its just and immense value.

Dr. Laguna added in it a good number of notes and comment of positive utility.

Dear Doctor kindly do me the kindness when writing, to inform me how it is to be sent and conditions and guarantees which I shall have, so that the book is neither lost nor damaged, as this would cause me great grief as I value it very much.





Extract From Mr. Wilkinson's letter dated from Barcelona, 22nd
October 1909, received here the 25th inst.

"re Antiquities. Dr. Degollado Oht. consejo de Ciento, Barcelona,
"with whom you have recently had some correspondence on this subject showed
"me yesterday some very old medicine books. They are in a fairly good
"state of preservation and to my untutored eye appear genuine. Will now
give you a few particulars on each.

"Fyrocunic Pharmacopeo, metodo Medico by Francisco de Mena Cyeto,
"Boticario en Getafe primero en la Imperial de Madrid. 1683. The above
"is an extract from the title page, there is a preface in verse with
"occasional headings in red print.

"Bound in card with leather back and parchment corners.

"Palestra Pharmaceutica, Treating of the selection of simples and
"making chemical preparations by Juan Higgins first doctor to King Philip
"V. This is a rough translation and paraphrase of the title page. 1725.

"Curso Quimico. Shewing the way to perform the usual operations in
"the preparation of medicine by the same author. 1718. Has a preface dated
"1702.

"Course of Pharmaceutics. A sort of catechism or cram book which is
"rather interesting. Date 1775 bound in parchment.

"The above books are of Spanish origin, by that I mean not mere
"translations but shewing actually the Spanish point of view in Medicine.
"Whether Higgins was an Irishman or a Spaniard I cant say but the name is
"nothing to go by as the Irish and Scotch as you know have left their names
"in continental history.

"The doctor also has at his disposal a DISGORIDES (?) dated 1500
"I regret I do not exactly know what this is but you of course will know
"whether it is of any interest.
"He is quite willing to lend these things for exhibition, and is not
"particularly keen to seal. However, he says that if any one takes a fancy
"to them during the exhibition he is open to an offer so as to oblige."
