To the Mayor, Aldermen and Councillors of the Metropolitan Borough of Stepney.

Your Worship, Ladies & Gentlemen,

I have the honour to present to you my Annual Report on the state of the public health in Stepney for the year 1962.

The 1961 Census returns show a decline in the population from 98,858 in 1951 to 92,000 (the estimate of the Registrar-General for 1962 being 90,480). Density, i.e. persons per acre, declined from 56 to 51 in the last decade. Structurally separate dwellings occupied increased from 24,895 to 26,524; persons per room declined from an average of 0.94 to 0.86, reflecting some improvement in housing.

In the early part of the year outbreaks of Smallpox occurred in a neighbouring county, and elsewhere in the country. This led to many requests from the general public for vaccination by their family doctors and at London County Council clinics. Numerous visits were made by officers of the Department, to keep under surveillance persons arriving from endemic areas abroad and secondary contacts of cases in this country.

Housing, in all its facets, continues to occupy a great deal of the time of the Department. Numerous deputations have been sent by the Council to the Ministry of Housing and Local Government and to the London County Council, with additional meetings at officer level to plan a concerted effort to rid the Borough of its existent 'black spots'. There is little doubt what ought to be done in the case of many slum tenement blocks, and other sub-standard properties. However, the shortage of land available for building at a reasonable price thwarts many urgent schemes. Whilst agreeing with a comprehensive development scheme for the area, it is irksome, to say the least, to observe large derelict areas left barren awaiting planned development and meanwhile attracting refuse dumping and caravan squatters. It is the conviction of many that revolutionary methods of building and a rationalisation of the industry, coupled with the will to make a top national priority of the need to provide decent homes for all, could quickly remove the scourge of slums and squalid overcrowded housing. As it is, a depleted public health inspectorate spends an increasing amount of time in an attempt to enforce standards in the worst type of property, often to the detriment of the necessary supervision of property whose useful life could reasonably be extended by maintenance of a reasonable state of repair.

The Housing Act 1961, particularly its powers in respect of Houses in Multiple Occupation, has brought a great number of houses in the Borough within the scope of the Department to ensure better standards of management and the provision of additional amenities in these properties. The formation of an expanded housing section in the Department to survey houses in multiple occupation, and assist landlords in their schemes for conversion, is already bearing fruit in a growing number of such houses being regularly inspected to ensure better standards. Management orders are being made, as required. The task is time-consuming, relying as it does on persuasion in the first instance, and because of the absence of any minimum statutory standard of essential amenities written into the standard of fitness.

In order that improvements to sub-standard property might be accelerated in this area the definition of standard of fitness contained in Section 4 of the Housing Act, 1957, should be so amended that a house is deemed to be not suitable for occupation unless reasonable amenities are provided therein.

To turn to a more comforting and encouraging aspect of the year's work, services for the care of the aged have been improved. The number of old people supplied with meals at clubs, or at home, continues to increase - thanks to the excellent work of The Stepney Old People's Welfare Association, and the purpose-built kitchen and club of the Women's Voluntary Service. With the decision of the Council to take over, as from April 1st 1963, the financial provision of this service, and using further powers now available, it is hoped to plan the integration of an invalid meals service within the existing old people's meals service. The Council has increased its subsidy to the flourishing Workroom for the Elderly which continues to run under a voluntary committee in premises owned by the Borough Council. The wisdom of setting up a Holiday Centre at Sandgate ensures that 18 Old Age Pensioners weekly can enjoy a cheap holiday away from Stepney under excellent conditions. The remaining 18 places filled as they are in the season by young family groups, maintains an all-age group clientele which is appreciated by most residents.

For some time, a survey of old people in the Borough has been discussed. Whilst this has not been possible under statutory authority, young people's groups of different religious affiliations are making door-to-door surveys in selected parts of the area. Their work may not be statistically valid by the standards of a professional social survey yet they have revealed old people in need. At the same time they have acquired an awareness of community problems, knowledge of which is likely to prove more beneficial in terms of human relationships than an arid scientific investigation.

The Consultant Chest Physician, Dr. R.M. Orpwood, contributes a general item on Tuberculosis in Stepney, on page 48 of the report. There has been some improvement over the year, but with the added problems that

arise in a 'mixed population' further work is required in selected groups "at risk". A project for 1963 includes special visits by the Mass Radiography Unit to lodging houses, areas showing high infection rates, and also an experimental once-weekly day visit to a static site in the Borough.

The psycho-geriatric ward, day hospital, and club at St.Clement's Hospital continue to flourish. An item taken from the annual report of the Consultant Psychiatrist is included on page 22. Provision of a hostel to care for mentally frail old people is still required in the Borough, as is the need for day clubs in the community to link hospital therapy with ordinary life outside.

A discussion on the rising rate of illegitimacy and venereal disease is on page 10. It is hoped that 1963 will bring a concerted effort with other interested statutory and voluntary bodies to reach the vulnerable younger age groups.

The policy of declaring smoke control areas, under the Clean Air Act, came under criticism with the 'smog' in December, 1962. Fortunately, the mortality rate attributable to this smog was less than that in a similar incident during 1952. The present schemes to reduce smoke emission by extending smoke control areas were vindicated. Research is required to find methods to reduce the sulphur content in fuels, prior to sale, so that health hazards from oxides of sulphur shall be minimised.

Stepney is a challenge. Much has been achieved, particularly in the post-war period, but much remains to be done before the new Stepney can be said to have emerged.

In conclusion I express gratitude to the Chairman and Members of Committees for their support. The continued co-operation of the Town Clerk and other Chief Officers of the Council and their staffs are acknowledged. To the staff of the Public Health Department I extend grateful appreciation of their loyal and efficient help at all times.

1. STATISTICS AND SOCIAL CONDITIONS OF THE AREA

General Information

The Metropolitan Borough of Stepney is bounded on the west side by the City of London, on the east by the borough of Poplar, on the north by the boroughs of Shoreditch and Bethnal Green and on the south by the River Thames, the river boundary being some 2.39 miles in length.

The Borough is roughly rectangular in shape, the length being 2.3 miles, the breadth varying from $1-l\frac{1}{2}$ miles and contains approximately 83 miles of streets. The area of the borough is 1,902 acres and of this the river accounts for 136 acres and inland waters consisting of docks and canals cover 75 acres.

Dark blue London Clay is found under the whole Borough at a depth of between 20-30 feet from the surface. Above this level are layers and patches of gravel and sand, brown and yellow clays being found nearer the surface. In some parts of the borough there are layers of "made" ground, the result of earlier habitation, and as is to be expected the flow of subsoil water is towards the river.

The area is to a large extent industrial in character, factory premises being spread throughout the Borough but tending to be concentrated towards the western end, with docks and wharves stretching along the whole of the river front which forms the southern boundary.

The chief industry of the Borough is the manufacture of clothing of all kinds, and it is estimated that one-third of the tailoring industry of London is carried on in Stepney. Other major industries include brewing, engineering, and the manufacture of furniture. Stepney is also one of the most important wholesaling districts in London. The Spitalfields Wholesale Fruit and Vegetable Market and the London Fruit Exchange are situated in the Borough. Notable landmarks in the borough include the Tower of London and the Royal Mint.

Fifty Years Ago

The Annual Report of the Medical Officer of Health for the year 1912 contains the following information :

The estimated population was 277,315 and the birth-rate was reported to be 30.9.

The death rate (uncorrected) was 15.3 per 1,000 population and the infant mortality rate 110 per 1,000 births. Among the causes of deaths reported were: Tuberculosis 538, Diarrhoea and enteritis 178, Measles 172, Cancer 232, Premature Births 184, Whooping Cough 90, Alcoholism 34, Diphtheria 25 and Scarlet Fever 14.

Deaths of children under one year included 178 from Diarrhoea and enteritis, 32 from Measles and 51 from Whooping Cough. There were 175 inquests on children under five years of age, 40 deaths being attributed to convulsions, 40 to overlying in bed by parents and 12 to burns and scalds.

Notifications of infectious diseases included 340 Diphtheria; 893 Scarlet Fever; 51 Enteric Fever, and 2,678 Pulmonary Tuberculosis.

Of the 1,249 samples of food analysed, 162 (13%) were found to be adulterated, as a result of which 79 prosecutions were taken. 130 samples of milk and 18 samples of butter were found to be adulterated. Of 118 samples of milk taken on Sundays, 15.2% were adulterated.

Legal proceedings were taken in 175 instances under the Public Health Act, Food and Drugs Acts and other Acts and Byelaws. The occupiers of 23 food premises were summoned for not keeping their premises in a clean condition. A wholesaler was sent to prison for four months with hard labour for selling for human consumption corned beef which was unsound.

Twenty-four pages were devoted to a report by the Medical Officer of Health on proposals suggested for a scheme for the prevention of tuberculosis.

Mothers-to-be employed in their own homes frequently worked to within a few hours of confinement and resumed work fourteen days later.

A man was kept in custody for eight days after being arrested for failing to appear to answer a summons regarding overcrowding. 17,135 inspections were specially made during the year for the purpose of detecting overcrowding.

The Reverend E. Carter, M.A., Vicar of St.Jude's Church, Whitechapel, and his wife, lost their lives when the s.s. "Titanic" foundered.

There were 32 cowsheds in the Borough licensed for the keeping of 917 cows.

The Report of the Borough Engineer and Surveyor stated that the earliest recorded street numbers in London were in Great Prescot Street, Stepney: this was mentioned by Hatton in 1708, and as the street was inhabited by rich foreign merchants it is probable that the system of numbering was introduced from abroad.

14,895 loads of hay and straw were brought into the Whitechapel Hay and Straw Market.

Census, 1961

The Report for the County of London on the Census of population taken in 1961, reveals the following information with regard to this Borough.

The population has decreased by 6,858 since the last census in 1951, equivalent to a reduction of 0.71% per annum which is the approximate mean for the County. During the intercensal period 1931-51, the population decrease in Stepney was the highest in London, namely 4.05% per annum. The excess of births over deaths for the last ten years would have given an increase of population of 0.69% per annum: the indication is that there was an annual emigration from the Borough of 1.4% of the population.

Of the total population of the Borough enumerated in the Census 6,550 resided in hotels, hostels, old people's homes, and other miscellaneous establishments.

The number of private households in the Borough has decreased by 635, whilst the number of structurally separate dwellings has increased by 1,629. Of the 26,524 dwellings in the Borough, 10,141 are Local Authority owned. The density of persons per room is 0.86%, as compared with 0.94% for 1951. The percentage of persons at more than $1\frac{1}{2}$ per room is 16.2, the fourth highest in the metropolitan area.

Households numbering 5,212, equivalent to 18% of the total, live in shared dwellings. Buildings containing more than one dwelling number 2,076.

Households without cold water supply in the dwelling number 232 (0.8%), without hot water supply 15,830 (54.2%), without fixed bath 16,530 (56.6%) and without a water-closet 587 (2.0%). 10,578 house-holds (40.4%) have the exclusive use of all the above amenities.

The number of persons of pensionable age, that is men over 65 and women over 60, is 12,193, there being 13 persons over 95 years of age.

Persons born outside the British Isles number 9,993, including 1,599 West Indians, 905 Indians, 789 Pakistanis, 770 Maltese, 698 Cypriots, 598 Africans and 296 other Asians. 5.9% of the population were born in the Colonies and Commonwealth countries, slightly more than the figure for the County of London which is 5.8%.

Population

The Registrar-General's mid-year estimate for 1962 is 90,480. Last year's estimate was 91,710.

The density of population is now 51.23 persons per acre. In 1912 it was 157 per acre.

During the year there was a natural increase in population of 719; that is there were 719 more births than deaths. The Registrar-General estimates the population to be 1,230 less than last year, the indication being that 1,949 persons have moved out of the Borough.

Births

The total number of live births registered in the Borough, during the year, was 4,396 and of this 2,700 belonged to other areas. In addition 156 births belonging to Stepney occurred outside the borough, making a total of 1,852 births (945 Males; 907 Females) to Stepney residents.

The live birth rate is 20.47 per 1,000 population, the highest since 1946. The rate when adjusted by the comparability factor is 18.6 compared with the rate for England and Wales of 18.0, the highest since 1947.

Illegitimate live births numbered 269, representing 14.31 per cent of the total live births.

Still-births numbered 36, representing a rate of 19.06 per 1,000 total births, compared with 18.1 for the country as a whole.

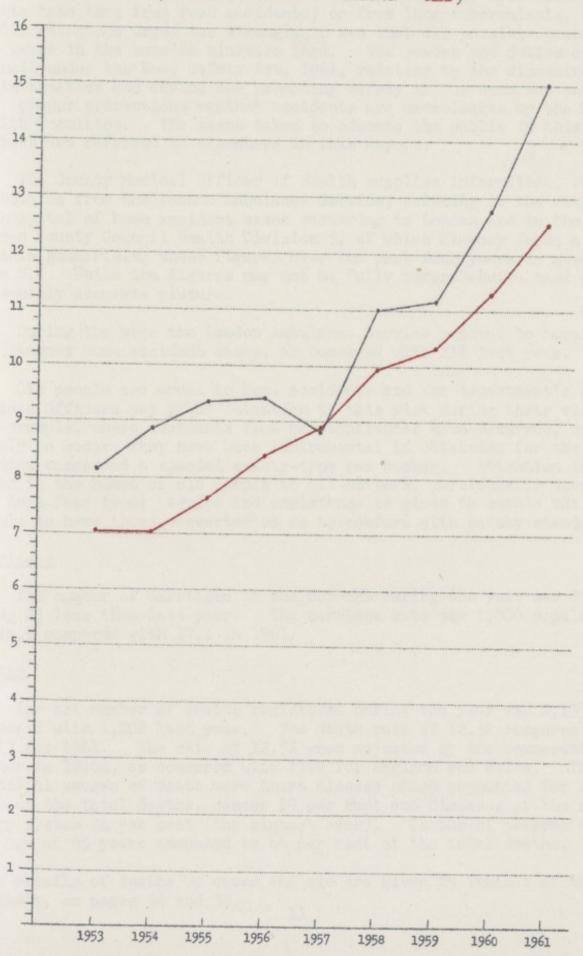
Illegitimate Births

The graph (opposite) shows the increase in illegitimate births since 1957 for the London County Council area, and for Stepney. These figures taken with the rising number of cases of venereal disease, perhaps demonstrate changing moral values in our society. Unfortunately, children born out of wedlock show higher morbidity and mortality rates compared with those born into a normal family. Also the social ostracism met by the unmarried mother creates a mental atmosphere which cannot be conducive to the wellbeing of the developing child. As has been said, there are no illegitimate children, only illegitimate mothers and fathers! Whilst to welcome the trend evidenced by the rising illegitimacy rate would be nonsensical, yet there should be no doubt about what to do to help the child involved. This would appear to be an age of transition in respect of moral codes. It behoves the older generation to seek a synthesis of that which is best in the old tradition - particularly in regard to stable family life - with that which is laudable in the new, namely, franker, less hypocritical views on sex. To condemn youth, whilst not providing positive standards for their aspirations, will do nothing to prevent a trend which can prejudice the health of an increasing number of vulnerable babies and children.

Accidents in the Home

Many more deaths throughout the country occur now from accidents in the home than from road accidents, or from lung tuberculosis, and the public cannot be urged too strongly to see that all possible precautions are taken in the home to minimise them. The powers and duties of the Council under the Home Safety Act, 1961, relating to the dissemination of information and advice for promoting safety in the home and encouraging proper precautions against accidents are exercisable by the Public Health Committee. The means taken to educate the public in this respect are referred to elsewhere in this Report.

The County Medical Officer of Health supplies information, which he obtains from the London Ambulance Service, relating to the removal to hospital of home accident cases occurring in London and in the London County Council Health Division 5, of which Stepney forms a part. A table summarising these figures over the past four years is given on page 61. While the figures may not be fully comprehensive they give a reasonably accurate picture.

During the year the London Ambulance Service removed to hospital 155 Stepney home accident cases, as compared with 218 last year.

Old people are prone to home accidents and the department's women Hygiene Officers pay great attention to this risk during their visits. For example, where accidents from gas appliances have occurred, or are likely to occur, they have been instrumental in obtaining for the old persons concerned a special safety-type gas cooker. Attention is also given in the homes of old people to oil-heaters, particularly those of the drip-feed type; advice and assistance is given to enable the old people to have these converted so as to conform with safety standards.

Marriages

The number of marriages in the Borough during the year was 764, being 23 less than last year. The marriage rate per 1,000 population is 16.9 compared with 17.1 in 1961.

Deaths

The net number of deaths registered during the year was 1,133 compared with 1,208 last year. The death rate of 12.52 compares with 13.13 for 1961. The rate of 12.52 when adjusted by the comparability factor is 12.64, as compared with 11.9 for England and Wales. The principal causes of death were heart disease which accounted for 29 per cent of the total deaths, cancer 19 per cent and diseases of the respiratory system 24 per cent (the highest ever). Deaths of persons over the age of 65 years amounted to 66 per cent of the total deaths.

Details of deaths by cause and age are given in Table I of the Appendix, on pages 58 and 59.

Infant Mortality

Deaths of infants under one year numbered 33, giving a rate of 17.82 per 1,000 live births, the lowest ever recorded - as is the rate (21.4) for England and Wales.

The tables on page 60 show the deaths from stated causes at various ages under one year, together with comparative figures over the last five years.

Perinatal Mortality

The perinatal mortality rate of infants (viz. still-births plus deaths occurring in the first week of life) was 30.72 as compared with 36.78 last year.

Neonatal Mortality

During the year there were 24 deaths of infants under four weeks old, representing a neonatal mortality rate of 12.96. Last year there were 32 neonatal deaths, the rate being 17.17.

Maternal Mortality

There were no maternal deaths during the year.

Accidental Deaths

The number of deaths due to accidents was 31, or nine less than last year. These included 9 due to motor vehicles (one more than in the previous year); 9 in the home; 1 at work; 1 from drowning, and 11 due to various other causes. (See Table 2 on page 59 relating to Road Accidents.)

II. GENERAL PROVISION OF HEALTH SERVICES

AGED PERSONS WELFARE

The Council is empowered by Section 47 of the National Assistance Act, 1948, as amended by the National Assistance (Amendment) Act, 1951, to make application to a Court of Summary Jurisdiction for an Order for the removal to a hospital or institution of any aged, infirm or physically incapacitated person living in insanitary conditions and who is in need of care and attention.

During the year, it was necessary to apply for five Removal Orders and one Extension Order under this enactment in respect of the following persons:-

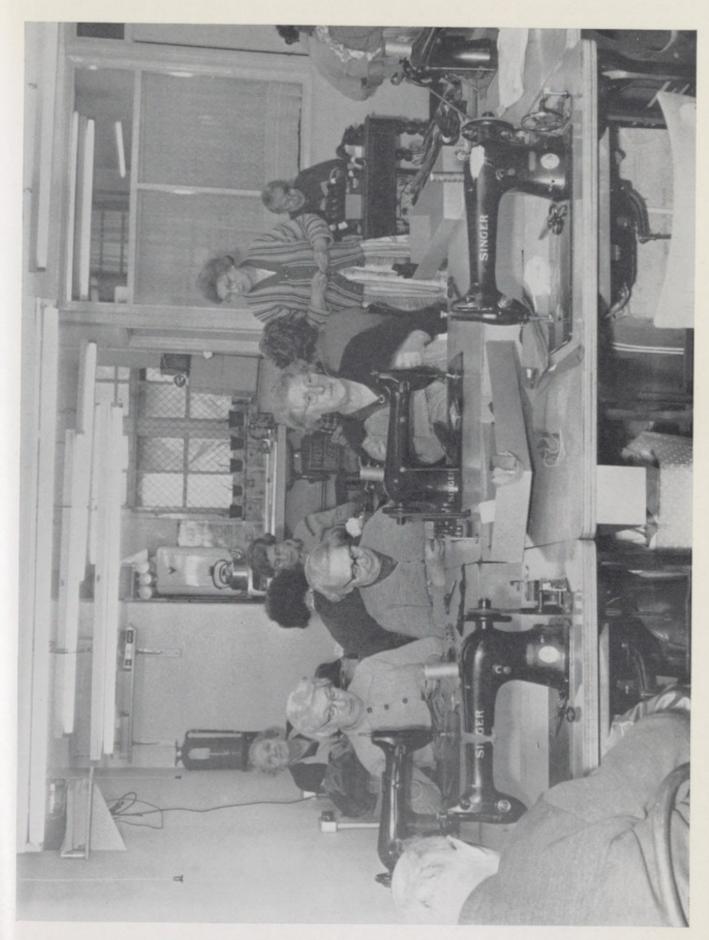
In addition to those removed under Magistrate's Orders, admission to a hospital or institution was obtained for 18 other persons.

Two women officers, one a State Registered Nurse and certificated Health Visitor, are employed for visiting aged persons in the Borough, and 3,252 visits were made by these officers during the year.

A register of all old persons visited is kept in the Department. Amendments made to the Register during the year are as follows:-

The Department continued operating its Laundry service (begun in 1951) for the chronic sick who are unable by reason of ill-health, senility, etc. to keep their personal laundry and bed linen in a clean condition. During the year, 343 parcels of laundry were dealt with.





In order to prevent injury, or danger of injury, to health, Section 43 of the London County Council (General Powers) Act, 1953, operated by the Borough Council, makes provision for the personal cleansing in their own homes of aged persons who are verminous or otherwise in need of bathing. 910 baths were given to 82 old people during the year by the Council's Home Bathing service, which was inaugurated in 1950.

The National Assistance (Amendment) Act 1962 substitutes a new section for Section 31 of the Act of 1948, with the effect of extending previous powers of local authorities under this section so as to enable them (a) to assist voluntary organisations in providing meals or recreation for old people by making a contribution towards the cost thereof; to provide by gift or loan or otherwise, furniture, vehicles or equipment; to permit the use of premises belonging to the local authority; to make available the services of the local authority's staff connected with the premises or vehicles which the organisation is permitted to use, and (b) to provide meals and recreation for old people either directly or through the agency of voluntary organisations and to recover such charges (if any) as the authority may determine, having regard to the cost of the service.

The Council's grant for the year 1962-3 to the Stepney Old People's Welfare Association, for allocation as appropriate to the various organisations in the Borough catering for the welfare of old people, amounted to £8,800.

There are eighteen old pople's clubs in the Borough, all affiliated to the Stepney Old People's Welfare Association.* Three clubs closed during the year and a new one opened. The Council is represented on the Association by the Chairman of the Public Health Committee and other members of the Council and by the Medical Officer of Health.

A list of Clubs and the facilities thereat will be found on page 80.

A grant of £1,410 was also made to the Workrooms for the Elderly, a voluntary organisation, £410 being in respect of adaptation, rent and rates of premises owned by the Council and made available to the organisation in April this year. (See photograph opposite page 14).

There are now five vehicles employed by the various voluntary organisations in delivering meals to old people. The Mobile Meals Service operated by the Stepney Old People's Welfare Association, the Women's Voluntary Service and the Beaumont Hall Settlement stepped up

their deliveries to a weekly average of 923 meals to homebound old people. Eight of the old people's clubs, which include luncheon clubs among their facilities, provided an average of 665 meals each week.

A Chiropody service is provided by the Stepney Old People's Welfare Association at clinics situated in five of the old people's clubs in the Borough, and an average of 278 treatments including domiciliary treatments were given each month during the year.

This year saw the completion of the first project of the Stepney Old People's Housing Association Ltd., namely the provision of eleven units of accommodation for single and married old persons, and accommodation for a caretaker, obtained by acquisition of the lease and the conversion of Nos.27 and 28 Tredegar Square which were formerly requisitioned by the Council. The Council assisted in the project with an interest free loan of £6,700.

As a frontispiece to this report there is a photograph of a former 17th century almshouse chapel in the Borough, opened this year by the County Council as a Rehabilitation Centre for handicapped persons.

AMBULANCE FACILITIES

The London County Council is responsible under Section 27 of the National Health Service Act, 1946, for the provision of Ambulance transport within the administrative County of London.

DECEASED PERSONS

<u>Inquests</u>. Inquests were held on 50 residents of the Borough, the verdicts being 7 deaths due to road accidents; 21 other accidents; 15 suicides; 1 acute alcoholism; 1 misadventure; 2 manslaughter; 1 murder and 2 open verdicts.

Burials. Section 50 of the National Assistance Act, 1948, places a duty on the Council to arrange for the burial of any persons found dead within the Borough where no private arrangements have been made.

23 such burials took place during the year - 18 adults and 5 children, at a cost of £266 of which sum £129 was recovered by the end of the year either from the estates of the deceased persons, from liable relatives or by way of grants made under the National Insurance Act 1946.

15 requests for burial came from H.M.Coroner's Officer, 7 from relatives and one from a friend of the deceased.

It is often necessary where persons living alone have died in the Borough, to dispose of the contents of their homes. This is done in conjunction with relatives of the deceased, or with the Treasury Solicitor where there are no known relatives, and has the effect of releasing the accommodation for housing purposes as soon as possible.

FREE WASHING FACILITIES

The Council provides free washing facilities in 16 of the twentytwo Public Conveniences in the Borough, with the aim of promoting food hygiene and cleanliness.

HEALTH EDUCATION

The programme of health education continued throughout the year. Each month a different topic is chosen, either to coincide with a national campaign or at a time of year when the incidence of a particular health hazard increases.

The operation of the Council's third Smoke Control Order was given intensive publicity in that part of the Borough covered by the order.

The Department's Poster Boards were used to display various posters during the year, as were also the Council's official notice boards and those affixed to lamp columns in street markets in the Borough. The occupiers of several large factories and some chemists' shops accepted posters for display and leaflets for distribution. With the co-operation of the Borough Librarian, bookmarks and leaflets on various health subjects were distributed from the lending section of the borough Libraries. Some 3,000 posters and 21,000 leaflets were distributed.

In view of the dangers associated with defective and badly maintained oil heaters, posters and leaflets were distributed in the winter months. Copies of posters were printed in Greek and Turkish for the benefit of non-English speaking Cypriots. The Pakistan High Commissioner's Office was approached for a translation of the posters into Bengali and Urdu to help Pakistani and Indian residents in the borough. A monthly bulletin giving details of the incidence of infectious diseases, and data supplied by the local office of the Ministry of Pensions and National Insurance on persons claiming sick benefit - plus health propaganda material for surgery waiting-rooms, were circulated to local general practitioners and hospitals.

In an attempt to put over by more direct means elements of positive health, a course of four weekly lectures on Food Hygiene and practice, supported by films and practical demonstrations, was held at the Public Health Department. These were attended by the food supervisory staffs of local firms undertaking food manufacturing processes or running large workers canteens. The food inspectors in their daily work at such premises endeavour to raise the standards of food hygiene. Lectures and film shows were also given to a local school, to a postgraduate group of social science students, and at a local hospital to a regional meeting of the Royal College of Nursing during the smallpox outbreak in other parts of the country.

By invitation of the Medical Officer of Health, City of London, and St.Bartholomew's Hospital, E.C.l, the facilities of the diagnostic clinic for women at the hospital were made available to residents and workers in Stepney, in addition to those working in the City. This clinic aims to detect malignant, or other gynaecological pathological states, at a time when preventive measures can guarantee cure. Perhaps

2 per cent (1 in 50) of working-class women who have borne children might expect to develop cancer of the womb (cervix) in present conditions. Curative treatment is often possible if the condition is detected at an early stage. Firms employing women in the borough were circularised urging the value of these preventive health investigations for women over the age of 35 years. A pelvic examination and a cervical smear (Papanicolau technique) is undertaken, by appointment, at the clinic.

This year the Council became affiliated to the Home Safety Section of the Royal Society for the Prevention of Accidents, advantage being taken of the purchase of publicity material made available by that body which was used in a campaign held during the month of July.

Publicity was also given to the Council's Holiday Centre by means of advertisements in the Press, slides shown in local cinemas, posters and leaflets. A campaign on the relationship between smoking and health was also carried out. Vacant sites in the borough were posted up with notices warning the public against depositing rubbish and also against the use of the land as caravan sites.

Publicity was given to other subjects including diphtheria immunisation; vaccination against poliomyelitis; food hygiene; influenza, and the care of the elderly.

HOLIDAY CENTRE

During the year 1,137 Stepney residents spent a holiday at the Council's Holiday Centre, The Manor House, Sandgate, near Folkestone, Kent: this number included 723 aged persons and 146 children. The total number of weekly bookings was 1,268.

The Holiday Centre is open all the year round and is available to any resident of the Borough, young and old — half the total accommodation is alloted to the latter each week. Coach transport is provided to and from the Manor House and the Public Health Department.

The management and control of the Holiday Centre are vested in the Council's Physical Training and Recreation Committee, and the day-to-day administration is the responsibility of the Medical Officer of Health.

Difficulty is experienced in getting residents of the Borough to use the facilities for a holiday in the Winter. It is appreciated that because of work and school commitments families with children cannot take advantage of the holiday centre, but one might consider that old people would welcome a winter holiday. The intensive publicity measures taken in the autumn (referred to above) as well as personal contact by the department's Hygiene Officers have resulted in only a slight improvement in winter bookings.

Investigations were carried out on 140 specimens submitted by the Medical Officer of Health and by medical practitioners in the Borough during the year. The specimens comprised 113 faeces, 17 throat swabs and 10 rectal swabs.

PSYCHO-GERIATRIC SERVICE - ST.CLEMENT'S HOSPITAL

The catchment area for the psycho-geriatric services provided at St.Clement's Hospital comprises the boroughs of Bethnal Green, Poplar and Stepney. The Consultant Psychiatrist, Dr.W.M.Ford Robertson, at the Psycho-Geriatric Day Hospital and Dundee Ward in St.Clement's Hospital, reports:

"As the Day Hospital and Dundee Ward have now evolved as one integrated unit it has seemed appropriate to summarise the results of inpatient care. There was a turnover of about two patients a week in this 22-bedded ward, the average length of stay being 11.5 weeks. During the year the Day Hospital with 24 places had a total of 5,391 attendances - 4,161 females and 1,230 males. The principal diagnostic categories were - in order of frequency - depressive illness, confusional states, paranoid states and dementia. Practically all those discharged home or to hostels (almost three-quarters of the discharges) were improved. Arrangements were made for many discharged from the ward to attend the Day Hospital, with which they had become familiar through visits during their stay. Delays of several months, however, were almost invariably experienced before transfer of patients to Long Grove or Part III accommodation could be effected. Most of such patients were found after admission to be demented and unfit to return home. The demand for beds from the community remains considerable.

"During our second year, the capacity of the Day Hospital has been seen in clearer perspective both in its potential and in its limitations. This is, we believe, the result of increased clinical experience, and also better co-operation and understanding from all those in the community whose interest lies in the aged and mentally ill. There has been no lack of candidates to fill the 24 places with the result that patients have been better selected, which is partly reflected in the increased proportion and improved mental state of patients eventually discharged in 1962. Referrals by psychiatrists have been confined to those with undoubted mental illness. Patients from all other sources have been assessed at our Out-Patients Department prior to acceptance.

While the rate of admission and the overall distribution of diagnosis have altered little, and the factor of social isolation remains important in nearly every case, the proportion of patients suffering from little more than loneliness has been reduced.

"In spite of the encouraging improvement in the discharge figures, by comparison with Day Hospitals for younger patients, the turnover is low and the numbers returned to the community perhaps unimpressive. However, when mental illness is superimposed on ageing, with such factors as social isolation and diminished resistance with greater incapacitation by illness, perhaps our figures cannot be much improved. In the more severely ill patients, Dundee Ward is the place of choice as the first stage of treatment. Later, the Day Hospital is used for rehabilitation. The Day Hospital serves best the convalescent and those whose illness is moderately incapacitating, often insidious in onset and chronic in course. In such cases the Day Hospital supplies an alternative to permanent in-patient treatment. Response is fairly rapid to full-time attendance but reduction may lead to difficulties, and to cut down too much may be to see a return of symptoms. service given by the Day Hospital, even supposing not more than 50 per cent of its patients are returnable to the community, can also be gauged by those it manages to keep out of hospital, general or psychiatric, as permanent residents. This is in line with the idea that the aged should be kept in community care as long as possible. Our capacity to do this more effectively, and on a larger scale, will depend on the development of club facilities in the community of a kind different from those well established for persons without psychiatric disability, usually in the first decade after retirement. This aspect of after-care deserves to receive much more urgent consideration; we ourselves have taken the following steps to develop our own ideas.

"Late in the year we formed a social club within the Day Hospital itself which on two afternoons a week is open to any ex-patients living nearby and prepared to attend without provision of transport. The work of the Social Department has been extended but still more has to be done, especially in the community in conjunction with the welfare officers of the Local Authority and Voluntary Associations. Relations with such bodies have been fostered through the bi-monthly meetings of our committee and by the routine forwarding of information about patients to the Medical Officers of Health and their welfare staffs, as well as to Practitioners, when patients are admitted and discharged. Having been enlarged the membership of the Day Hospital Committee has become more representative and useful."

SWIMMING AND SLIPPER BATHS

Four Swimming Baths are provided by the Council in the Borough. The Open Air Swimming Bath at Goulston Street was reopened in May after reconstruction. During the year the number of Swims taken amounted to 125,583, comprising 18,204 adults and 107,379 children and juveniles.

The water is subjected to a continuous chlorination and filtration process, passing through the filters once every 31-hours. 30 samples were taken during the year for bacteriological and 30 for chemical analyses. Four samples showed the presence of b.Coli while some revealed a low free chlorine content and/or pH value.

The number of Slipper Baths taken during the year at the four Council establishments was 161,105, which included 5,745 by old age pensioners and six by unemployed persons who were admitted free of charge:

The total number of persons admitted to all sections of the Baths and Washhouses Department, including the Laundry, was 325,453.

III. SANITARY CIRCUMSTANCES

The District Public Health Inspectors served 2,308 Notices during the year, and in 46 cases legal proceedings were employed to enforce compliance therewith.

At the end of the year, the Department was still four below the establishment of District Inspectors.

Aspects of the work of the inspectors not covered in the following paragraphs will be found in the statistical appendix, pages 64 to 66.

Certificates of Disrepair (Rent Act. 1957)

During the year, 29 applications under the Rent Act 1957 were received from tenants for Certificates of Disrepair, 13 certificates being issued. The Council exercised its right under paragraph 5 of the First Schedule to the Act in refusing to accept undertakings from landlords in respect of eight premises.

Clean Air

The Borough's third Smoke Control Order made under the Clean Air Act, 1956, was confirmed by the Minister of Housing and Local Government in March and came into operation on 1st October, 1962. At the end of the year the Minister's confirmation of Area No.4 was awaited.

Area No.3 is one of 90 acres and comprises 1,914 dwellings and 145 commercial, industrial and other premises. A survey of the area revealed that the number of appliances in dwellings which were in regular use, and which required replacement or adaptation, was 670.

There is, in the Public Health Offices, a Smoke Control Exhibition always open to the public in which is displayed various types of approved space heating and cooking appliances and authorised fuels. Arrangements are also made with the Solid Smokeless Fuels Federation for their Demonstration Van to tour each smoke control area for a week, immediately prior to the date the Order comes into operation.

Facing the next page is a Map showing the Smoke Control Areas established in the Borough.

Under the provisions of Section 3(3) of the Clean Air Act, 1956, furnaces may not be installed in buildings unless notice of proposal to install has been given to the Council. Notices were given to the Council of proposal to install furnaces in 30 premises. Persons who installed furnaces in two premises without giving the requisite notice were cautioned.

Measurements of air pollution are taken regularly in the Borough by means of lead peroxide instruments which give monthly records of the concentration of sulphur in the air, and also by combined smoke filters and volumetric sulphur dioxide apparatus which afford daily readings. The use of deposit gauges which gave records of soluble and insoluble matter deposited was discontinued after November this year.

Details of visits and inspections made by the Smoke and Factories Inspector are given on page 67.

Drainage and Sanitary Conveniences

Considerable use is being made of Section 25(1) of the London County Council (General Powers) Act, 1955, whereby a Public Health Inspector can serve a notice requiring the owner to clear an obstructed drain within 48 hours, and if the notice is not complied with during that time the Council may themselves execute the work and recover the cost from the person responsible. Notices under this section served during the year numbered 263, the Council having executed the work in 51 instances.

Seven summonses were taken out for failure to comply with notices served under Section 40 of the Public Health (London) Act, 1936, for the repair of defective drains, and two for failure to comply with notices served under the London County Council (Drainage) Byelaws. Fines amounting to £15 with costs of £25.14.0d were imposed.

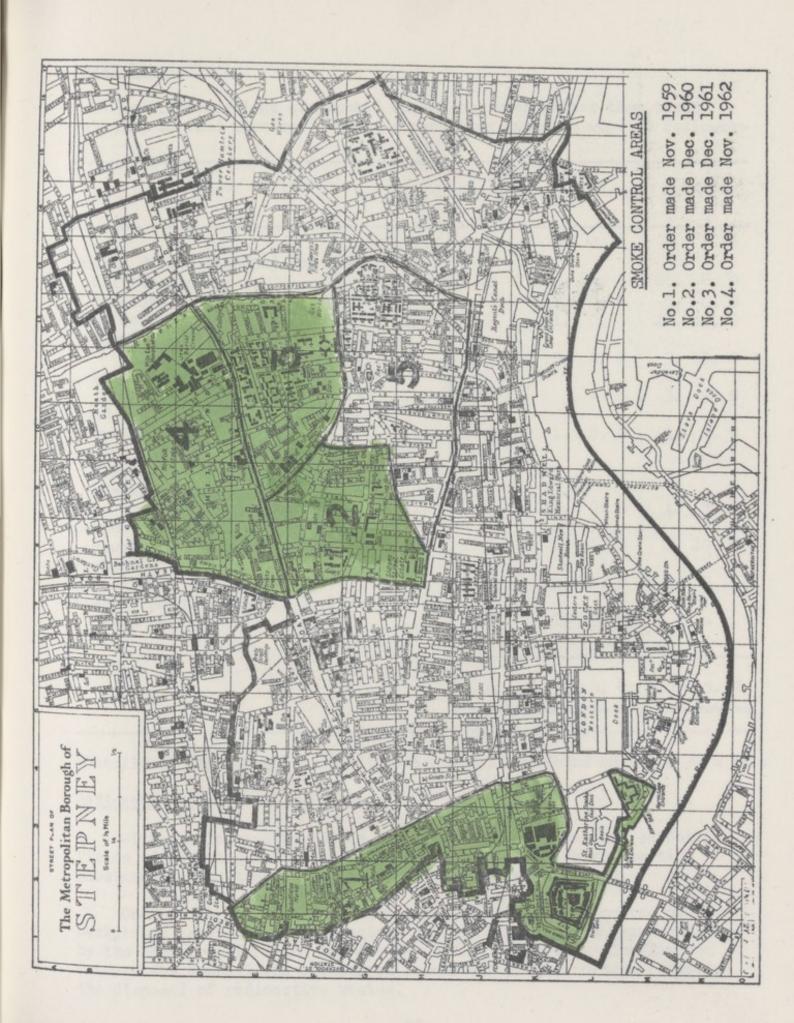
Factories

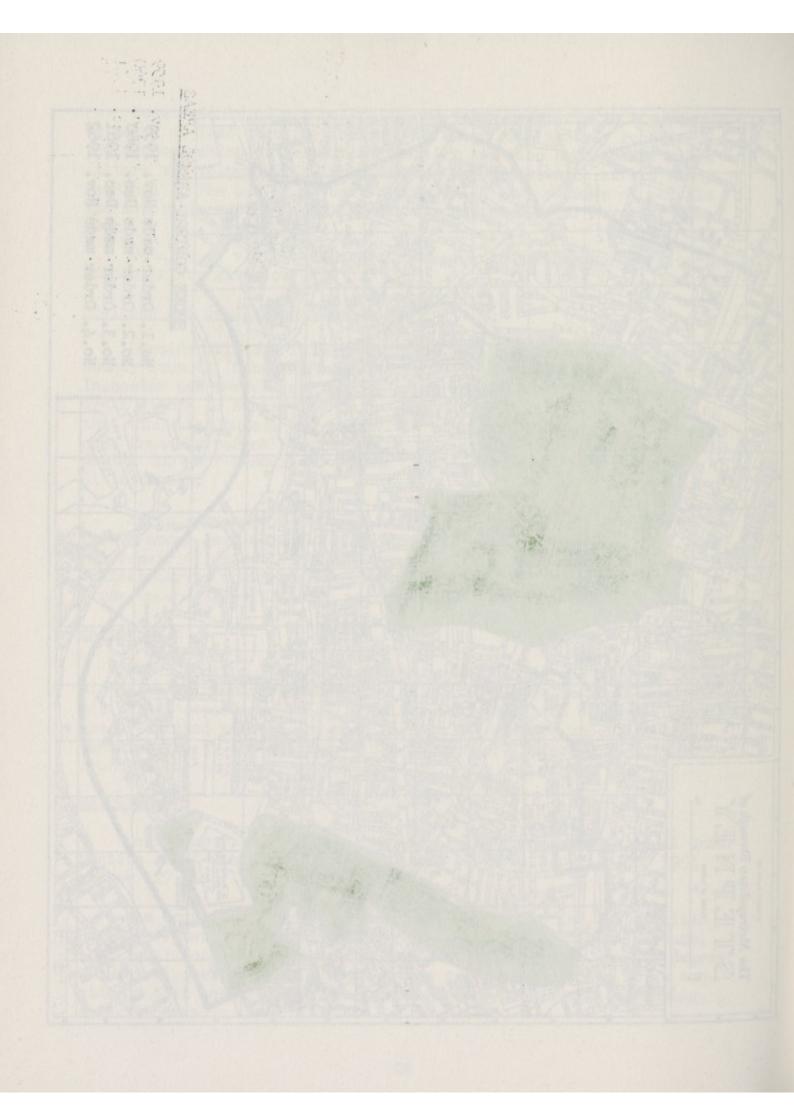
Under Section 153 of the Factories Act, 1961, the Medical Officer of Health is required among other things to report to the Council in his annual report specifically on the administration of, and furnish the prescribed particulars with respect to, matters under the Act administered by the Council. The particulars referred to will be found in the Appendix, pages 68 and 69.

Hairdressers

Hairdressers and barbers premises registered by the Council under Section 18 of the London County Council (General Powers) Act, 1954, number 127.

The Council supported representations made to the Metropolitan Boroughs' Standing Joint Committee by another metropolitan borough, that local authorities should be enabled to exercise a greater degree of control over premises and to refuse registration where it is considered that the premises are unsuitable for use as a hairdressing establishment.

Radioactivity

With the increasing use in the industrial, medical and scientific fields of ionising radiations and materials containing radioactive substances, attention is being given to this modern hazard.

One of the Public Health Inspectors has attended a course of background training on radiological health and safety as recommended by the Ministry of Health in Circular 31/61. There is also liaison between the Council and a research laboratory in the Borough regarding the disposal of radioactive wastes.

Refuse Disposal

The Public Cleansing Officer has kindly supplied the following information on refuse disposed of during the year :-

Where possible refuse collection is carried out by means of "Paladin" containers, mainly from blocks of flats, throughout the borough. This method was adopted in 1955 since when 732 of these containers have been installed.

The Cleansing Department carried out 26,511 cleansings of 5,131 street gullies by means of mechanical gully emptiers.

Lodging Houses - Common

There are three common lodging houses in the Borough, providing accommodation for 726 persons as follows :-

Another dormitory at 177, Whitechapel Road was brought into use during the year, increasing the accommodation by 23 beds. At the invitation of the Salvation Army, members of the Public Health Committee carried out a tour of inspection of this lodging house.

Accommodation was re-opened during the year at the Empire Memorial Hostel increasing the facilities available to seamen by 43.

Lodging Houses - Other

In addition to the licensed common and seamen's lodging houses, there are two other premises in the Borough which provide lodgings but which are not subject to licensing or registration, viz: Tower House and Providence Row Night Refuge.

Tower House (formerly known as "Rowton House"), which was opened in 1902, provides accommodation for 694 men and Providence Row Night Refuge for 77 men, women and children.

Half the poultry slaughterhouses in the Borough were established before the function of granting Establishment Orders was transferred from the County Council to the Borough Council. The orders for such premises not being renewable annually, the Borough Council have no powers to impose conditions regarding, for example, the hours during which slaughtering and delivery of poultry may take place. In the absence of such conditions nuisances have arisen from noise, particularly, in the early morning.

The Council during the year made representations to the Secretary of State, the London County Council and the Metropolitan Boroughs' Standing Joint Committee urging that powers be conferred upon the Council to permit them to review all establishment orders annually, and to impose conditions.

Representations were also made to the appropriate authority expressing the Council's hope that everything may be done to expedite the establishment of a centralised poultry slaughterhouse.

Rodent Control

In accordance with the requirements of the Ministry of Agriculture, Fisheries and Food, statistics on Rodent Control work carried out by the Department during the year were submitted to the Ministry. During this period 2,421 dwellings and other premises were inspected, and 1,027 were found to be infested with mice or rats. Treatments were carried out by the Department's rodent control staff to 839 properties found to be infested, the charges made for servicing business premises amounting to £401.

By the implementation of Section 4 of the Prevention of Damage by Pests Act 1949, it has been found possible to clear bombed sites of refuse which would otherwise act as possible harbourage for rats and other vermin.

Moreover under the same section which permits specified works to be carried out, it has been possible to require sites to be fenced in by the owners.

Legal proceedings were taken against the owners of three properties for failing to comply with notices served under Section 4 of the Prevention of Damage by Pests Act, requiring the removal of rat harbourage and the prevention of deposition of further harbourage by the erection of a closed fence or wall around the sites. The summonses were proved, fines totalling £12 with costs of £1 being imposed.

A copy of the return furnished to the Ministry is on pages 62 & 63.

The Council carries out on behalf of the Stepney Group Hospital Management Committee any necessary treatments for rodent infestation at Hospitals and other premises in the Borough, which come under the control of that Committee.

Shops

The number of premises in the Borough covered by the provisions of the Shops Act 1950, is 3,134. Certificates were granted during the year under Section 38(6) of the Act in respect of two premises exempting them from compliance with sanitary accommodation provisions.

Water Supply

The whole of the Borough is supplied with water by the Metropolitan Water Board, which is the authority responsible for its purity. The quantity and quality of water supplied by the Board during the year have been satisfactory. All the premises in the Borough are supplied individually direct from the public water mains.

The number of instances where the water supply to premises was repaired or reinstated, following action taken by the Department, totalled 140, and the Metropolitan Water Board was notified on 40 occasions where wastage of water was taking place.

During the year, 24 notices were received from the Metropolitan Water Board of withdrawal of water supply: in six premises for non-payment of rates and in 18 because of defects in the service.

Water Certificates

Water certificates as to new dwellings having a proper and sufficient supply of water, were issued under the provisions of the Public Health (London) Act, 1936, in respect of 743 dwellings.

Wells

Bacteriological and chemical analyses of water from the four deep wells in use industrially in the Borough are made periodically and the results reported to this Department. All were reported as satisfactory.

IV. HOUSING

Clearance Areas

During the year two clearance areas, involving 149 houses, were declared by the Borough Council.

Demolition Orders

The Council made demolition orders in respect of three premises during the year. As a result of appeals, one order was quashed, and closing orders were substituted for the remaining two demolition orders. An appeal against a Closing Order made by the Council was dismissed.

Overcrowding

During the year 57 cases of alleged overcrowding were investigated, 32 of which were confirmed and referred to the London County Council.

Twenty overcrowded families were rehoused by the London County Council and 8 by the Borough Council.

The Register of overcrowded premises was reviewed during the year. It was found, following a survey, that for reasons such as children having married or obtained other accommodation, removals, etc., the register was reduced from 355 to 183.

Underground Rooms

There are approximately 1,500 underground rooms in the Borough used for living or sleeping purposes, of which 1,450 are unfit. During the year, 7 rooms were closed and Closing Orders on three rooms were determined.

A summons issued for the occupation of an underground room in contravention of a closing order resulted in the owner being fined £4 with £3.3.0 costs.

Town & Country Planning (Housing Accommodation) Direction, 1952

Under this Order the Borough Council is consulted by the London County Council (the Planning Authority) before applications are determined for planning permission for development involving change of user of premises from use as a dwelling. Investigations of 22 such applications were carried out during the year.

Applications for Rehousing

At the end of the year, there were 2,472 applications for rehousing on the Housing Manager's register. These included the tenants of 154 Council dwellings who desired larger or smaller accommodation.

Preferential Housing on health grounds

Thirteen of the 25 cases investigated were found to come within the Council's Points Scheme.

Caravans

Although not many caravans find their way into the Borough to park on derelict sites, the few that do arrive cause no little concern because of inadequate environmental hygiene conditions (see photograph). The metropolis cannot offer these facilities for this type of dwelling. Water is obtained by buckets from nearby residents, refuse is disposed of by distribution over the site around the caravan, and pail closets are often emptied into the sewer via the nearest street gully.

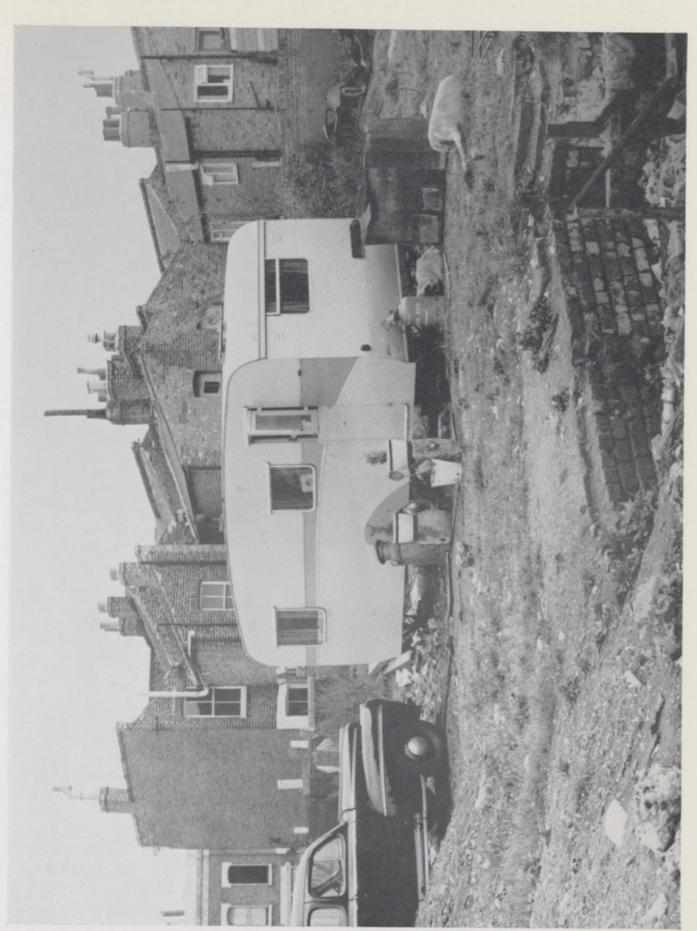
To employ the processes of the available laws in order to move caravans off unsuitable sites is an arduous and tardy procedure. The first difficulty occurs in serving a summons - the owner or occupier of the caravan invariably and coincidentally is absent when the Warrant Officer calls. The next hope (often a vain one) is that he will appear at Court to answer the summons. After a lengthy period - often as long as six months - the summons is heard, complaint proven and the defendant perhaps fined £1. In effect, he can live at a rent of £1 for six months and, in consequence, often stays on the site awaiting a further summons, or may condescend to move his caravan on to a derelict site in the next street. There is no provision for the Court to order the removal of the caravan. The time spent by officers of the Council to hatch this egg is out of all proportion to the result achieved.

In order to prevent nuisances arising from misuse of open sites there should be legislation to compel the person who demolishes any premises to enclose the site by a suitable wall, not chain link fencing or chestnut paling, before he leaves the site.

Summonses numbering 11 were taken out against caravanners who contravened Section 22 of the London County Council (General Powers) Act, 1959, by stationing their caravans on land which was not licensed for the purpose. Five summonses were heard, resulting in fines of £17 with costs of £4.3.0d.

Houses in Multiple Occupation

Part II of the Housing Act, 1961, extends the powers given to local authorities under Sections 36 and 90 of the Housing Act, 1957, to deal with houses in multiple occupation. Although the Act itself came into operation on 24th November 1961, the Regulations made thereunder, namely, the Housing (Management of Houses in Multiple Occupation) Regulations 1962, did not come into force until 22nd May 1962.





Briefly the new powers are: (1) to make good neglect of proper standards of management; (2) to require the execution of works necessary to provide minimum facilities and amenities; (3) to increase the penalties for failure to abate overcrowding; (4) to apply a direction to a house in multiple occupation limiting the number of persons who may live therein, and (5) to enable a local authority to carry out works in default.

The administrative work necessary to implement the provisions of this legislation is voluminous, and the time required to deal effectively with premises is not less lengthy because of the rather complicated procedure laid down and the right of persons affected to appeal at every stage of the proceedings.

There are several thousand houses in multiple occupation, formerly known as houses let in lodgings, in the Borough. (The definition of a house in multiple occupation is one which is let in lodgings or occupied by more than one family). The Council agreed with a recommendation that, in the first instance attention be given to those premises occupied by three or more families and that action under Section 90 of the Housing Act, 1957, relating to overcrowding caused by single male persons be taken against the owner/occupier of the premises. It was also agreed that action requiring the provision of essential facilities and amenities, such as sinks, baths, hot water supply, etc., be confined to those premises which had an expectation of at least 15 years life.

A problem to be considered is the availability of labour, direct or otherwise, to carry out the necessary works on behalf of the Council in default of the person on whom notice is served. Another difficulty arises in the rehousing of the overspill, whether temporary or permanent, occasioned by the installation of these facilities.

The Act provides for specifications of works to be included in notices served: because of the amount of work this involves and the acute shortage of public health inspectors, the Council at the end of the year appointed two officers, with practical building experience, as Housing Assistants to draw up specifications and carry out inspections under the supervision of the Public Health Inspector (Housing).

The Council also adopted a set of standards to be applied in connection with the provision of additional services and facilities, and agreed with the recommendation of the Minister that informal approach be made, in the first instance, to persons owning or managing these premises.

By the end of the year 222 houses had been inspected and detailed reports submitted. Informal approach regarding the absence of proper standards of management and the need for provision of essential facilities, was made in respect of 21 premises; action was taken with regard to overcrowding in 17 premises, and notices of intention to make management orders were served in three instances. This work is now continuing at a faster rate.

Standard Grants and Improvement Grants

In conjunction with officers of the Borough Engineer and Surveyor's Department, the Housing Inspector inspected 16 premises regarding which applications had been made to the Council for standard or improvement grants.

New Housing

During the year, 770 new dwellings were completed in the Borough: 258 by the Borough Council, 489 by the County Council and 23 by private enterprise. (See Appendix, page 77).

A total of 8,428 new permanent dwellings have now been constructed in the Borough since the war: 5,515 by the London County Council, 2,617 by the Borough Council, 69 by the Corporation of London and 227 by private enterprise.

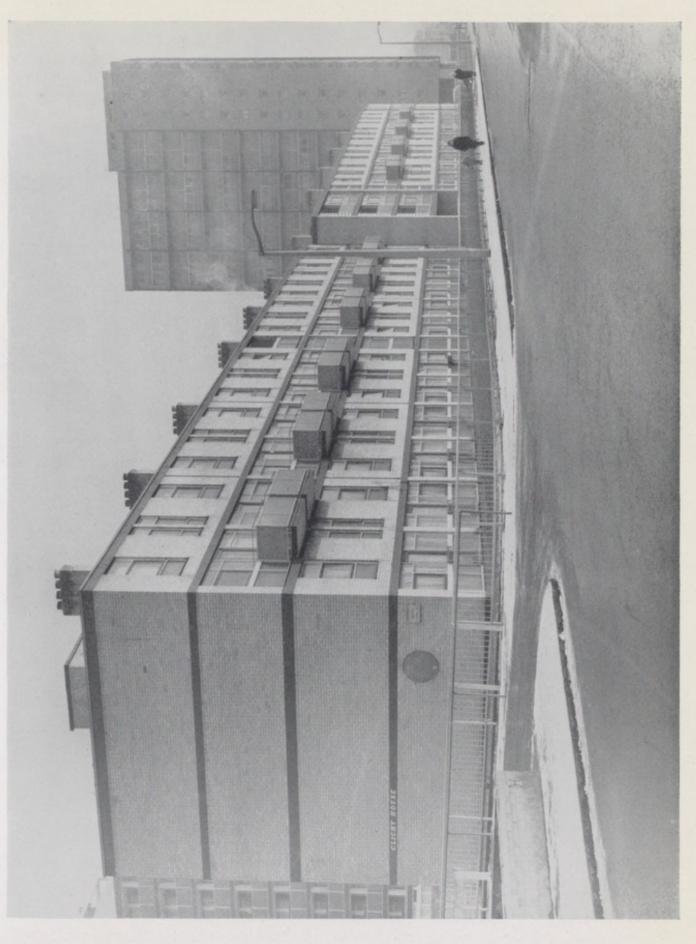
At the end of the year units of accommodation owned by the Council numbered 4,351, comprising 3,927 erected by the Council and 424 formerly requisitioned and other premises purchased.

V. INSPECTION AND SUPERVISION OF FOOD

At the beginning of the year some newspapers gave publicity to stories of children in various parts of the country having been taken ill following consumption of imported sweets consisting of toffee contained in an ordinary cockle shell. Four samples were taken from confectioners in the Borough but no pathogenic organisms found.

Milk vending machines in the Borough received regular attention, samples being frequently taken both for chemical analysis and for bacteriological examination.

As part of the Christmas trade, sweets described as "Chocolate Whisky Bottles containing genuine whisky" appeared in several shops in the Borough. Samples taken contained approximately only 20% proof spirit instead of 65%. Following discussion with the importers, a satisfactory label and description was agreed.

Towards the end of the year swabs were taken of prepacked poultry at pre-packing premises in the Borough and of cut poultry exposed for sale in retail butcher and poultry shops. Gutting tables were also swabbed. Of 83 swabs submitted for bacteriological examination for the presence of salmonella organisms, 5 were found positive (including one from a gutting table). Swabbing of poultry is being continued and measures to be taken to reduce the risk of salmonella cross infection are under active consideration. Any steps which reduce the reservoir of those salmonellae organisms liable to infect the general public are to the benefit of the public health. Perhaps, more emphasis in this field is desirable when it is known that 'food poisoning' outbreaks continue at a high rate in this country.

Sampling of desiccated coconut and of imported egg products continues at the wharves and results show that improvement is being maintained consequent upon the policy of detention and sampling of all consignments. The same can be said of tea imports, sampled and analysed for excessive lead. More consignments of all these commodities are now found to be satisfactory, which suggests that the action of the Riparian and Port Health Authorities has resulted in more careful production and handling in the exporting countries.

Licensing Act. 1961

This Act gives local authorities powers to inspect restaurants, residential hostels, and the like, in respect of which applications are made to the licensing justices for the grant of licences to enable intoxicating liquor to be sold therein. Similar powers are conferred on local authorities as regards licensed clubs together with the right to object on one or more specific grounds when applications for registration, or renewal thereof, come before the licensing justices. The Council authorised the Public Health Inspectors to inspect these premises, and reports are made as to their suitability and convenience for the purpose, having regard to their character, condition, size and nature. Where the Council objects to the granting of a licence, in consequence of the report of the Public Health Inspector, it is necessary for the inspector concerned to attend

A DESCRIPTION ON MALENTANOS OF MOSE before the Magistrates at the hearing of the application. Reports on 35 applications were made during the year.

Bacteriological Examination of Foodstuffs

Samples submitted for bacteriological examination numbered 1,161. These comprised 827 samples of desiccated coconut, 151 imported dried and frozen egg, egg albumen, spray, crystals, etc., 26 ice cream, 38 tuberculin tested (pasteurised) milk, 16 pasteurised milk, 14 sterilised milk, 1 cooked salt beef, 4 sugar confection in sea-shells, l ice cream lolly, and 83 swabs taken from poultry premises.

Six samples of dried egg albumen crystals and one egg albumen sample were found to contain various salmonella organisms and the packages were detained under the Public Health (Imported Food) Regulations for re-export or heat treatment. Six samples of desiccated coconut contained salmonellae and were released for either sterilisation under supervision, or for re-export for processing. Two tuberculin tested (pasteurised) milk samples failed the Methylene Blue Test, repeat samples being satisfactory. Five swabs taken from poultry premises were positive to salmonellae.

Towards the end of 1961 illness occurred among 300 boys at a Naval Training establishment in Suffolk, alleged to have been caused by eating raw apples contaminated with an organic phosphorous insecticide to an amount equivalent to 10 parts per million. The apples were supplied by a wholesaler in Spitalfields Market, in this Borough, who obtained them from a farm in Kent. Exhaustive investigations were carried out and subsequent reports failed to substantiate the alleged cause of the outbreak of diarrhoea and vomiting.

Bakehouses and Bakers Shops

A summons was issued against the proprietor of a baker's shop for selling cake containing a foreign body. A fine of £10 with costs of £5.5.0d was imposed.

Chemical Sampling of Foodstuffs

Samples submitted for analysis to the Public Analyst numbered 412 for the year. The Report of the Public Analyst appears on pages 54-56. deer descent of mewor settinodies facel savin to

Export Certificates

94 certificates were issued in respect of the examination of a variety of foodstuffs exported to the United States, South America, Canada, Sweden, Italy, Malta, Israel, Spain and Kuwait.

Grocers Shop

Legal proceedings taken against a grocer for selling an article of confectionery which was unfit for human consumption resulted in the imposition of a fine of £10 with £5.5.0d costs.

Ice Cream

There are 22 premises in the Borough registered for the manufacture of Ice Cream, but only two were used for this purpose during the year. Inspections were made from time to time under the Ice Cream (Heat Treatment, etc.) Regulations, 1959, and no contravention of the regulations found.

17 samples of Ice Cream submitted for chemical analysis showed an average fat content of 9.97 per cent.

26 samples were subjected to the Methylene Blue reduction test, with the following results:-

The three unsatisfactory samples (Grades III and IV), manufactured in the Borough, were taken from two firms. Advice was given on production methods and subsequent samples taken proved satisfactory. The three Grade IV samples manufactured outside the Borough were obtained from the same retailer: the local authority concerned was notified.

Cautionary Letters

On instructions of the Public Health Committee, cautionary letters were issued in respect of the following contraventions:-

Sale of pork sausages deficient in meat.

Sale of pork sausages deficient in meat and containing excess quantity of preservative.

Failing to screen properly a fish stall.

Milk Samples

Milk samples taken and submitted for chemical analysis during the year numbered 82, including nine taken at hospitals, schools and day nurseries in the Borough.

The average fat and solids-not-fat contents of ordinary milk samples analysed were 3.62 and 8.55 per cent. respectively, while those of the super-fatted variety were 4.40 and 8.89 per cent.

Poulterers! Premises

Eight summonses issued against the proprietor of a poultry shop for contravention of the Food Hygiene Regulations resulted in the person being fined £8 with £3.3.0d costs. Bacteriological examination was carried out on 83 swabs taken from preparation tables, utensils, etc., in poulterers' premises. 5 of the samples were found to be positive to salmonellae.

Public Health (Imported Food) Regulations, 1937-48

181 Detention Notices and 314 Release Notices were served under the Regulations. These affected a variety of foodstuffs including butter, cereals, chillies, cocoa, cocoe-butter, coconut, coffee, dried fruit, egg powder, ginger, ground nuts, gum tragacanth, honey, lard, assorted canned goods, offals, senna pods, spices, sugar and tea.

Two consignments of meat and animal casings, which arrived unaccompanied by the official certificates, were subsequently released on production of the certificates. 140 carcases of mutton, representing a 5 per cent. examination, were examined for caseous lymphadenitis by the cutting of the lymphatic nodes. All the carcases examined were found to be free from disease.

Sanitary Accommodation in Refreshment Houses, Inns. &c.

Section 25 of the London County Council (General Powers) Act, 1959, enables a metropolitan borough council to require the provision of sanitary conveniences at inns, refreshment houses, etc.

Following the making of this legislation doubt arose as to the interpretation of the phrase "refreshment house". Accordingly the

County Council promoted legislation defining a refreshment house as any building in which food or drink is sold to, and consumed by, the public. This definition was included in Section 25 of the London County Council (General Powers) Act, 1962.

During the year the Council adopted a set of standards for sanitary conveniences to be applied in connection with the provisions of the Act.

The provision of washing facilities was originally included in the 1959 Bill but was deleted during its passage through Parliament. This Council supported the views of the Metropolitan Boroughs' Standing Joint Committee that the County Council should be asked to make a further approach to Parliament on the matter.

Sausages (Meat Content)

Analysis of 19 samples of pork sausages and 4 samples of beef sausages showed the average meat content to be 69.5 per cent. and 64.75 per cent, respectively. Two formal samples of pork sausages taken were found to be deficient in meat and the vendors were cautioned.

Unsound Food

The following quantities of unsound foodstuffs were disposed of during the year under the Public Health (Imported Food) Regulations, 1937-48, and the Public Health (London) Act, 1936:-

Approximately 96 tons of unsound food was allowed to be used for chemical or animal feeding purposes, or for manufacturing purposes other than for human consumption, the remainder being delivered to, or collected by, the Public Cleansing Department, at whose riverside depot it was mixed with household refuse, under the supervision of the Public Cleansing Officer, and removed by barge to a controlled tipping site in Essex.

Approximately 2,250 condemnation certificates in respect of unsound food were issued in 1962.

The weight of the foodstuffs examined was 78,730 tons, comprising 42,592 tons of fresh fruit and vegetables, 16,457 tons chilled and frozen meat and offals, 11,396 tons preserved meats and sausages, etc., 5,411 tons bacon, 1,972 tons butter, 126 tons confectionery, 261 tons preserved fruits and vegetables, 121 tons eggs, 194 tons horsemeat, 90 tons cheese, and 110 tons miscellaneous foodstuffs.

Foodstuffs found to be unsound, and which were stopped and destroyed, amounted to 17 cwts.

VI. PREVALENCE OF, AND CONTROL OVER INFECTIOUS AND OTHER DISEASES

Weather Conditions

January was wet but very sunny and had a mean temperature a little above average with sleet and snow on three days. February was very dry and sunny, with sleet and snow on five days. March was exceptionally cold, very frosty and with sleet or snow on ten days.

April was rather cold with average rainfall, whilst May was cool, dull and rather dry. June was dry with rather more than average sunshine, but from then on the summer was dull, cool and, with the exception of August, wet.

October was dry and very sunny, November too being dry but with less than average sunshine. December generally was cold and sunny, with fog from the 3rd to 7th. Snow fell on Boxing Day and presaged a period of frost lasting well into 1963 when many weather records were broken.

Notifications

The number of notified cases of infectious diseases (corrected for revised diagnoses and duplicate notifications) during the year was 772, the lowest ever recorded.

Table 14 on page 74 shows cases notified together with comparative figures over the last ten years. A list of diseases which are notifiable in the County of London is shown in Table 16 on page 76.

Cancer

The number of deaths from cancer during the year was 214 (22 less than last year). Deaths from lung cancer numbered 66, which is 13 less than in 1961. The male death rate from lung cancer in England and Wales increased from 567 per million population in 1952 to 895 in 1962, the female death rate increasing from 98 to 146 during the same period. The graphs facing the following page show the increase in the rates of deaths from lung cancer since 1951, compared with the rates of deaths from cancer of all sites where little change has occurred.

Diphtheria

No notifications of Diphtheria were received for the second year in succession and none was received in the whole County, the first time since records were kept.

The number of Stepney children immunised at London County Council

Seventeen swabs were forwarded by general practitioners to the Mile End Group Laboratory where bacteriological examinations are carried out on behalf of the Borough Council.

Dysentery'

There was a decrease in the incidence of Sonne Dysentery, 31 cases being notified compared with 48 cases last year.

Enteric Fever

No cases of Enteric Fever were notified during the year.

Erysipelas

During the year, 4 notifications were received (compared with 119 in 1936).

Food Poisoning

There were 8 cases of Food Poisoning notified in the Borough during the year. Salmonella organisms were isolated in two cases.

A Report of the Public Health Laboratory Service on Food Poisoning in England and Wales during 1961 states that the picture differs little from that of previous years. The total reported incidence has fallen gradually over the last six years and the number of fatal cases has fallen. A disturbing feature is the increased prominence of incidents due to Salmonellae other than salmonella typhi-murium, which show both a relative increase in recent years and an absolute increase over 1960.

Malaria

One case of Malaria was notified.

Measles

Notifications of Measles in the Borough numbered 438, compared with 1,906 last year. There were no deaths from the disease. Notifications received towards the end of the year showed evidence of the beginning of the biennial epidemic.

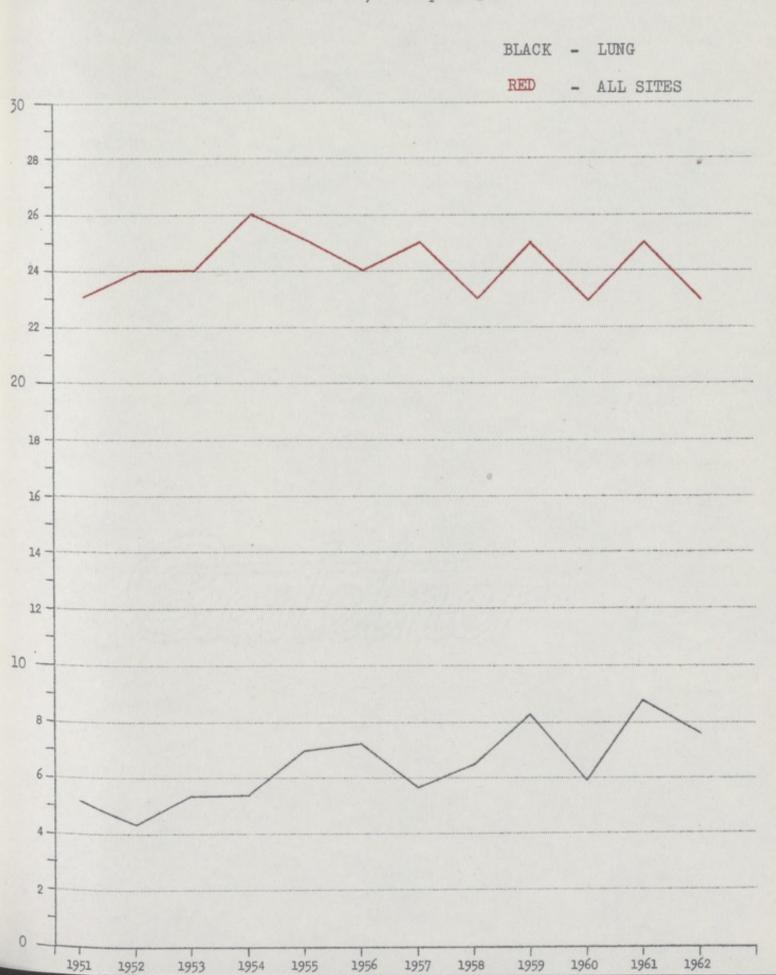

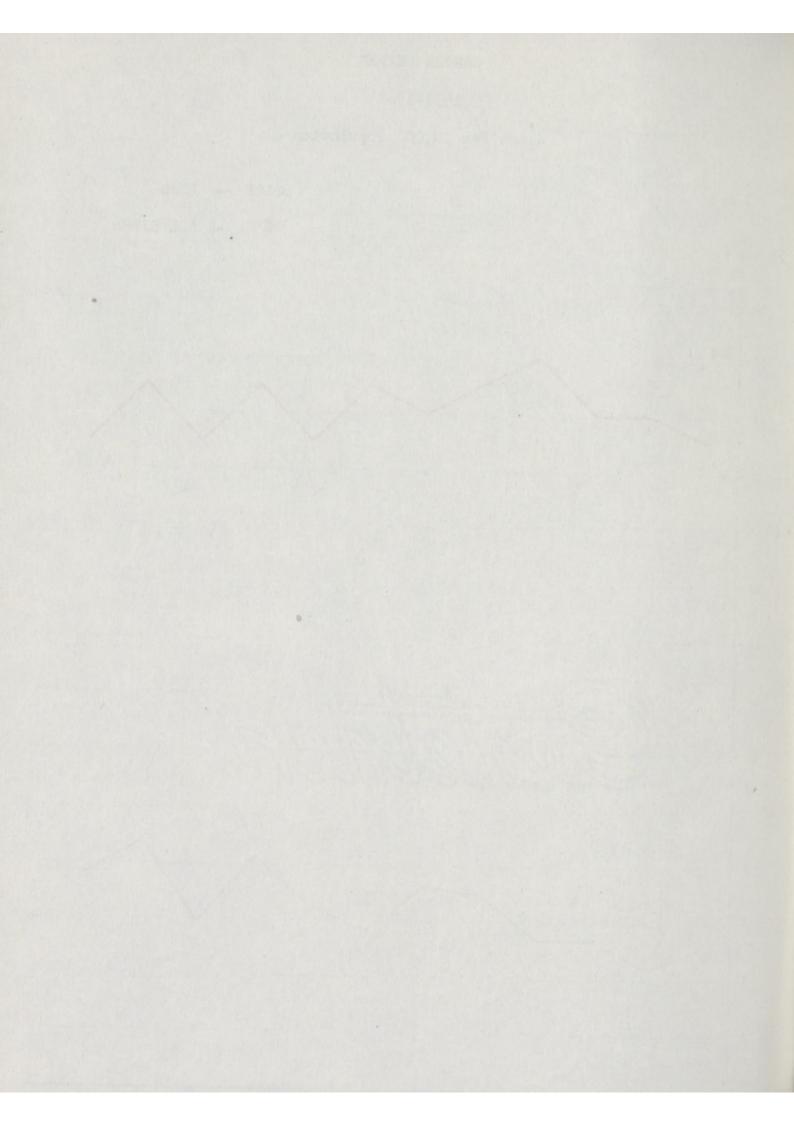

Ophthalmia Neonatorum

One case, in a resident of the Borough, was notified during the year.

Poliomyelitis

Three notifications of Poliomyelitis were received, the diagnosis being confirmed in one paralytic case.

Vaccination against poliomyelitis is carried out by the Divisional Health Department of the London County Council and is available to all persons up to the age of 40.

Puerperal Pyrexia

There were 15 notifications during the year compared with 87 in 1961. Of these, six were residents of the Borough.

Scabies

Scabies is still notifiable under the County of London (Scabies)
Regulations, 1943. The number of cases formally notified was 33 compared with 50 last year.

73 scabies patients and contacts were treated by medicinal baths at Branch Road Treatment Centre and their clothing disinfested, viz:-

The number of baths given totalled 106.

Scarlet Fever

There were 24 cases notified and no deaths from the disease.

Smallpox

No cases of Smallpox were notified during the year and it was not necessary to take action under the Public Health (Smallpox) Regulations.

The occurrence of a case of Smallpox in a metropolitan borough at the end of 1961 and another at the beginning of 1962 led to a heavy demand for vaccination, 600,000 persons being vaccinated in London, 250,000 of them for the first time.

Frequent notifications are received from Port and Airport Authorities of persons coming into the Borough who may have been in contact with smallpox. Observation is kept on such persons by officers of the Public Health Department for the necessary period.

The number of children successfully vaccinated or revaccinated against smallpox at London County Council clinics, during the year, was 8,533.

Certificates were issued in respect of 115 consignments of rags and waste material exported to Spain and Italy to the effect that the area was free from smallpox and yellow fever.

Tuberculosis

I am indebted to Dr.R.M.Orpwood, M.R.C.S., L.R.C.P., D.P.H., Chest Physician at the Stepney Chest Clinic, for the following report on Tuberculosis in the Borough:

"One of the commonest mistakes today in relation to the study of the progress made against infectious disease is the view, quite frequently quoted, that Tuberculosis has already been conquered and need no longer be considered a serious problem.

"It is true that the number of people who die from this disease has been markedly reduced in the whole country (a reduction in which Stepney has shared). This has been due mainly to improved methods of treatment, new drugs, etc. In the number of fresh cases diagnosed, however, the reduction has not been so marked. It should be noted that the death rate in England and Wales between 1950 and 1960 dropped by over 80%, but the notification rate over the same period dropped by This fact can give no cause for complacency or lessening of effort. A similar drop in the number of fresh cases of Tuberculosis in Stepney diagnosed for the first time has been slow to show itself in recent years, mainly because of the relatively unchanged proportion of new cases discovered amongst specialised groups of population commonly found in Stepney and similar areas, e.g. lodging house inmates, vagrants, immigrants from overseas, etc. For several years the latter group has formed about a quarter to a fifth of the total new cases in Stepney. This proportion, however, is showing signs of decreasing and the position may be expected to improve in this respect during the next 5 to 10 years, provided no large scale immigration without adequate medical safeguards is resumed.

"During 1962 the use of all the well-established methods of detection of this disease has been pursued. The Stepney Chest Clinic, which is under the control of the Stepney Group Hospital Management Committee, remains, apart from its other functions in the diagnosis and treatment of non-tuberculous chest conditions, the centre of the attack on Tuberculosis.

"The facilities for the examination of any suspected case of tuberculosis continue to be available for patients referred by general practitioners, or by other medical departments in Hospitals and the School Medical Service. The family "contacts" are seen at regular intervals as they form a group which are specially liable to contract this disease. Fewer contacts are found at the present time to have tuberculosis mainly because of the efficacy of B.C.G. (anti-T.B.) vaccination; the latter is available at the Chest Clinic for this specialised group.

"Routine surveys by the London County Council medical staff at schools in connection with B.C.G. for school-leavers frequently discover a few cases of children who show evidence of T.B. infection. Although usually such children show no evidence of actual disease, as a precaution they are regularly X-rayed at the Chest Clinic over a period of 2 years at least as a safeguard.

"In 1962 we had operating for the first time a new scheme for X-ray facilities through the Chest Clinic, open to all general practitioners: this is already proving a valuable form of case discovery and has great potentialities for the future.

"Tuberculosis cannot be regarded as being beaten until the last case has been diagnosed and successfully treated, and clearly we have some way to go before this stage is reached. The presence of even a handful of infectious cases can be a potential source of danger. Tuberculosis has sometimes been referred to as the "sleeping dragon" and may still give us some unpleasant surprises. Compared with 25 years ago the position is very good but continued effort is still called for to complete the final eradication of this monster."

As shown in the graph facing page 50 there was a consistent decline over the last five years in the morbidity rate for the Borough. The mortality rate does not demonstrate a fall during this period. However, dealing with such small numbers, this may not be statistically valid; national figures show that mortality has decreased to a considerably greater extent than morbidity (as discussed in the report of the Chest Physician above). The male death rate for Pulmonary Tuberculosis in England and Wales decreased from 304 in 1952 to 93 in 1962, and the female death rate from 128 to 28 per million population.

Analysis of data (Table I, page 50) indicates the large number of notified cases from common lodging houses, seamen's lodging houses, and from the immigrant population in the Borough. Notifications of immigrants have remained constant, or have slightly increased, whilst the other groups show a decrease. Hence the percentage of cases per year increased from 22 per cent in 1958 to 37 per cent in 1962 for immigrants. Most of these persons, of Asiatic origin, congregate in some of the worst areas of the borough living under grossly overcrowded conditions which further increases the chance of cross-infection. As reported in the Housing section, a limited policy was approved by the Council to abate these grossly overcrowded tenancies - particularly in respect of single males who often occupy upwards of four persons to a room for sleeping purposes.

The arrangements made with the High Commissioners of Malta and Cyprus continue whereby reports on conditions at proposed addresses of would-be immigrants from those countries are supplied by the Department. A recommendation made by the Borough Council that such a scheme should be applied to other countries was supported by the Metropolitan Boroughs' Standing Joint Committee. A compulsory health check including a

routine chest X-ray of all immigrants would be more salutary to help reduce this increasing reservoir of infection arising from our 'open-door' policy. The age groups commonly affected amongst immigrants are those under 45 years, principally males (see Table II). This is in contradistinction to the incidence in the native-born tubercular cases where the dangerous 'carriers' are chiefly found in the post-50 years ago group.

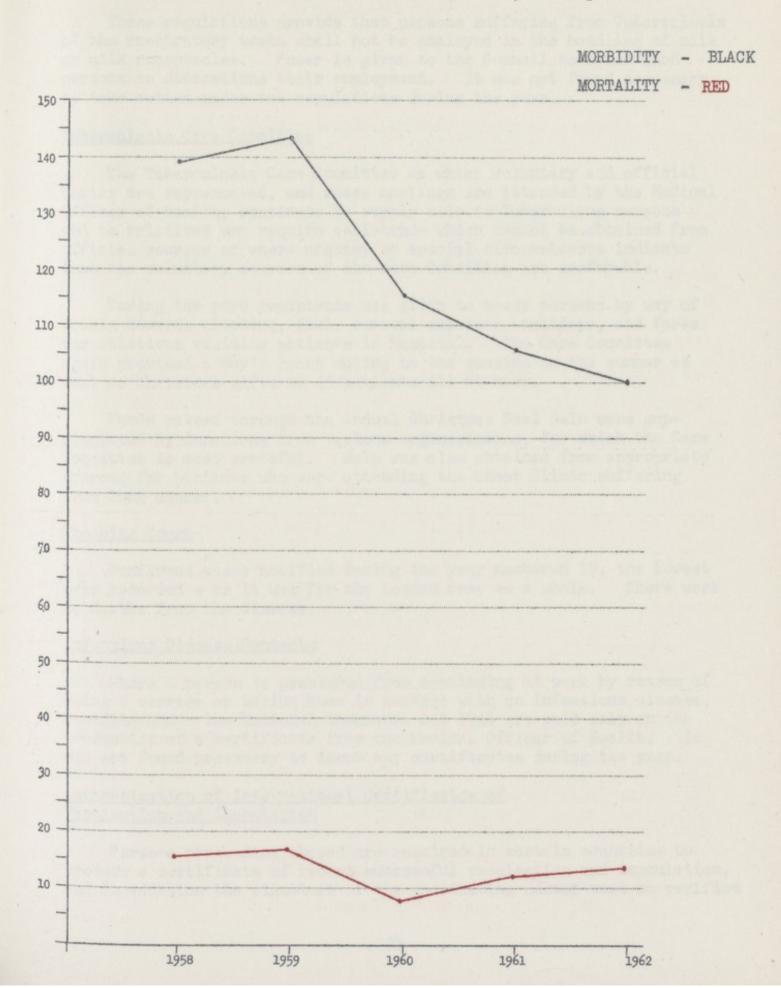

The number of primary notifications of Pulmonary Tuberculosis received, during the year, was 91 compared with 99 last year, and the number of non-pulmonary cases notified was 9, the same as in the previous year. The mortality rate for the year for pulmonary tuberculosis was 13 and for non-pulmonary nil per 100,000 of the population, compared with 12 and nil respectively for 1961. (For details of register and notifications see page 75).

115 visits were paid by the Public Health Inspectors to the homes of persons suffering from tuberculosis and appropriate action taken where public health nuisances were found to exist.

Public Health (Prevention of Tuberculosis) Regulations, 1925

These regulations provide that persons suffering from Tuberculosis of the respiratory tract shall not be employed in the handling of milk or milk receptacles. Power is given to the Council to cause such persons to discontinue their employment. It was not found necessary to take action under the regulations during the year.

Tuberculosis Care Committee

The Tuberculosis Care Committee on which voluntary and official bodies are represented, and whose meetings are attended by the Medical Officer of Health, continues to supply help to Tuberculous persons and to relatives who require assistance which cannot be obtained from official sources or where urgency or special circumstances indicate that the voluntary sources of the Care Committee are preferable.

During the year assistance was given to needy persons by way of grants towards clothing, fuel, removal expenses, holidays, and fares for relatives visiting patients in hospital. The Care Committee again provided a day's coach outing to the seaside in the summer as well as Christmas gifts to 45 patients ill at home.

Funds raised through the Annual Christmas Seal Sale were supplemented by donations from various organisations, for which the Care Committee is most grateful. Help was also obtained from appropriate sources for patients who were attending the Chest Clinic suffering from lung cancer.

Whooping Cough

Confirmed cases notified during the year numbered 18, the lowest ever recorded - as it was for the London area as a whole. There were no deaths from the disease.

Infectious Disease Contacts

Where a person is precluded from continuing at work by reason of being a carrier or having been in contact with an infectious disease, benefits under the National Insurance Act 1946 are paid only on the production of a certificate from the Medical Officer of Health. It was not found necessary to issue any certificates during the year.

Authentication of International Certificates of Vaccination and Inoculation

Persons proceeding abroad are required in certain countries to produce a certificate of recent successful vaccination and inoculation, and in addition the signature of the vaccinating doctor must be verified

by the Medical Officer of Health of the district. During the year, signatures on 4,001 certificates were verified as those of medical practitioners practising in Stepney and the certificates endorsed accordingly.

Venereal Disease

Attendances at special clinics for these diseases have shown an increase over the last 10 years. New Stepney cases attending clinics during the last three-quarters of 1962 for treatment and observation are shown in the following table. Separating the native-born from the immigrant population an interesting pattern emerges. Approximately two-thirds of the males but only one-tenth of the females attending are of immigrant origin. Thus, it would appear that unattached immigrant males are acquiring the disease from white consorts, who form by far the largest fraction of the reservoir of infection, as demonstrated by the fact that nine-tenths of those attending clinics are native-born women.

National figures show a similar upward trend. Particularly, gonorrhoea in the 'teenage' female is increasingly common. This group appears to be a vulnerable one, and requires special attention by health education methods to dispel any ignorance of the risks associated with promiscuous sexual behaviour. To this end, a number of meetings have been held in the Borough at which leaders of the local community, teachers, and youth club workers have been given an outline of these diseases and how they affect the community's health. It is hoped to plan a large-scale campaign in 1963 to reach youth club members and school-age groups. There are certain difficulties with health education schemes in a subject so associated with taboos and repression. Perhaps if sex education in its widest sense of fitting the person for life were paramount, sex education would fit into its rightful place therein.

The number of lice-infested persons bathed and whose clothing was disinfested at the Council's Cleansing Station, is as follows :-

Disinfection

Premises disinfected after infectious disease numbered 23, which included nine for pulmonary tuberculosis. 7,363 articles of clothing and bedding were steam disinfected, including 245 articles for export for which five certificates were issued.

Formaldehyde disinfection of 85,048 articles of clothing and 25 tons of rags for export was also carried out, during the year, for which 77 certificates were issued.

The charges for export and other disinfections carried out amounted to £49.

Treatments referred to above included those for infestations of cockroaches, beetles, ants, silverfish, and the like.

In addition disinfestation of the furniture and effects of families rehoused by the London County Council, was carried out on 14 occasions.

The Council continues to carry out on behalf of the Stepney Group Hospital Management Committee any necessary work of disinfestation at hospitals and other premises in the Borough coming within the control of that Committee.

SUMMARY OF PUBLIC ANALYST'S QUARTERLY REPORTS for the Year 1962
