## VESTRY MEETINGS AND COMMITTEES.

The return attached to this Report (pages 6 and 7) shows that the Vestry have held 34 meetings, and the various Committees 75 meetings, during the year ended Lady-day, 1889.

## SANITARY.

The Vestry have caused 144 notices for Abatement of Nuisances to be served during the past year, and in all cases the works ordered have been executed.

## PARLIAMENTARY BILLS.

ELECTRIC LIGHTING ACT (1882) AMENDMENT.—Against.

Petitions have also been forwarded to the Right Honourable W. H. Smith, M.P., for presentation during the year, viz.:—

ADVERTISING STATIONS (RATING).—In favour.

BEER ADULTERATION.—In favour.

HOUSING OF THE WORKING CLASSES (LONDON).—In favour.

LONDON COAL AND WINE DUTIES, (CONTINUANCE).—In favour.

PERSONAL PROPERTY (EXEMPTION FROM SALE).—In favour.

RATING OF MACHINERY.—Against.

SCHOOL BOARD FOR LONDON (PENSIONS).—Against.

UNITED TELEPHONE COMPANY.—Against.

VACANT GROUNDS (NUISANCES PREVENTION).—In favour.

ADVERTISING STATIONS (RATING).—The Bill seeks to enact an amendment in the law with respect to rating places used for advertisements, and on the 28th June, 1888, it was resolved to petition in favour of the Bill, and Mr. Burdett-Coutts was requested to introduce a clause to prohibit the use of permanent hoardings for advertising purposes without the license of the local authorities. The Bill was subsequently dropped.

BEER ADULTERATION.—By this Bill it is proposed to be enacted that the purity of beer shall be secured, and on the 28th June, 1888, it was resolved to petition in its favour. The Bill was eventually dropped.

BRIBERY (PUBLIC BODIES) PREVENTION.—On the 26th July 1888, it was reported that this Bill had been withdrawn.

EARLY CLOSING.—This Bill was rejected in the House of Commons on the 2nd May, 1888.

ELECTRIC LIGHTING ACT (1882) AMENDMENT.—This Bill, reported upon in the Vestry's Annual Report for 1887-8, received the Royal Assent on the 28th June, 1888.

HOUSING OF THE WORKING CLASSES (LONDON).—This is a Bill to facilitate the better housing of the working classes, and on the 5th April, 1888, a Petition was ordered to be presented in its favour. The Bill was subsequently dropped.

HORSE GUARDS AVENUE.—This Bill, which was reported upon in the last Annual Report of the Vestry, received the Royal Assent on the 24th July, 1888.

LONDON COAL AND WINE DUTIES (CONTINUANCE).—The Bill provides for the further continuation and appropriation of the Duties until the 31st December, 1900; and on the 5th April, 1888, it was resolved to petition in favour of the Bill. The Bill was subsequently withdrawn.

METROPOLIS LOCAL GOVERNMENT.—This Bill was withdrawn in the House of Commons on the 5th April, 1888.

METROPOLITAN BOARD OF WORKS (LOCAL MANAGEMENT, &c.).—The dropping of this Bill, which was reported upon in the Vestry's Annual Report for 1887-8, was reported on the 12th July, 1888.

METROPOLITAN BOARD (FIRE BRIGADE EXPENSES), No. 1.—The withdrawal of this Bill, which was reported upon in the last Annual Report, was reported on the 15th November, 1888.

METROPOLITAN BOARD FIRE BRIGADE EXPENSES (No. 2).—This Bill differs from No. 1, as it makes no provision for increased contributions from the Fire Insurance Companies. No action thereon was taken by the Vestry, and the Bill was subsequently dropped.

METROPOLITAN BOARD OF WORKS (THEATRES, &c.).—The second reading of this Bill in the House of Commons, was, on the 17th April, 1888, put off for 6 months.



PARLIAMENTARY BILLS—*continued.*

PARLIAMENTARY ELECTIONS (RETURNING OFFICERS' EXPENSES).—The dropping of this Bill, referred to in the Vestry's Annual Report for 1887–88, was reported on the 15th November, 1888.

PERSONAL PROPERTY (EXEMPTION FROM SALE).—This Bill proposes to exempt personal property (to a limited amount) from seizure and sale under legal process, and on the 5th April, 1888, it was ordered that the Right Hon. W. H. Smith, M.P., be informed the Vestry are in favor of the Bill. The Bill was subsequently dropped.

PUBLIC LIBRARIES ACT (1885) AMENDMENT.—This Bill was withdrawn in the House of Commons on the 7th May, 1888.

RATING OF MACHINERY.—The Bill provides for rating the annual value of machinery in addition to the value of the premises, and on the 28th June, 1888 it was resolved to petition against the Bill, which was eventually withdrawn.

SCHOOL BOARD FOR LONDON ELECTION.—This Bill, reported upon in the Vestry's last Annual Report, was, on the 15th November, 1888, reported as having been withdrawn.

SCHOOL BOARD FOR LONDON (PENSIONS).—The Bill is to enable the Board "to guarantee Superannuation allowances from the funds at their disposal," which funds are to be provided by a deduction of 2 per cent. from the salaries, wages, or emoluments of their officers and servants. On the 28th June, 1888, the Vestry determined to petition against the Bill, which did not pass into law.

SOUTH-EASTERN RAILWAY (ADDITIONAL LANDS).—This Bill is to enable the Company to acquire certain houses and lands in Villiers Street, Buckingham Street, and York Place. On the 13th December 1888, the deposit of a Plan and Book of Reference was reported, and on the 24th January following the Vestry resolved to petition against the Bill.

TECHNICAL INSTRUCTION.—This Bill was introduced for the purpose of promoting instruction in the principles of science and art and their application to specific industries and employments, and to provide for the cost of the same it was proposed that a rate not exceeding 1d. in the £ should be imposed. No action was ordered to be taken thereon, and the Bill was subsequently withdrawn.

**THEATRES (METROPOLIS).**—This Bill, which appears in the last Annual Report, was, on the 12th July, 1888, reported as having been dropped.

**UNITED TELEPHONE COMPANY.**—This Bill, which was reported upon in the Vestry's last Annual Report, was, on the 12th July, 1888, reported as withdrawn.

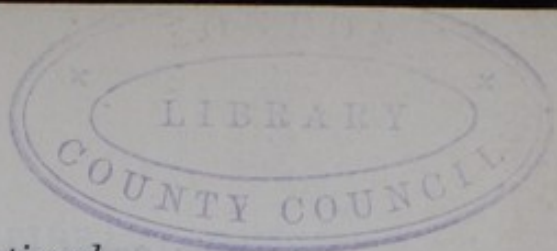
**VACANT GROUNDS (NUISANCES PREVENTION).**—This Bill is for the prevention of nuisances on vacant grounds and disused burial grounds, and on the 28th June, 1888, it was decided to petition in its favour. The Bill was eventually dropped.

**ELECTRIC LIGHTING.**

*(See also Parliamentary Bills.)*

On the 28th June, 1888, a draft of the South Metropolitan Electric Lighting Order, 1888, as amended by the Board of Trade was considered, when it was resolved to inform the Board that the Vestry had no observations to make thereon, but reserved to themselves the right of petitioning against the Order on the introduction of a Bill into the legislative houses for confirmation. Notices of intention to apply for Provisional Orders and Licenses to supply electricity within the parish by the Electric Power Storage Co., the London Electric Supply Corporation, the Westminster Electric Supply Corporation, and Messrs W. T. Glover & Co. were submitted on the 12th July, 1888. On the 26th July, it was reported that the Provisional Order Bill of the South Metropolitan Company had been introduced in the House of Lords. On the 18th October, it was resolved to inform the Board of Trade that the Vestry will consent to the granting of licenses to the Metropolitan Electric Supply Co. and the London Electric Supply Corporation, provided the licenses be amended so as to agree with the Provisional Order agreed upon with the South Metropolitan Electric Supply Co. in the month of June last, and that a clause be inserted prohibiting the respective Companies from acquiring or associating themselves with any other Company or persons supplying or intending to supply electricity within the parish. On the 13th December, 1888, the formal consent of the Vestry was given to the granting of a license to the Metropolitan Electric Supply Co. for supplying electricity within the

parish. The deposit of maps and copies of advertisements of intention to apply for Provisional Orders to supply electricity within the parish by the following Companies was reported on the 13th December, 1888, viz.:—the London Electric Supply Corporation, the Electrical Power Storage Co., and the Westminster Electric Supply Corporation. The formal consent of the Vestry to a license to the House to House Electric Supply Co. was given on the 24th January, 1889, on the 21st February, 1889, their consent to a Provisional Order to the London Electric Supply Corporation, and on the 7th March, their consent to a Provisional Order to the Electrical Power Storage Company.

CHARING CROSS ROAD, TRIANGULAR LAND IN.

On the 12th July, 1888, Mr. James stated that he had induced the Metropolitan Board to temporarily withdraw the land from letting by public auction, and on the same date it was resolved to request the Board to dedicate the land to the use of the public.

On the 13th December, 1888, the Vestry resolved to request the Metropolitan Board to demolish the Tavern thereon, and to hand over the space to the Vestry, for the purpose of planting the ground with shrubs, and fencing the same.

On the 10th January, 1889, Mr. James stated that the Board had given directions for the demolition of the Tavern, and the enclosing and planting of the ground, and he suggested that the Commissioners of H.M. Works, &c., be requested to pull down the old Work-

house wall in Hemming's Row, to erect iron railings, and to level and turf the land at the rear of the National Gallery; and on the same date the Vestry passed a vote of thanks to Mr. James for his services, and adopted his suggestions.

On the 21st February, 1889, a letter was submitted from the Commissioners of H.M. Works, &c., stating that as the future appropriation of the land is uncertain, there would be some difficulty in adopting the suggestions, when it was resolved to request the Right Hon. W. H. Smith, M.P., to receive a deputation thereon. On the 7th March, 1889, a letter was submitted from Mr. Smith, stating that he was unable, as First Lord of the Treasury, to receive the proposed deputation, but he would communicate privately with the First Commissioner of Works on the subject.

## METROPOLITAN BOARD OF WORKS.

On the 21st February, 1889, it was determined that, having regard to the approaching retirement of Mr. James, a Committee of the whole Vestry be formed for the purpose of giving practical expression to the opinion of the Vestry of the value of his services.

## CHURCHWARDENS AND SIDESMEN.

On the 5th April, 1888, Mr. William Challice and the Right Hon. Lord Kinnaird were respectively elected Senior and Junior Churchwardens, and Messrs. William Stephens Cross and Robert Walker, Sidesmen to the Senior Churchwarden for the then ensuing year; and, on the 19th April, 1888, Messrs. Robert Stokes and Thomas Prescott were elected Sidesmen to the Junior Churchwarden for the like period.

## MR. DAVID LAING.

On the 12th July, 1888, an illuminated copy of a resolution and a silver bowl were presented to Mr. David Laing in recognition of the exceptional duties performed by him during his tenure of the office of Churchwarden for a period of three years.

## VESTRY ELECTIONS.

The Annual Election of Members of the Vestry and Auditors for Ward No. 2, took place on the 7th May, 1888. Polls having been demanded in Wards Nos. 1 and 3, the elections took place on the day following.

## PARISH MAP.

On the 7th February, 1889, instructions were given to the Surveyor to correct the present Parish Map by showing the alterations made since its correction in 1855.

## DISQUALIFICATION OF A MEMBER OF THE VESTRY.

On the 21st February, 1889, it was reported that Mr. J. Hemming, having ceased to be a rated occupier of the parish, his office had been thereby vacated.

## RESIGNATIONS OF MEMBERS OF THE VESTRY.

On the 20th September, 1888, the resignation of Mr. J. H. Heathman was submitted, and accepted with expressions of regret and on the 4th October, Mr. J. H. Parish resigned his office, which was accepted in like manner.

## WHITCOMB STREET IMPROVEMENT.

The Metropolitan Board of Works, having undertaken to contribute one-half of the cost of widening the street from Panton Street to the Lyric Club, negotiations, extending over a considerable period, were entered into with the freeholders and leaseholders of the properties required for that purpose. Instructions were subsequently given for a valuation to be made (which amounted to £105,000), for the acquisition of the properties required for widening the street on the west side, from Panton Street to Pall Mall East, and the Metropolitan Board was requested to contribute half the cost of the same; this request was declined by the Board, and the properties required for the partial widening of the street were subsequently acquired by the Vestry.

## PROPOSED NEW VESTRY HALL.

*(See also Free Public Library).*

An Agreement with the Metropolitan Board of Works for the purchase of lots Nos. 39 and 40 Charing Cross Road, for the sum of £19,500, was sealed by the Vestry on the 3rd May, 1888. An Agreement for the assignment of the Vestry's interest in lots Nos. 37 and 38, Charing Cross Road for the sum of £2,800, to Mr. W. S. Gilbert, for the purpose of building a Theatre, was sealed on the 17th May, 1888. On the 31st May, Mr. Robert Walker was instructed to

prepare the preliminary plans required by the Board, and on the 2nd August Mr. Walker was appointed the Architect. On the 14th June, it was determined to offer the land not required by the Vestry (being portions of the sites of Nos. 113, 114, and 115, St. Martin's Lane) to the Commissioners of Public Libraries, &c. On the 26th July, 1888, a letter was submitted from the Metropolitan Board of Works, agreeing to advance a sum of £40,000 for the purpose of defraying the cost of the site, being £20,500 payable to the Marquis of Salisbury and £19,500 to the Board for their respective interests. On the 9th August it was determined to sell the land above mentioned to the Free Library Commissioners for £8,000, and, on the 4th October, the acceptance of the offer by the Commissioners was submitted to the Vestry. On the 9th August, 1888, the offer of the Metropolitan Board to contribute £1,500, being one half of the cost (estimated at £3,000) of setting back Nos. 113, 114, and 115, St. Martin's Lane, was submitted. On the 18th October, 1888, the amended plans and elevation of the building were submitted by Mr. Walker, and approved, and he was instructed to prepare and submit detail and working drawings to the Board for their approval. On the 1st November a letter was submitted from the Free Library Commissioners, stating that the proposed new plan took away land first offered, which they were unwilling to relinquish; and instructions were then given to the Architect so to amend the Plans as to give to the Commissioners the same area of land as that originally offered, and to forward the amended drawings to the Board. On the 7th February, 1889, it was resolved to offer a sum of £1,000 to Messrs. Holt and Bates for the possession of their premises (No. 114, St. Martin's Lane) and to request the Metropolitan Board to advance the sum of £25,000 for the building; and instructions were then given to the Architect forthwith to submit plans to the Board for their approval. On the 7th March, 1889, the Architect reported that he had supplied the Board with all the information they required. On the 21st March, 1889, the Clerk reported that the Metropolitan Board were prepared to advance the sum of £25,000 required on certain conditions then enumerated, and that he had approved the draft of the necessary Mortgage Deed for that purpose. The Clerk's proceedings, as reported, were duly approved and adopted. On the

21st March, 1889, it was resolved, under certain conditions, to offer Messrs. Holt and Bates the sum of £1,000 for giving up possession of their premises, No. 114. St. Martin's Lane, on the 15th April then next.

## FREE PUBLIC LIBRARY.

(*See also Proposed New Vestry Hall.*)

On the 3rd May, 1888, Messrs. Roger de Coverley, Lionel Charles Drummond and Thomas Prescott were re-elected Commissioners. On the 20th September, the Vestry sanctioned the borrowing of a loan of £20,000, required by the Commissioners for the purchase of land, and for the erection of the building.

## H.I.M. THE EMPEROR OF GERMANY.

On the 28th June, 1888, a vote of sympathy with Her Majesty the Queen and the Members of the Royal Family on the decease of the late Emperor, Frederick the Third, was passed, and on the 26th July a letter of acknowledgment from the Secretary of State for the Home Department, on behalf of Her Majesty, was submitted.

## CECIL COURT.

On the 13th December, 1888, the Solicitors reported that they had provisionally approved draft of the Agreement for the widening of the Court, but they were unable finally to approve of the same until it had been submitted to the Solicitors to the Marquis of Salisbury, when it was resolved that, subject to the Agreement being finally approved by the Solicitors, the Churchwardens be authorised to affix the Seal of the Vestry thereto.

## MAIN ROADS, MAINTENANCE OF.

On the 21st March, 1889, it was determined to make application to the London County Council for orders that certain streets in the parish should be declared to be main roads under the Local Government (England and Wales) Act, 1888, on the understanding that the Vestry should retain their control, and receive an annual payment from the Council in respect of the cost of maintenance of the roads.



### SPECIAL GENERAL WORKS COMMITTEE.

On the 17th May, 1888, the above Committee submitted their Scheme for Slop and Dust Collecting, Watering, General Works Repairs to Footways and Carriageways, Flushing Sewers, and Gulleys, and cleansing Channels and Urinals. On the 11th June, the Scheme was adopted and a Sub-Committee appointed for making the necessary arrangements. On the 12th July, Mr. Gabriel's tender for wharfage accommodation, and that of Mr. Clarkson, for the supply of vans, horses, harness, drivers, &c., were accepted. Consequent upon the increased work in the Surveyor's department, a Clerk was appointed to assist him, and also a Foreman of General Works and labourers necessary for the purpose. On the 15th November, 1888, the acceptance of tenders for the supply of stone, wood blocks, cement, lime, ballast, and sand was reported. Comparative statements have from time to time been submitted by the Committee showing a considerable decrease in the cost of the various work as compared with the Contract system. Numerous meetings have been held by the Committee, and the attendances of the members thereat are duly recorded on pages 6 and 7 of this Report.

### SALE OF FOOD, &c., ACTS.

A summons was heard on the 9th August, 1888, at Marlborough Street Police Court in respect of a sample of Mustard certified by the Public Analyst as adulterated, when the vendor was fined £1 and costs.

### ST. MARTIN'S PUBLIC BATHS AND WASH-HOUSES.

Messrs. James Mason Andrew and James Hemming, were on the 17th May, 1888, elected Commissioners of the above for the usual term of 3 years.

### ST. MARTIN'S MIDDLE CLASS SCHOOL FOR GIRLS.

On the 13th December, 1888, Mr. J. M. Andrew and Mr. T. Hill were respectively re-elected Governors of the above School for the customary period of 5 years.

### CAMDEN TOWN CEMETERY ACT.

On the 28th June, 1888, Mr. David Laing was elected a Trustee under the above Act in the place of Mr. Francis John Barron, resigned.

## HOUSES LET IN LODGINGS, &amp;c.

Monthly inspections of the above houses, 246 in number, have been made by the Inspector for that purpose, who has found the regulations generally complied with. 95 notices have been served during the year, and the works required to be effected have in all cases been executed without having to resort to legal proceedings.

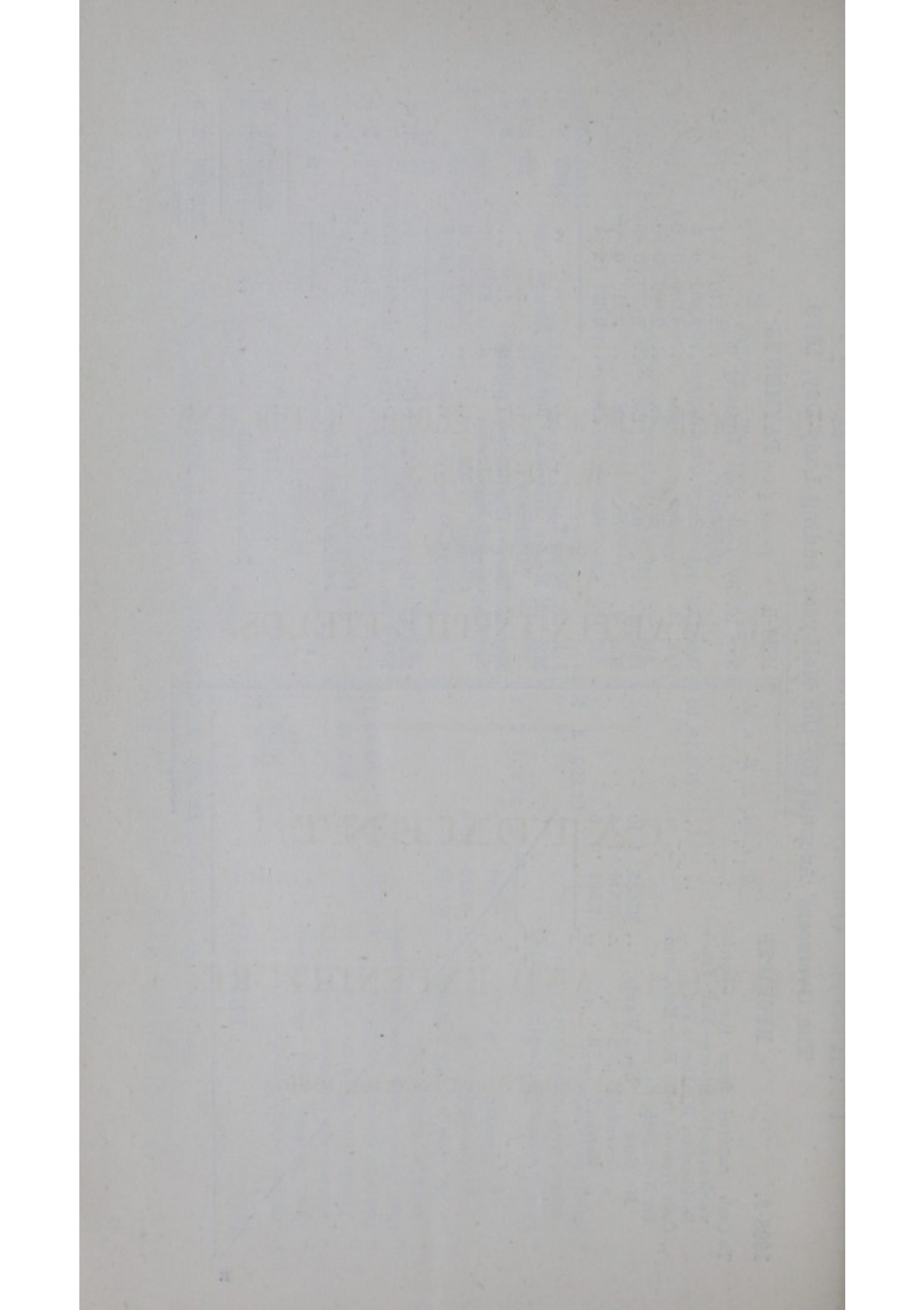

# MEDICAL OFFICER'S REPORT,

## 1888.

*Annual Report on the Health of the Parish of St. Martin-in-the-Fields,  
for the Year 1888.*

TO THE VESTRY OF ST. MARTIN-IN-THE-FIELDS.

GENTLEMEN,

I have the honour of submitting to you my Nineteenth Annual Report on the health and sanitary condition of the Parish.

In my Annual Report for the previous year, 1887, I mentioned the outbreak of Scarlet Fever in the Metropolis, which epidemic continued on for the first few months of the year 1888. In London the number of deaths due to this disease in the year 1888, was 1209, a mortality less than in the previous year. In our own parish every precaution was taken against the spread of the complaint, in the way of isolation and disinfection, with the result that it was a very rare event for a second case to occur in the same house. Many cases of Scarlet Fever are concealed from the Sanitary Authority, when, of course, the necessary safeguards are not so well applied for the protection of the community. The Compulsory Notification of Infectious Diseases would get over this difficulty.

### BIRTHS.

In the year 1888 the Births numbered 276, the lowest number of the last ten years.

The Birth-rate of the Parish for the year 1888 would be 15·0 per 1,000.

The Births registered in London in 1888 numbered 131,080, and were in the proportion of 30·7 to 1,000 inhabitants. This is the lowest birth-rate recorded in London since 1841, when the rate was 30·4.

#### DEATHS.

During the year 1888 the number of Deaths registered in St. Martin-in-the-Fields was 399. This mortality is the lowest of the last ten years.

Of the above 399 Deaths, 195 occurred in the Charing Cross Hospital, and of this number who died in that Institution, 165 were non-residents of the Parish. In public Institutions outside the Parish, and including the parishioners of St. Martin-in-the-Fields who died in the Strand Union Workhouse, Edmonton, the deaths numbered 93. In Table No. VI. will be found full details of these 93 deaths.

The Death-rate of the Parish for the year 1888 would be 17·3 per 1,000, rather less than in the previous year.

Ratio of deaths to population, about 1 in 57. The deaths registered in London in the year 1888 numbered 78,848, and corresponded to an annual rate of 18·5 per 1,000. This is far the lowest death-rate as yet recorded in London.

## CAUSES OF DEATH.

**ZYMOTIC DISEASES.**—The seven principal Zymotic Diseases are Small-pox, Measles, Scarlet Fever, Diphtheria, Whooping Cough, Fever, and Diarrhoea.

The deaths arising from this class of malady were 24. This number includes those non-parishioners who died in the Charing Cross Hospital. After deducting those non-parishioners, and adding those parishioners who died in Institutions outside the Parish, the mortality due to St. Martin-in-the-Fields would be 33. This mortality is in excess of the previous year, and is due to the epidemic of Scarlet Fever and Measles. See Table 5.

**SMALL-POX.**—No death or illness from this disease came to my knowledge.

**MEASLES.**—From this complaint 9 deaths were recorded, and 1 of a parishioner in the Metropolitan Asylums Hospital, making a total of 10. This disease assumed, in the Metropolis, an epidemic form, which began about the first week in October, after which the mortality rose very rapidly to a maximum in the middle of December, when as many as 184 deaths were registered in a single week.

**SCARLET FEVER.**—One death occurred within the Parish, one of a parishioner in King's College Hospital, and seven in the Metropolitan Asylums Hospital, making in all a total of nine. The number of cases of this complaint, which came under my notice, was 26, and 24 of these were sent to hospital. In 1887, the Metropolitan Asylums Board admitted into their hospitals 5,900 Scarlet Fever cases, and in 1888, the number was 4,498. In the former year, the maximum number under treatment at one and the same time was 2,611; in 1888, 954. The deaths in London from this disease numbered 1,209, and were in the proportion of 0·28 to 1,000 inhabitants, the average annual rate in the preceding decennium having been 0·46.

**DIPHTHERIA.**—Three deaths, from this disease, occurred in the Parish, all in the Charing Cross Hospital, two of these were non-residents, and two deaths of parishioners took place in King's College Hospital, so that the Parish would be credited with three deaths from Diphtheria.

WHOOPING COUGH.—Four deaths were attributable to this malady.

FEVER.—This includes Typhus, Typhoid, Simple Continued Fever, and Remittent Fever. A death from Typhus occurred in a gentleman staying at a private hotel, he was ailing when he took up his residence there. A death from Typhoid of a parishioner took place in the Central London Sick Asylum Hospital, and an inmate of the Strand Union Workhouse, who was formerly a resident of St. Martin-in-the-Fields, died of Typhoid Fever, making a total of three.

DIARRHŒA.—Five deaths were due to this complaint, one of which was a non-resident who died in the Charing Cross Hospital, this circumstance would credit the Parish with only four deaths, This mortality is very low, and is attributable to the very cool summer of 1888.

The deaths from all other causes, with the ages at death, will be found fully detailed in Table 2.

#### MORTUARY CHAPEL.

This most useful building, situated in Drury Lane, I have ascertained from the keeper, has had, during the last fourteen years, 373 bodies deposited in it during the interval between death and burial.

#### THE SALE OF FOOD AND DRUGS ACT.

Under the above Act, 26 different articles of food were submitted to analysis, as follows:—

In the case of the adulterated mustard, legal proceedings were instituted, with the result that the magistrate inflicted a fine of 20s. upon the seller.

#### SANITARY WORK.

During the year 1888, notices to the number of 107 were served upon the owners or occupiers of property, also numerous verbal recommendations to remedy sanitary defects, and 26 notices were served for the purpose of disinfection after infectious disease.

Champion House, White Hart Street, which has been such a source of trouble and annoyance ever since it was built, owing to the unsanitary condition of the place, has been put into a thorough state of repair, and is now occupied by a very respectable class of tenants, who are cleanly and orderly in their habits.

#### BAKE-HOUSES.

The bake-houses have been duly inspected, and were all found in a satisfactory condition.

#### HOUSES LET OUT IN LODGINGS.

Your Inspector, whom you appointed permanent inspector of these houses, has regularly inspected them, and reported to me all sanitary defects that came under his notice.

The pipe-sewers have been regularly flushed, those gullies emitting offensive effluvia have also been flushed with carbolic acid and water, and the several courts and passages in the parish lime-whited.

During the year 2 lamps in Cecil Court and 1 at Salisbury Wharf have been cut off in consequence of improvements which are taking place, and 1 new lamp erected upon urinal, Charing Cross Road. The position of the lamps in Chapel Court, Long Acre, have been altered, for the prevention of nuisances therein.

The total cost of lighting, cleaning, maintenance, &c., amounted to £2,505 4s. 10d., as against a cost in the previous year of £2,839 17s. 7d., the decrease being the result of the Vestry's action in reducing, on the 1st January, 1888, the burning hours from 4,300 to 3,940 per annum, and of the Gas Company in reducing the price of gas on the same date, from 2s. 5d. to 2s. 2d. per 1,000 feet.

#### SLOP AND DUST COLLECTING.

During February, 1888, this subject was referred to a Special Committee of the Vestry to consider as to the advisability of the work of collection being performed by the Vestry or under a contract.

On the 17th May, the committee reported in favour of this work being done by the Vestry purchasing the Slop and Dust Vans and hiring horses and drivers for the same, the Report being adopted by the Vestry on the 11th June.

Tenders from Mr. J. S. Gabriel, for receiving slop at 2s. per cubic yard, and rough dust at 3s. per load of  $2\frac{1}{2}$  cubic yards; the Bristol Wagon Works Company for supplying vans at £43 10s. 0d. each, and from Mr. H. Clarkson for the supply of horses, drivers, machine brooms, and any additional vans required, at a schedule of prices, were subsequently accepted.

Two ganger sweepers are employed at 19s. each, and 6 sweepers at 18s. each per week.

The dusting is divided into 3 districts, one dustman being employed to each, and paid at the rate of  $4\frac{1}{2}$ d. per load.

The tabulated statement attached to this Report contains particulars of the work performed since 18th August last, the date of the commencement of the scheme.

## MORTUARY.

Galvanised zinc has been fixed under the roof of the Mortuary under the Parish Churchyard, a wooden platform provided, and the walls covered with matched boarding and painted throughout at a cost of £35 13s. 6d.

## STREET NAMES.

Street name plates have been fixed in Charing Cross Road, Trafalgar Square, and Buckingham Street, at a cost of £4 0s. 8d.

## REPAIRS TO SEWERS AND GULLIES.

On the 25th December last the Vestry, in common with other works, took over the cleansing and repairs to sewers and gullies, a sewerman at 30s. and a labourer at 20s. per week being permanently employed.

The cost of repairing sewers and flushing boxes, and providing and repairing side entrance covers, amounted to the sum of £62 1s. 3d.

Prior to 25th December last the cleansing of the covered sewers was performed by contract, at £25 per mile per annum on  $3\frac{3}{4}$  miles, and the gullies at 2s. 6d. per annum on 420. Since that date the work has been undertaken by the Vestry.
