Inquiry into the alleged Darkening of the Hair of the English in the Present and Recent Generations (see overleaf).

THE inquiry deals with all individuals, from the children upwards, in each stage of direct genealogical ascent, to the grandparents inclusive, or even to the great-grandparents. It also deals with the brothers and sisters of each of those individuals, Consequently the data asked for refer to a series of groups of brothers and sisters, each of which contains one of the individuals just mentioned.

The following Table assigns Register Numbers, by which each direct ancestor may be specified. No. I signifies a child irrespectively of sex, but all the other odd numbers refer to females, and all the even numbers to males. See the list overleaf. The Table will be found very convenient, and to admit of indefinite expansion,

The Table will be found very convenient, and to admit of indefinite expansion, with the invariable result that the Register Number of any individual when doubled gives that of his father, and this, with the addition of I, gives that of his mother.

Explanation of the reason for the inquiry, overleaf.

It is alleged that on the whole the hair of English children is darker than that of their parents, and it is asserted that the English race is gradually but surely becoming dark-haired. The object of the present inquiry is to test the truth of this statement. It is probable that the recent and rapid changes in English habits have caused certain sub-types to prevail in the struggle for existence, that were repressed before, and it is of interest to know what these sub-types are. The colour of animals is often found to be intimately correlated with their power or incapacity to thrive under certain conditions, and it may well be the same in the case of man. Again, it is undoubtedly the fact in America, where the mental fidget, social worry, business anxiety, and other conditions that characterise modern civilisation, are even more pressing than with us, that black-haired persons are less liable to permanent ill-effects from nearly every form of disease than those who are fair-haired. (Baxter.)

It is desired to ascertain, primarily in regard to the middle and upper classes

of English society,-

(I) Whether it be true that children born during a recent period in England are darker than their parents.

(2) Whether there is any change in

other personal characteristics.

(3) Whether dark-haired and other

types differ in fertility.

(4) Whether the English race as a whole is becoming more dark-haired or otherwise changed, as the outcome of two possibly opposing tendencies, namely, of the most enduring type being the least prolific.

A suitable number of these papers with blank schedules overleaf, will be sent to any competent correspondent who is willing to collect information concerning the members of his own family. The most valuable returns by far will be those that extend to all the eight grandparents of the young family, and it is believed that the parents of many young families are competent to furnish such returns in their behalf, being themselves sufficiently young to obtain the required information concerning their own grandparents, great uncles and aunts, and, of course, of their parents, uncles,

aunts, brothers, and sisters. An inquiry of this completeness requires 15 forms to be filled up. The information concerning the brothers and sisters of direct ancestors is of importance in two ways, first as regards the question of fertility, and secondly as useful evidence of the race of that ancestor being more or less mixed. If a man who was himself fairhaired had dark-haired brothers and sisters, we should infer that most of his own ancestors had been dark-haired, and that he would be more likely to have dark-haired descendants than one whose brothers and sisters were all fair-haired. The two cases ought to be sorted into different statistical groups.

Returns will be of little value that do not include at least all the four grandparents, the parents, some of the uncles and aunts, and the brothers and sisters of

the present generation,

Inquirers will often discover to their surprise that more of the desired information can be obtained concerning past generations than they could have sup-posed. Locks of hair will have been preserved, and perhaps forgotten portraits will be discovered to exist; besides this, the memories of elderly relatives and family friends are occasionally very tenacious, and will be often found corroborative of one another. The inquiry will have the merit of being accompanied by incidental pleasures; it will be an excuse for corresponding with distant friends and relations on topics of common interest, and it is probable that not a few facts of family history much prized by its members will in many cases be incidentally brought to light by its means.

Whoever may kindly undertake to collect data for me, will have the trouble of filling the blanks in the heading of the forms that are allotted to his family. The father and mother of (1) will be the same in all of them. He will also have the trouble of sending each form to be filled by the member of the family whom he thinks best able to do so, and when he has received them all back, of transmitting them to my address as below-



RULES

GOVERNMENT of THE CLUB

The Club shall be called the ALPINE CLUB.

П

The management of the Club shall be vested in a President, two Vice-Presidents, an Honorary Secretary, and a Committee of Eight Members. Three shall be a quorum. The Honorary Secretary shall act as Treasurer.

III

All the Officers of the Club and the Committee shall be elected annually by ballot, but shall in all cases be eligible for re-election, subject to the following limitations; namely, that the President and the Vice-Presidents shall not hold office for more than three years consecutively, and that the two senior members of the Committee shall go out annually by rotation. The Committee shall have power to add to their body, as an extra member, the Editor of the Alpine Journal for the time being, or the Honorary Librarian for the time being, or anyone who shall have served the office of President, Vice-President, or Secretary of the Club. The extra members of the Committee shall not exceed five in number at one time, and shall have all the powers of ordinary members. They shall be elected for one year only, but may be re-elected, though not for more than three years consecutively. This last restriction shall not apply to the Editor of the Alpine Journal, or the Honorary Librarian for the time being.

IV

The names of members intended to be proposed for the offices of President and Vice-President, and for the Com-

mittee, together with the names of those who retire by rotation, are to be submitted to the members, or put up in the Club-room, at least a week before the day of election.

V

In case of a vacancy occurring in the office of President, one of the Vice-Presidents shall execute that office until the next annual meeting for the election of public officers. In the case of a vacancy occurring in the office of Vice-President, the Committee shall have power to appoint a member of the Club to act as a Vice-President for the same period. In the case of a vacancy occurring in the Committee, it shall be competent to the latter or to any member of the Club to propose a candidate for election at the next or any subsequent General Meeting during the then current year.

MEETINGS and DINNERS of THE CLUB

VI

The Annual General Meeting of the Club for the election of the President, Vice-Presidents, Members of the Committee, and Honorary Secretary for the ensuing year, shall be held in November or December. A General Meeting of the Club shall also be annually held in January or February for passing accounts, and for general business.

VII

The Committee shall have the power to call general meetings of the Club whenever they shall think fit, and to make from time to time such regulations consistent with these Rules as they all think necessary for the well-being of the Club Minutes of their proceedings shall be entered in a book, and confirmed at their next meeting.

VIII

An Extraordinary General Meeting of the Club shall be called on a requisition in writing, signed by any ten members, being sent to the Honorary Secretary, and ten days notice shall be given of such meeting.

f3-

IX

No new rule or alteration of a rule shall be made except at a General Meeting, nor without the sanction of two-thirds of the members then present: notice of such meeting, setting forth such proposed new rule or alteration of a rule, shall be given at least ten days previously to every member of the Club. No original motion affecting the rules or the finances of the Club shall be entertained at any meeting unless notice thereof shall have been given in the circular last issued before such meeting.

X

The members of the Club shall dine together once in every year, on a day to be fixed by the Committee. Except under special circumstances, the dinner shall take place in December. Every member shall be at liberty to introduce, at his own expense, friends at the dinners of the Club. Notice of the date appointed for the dinner shall be sent by the Honorary Secretary to each member at least fourteen days before such day; and every member proposing to attend the dinner shall send notice to the Honorary Secretary of such his intention, and also of his intention to introduce a friend or friends, if he so intend, four days at least before the day appointed. A dinner of the Club shall also take place in May or June of each year, provided that not fewer than twenty members shall, on or before the 20th May, signify to the Committee, in writing, their intention of attending such dinner, if held.

ELECTION of MEMBERS

XI

Every candidate for admission to the Club shall be proposed by a member having personal knowledge of him, and seconded by some other member; unless he be a foreigner, or an Englishman living habitually beyond the limits of Great Britain and Ireland, in which case the Committee may dispense with such personal knowledge. Every candidate shall be balloted for at a General Meeting of the Club, and one black ball in ten shall exclude. No election shall take place unless twelve members are present. Not more than ten candidates shall be balloted for on any one evening.

XII

The name of every candidate, together with a list of mountain expeditions, or a statement of the contributions to Alpine literature, science, or art upon which he founds his claim for membership, shall be first submitted to the Committee, who shall decide upon the sufficiency of his qualification.* After having received their approval, and after election, the name of the new member, and the statement of his qualification, shall be entered in a book which shall be kept in the Club-room and be open to the inspection of members. The Christian name and surname of each candidate, together with the names of his proposer and seconder, his address, and his profession or other description, shall be written on a separate card, which shall be posted up in the Club-room a fortnight before the day of balloting, and shall, when the ballot takes place, be placed over the ballot-box of each candidate. The particulars so stated on the candidate's card shall be sent by post to each member at least one week before the day of balloting.

XIII

Members who may wish to support a candidate may do so by signing their names on his card, or by sending to the Secretary an intimation of their desire to support such candidates, when their names will be placed on the card by the Secretary, it being understood that such signatures, whether sent to the Secretary or placed on the card by members, imply a personal knowledge of the candidate, and also that they will not be counted as votes in the ballot. No name shall be placed on the card by members or the Secretary on the day of ballot.

XIV

Unless twelve white balls are deposited in favour of a candidate, he shall not be elected; but if his non-election arises solely from the fact of less than twelve white balls being deposited, he shall be put up again for ballot at the next

meeting. A candidate who is rejected by one black ball only shall be put up again for ballot at the next meeting. A candidate who is rejected by two or more black balls shall not be proposed again within twelve months.

PRIVILEGES and LIABILITIES of MEMBERS

XV

Each member shall pay an entrance fee of One Guinea, and an annual subscription of One Guinea: the subscription to be due on the 1st of January in each year. No member shall vote on any occasion whatever until he shall have paid his annual subscription, and the names of any members whose subscription shall be in arrear for three months shall be posted on a list in the Club-room, and notice shall be sent to them by the Secretary; and anyone whose subscription shall be in arrear for twelve months shall cease to be a member of the Club: provided always that the Committee shall have power, upon payment of all accruing arrears, to re-admit any member who shall have been excluded on this ground. No member whose subscription has been in arrear more than three months shall attend any of the Club dinners, or make use of the Club-room, or receive the Club publications.*

XVI

New members are to pay the subscription immediately on their election, and shall not enjoy any of the privileges of the Club until they have done so; but members elected between the 1st of July and the 1st of January shall not be required to pay any subscription for the ensuing year. The election of any member who does not pay his entrance fee and first year's subscription within three months of the date of his election, shall be null and void.

XVII

Any member, elected prior to the 1st of March 1872, who may be absent from England during the whole period for which the annual subscription is payable, may be exempt from the

subscription during such absence, but, while so exempt, he shall not receive the Club publications.

XVIII

The officers of the Club, together with the Committee, shall have the power of electing suitable persons as honorary members.

XIX

A Special General Meeting, convened for the purpose of considering the conduct of any member of the Club, shall have power to expel him by a majority consisting of not less than ten members, the vote being taken by ballot. Such member shall have his subscription for the current year returned to him.

XX

No book or publication shall be taken away from the Clubrooms unless by the Editor for the time being of the *Alpine Journal*, or, with special leave from the Committee, by a member engaged in study or research connected with the objects of the Club.

REGULATION MADE BY THE COMMITTEE in accordance with Rule VII.

Every candidate for admission to the Club shall, before his claims are considered by the Committee, transmit to the Hon. Secretary, through his proposer or seconder, a list of his mountaineering expeditions, with a statement of the year or years in which such expeditions were made. Such list shall be signed by the candidate.

The Committee may, however, under very special circumstances, dispense with the signature of the candidate and accept that of his proposer or seconder instead.

N.B.—The Club-room, at 8 St. Martin's Place, Trafalgar Square, is open daily. Members will be admitted by the Housekeeper at any time during the day; or they can obtain from the Assistant-Secretary, by payment of One Shilling, a key of the outer door.
