

#### SPECIAL DIRECTIONS FOR TREATMENT.

Ist. For Hay Fever.—When the date of the attack is definitely known, the treatment should commence a few days before the expected time, to prevent, if possible, the formation of the disease, or at least to mitigate its violence. Take a teaspoonful (undiluted, and with nothing after it) every three hours; if sneezing should set in, every hour night and day until the attack is entirely broken up and the disease is under control. Then prolong the interval to three hours, and gradually more, as directed by the label. As the causes of the disease pervade the atmosphere till frost, the hourly treatment must be resorted to at the slightest symptoms of relapse.

2d. For Chronic Catarri.—Take a teaspoonful every hour night and day, until the head is clear and the disease entirely under control. Then take a teaspoonful every three hours, gradually increasing the interval to three times a day until all traces of the disease have disappeared.

3d. The remedy should never be taken on an empty stomach. Small portions of food should be taken "between meals" during treatment, and also before breakfast, to promote digestion and prevent irregularity in the doses. The success of the treatment depends largely upon regularity, and placing the system under the specific influence of the remedy as soon as possible.

4th. Persons with sensitive stomachs and easily nauseated, may take only half-doses at intervals of three hours, till they become accustomed to the remedy; but the sooner they can take it every hour, the sooner the desired result will be obtained.

5th. During the Hay Fever season patients should never leave the house without the remedy for instant use in case of threatening symptoms. 6th. The above directions are applicable to the treatment of Spasmodic and Chronic Asthma, Spasmodic Croup, Whooping Cough, Acute Catarrh and Bronchitis, Influenza, and the endless variety of Catarrh and Sneezing Head Colds prevalent throughout the year. For general directions see label. For infants of a few months old the dose should be from (5) five to (20) twenty drops, according to age, at same intervals, until relieved.

7th. The effect of this remedy is so evanescent that oft-repeated doses are required to keep the system under its influence; therefore patients need fear no bad results, as its effect ceases with its use. It is not prescribed on the principle of substituting one pathological condition for another; its object is simply to promote natural vital processes, whereby diseased elements are eliminated from the system, and functional and organic changes are prevented. The condition of those who have been relieved by it is abundant guarantee of its safety. Its value by no means terminates with the Hay Fever season.
