To serve this purpose properly it is necessary that it should be freed as well from mechanical impurities as from an excess of the animal salts contained in it. We refine and re-crystalize our sugar of milk on our own premises, and after having been thoroughly dried it is pulverized on our mills that were never used for any other purpose. Many sophistications are introduced into this article by various dealers, and physicians should be careful from whom they purchase. Its character and test are for the most part easily applied. They are also described in the American Homœopathic Pharmacopæia.


