

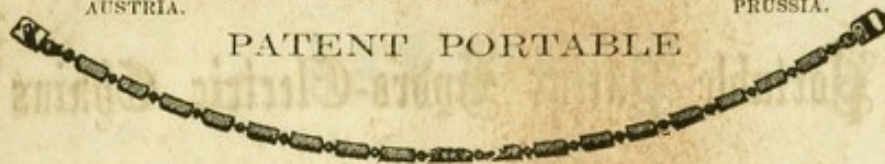

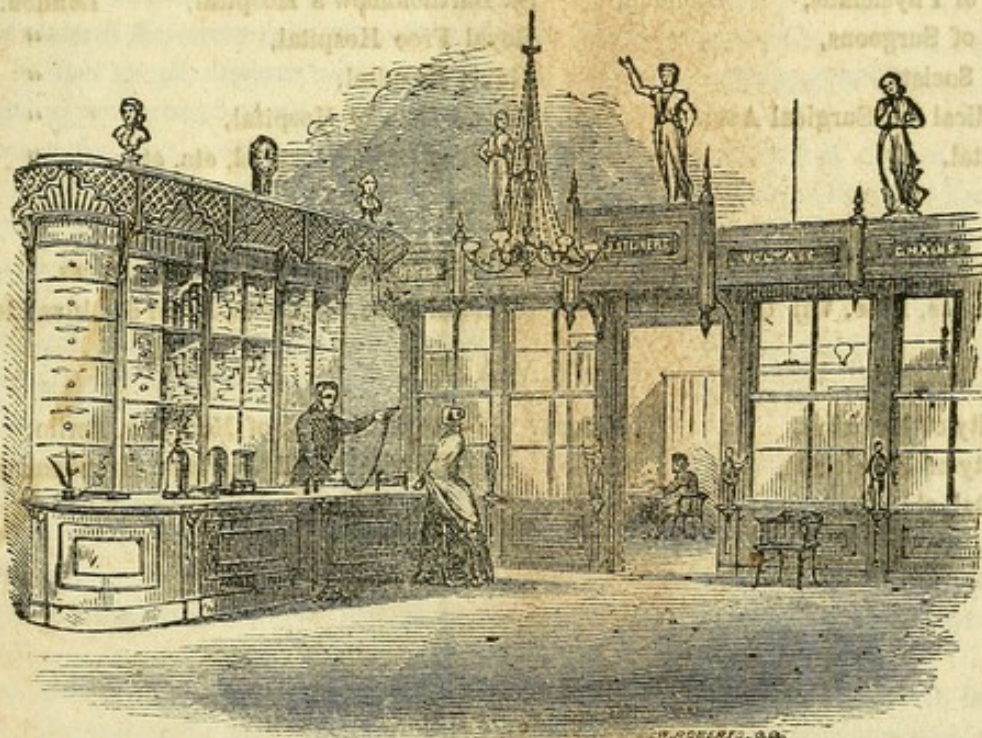

P R E F A C E .

IN offering to the people of the United States a greatly improved and strictly scientific apparatus for the relief of local pains, and permanent cure of a class of diseases called "nervous," it is necessary that a brief and truthful history of the effects of the Patent Hydro-Electric Voltaic Chain should be given to all, together with a clear and definite description of their mode of use in every case, for which they are recommended.

It is a well known fact, that since the introduction of the P. H. E. Chains before the world in England, France, Germany, and many other countries in Europe, as well as since their introduction in the United States, the cures, which have been effected in Nervous Diseases, are UNPARALLELED in the annals of Medicine. All the certificates, which the short space of this pamphlet permits of recording and presenting to the reader, are truthful cases from intelligent persons, who have given their testimony in favor of the chains of their own free-will.

It is not claimed that every case of nervous disease can be permanently cured by the use of the Chains. Neither are all diseases cured by the judicious use of medicine, administered by the most learned and experienced physician. It has been ordained by a Wise Creator, and it is an unalterable law of nature that man must die,—that the harp of thousand strings cannot always keep in tune! Pain and Suffering, Disease and Death have been entailed upon mankind, as long as it has ever existed and doubtless ever will! Still it is no less the duty of the philanthropic Physician, the discoverer of new principles in the art of curing disease, or of any person in whatever situation in life, to bestow upon suffering humanity the result of his practice and experience, in relieving the pain and suffering, incident to mankind! What more pleasing task can there be, than assuaging the pains and ills of life—bringing health and life to the sick and afflicted, and joy and consolation to the desponding and disheartened?

A large majority of the certificates of cures are forged, the persons never existing, or else these testimonials were hired.

There is no article that has ever been presented to the American people, that has been received with such universal approbation, that has been so highly spoken of and recommended, that can produce so many well authenticated certificates from the first scientific men, medical and otherwise, in the world, of its strictly scientific character and its beneficial effects in treating the diseases for which they are recommended, than the Patent Hydro-Electric Voltaic Chain!

They have been submitted to the people of the United States upon their own merits, asking no praise which they were not deserving of, but confident in the belief that they are destined to produce a complete revolution in the relief and cure of a large class of diseases called "nervous!" THE SAME MAY BE SAID of liquids, called Negative or Positive Electric Fluids, as no such thing is in existence in such a form; neither can electricity be supposed separated into different parts, the terms Positive and Negative being but imaginary, and representing a Negative Electric Fluid bottled up, is downright nonsense! Kind Reader:—Just fancy part of your nervous fluid—considered to be the same as “Electric Fluid,” preserved in phials and sold at so much a bottle, showing beautiful colors from its extreme age, and to fill up for any loss of it in your body at any time!

If the reader will take the trouble to inquire, he will find that no other Electrical Apparatus, producing an uninterrupted current of Electricity similar to Pulvermacher's H. E. V. Chains has ever been patented by the United States Government, or recommended by the most learned physicians in the world, and introduced as a remedial agent into almost every hospital in the world!

While the construction is simple, the amount of Electricity produced IS VERY GREAT and the effects POWERFUL. Six links of the usual chain decomposing acidulated water in the Voltameter. Eight links will decompose pure water in the same instrument. A thirty link chain will produce sparks if applied to the temples, and two of them will produce perceptible shocks if the current be interrupted. The chain forms in fact a voltaic-battery; every link of it representing an element on the voltaic principle, and will therefore produce all the phenomena of a strong voltaic pile.

The patient will find CLEAR and FULL DIRECTIONS for the mode of applying the chain in every case, with a brief theory of the principal diseases; also auxilliary suggestions for the speedy relief of each complaint. While we strictly object to the use of taking SICKENING, DISGUSTING NOSTRUMS INTO THE STOMACH at the time of using the chain, strict attention to diet, exercise, bathing, pure air, etc., should be observed in all cases.

We have sought to introduce into the pamphlet as many valuable receipts and rules as the space will admit of, which will be found of great service to all. We trust that the reader will carefully peruse these few pages, here respectfully offered, and if the evidence is sufficient to induce a trial of the Electric Chain, we will cordially present our thanks for being able to convince people of the folly of the OLD and WORN OUT theory and practice, of making a drug-shop of the stomach for every ill “to which flesh is heir to,” and we firmly assure the public that **WHAT HAS BEEN TOLD IS THE TRUTH, THE WHOLE TRUTH, AND NOTHING BUT THE TRUTH!!!**

HISTORY OF THE ELECTRIC CHAIN.

Electricity, either in one form or another, has been used in the cure of disease to a greater or less extent from the earliest discovery of this wonderful and singular agent. Although, at first used but imperfectly, and but with little success, still after a series of patient and brilliant experiments, improvements took place, alterations and modifications occurred, bringing it under control of the inventive mind, and rendering it a passive agent, for good or evil, until it is now considered one of the greatest blessings, ever conferred on mankind. In proof of this, the history of the Magnetic Telegraph, the wonderful change that has been effected during the last few years, in sending intelligence, swift as thought, from the remotest part of the world, is sufficient to afford some idea of the value and benefit of Electricity to the world at large. From a wild unbroken steed, it has been taught to be submissive and obedient to the will of man; obeying his wishes and conferring countless blessings to untold millions.

With awe and wonder do we contemplate the lightning bolt from the heavens, unchained and wild, spreading death and destruction to everything in its course; yet how soon is fear changed to love, wonder and astonishment, when we behold the same powerful agent the playmate of the child, or amusing the learned philosopher in his secret laboratory, caused to fly to the uttermost parts of the globe, and like a carrier-dove returning again to him who willed it! Since the experiments of that great founder of Metallic Electricity Galvani, who discovered that by its application to the nerves of animals recently dead, life can be infused into them, with regard to all their usual movements, there has been discovered to exist a close relation between what is termed Vitality or Nervous Fluid and Electricity! That Electricity always pervades the human system to a greater or less extent, is no longer a doubt, and it is equally true that in certain Diseases, called Nervous, in which inflammation is absent, the healthy or natural amount of Electricity or Nervous Fluid in and around the part affected, is diminished in quantity and is also less equally distributed. By all these apparatuses, Electric Shocks, however interrupted, or broken Currents are produced, BUT NEVER A CONSTANT AND UNINTERRUPTED ONE. A great objection to all the above Batteries, also are their liability to get out of order, the inconvenience of applying them, and the few cases which occur, in which they may be applied to advantage.

Every intelligent physician is aware that Electricity, when administered in the form of shocks through the system, always produces a momentary stimulating effect, like alcohol, and is followed by great weakness or debility, without producing a constant and stimulating power. An Electric Battery producing shocks, should never be used but in cases of suspended life, by drowning, by a stroke of lightning, by poisoning through opium in some of its forms, or in an overdose of Chloroform or Ether. It is often used with much benefit in Palsy, either local or general. From the fact, that the only satisfactory mode of applying Electricity in the treatment of Nervous Diseases, is by passing it through the part or organ affected IN A CONSTANT AND UNINTERRUPTED CURRENT, with an apparatus of simple construction, which can be easily applied and worn by the patient, UPON OR NEAR the part thus affected, producing at the same time a powerful current if necessary, or lighter if required. Such an apparatus made its first appearance in Germany, in the year 1849, under the name and form of Pulvermacher's Patent Hydro-Electric Voltaic Chain. No sooner were these made known to the medical men of Germany, who sought every opportunity of testing their effects in the treatment of nervous diseases and in nearly EVERY CASE with complete success; then they at once took measures to have them secured to the inventor, in getting them patented from their government.

M. Carnochan, W. H. Van Buren, Alfred C. Post, and H. B. Bulkley, gentlemen well known to the medical profession throughout the United States. Their opinion concerning the strictly scientific character of the chains, and their beneficial effects in the relief and cure of Nervous Diseases, will be found in another part of the pamphlet. Also will be subjoined a selection from the hospitals and colleges, in which they are applied, and the certificates of the physicians connected with them, in favor of their wonderful curative effect.

Having during the last few months established agencies for the sale of Pulvermacher's Electric Chains, in all the principal cities in the United States, we are in daily receipt of the most ENCOURAGING ACCOUNTS of the demand and sale of the chains, and also that in nearly every instance, the purchaser was SATISFIED with the beneficial results which they accomplished. Orders for single chains

from all parts of the United States, South America, Mexico, West Indies, etc., are being constantly received, and testimonials from the highest and most responsible sources, are pouring in upon us. Many of these will be found in the pamphlet, of persons well known, and in no instance, is a certificate recorded without the consent of the person.

The prices of the chains, at retail, are \$5, and \$3. The one consisting of 30 links, or elements, and the other of 18 links, or elements. Their mode of use will be found very simple, and they are so constructed, that they will last a long while, seldom get out of repair, and are ever ready for immediate use.

Some have objected to a trial of the chains, on account of the price; but if patients will take into consideration, THE DURABILITY of the chains, which are frequently as useful after years' service, as when purchased, and compare the price with that paid for a bottle of some WORTHLESS and DISGUSTING COMPOUND, which in nine cases out of ten, renders patients rather worse than better, it will certainly appear, that the price paid for a chain, is comparatively a paltry sum.

We have thus given a brief history of the invention of the Patent H. E. V. Chains; their general adoption in nearly every hospital in the civilized world, and the great and satisfactory results they have effected, and that thousands of nervous diseases, have been relieved or cured by their use.

We would ask the reader, CAREFULLY to read the THEORY, and the MODE, by which the Electric Chain cures nervous diseases, which follows hereafter.

THEORY OR REASON

Why Electricity is the most valuable Agent in Relieving and Curing all Nervous Diseases.

A Nervous disease is one that is generally unattended by inflammation; the pain being confined to no particular place, but rapidly wandering from one part to another, producing, for the time, the most intense sufferings, and then leaving, perhaps the entire system, to return at stated periods.

We have said that when a person is in perfect health, that the Electricity of the system is in perfect harmony, and equally diffused, no particular part or organ possessing a larger amount than another, and the nerves, which spread like a net-work over and through the whole body, act as conductors for the nervous fluid, or Electricity. It is supposed that the brain and spinal marrow are the origin or fountain-head, where the Nervous Fluid is produced, and from thence sent along the nerves to every part of the body. It is as necessary to health that the brain and spinal marrow should be able to throw off a required amount of Electricity, and that the nerves should be in a condition to allow it to pass along their course, and that every organ should receive its due proportion, as it is, that the blood should circulate freely through every part of the animal system.

As already mentioned, it can easily be ascertained, if a part or organ possess sufficient Electricity or not, or in what proportion. After thousands of experiments in different diseases, it has now become a well established fact, THAT IN THAT CLASS OF DISEASES CALLED "NERVOUS," THE SUFFERING OR DISEASED PART, POSSESSES ALWAYS A LESSENED AMOUNT OF NERVOUS FLUID, OR ELECTRICITY.

Every person has doubtless experienced the happy relief from the pain of a nervous headache, or a painful joint, by a gentle rubbing or friction of the head or joint. By this simple process, the pain is in many cases instantly removed, from the fact, that an extra amount of Electricity is produced on the spot by that act.

Now the Electric Chains produce the same result, in a more powerful degree, by being worn for a time over or upon the part affected. They furnish that necessary element, (Electricity,) for the organ, which the system can no longer supply; the difficulty being either in the brain or spinal marrow, where the Nervous Fluid is generated, or upon the other hand, the Chain will remove

to their proper tone, the nerves leading—like the wires of the Magnetic Telegraph—to the parts affected, which may be broken or unable to allow such Fluid to pass along their course.

From the above scientific explanation, the patient will readily understand the Theory or Reason by which the Electric Chains will instantly relieve the most acute pains, and effect a permanent cure in the worse cases of chronic Diseases.

The reader has only to bear in mind, that,

1, Pain, wherever located, is caused by a diminished amount of the Nervous Fluid, or Electricity, in the part or organ affected, and that a continuance of pain, is always attended with weakness and debility; and that,

2, By restoring the natural amount of Nervous Fluid, or Electricity, by the use of the Patent Hydro Electric Voltaic Chain, the pain will be relieved, and the part, or organ, will be brought back to its natural condition.

General Rules to be observed in applying and using the Chains.

RULE 1. In all cases, the part or organ affected, should be between the two ends of the chain, which should always touch the skin, in order that the current of Electricity may pass from the white hook to the opposite end, THROUGH such part or organ. For example: if a chain is to be used for Chronic Rheumatism of the knee joint, the two ends of the chain should be applied upon each side of the joint, to cause an Electric current to pass right through, from one end of the chain to the other.

RULE 2. Before applying the chain, it should first be moistened, or drawn through common vinegar, or the Aromatic Fluid, which is to be had of all agents, and then applied as directed in Rule 1st. If the chain is to be worn constantly, it should be moistened twice or thrice each day, or so often as it becomes perfectly dry. But moistening it once, is sufficient to produce an Electric current for several hours. The chain should be washed or ripced in pure water every day, and wiped dry. It ought never to be folded up as long as it is wet, because it would then act upon itself. Neither should the chain touch another part of itself as long as it is worn on the body.

RULE 3. In applying the chain, the body of it, or links of which it is composed, need not touch the skin as long as the ends or buttons do so, but may be allowed to be outside of the clothing, or it may be enveloped in a cloth or oil silk. Sometimes the moisture of the vinegar or of the prepared aromatic fluid is unpleasant to the patient, and hence this advice.

RULE 4. If after being worn for a time, the part upon which the button has been applied should become sore or blistered, (as it often happens,) a thin piece of wet muslin may be placed between the button and the skin. If the current of Electricity is too strong for the patient, the vinegar or Aromatic Fluid may be diluted, or a certain amount of water added, until the patient can comfortably endure it. The power of the Electric current may easily be thus regulated.

RULE 5. If patients wish to convince themselves, that there is a perceptible current of Electricity produced by the chain, they may easily be satisfied by moistening a chain of 30 links, and placing the button attached to the yellow hook to their forehead, keeping the other in the hand. A less effect will be perceived with a smaller chain.

The following principles must ALWAYS be kept in view:

A. THE CURRENT TRAVERSES THE BODY THE SHORTEST WAY POSSIBLE FROM ONE END OF THE CHAIN TO THE OTHER.

B. THE CURRENT HAS, IN GENERAL, TO TRAVERSE THE NERVES AFFECTED, OR THE SEAT OF DISEASE.

For further particulars see the special disease, and the two diagrams with numbers.

REMARK :—The principal advantage of the Chain, above any modern improvements, is that it can be worn DIRECTLY UPON THE SKIN. By wearing it in contact with the body, the moisture of the skin keeps up a continual Electric current, in the same way as if it was a weak acid.

Rheumatism, Lumbago, Gout, etc.

Rheumatism is too well known to require an explanation of what the disease is, for there are but few persons who have not experienced the aches and pains, common to this complaint. Rheumatism is usually confined to the Joints, or the Muscles of the chest and back, and is considered and classed by physicians, as a Nervous disease, from the fact that the pain often changes from one part to another, with the rapidity of lightning. By applying the chain for this painful and lingering complaint, as directed in the General Rules given, and explained more fully and clearly by referring to the figures on the diagrams, for each particular location, the most acute pain is almost instantly relieved by the first application of the chain, and a permanent cure produced after wearing a chain for a few days. In many cases of long standing, it is necessary that its use should be continued for several weeks, in order that the suffering part should regain its natural amount of Nervous Fluid, or Electricity, and thus be restored to its healthy condition. A cure is more rapidly effected if strict attention be paid to diet, which should be vegetable, of a plain nutritious kind; avoiding FATTY articles, and all ALCOHOLIC drinks, unless it be porter or ale.

An attack of acute Rheumatism, when it is confined to a joint, should be treated at first by wrapping around the joint, a cloth wet with cold or ice water, and this should be changed as often as it becomes warm. In the meantime the chain should be applied as directed, in order to relieve the pain. After the case has continued for several days, and the joint has become weakened and debilitated, the joint should be kept enveloped in oil silk, or several folds of flannel cloth, and the chain used as before. No greasy liniment should ever be used; but gentle rubbing of the part with a dry hand, should be made use of, every day. Patients should avoid all active cathartics, but the bowels should be kept in a natural state, by the use of fruits, or a Seidlitz-powder. Blistering and bleeding is always injurious, and is not at the present day resorted to, by our most scientific physicians. The treatment, we have given above, is the one made use of in the different hospitals where the chains have been used extensively. The number of cases which have been greatly relieved or cured permanently of Rheumatism, are more than have ever been effected by any other means; and besides, when we take into consideration, that in a large majority of these cases, nearly everything else had been tried before resorting to the chains, the fact will speak for itself!

NEW YORK, November 6th, 1852.

SIR,—In April last I suffered of violent rheumatic pains in my left arm, and could not move it; my hand was swollen very much, and I felt very acute pains in touching it. I sent for my physician; in waiting for him my wife reminded me, that our neighbor spoke to her of Pulvermacher's Electric Chains, which, he said, were of excellent effect in toothache, headache, in rheumatism, and similar affections.

I then sent for the chains, and had fixed one end on my head, and the other on my arm. The softest touch caused a great deal of pain at first, but after having the chains applied for about ten minutes, they diminished very perceptibly. I was able to touch my hand, and the pains in my arm were now considerably less. The operation was performed with a chain of sixty links. Now a small chain of twenty-four links was fixed on my arm (having previously been moistened with vinegar,) and an India rubber cloth wrapped round. I then went to bed. Next morning my hand was still swollen, but the pains in my hand and arm were nearly gone; the long chain was then applied again for fifteen minutes, and afterwards the short one again fastened to my hand. The morning following the swelling and pain had disappeared, and I have not suffered since then, from rheumatism. My physician, whom I had informed of the application of the chains on the first evening, did not prescribe

anything, and I cannot ascribe my recovery, but to the curative powers of the Hydro-Electric Chains.

Neuralgia of the Face, and Neuralgic Diseases in General.

In a majority of cases the application of the chain for a few moments only is necessary to produce relief from pain, but in several instances—as intercostal neuralgia—neuralgia in the side—several hours elapse, before the pain leaves the part. The chain should be applied as often as the pain returns. In order to help the action of the chain the patient should keep in door, not expose the face to cold damp currents of the air, which are apt to retard the action of the chain.

For Neuralgic Diseases in general,—as Intercostal Neuralgia, or Neuralgia in the sides,—for Neuralgia in the limbs or uterus, the chains must of course be applied locally, in such a manner that the Electric Current can pass through the suffering part, according to the general rules, and on the principles before mentioned.

Paralysis, (Palsy,) Diseases of the Spine, etc.

The causes which generally produce Paralysis, or Palsy, are usually in the brain and spinal marrow, and arise from debility and chronic inflammation, followed by the softening of the substance which composes it. The usual symptoms which produce an attack of the symptoms, are pain, more or less severe, located in the base of the brain or along the course of the spine. Oftentimes the pain is so slight as to attract but little attention from the patient, being the forerunner of perhaps but a very slight attack of Palsy; the first symptoms of which are noticed as WEAKNESS OR INABILITY to use the limb or part affected. This condition gradually increases, until complete palsy takes place, and the limb becomes lessened in size; skin shrunken and cold, attended sometimes by a sticky perspiration.

When one entire side is paralyzed, the cause is located in the base of the brain OPPOSITE to the side affected. When confined to an arm, the pain is experienced along the upper part of the spine, for the reason, that the nerves, which supply the upper extremities, pass out from that region. A long continued use should be patiently persisted in—strict attention to diet—exercise—bathing and friction on the spine and skin, riding and walking in the open air, change of scenery and climate, and freedom from care and anxiety.

The patient is requested to follow strictly the following directions in applying the chains for the cure of Palsy:

If the case is one of PALSY OF THE SIDE, including the arm and leg, one end of the button attached to the white hook should be applied to the upper part of the spine, CLOSE TO THE HEAD, and the other button upon the lower part of the spine, NEAR THE HIPS. This is done by passing around the neck and body the elastic band accompanying each chain. By thus placing the chain, AN ELECTRIC CURRENT IS PRODUCED AND PASSED from the brain to the lower part of the spine, which touching the principal nerves, is sent through the entire system. For Palsy of the arm, one end of the chain may be applied upon the nape of the neck, and the other end upon the under surface, near the arm-pit; for the reason that the nerves, which supply the arm, are near the end of the chain in that locality; hence the effect of the chain is increased. The chain, however, can be changed, from time to time, to other parts of the arm, while one end should remain upon the spine, where it was first applied. Hysterics. Fits. Epilepsy.

Bronchitis. Loss of Voice. Asthma.

These diseases are frequently relieved by the first application of the Chain. The mode of applying the Chain in Asthma is by attaching the white hook end to the spine, near the base of the brain, and the other upon the chest, frequently changing the latter from one place to another.

For Bronchitis and loss of voice, or hoarseness, apply the chain upon the throat, or vocal organ, and allow it to remain for several hours each day. The white hook end to be attached on the top of the spine, at the back of the head. In most instances of severe hoarseness, the difficulty is soon REMOVED, and the voice reassumes its natural condition. The Chains are becoming also a popular remedy FOR DISEASES OF THE LUNGS, and many have been highly pleased, with their effects, who were laboring under incipient consumption.

St. Vitus Dance.

This is a strictly nervous disease. It has its origin in the Spinal Marrow, and is a disease usually confined to young persons from the age of ten to sixteen years of age. The person so affected possesses no control of the voluntary muscles, or muscles which are contracted by the will. The sudden contractions of these muscles in the entire system are familiar in every case of this disease. But little pain is experienced, and the general health often remains good.

In applying a Chain for St. Vitus Dance, a thirty link one should be made use of, by applying the white hook end upon the upper part of the spine, and the other end upon the lower part, let it then be worn until a cure is effected. The bowels should always be kept in a natural condition, by means of some of the Saline Cathartics, as Epsom Salts, or Soda and Rhubarb. Bathing and the Shower Bath should be daily used, as well as exercise in the open air when the weather will admit. As this disease is caused in many instances by irregularities of the female system, the chain may be worn sometimes in such a manner, that the white hook is attached to the spine, and the yellow one to the lower part of the abdomen.

There have been many cases of this disease cured by the use of the H. E. Chain, in different parts of the United States, during the last few months.

SCIATICA,

Or Nervous Complaint of the Hip Joint.

This most painful disease is quite common in our northern latitude. It is produced by exposure to wet and cold, over exercise, which in some measure alters or changes the course of the Nervous Fluid, or Electricity, from passing along the large Sciatic Nerve of the hip and thigh. In this case a thirty link chain should always be used, as it requires a large amount of Electricity, in order to relieve the pains, which is the most intense. In using the chain, the white hook should be attached upon the spine, just above the hips, and the other over the region of the pain. If blisters are produced by the chain, it facilitates the cure. The chain should be worn DAY AND NIGHT, until a cure be effected, as it often requires several weeks before the Nervous Fluid is equalized about the joint. The first application PRODUCES RELIEF FROM PAIN, or at least renders it much less severe or excruciating.

When the pain extends to the muscles of the thigh, and below the knee, the chain should extend from the hip to the hollow of the knee, or from the knee to the ankle, and fixed as indicated also in the diagram, No. 15.

Impotence and General Debility of the Genital Organs.

The H. E. V. Chains cannot be too highly praised or recommended to THOSE who are suffering from these complaints. It is not our province to speak of the causes which produce this prevalent

complaint, for there are but few persons, so affected, who are not well aware of its cause. Over indulgence and self abuse may justly be considered the true causes in nine cases out of ten. 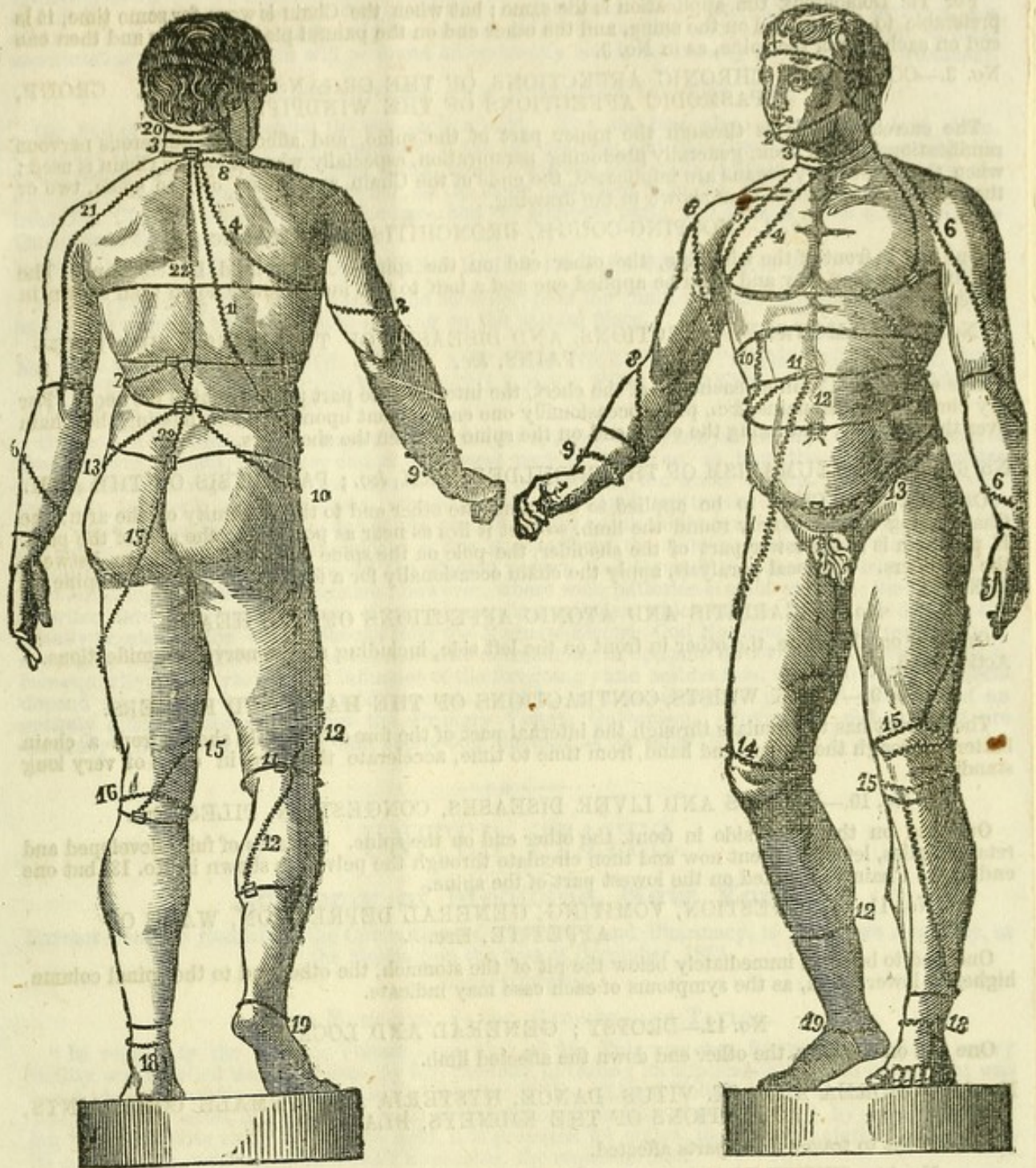

We add two diagrams, showing how the same chain may be applied or worn in different diseases, followed by an enumeration of complaints in which the chain has generally to be fastened as described. The number on the figures refer to the enumeration of each disease specified.

CHAIN

No. 1.—NERVOUS HEAD-ACHE, WEAK EYES, AMAUROSIS, &c.

For the relief of momentary head-ache, it is sufficient to apply a longer chain, well soaked with fluid (the hands covered with leather gloves), for one or two minutes, with one end (the last link) on each side of the head, where the pain is situated, and when the prickling sensation is felt strongly, remove one end and apply it instantly again, varying the places of application, so that the current circulates in various directions through the part affected. For weariness of the eyes, colds, &c., where the nerves want only a momentary impulse, the application is the same; but for long standing and deeply seated diseases of this character, a small chain has to be worn for some time, as shown in the drawing, varying the application occasionally, by making the current traverse the upper part of the spine, as shown in No. 3.

No. 2.—TOOTH-ACHE AND TIC DOULOUREUX.

To relieve acute tooth-ache, use a long Chain for a short period, as prescribed for head-ache, but applying one end either on the cheek, the front or back of the gum, or in the tooth (well cleaned out), according to the situation of the pain; and applying the other end for pains in the upper jaw, on the upper part of the cheek; for pains in the lower jaw, under the ear. (For proper conductors, see under Accessories.) To reduce swelling, lingering pain, and, in short, cure the disease, and prevent the return of the acute pain, fix a small Chain, as shown in the diagram, or pass a longer Chain round the neck, so that the two ends are placed on each side of the spine, and the rest of the Chain hangs down over the chest, on the principle of No. 3.

For Tic Douloureux the application is the same ; but when the Chain is worn for some time, it is preferable to fix one end on the spine, and the other end on the painful place, and now and then one end on each side of the spine, as in No. 3.

No. 3.—COLDS, AND CHRONIC AFFECTIONS OF THE ORGANS OF SENSE. CROUP, SPASMODIC AFFECTIONS OF THE WINDPIPE.

The current circulates through the upper part of the spine, and affects the numerous nervous ramifications of the neck, generally producing perspiration, especially when a longer Chain is used ; when the respiratory organs are implicated, the ends of the Chain are placed on the spine, two or three inches lower down than shown in the drawing.

No. 4.—HOOPING-COUGH, BRONCHITIS, ASTHMA, &c.

One end in front of the windpipe, the other end on the spine. Action mild, but constant. The end in front may now and then be applied one and a half to two inches lower down than shown in the drawing.

No. 5.—PULMONARY AFFECTIONS, AND DISEASES OF THE CHEST, SHOOTING PAINS, &c.

One end of the Chain on each side of the chest, the intermediate part passed behind the neck. For dry chronic coughs, pains, &c., place occasionally one end in front upon the chest, passing the Chain over the shoulder, and fixing the other end on the spine between the shoulders.

No. 6 and 8.—RHEUMATISM OF THE SHOULDER, ARM, &c. ; PARALYSIS OF THE ARM.

One end of the Chain to be applied to the spine, the other end to the extremity of the arm, the Chain being wound loosely round the limb, so that it lies as near as possible to the seat of the pain. If the pain is in the lower part of the shoulder, the pole on the spine must be lower down between the shoulders. For local paralysis, apply the chain occasionally for a few hours along the spine, as in No. 22.

No. 7.—CARDITIS AND ATONIC AFFECTIONS OF THE HEART.

One end on the spine, the other in front on the left side, including all the nervous ramifications.—Action Mild.

No. 9.—WEAK WRISTS, CONTRACTIONS OF THE HAND AND FINGERS.

The current has to circulate through the internal part of the fore-arm. Mild shocks from a chain battery, through the fingers and hand, from time to time, accelerate the cure in cases of very long standing.

No. 10.—BILIOUS AND LIVER DISEASES, CONGESTION, PILES, Etc.

One end on the right side in front, the other end on the spine. In cases of fully developed and retained piles, let the current now and then circulate through the pelvis, as shown in No. 13, but one end of the Chain to be fixed on the lowest part of the spine.

No. 11.—INDIGESTION, VOMITING, GENERAL DEPRESSION, WANT OF APPETITE, Etc.

One end to be fixed immediately below the pit of the stomach, the other end to the spinal column, higher or lower down, as the symptoms of each case may indicate.

No. 12.—DROPSY ; GENERAL AND LOCAL.

One end on the liver, the other end down the affected limb.

No. 13.—CHOREA AND ST. VITUS DANCE, HYSTERIA AND FEMALE COMPLAINTS, AFFECTIONS OF THE KIDNEYS, BLADDER, &c.

The current to traverse the parts affected.

No. 14.—WHITE SWELLING, AND ULCERATION OF THE KNEE JOINT.

The current circulates through the posterior part of the joint, to stimulate the absorbents.

No. 15.—SCIATICA, LUMBAGO, Etc.

One end of the Chain at the bottom of the spine, the other end in the hollow of the knee ; the intermediate part being wound loosely round the affected limb.

No. 16.—RHEUMATISM IN THE KNEE JOINT.

(See figure.)

No. 17.—INDOLENT ULCERS, VARICOSE VEINS, Etc.

The ulcer is to be traversed by the current, as shown in the drawing, to restore vitality. For varicose veins, the interrupting cylinder has to be inserted, and the chain fixed as for ulcers, so that it does not touch the affected place, but sends the current through it ; when, however, there is the least inflammation, the Chain must, in this disease, be left off for some time.

Nos. 18 and 19.—WEAK ANCLES, GOUT, Etc.

In cases of gout in the toe, it is preferable to fix one end, as often as it can be done conveniently, on the toe suffering, and the other end on the inside of the ankle, the Chain, if a long one, being wound round the foot. As soon as the gout then begins to travel, it must be followed up by applying the Chain wherever the pain is felt, taking at the same time a mild aperient ; when the flying pains

are gone, and goutish pains still left in the feet and toes, apply the Chain again on the foot, and repeat the operation as above stated, until all pains have left. Gout, and particularly podagra, is a disease which can, in most cases, only be relieved safely by degrees, and, of course, under medical superintendence. The Chain will be found an eminently beneficial remedy under proper treatment.

No. 20.—DEAFNESS AND DISEASES OF THE EAR.

One end of the Chain behind the ear—action mild. Now and then place one end of a long chain, by means of the pointed sponge conductor, in the ear channel, and the other end on the opposite side of the head, and when the prickling is felt, remove one end and apply it again instantly, varying the direction of the current through the ear, on the same principles as in No. 1. Occasional mild shocks from the Chain Battery through the ears, and the adjacent parts, will greatly assist and accelerate the cures of these inveterate diseases.

No. 21.—NEURALGIA AND SHOOTING PAINS IN THE SHOULDER AND UPPER ARM.

If the pain is in the lower part of the shoulder, pass the chain over the shoulder under the arm, and to the spine, so that the Chain is lying on the painful place.

No. 22.—DISEASES OF THE SPINE AND THE NERVOUS SYSTEM; GENERAL DEBILITY AND WANT OF POWER; EPILEPSY; FITS; GENERAL NERVOUSNESS; GENERAL PARALYSIS.

One end of the Chain in the nape of the neck (for epilepsy and paralysis as high up as the hairs of the head will permit), the other end at the lowest part of the spine, so that the current circulates through the whole spinal column; animating and invigorating the whole system. In paralytic, and, generally, in deeply-seated diseases, which require prolonged treatment, it is of great benefit, in addition to the continuous influence of the portable chain occasionally (say once a day, or once every second or third day), to communicate a few shocks from the more powerful Chain Batteries (for Physicians, etc.) along the course of the affected nerves, and through the diseased parts, in order to give additional impulse to the system; however, where such batteries are not at hand, the occasional insertion into the portable Chain of an interrupting cylinder, which may be had at the depots, will greatly accelerate the cure. Shocks from the Magneto-Electric Coil Machine, formerly much in use, are highly objectionable, because the alternate currents are in opposite directions, every single shock, consequently, counteracting the influence of the foregoing; and besides this, the whole of their effects depend upon secondary or induced currents, which, in a physiological point of view, are of an entirely different character from the Primary Voltaic Galvanism. Physicians and patients are earnestly advised not to use a Chain and a Coil Machine at the same time.

Academy of Medicine, New York.

Extract from the Records of the Committee on Chemistry and Pharmacy, to the above Academy, at the Meeting on the first of December, 1852.

COMMITTEE:

DRS. MACNEVEN, SAYRE, GARRISH, AND TAYLOR.

"In regard to the Electric-Voltaic apparatus of Mr. Pulvermacher, for medical purposes, every facility was afforded the committee, by Mr. Steinert, of testing its applicability. This instrument was found to be, essentially, an ingenious modification of the original Voltaic pile; it consists in a chain composed of a series of zinc and copper wires, arranged on bits of porous wood, by simply moistening this chain with vinegar, or acetic acid, it is prepared for action, the porous material entering into its composition, holding, as in Volta's apparatus, the requisite fluid.

"A Galvanic instrument of this form is well calculated for medical purposes, from being so readily available when required. In examining it, in reference to its advantages for ready application, the power, intensity, and permanency of action it was capable of manifesting, was also duly considered.

"The chains exhibited to the committee were of two sizes, with power proportionate to their respective dimensions. The smallest sized chain is intended where moderate power only is requisite; the larger chain is intended to supply power equal to any demand, which would probably be made for medical purposes. One of the latter size, after having been once thoroughly moistened with vinegar, and left exposed to the air, was found to be capable of deflecting the galvanometer for two hours and a half. If enclosed in oiled silk, as the chains are designed to be when worn upon the person, this action is of course prolonged. In the ordinary use of the instrument, however, the permanency of its action must be maintained by moistening the chain from time to time, say about once in fifteen or twenty minutes, with vinegar. The number of links may be readily increased by connecting two or more chains together, and the intensity of the Galvanic current proportionately increased. Four chains, of sixty links each, having been thus connected, the intensity of the electric current was found to be augmented to a degree too painful to endure.

"The most complete form of the apparatus examined is provided with a handle, containing an armature moved by clockwork, for regulating the circuit. In the less complete form of the instrument an attachment, containing a spring, is provided, which may be made to effect, though imperfectly, the same purpose.

"On the facts above stated, the committee is of opinion that the Voltaic Chain of Mr. Pulvermacher, while it presents an instrument of the requisite efficiency, has the advantage, for medical

purposes, of being more portable, more readily available, and more economical in its use, than the Electro-Galvanic instruments at present employed."

It is a modification of the Voltaic pile, giving us all the effects of Galvanism in a form much more convenient, and much more manageable, than the machines in ordinary use, and less apt to get out of order. It has the very desirable property of creating a continuous uninterrupted current of electricity of moderate tension, and always in one direction.

The inventor received the unanimous thanks of the French Academy of Medicine; and the practical value of the instrument is attested by Drs. Golding Bird, Pereira, and many others of the first medical men in London. An agency is about to be established in this city, the particulars of which will be made known by means of circulars and advertisements, when the arrangements are completed for the requisite supply of the instruments. In the meantime, the merits of the article will be tested at the hospitals and in private practice, as cases proper for its use may present themselves.

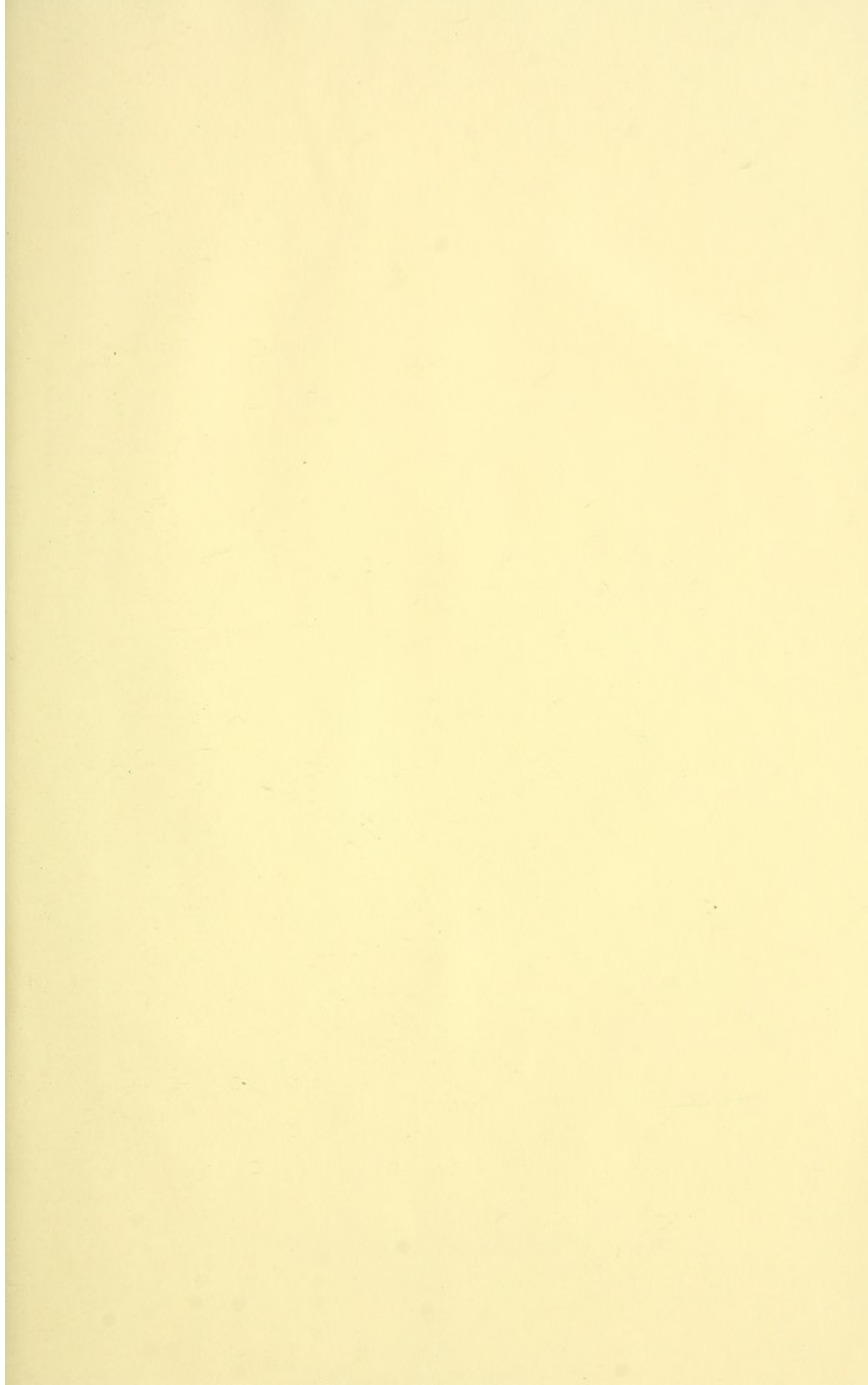
