

## CAP. X.

AN ACT FOR MAKING FURTHER PROVISION FOR THE EFFEC-TUAL PERFORMANCE OF QUARANTINE. [12th march 1805.]

TATHEREAS by an Act, passed in the thirty-ninth and fortieth years of the reign of his present Majesty, intituled, An Act 50 & 40 G. 3. for erecting a Lazaret on Chetney Hill, in the county of Kent, and c. 80. for reducing into one act the Laws relating to Quarantine, and for making further provisions therein, and by other acts antecedent thereto, provision was made as well for purchasing lands for erecting a Lazaret as for defraying the expenses of building the same, and for maintaining a proper establishment of officers necessary for enforcing a due performance of quarantine: in pursuance of which, lands were purchased at Chetney Hill, in the county of Kent, and progress was made in the erection of a Lazaret there; but the funds granted by the said act of the thirtyninth and fortieth years of his present Majesty having been found insufficient for completing the same, and for the payment of competent salaries to the officers who were to have the charge thereof, and other necessary expenses attendant on the quarantine service, according to the plan which had been approved of and directed by his Majesty, by and with the advice of his privy council, a further sum was granted by an Act of the last session of Parliament: And whereas it is expedient that provision should be made for a due application of the same; be it therefore enacted, by the King's most excellent Majesty, by and with the advice and consent of the Lords, Spiritual and Temporal, and Commons, in this present parliament assembled, and by the authority

Treasury to of the same, That it shall and may be lawful for the Lords Comappoint officers, &c.

tions for com- missioners of his Majesty's Treasury, or any three or more of pleting the Lazaret, and them, or the Lord High Treasurer for the time being, from and after the commencement of this act, to give directions for completing the said Lazaret, upon the said lands so purchased on Chetney Hill, in the county of Kent, with all necessary and convenient accommodations for the purpose of performing quarantine, according to the plan which has been approved of and directed by his Majesty, by and with the advice of his privy council; or to such other plan as his Majesty, by and with the advice of his privy council, may from time to time approve and direct; and for defraying the expenses attending the same, to cause any part of the money so granted, to be issued when it shall be necessary for the said service; and the said Lazaret. when completed, and all the buildings and accommodations thereto belonging, shall be under the management, order, and direction of such officers as shall be appointed by the lords commissioners of his Majesty's treasury, or any three or more of them, or the lord high treasurer for the time being, for keeping the same fit and ready for the reception of persons and goods, and for their due performance of quarantine; and such officers respectively shall have such salaries as shall from time to time be appointed by his Majesty, by and with the advice of his privy council; and the salaries of the said officers, and all contingent expenses, shall be defrayed out of the funds, and in the manner in which the charges and expenses of performing quarantine are at present defrayed, until such time as a revenue shall be raised sufficient for those purposes, in the manner herein after mentioned.

Floating Laprovided un-til the Lazaret shall be completed.

II. Provided always, and be it enacted, That until the said Lazarets may be zaret shall be in a state fit and proper to be used, it shall and may be lawful for the lords commissioners of his Majesty's treasury to provide one or more floating Lazarets, which shall be used for all the purposes for which the said Lazaret is intended by this act; and all the rules, regulations, and provisions in this act contained, shall be deemed and taken for all intents and purposes, to be applicable to such floating Lazaret or Lazarets, until the Lazaret on shore shall, by his Majesty, his heirs or successors, by and with the advice of his or their privy council, and by order of the same, notified by proclamation or published in the London Gazette, have been declared to be fit for the due performance of quarantine therein.

III. And whereas it is reasonable that the owners of ships, Duties shall vessels, and cargoes, which in future shall have to perform quar-be paid by antine, should defray the charge incurred thereby; be it further vessels. enacted, That there shall be raised, levied, collected, and paid to his Majesty, his heirs and successors, the several and respective duties and customs herein-after mentioned; that is to say,

For every ton burthen of every ship or vessel, which ship or ves-puties. sel, or the cargo of which or any part whereof shall have performed quarantine in any port or place in Great Britain, or the islands of Guernsey, Jersey, Alderney, Sark, or Man, and which shall have arrived from any part of Turkey, or from any port or place in Africa, within the Streights of Gibraltar, or in the West Barbary on the Atlantic Ocean, with a clean Bill of Health, seven shillings and sixpence:

For every ton burthen of every such ship or vessel, which shall have so arrived without a clean Bill of Health, fifteen shillings. For every ton burthen of every such ship or vessel, which ship or vessel, or the cargo of which or any part whereof shall have performed quarantine in any port or place in Great Britain, or the islands aforesaid, and which shall have arrived from any port or place whatever, (except from any part of Turkey, or from any port or place in Africa, within the Streights of Gibraltar, or in the West Barbary on the Atlantic Ocean) with a clean Bill of Health, three shillings:

For every ton burthen of every such ship or vessel which shall have so arrived without a clean Bill of Health, ten shillings:

For every ton burthen of every such ship or vessel arriving in any port or place in Great Britain, or the Islands aforesaid, with a cargo which, in whole or in part, shall consist of goods, wares, or merchandise, the growth, produce, or manufacture of Turkey, or of any port or place in Africa, within the Streights of Gibraltar, or in the West Barbary on the Atlantic Ocean, and which ship or vessel, or the cargo of which or any part whereof shall have performed quarantine in any port or place in Great Britain, or the Islands aforesaid, and which shall have arrived from any port or place whatever, seven shillings and sixpence:

For every ton burthen of every ship or vessel which shall have so arrived under such circumstances as shall induce his Majesty, by and with the advice of his privy council, or the lords or others of the privy council, or any three or more of them, under the authority herein after given, to subject such ship or vessel to the like quarantine as ships arriving from Turkey with clean Bills of Health, seven shillings and sixpence:

For every ton burthen of every ship or vessel which shall have so arrived under such circumstances as shall induce his Majesty, by and with the advice aforesaid, or the lords or others of the privy council, or any three or more of them as aforesaid, to subject such ship or vessel to the like quarantine as ships arriving from Turkey without clean Bills of Health, fifteen shillings:

For every ton burthen of every ship or vessel, which ship or vessel, or the cargo of which, or of any part whereof, shall have performed quarantine in any port or place in Great Britain, or the Islands aforesaid, and which ship or vessel shall enter inwards in the port of London, an additional duty of one shilling.

Duties shall be recovered as duties of Customs.

Exemptions from duties.

All which several and respective duties shall be raised, levied, collected, and paid, and shall be sued for, recovered, and accounted for in the same manner, and subject to the same rules, regulations, penalties and forfeitures, as any duties of customs are now subject to by law, as far as the same are applicable thereto: Provided always, That no ship or vessel of war, or transport or other ship or vessel employed in the service of his Majesty's government, nor any ship or vessel which shall not be bound to any port or place in Great Britain, or the Islands of Guernsey, Jersey, Alderney, Sark, or Man, and which shall have really put into any port or place in Great Britain, or the Islands aforesaid, in distress; nor any ship or vessel which shall have been obliged to perform quarantine only by reason of having certain goods, wares, and merchandise on board, and not producing the proper declaration or document as to their growth, produce or manufacture; nor any ship or vessel arriving in any port or place in Great Britain, or the Islands aforesaid, with a clean Bill of Health from any port or place whatever, except from any part of Turkey, or from any port or place in Africa, within the Streights of Gibraltar, or in the West Barbary on the Atlantic Ocean, in ballast, or whose cargo shall consist wholly of salt; nor any ship or vessel which shall, together with its cargo, have duly performed quarantine in the Lazarets of Malta, Ancona, Venice, Messina, Leghorn, or one of them, and shall sail from thence, and arrive at any port or place in Great Britain, or the Islands aforesaid, with proper documents and vouchers attesting the same, to the satisfaction of his Majesty, his heirs or successors, or of his or their

privy council, shall be liable to or charged with any duty underthis act.

IV. Provided always, and be it further enacted, That if after puties may making good (in the manner herein-after mentioned) to the con- & afterwards solidated fund of Great Britain, of the sums of sixty-five thousand increased. pounds, granted by the act of the thirty-ninth and fortieth years of his present Majesty, and of thirty thousand pounds, granted by an act of the last session of Parliament, or of so much thereof as shall be found necessary to issue for the services aforesaid, it shall appear to the lord high treasurer, or the lords commissioners of his Majesty's treasury, for the time being, that the duties hereby granted are more than sufficient to defray the charges and expenses already incurred, and also such further expenses as may be necessary for carrying the several purposes of this act into execution, it shall and may be lawful for the said lord high treasurer, or lords commissioners for the time being, from time to time, by any warrant or warrants under the hands of the said lord high treasurer, or of the said lords commissioners for the time being, or of any three or more of the said lords commissioners, to order and direct, that the duties hereby granted shall be reduced in such proportion and manner as they shall think proper, and also by like warrant or warrants (in case the said necessary expenses should afterwards require an increase of the said duties) to order and direct that the same shall be again raised and increased to any amount not exceeding the sums which have been before granted by parliament as aforesaid; and such warrant or warrants shall be sufficient authority to the commissioners and officers of the customs for raising, levying, collecting and recovering, the several and respective duties specified and contained in such warrant or warrants; any law or usage to the contrary notwithstanding.

V. And be it further enacted, That no ship or vessel upon Ships not to which the tonnage duty by this act imposed shall be due and pay- to clear inable shall be permitted to be cleared inwards in any port of the duties are Great Britain, or the Islands of Guernsey, Jersey, Alderney, Sark, or Man, unless the said tonnage duty shall have been first duly paid to the proper officers of the customs appointed to receive the same, or the commissioners of the customs shall otherwise direct; and that the tonnage of every ship or vessel shall How the tonbe computed and taken, for the purpose of ascertaining the said nage shall be computed. duties according to the register thereof, under the provisions of an act, passed in the twenty-sixth year of his present Majesty's reign, intituled, An Act for the further Increase and Encourage-

ment of shipping and navigation; and in case of any dispute or doubt relative thereto, the same shall be ascertained by admeasurement, in the mode and manner prescribed in the said lastmentioned act.

Ship owners to recover duporters.

VI. And be it further enacted, That it shall and may be lawties of the im-ful for the owner or owners of any ship or vessel, in respect of which any of the duties imposed by this act shall have been paid, to demand and recover from the respective importers, proprietors, or consignees of any goods or mercandise brought or imported in any such ship or vessel, such sum or sums of money as shall be equal to the just and reasonable contribution which the proportion of tonnage that such goods and merchandise bear to the tonnage burthen of the ship shall require, and no more; such proportion of tonnage to be ascertained according to the usage of merchants in like cases.

Duties to be carried to consolidated fund of Great Britain.

VII. And be it further enacted, That the monies arising from the duties hereby granted shall be paid into the receipt of His Majesty's Exchequer, and carried to and made part of the consolidated fund of Great Britain; and that in the office of the Auditor of the Receipt of His Majesty's Exchequer there shall be provided and kept a book or books, in which all the monies arising from the said duties and paid into the said receipt shall be entered separate and apart from all other monies paid or payable to His majesty, his heirs or successors, upon any account whatsoever.

VIII. And be it further enacted, That the money so raised, Application VIII. And to at the desired and paid, shall be applied in the first place to defray the annual expenses of the said floating Lazaret, and land Lazaret, and all other annual expenses which shall be incurred in the execution of this act; and in the next place to make good any money that shall have been issued for purchasing the lands on Chetney Hill, and for the erecting of the said Lazaret, and for providing the necessary and convenient accommodations thereto belonging, in manner herein-before mentioned, and to no other purpose whatsoever.

IX. And whereas it is expedient that the said herein-before 39 & 40 G. 3. e. 80, etc. repealed, ex-recited act, passed in the thirty-ninth and fortieth years of the rears of duty, reign of his present Majesty, and every other act or acts heretofore passed concerning quarantine, together with such further provisions as are found to be necessary to be made in respect thereof, should be reduced into one act; be it therefore enacted, That the said act so passed in the thirty-ninth and fortieth vears of the reign of his said present Majesty, as aforesaid, be

repealed, and that every other act or acts heretofore passed, in so far as the same do or may be deemed or construed to relate to the performance of quarantine, shall be and the same are hereby repealed; save and except so much of the said act passed in the thirty-ninth and fortieth years of the reign of his present Majesty as relates to the repeal of former acts, and to the payment and recovering of any duties imposed by the said act, which shall be due and unpaid at the time of passing this act, and also save and except as to any offence or offences done or committed before the passing of this act, by any person or persons, against any law concerning quarantine; and as to any fine, penalty, forfeiture, or punishment, fines penalties, forfeitures, or punishments, to which any such person or persons may be liable by reason of the same; and also as to any action, suit, prosecution, or other proceeding brought or commenced, or which shall hereafter be brought or commenced, for or on account of any such offence or offences so done or committed as aforesaid.

X. And be it further enacted, That all ships and vessels, as What ships shall be liable well his Majesty's ships of war as all others, coming from or to quarantine. having touched at any place from whence his Majesty, his heirs or successors, by and with the advice of his or their privy council, shall have adjudged and declared it probable that the plague, or any other infectious disease or distemper, highly dangerous to the health of his Majesty's subjects, may be brought; and all ships, vessels, and boats receiving any person, goods, wares, and merchandise, packets, packages, baggage, wearing apparel, books, letters or any other articles whatever, from or out of any ships or vessels so coming from or having touched at such infected place as aforesaid, whether such persons, goods, wares, and merchandise, packets, packages, baggage, wearing apparel, books, letters, or other articles, shall have come or been brought in such ships or vessels, or such persons shall have gone, or articles have been put on board the same, either before or after the arrival of such ships or vessels at any port or place in Great Britain, or the Islands of Guernsey, Jersey, Alderney, Sark, or Man, and whether such ships or vessels were or were notbound to any port or place in Great Britain or the Islands aforesaid; and all persons, goods, wares, and merchandise, packets, packages, baggage, wearing apparel, books, letters, or any other articles whatever, on board of any such ships or vessels so coming from or having touched at such infected place as aforesaid, or on board of any such receiving ships, vessels, or boats as aforesaid, shall be and be considered to be liable to quarantine

within the meaning of this act, and of any order or orders which shall be made by his Majesty, his heirs or successors, by and with the advice of his or their privy council concerning quarantine, and the prevention of infection, from the time of the departure of such ships or vessels from such infected place as aforesaid, or from the time when such persons, goods, wares, merchandise, packets, packages, baggage, wearing apparel, books, letters, or other articles shall have been received on board respectively; and all such ships, vessels, and boats as aforesaid, and all persons, (as well Pilots as others,) goods, wares and merchandise, and other articles as aforesaid, whether coming or brought in such ships, vessels, or boats, from such infected place as aforesaid, or going, or being put on board the same, either before or after the arrival of such ships, vessels, or boats, at any port or place in Great Britain, or the Islands aforesaid; and all persons, goods, wares, and merchandise, and other articles as aforesaid on board any such receiving ship, vessel, or boat as aforesaid, shall, upon their arrival at any such port or place, be obliged to perform quarantine in such place or places, for such time and in such manner as shall from time to time be directed by his Majesty, his heirs or successors, by his or their order or orders in council, notified by proclamation, or published in the London Gazette; and that until such ships, vessels, and boats, persons, goods, wares, and merchandise, and other articles as aforesaid, shall have respectively performed and shall be duly discharged from such quarantine, no such person, goods, wares, or merchandise, or other articles as aforesaid, or any of them, shall either before or after the arrival of such ships, vessels, or boats, at any port or place in Great Britain, or the Islands aforesaid, come or be brought on shore, or go and be put on board any other ship, vessel, or boat, in order to come or be brought on shore, in any such port or place, although such ships or vessels so coming from such infected place as aforesaid may not be bound to any port or place in Great Britain, or the Islands aforesaid, unless in any such manner and in such cases, and by such license as shall be directed or permitted by such order or orders made by his Majesty, his heirs or successors, in council as aforesaid; and all such ships, vessels, and boats, whether coming from such infected place as aforesaid, or being otherwise liable to quarantine as aforesaid, and all persons, (as well Pilots as others,) goods, wares, and merchandise, and other articles as aforesaid, whether coming or brought in such ships, vessels, or boats, or going or being put on board the same, either before or after the arrival of

such ships, vessels, or boats, at any port or place in Great Britain, or the Islands aforesaid, and although such ships, vessels, or boats, shall not be bound to any port or place in Great Britain, or the Islands aforesaid; and all commanders, masters, or other persons having the charge or command of any such ships, vessels, or boats, whether coming from any infected place, or being otherwise liable to quarantine, as aforesaid, shall be subject to all the provisions, rules, regulations, and restrictions contained in this act, or in any order or orders which shall be made by his Majesty, his heirs and successors, in council as aforesaid, concerning quarantine and the prevention of infection, and to all the pains, penalties, forfeitures and punishments contained in this act, for any breach or disobedience thereof, or of any order or orders of his Majesty in council, made under the authority thereof.

XI. And whereas certain sorts of goods and merchandise are Goods specimore especially liable to retain infection, and may be brought der of counfrom places infected into other countries, and from thence im-shall be made ported into Great Britain, or the Islands aforesaid; be it enacted, subject to quarantine. That all such goods and merchandise as shall be particularly specified for that purpose in any order or orders made by his Majesty, his heirs or successors, in council, concerning quarantine and the prevention of infection as aforesaid, which shall be brought or imported into any port or place in Great Britain, or the Islands aforesaid, from any foreign country or place, in any ship or vessel whatever, and the ships or vessels in which the same shall be brought, and also all ships and vessels which shall arrive from any port or place whatever under any alarming or suspicious circumstances as to infection, shall be subject and liable to such regulations and restrictions as shall be made by such order or orders of his Majesty, his heirs or successors, in council as aforesaid, respecting the same.

XII. And be it further enacted, That it shall and may be law- The privy ful for the lords and others of his Majesty's privy council, or any make such three or more of them, to make such order as they shall see ne- shall think cessary and expedient upon any unforeseen emergency, or in any upon emerparticular case or cases with respect to any ship or ships, vessel gencies. or vessels, arriving and having any infectious disease or distemper on board, or on board of which any infectious disease or distemper may have appeared in the course of the voyage, or arriving under any other alarming or suspicious circumstances as to infection, although such ship or ships, vessel or vessels, shall not have come from any place or places from which his

Majesty, his heirs or successors, by and with the advice of his or their privy council, may have adjudged and declared it probable that the plague, or any such infectious disease or distemper may be brought, and also with respect to the persons, goods, wares, and merchandise, and other articles as aforesaid, on board the same, and in case of any infectious disease or distemper appearing or breaking out in Great Britain, or the Islands aforesaid, to make such orders, and give such directions, in order to cut off all communication between any persons infected with any such disease or distemper and the rest of his Majesty's subjects, as shall appear to the said lords or others of his Majesty's privy council, or any three or more of them, to be necessary and expedient for that purpose, and likewise to make such orders as they shall see fit for shortening the time of quarantine to be performed by particular ships or vessels, or particular persons, goods, wares, merchandise, or any other articles, or for wholly releasing particular ships or vessels, or particular persons, goods, wares, merchandise, or other articles from quarantine, absolutely or conditionally, and generally to mitigate the strict performance of quarantine in particular cases, as special circumstances shall appear, in their judgment, to require; and all such orders so made by the lords or others of the privy council, or any three or more of them as aforesaid, shall be as good, valid, and effectual, to all intents and purposes, (as well with respect to the commander, master, or other person having the charge of any such ship or vessel, and all other persons on board the same, as with respect to any other persons having any intercourse or communication with them, and to the penalties, forfeitures, and punishments, to which they may respectively become liable,) as any order or orders made by his Majesty, his heirs or successors, by and with the advice of his or their privy council concerning quarantine, and the prevention of infection as aforesaid, and notified by proclamation or published in the London Gazette.

Regulations which infecpear, within or without the Streights of Gibraltar, previous to the Lazaret at Chetney Hill being completed.

XIII. And be it further enacted, That if the plague, or such Regulations for vessels in other infectious disease or distemper as aforesaid, shall appear which infec-tions shall ap- on board any ship or vessel within the Streights of Gibraltar, the commander, master, or other person having charge thereof, shall immediately proceed to some one of the foreign Lazarets, and there perform quarantine, until such time as the land Lazaret, to be erected as aforesaid shall, by his Majesty, his heirs or successors, by and with the advice of his or their privy council, and by order of the same, notified by proclamation, or published in

the London Gazette, have been declared to be fit for the due performance of quarantine therein; but if such plague, or other such infectious disease or distemper as aforesaid, shall appear on board any ship or vessel without the Streights of Gibraltar, then the commander, master or other person having the charge or command thereof, shall (unless such land Lazaret shall have been so declared to be fit for the due performance of quarantine therein) immediately proceed to the harbour of Saint Helen's, Tean and North Withel, being two of the Islands commonly called The Islands of Scilly, or to such other place as his Majesty, his heirs or successors, by and with the advice of his or their privy council, shall from time to time direct and appoint: where being arrived he shall make known his case to some officer of the customs there, who shall immediately acquaint the Governor, deputy Governor, or other principal magistrate thereof, and also the principal officer of the customs at some port in England near thereunto; and the said principal officer of the customs at such near port in England shall with all possible speed send intelligence thereof to the commissioners of the customs in the port of London; and the said Governor, deputy Governor, or other principal magistrate shall, in like manner, with all possible speed, send intelligence thereof to the privy council, to the end that such measures may be taken for the comfort and support of the crew and passengers on board such ship so infected, and such precautions used to prevent the spreading of the infection, as the case shall require; and the said ship or vessel shall there remain until directions shall be given relative thereto by the lords or others of his Majesty's privy council, or any three or more of them; nor shall any of the crew or passengers on board thereof go on shore; but in case the said commander, master or other person having charge of the said ship or vessel so infected, shall not be able to make the said Islands of Scilly, or other place so appointed by his Majesty as aforesaid, or shall be forced by stress of weather or otherwise to go p either of the channels, it shall not be lawful for him to enter with such ship or vessel into any other port or place in Great Britain, or the Islands of Guernsey, Jersey, Alderney, Sark, or Man, but he shall remain in some open road till he receives directions relative thereto from the privy council, and he shall use every necessary means in his power to prevent any of the ship's company or passengers from going out of his ship, and to avoid all intercourse with other ships, vessels, or persons; and such ship's company or passengers shall, until such com-

mander, master, or other person shall have received such directions, remain in such ship, and shall avoid all intercourse with other ships, vessels, or persons; and such master, and every other person on board such ship or vessel shall obey such directions as he shall receive from the lords or others of his Majesty's privy council, or any three or more of them as aforesaid; and the said commander, master, or any other person on board such ship or vessel as aforesaid, who shall not act conformably to the provisions and regulations herein directed, or shall act in disobedience to such directions as shall be received on board such ship or vessel from the lords or others of the privy council, or any three or more of them as aforesaid, shall be adjudged guilty of felony, and shall suffer death as in cases of felony, without benefit of clergy.

Masters of ships to make signals on ships at sea, or being with-Guernsey, &c. on penal-ty of 200/.

And be it further enacted, That every commander, master, or other person having the charge of any ship or vessel meeting other liable to the performance of quarantine, shall be and is hereby required at all times when such ship or vessel shall meet with leagues of the United King. any other ship or vessel at sea, or shall be within four leagues United King. any other ship or vessel at sea, or shall be within four leagues of the coast of Great Britain or Ireland, or the Islands of Guernsey, Jersey, Alderney, Sark, or Man, to hoist a signal to denote that his ship or vessel is liable to the performance of quarantine, which signal shall be, in the day time, if the said ship or vessel shall have a clean bill of health, a large yellow flag of six breadths of bunting at the main-topmast head; and if such ship or vessel shall not have a clean bill of health, then a like yellow flag, with a circular mark or ball entirely black in the middle thereof, whose diameter shall be equal to two breadths of bunting; and in the night time the signal shall in both cases be a large signal lanthorn, with a light therein (such as is commonly used on board his Majesty's ships of war,) at the same masthead; and such commander, master, or other person, shall keep such signals respectively, as the case shall be, hoisted during such time as the said ship shall continue within sight of such other ship or vessel, or within four leagues of the said coasts or Islands, and while so in sight, or within such distance, until such ship or vessel so liable to quarantine as aforesaid shall have arrived at the port or place where it is to perform quarantine, and until it shall have been legally discharged from the performance thereof; on failure whereof such commander, master or other person having charge of such ship or vessel so liable to the performance of quarantine, shall forfeit and pay for every such offence the sum of two hundred pounds.

# ORDER IN COUNCIL.

### AT THE COURT AT THE QUEEN'S PALACE,

THE 5th DAY OF APRIL 1805.

### PRESENT,

THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

TATHEREAS by an act passed in the present session of parlialiament, intituled, An Act for making further provision for the Effectual Performance of Quarantine, it is amongst other things enacted, That, from and after the fifth day of April one thousand eight hundred and five, all ships and vessels, as well his Majesty's ships of war as all others, coming from or having touched at any place from whence his Majesty, his heirs or successors, by and with the advice of his or their privy council, shall have adjudged and declared it probable that the plague or any other infectious disease or distemper, highly dangerous to the health of his Majesty's subjects, may be brought, and all ships vessels and boats receiving any person, goods, wares and merchandise, packets, packages, baggage, wearing apparel, books, letters, or any other articles whatever from or out of any ships or vessels so coming from or having touched at such infected place as aforesaid, whether such persons, goods, wares and merchandise, packets, packages, wearing apparel, books, letters, or other articles, shall have come or been brought in such ships or vessels, or such persons shall have gone, or articles have been put on board the same, either before or after the arrival of such ships or vessels at any port or place in Great Britain, or the islands of Guernsey, Jersey, Alderney, Sark, or Man, and whether such ships or vessels were or were not bound to any port or place in Great Britain or the islands aforesaid; and that all persons, goods, wares and merchandise, packets, packages, baggage, wearing apparel, books, letters, or any articles whatever, on board any such ships or vessels so coming from or having touched at such infected place as aforesaid, or on board of any such receiving ships, vessels, or boats as aforesaid, shall be and be consi-

dered to be liable to quarantine within the meaning of the said act, and of any order or orders which shall be made by his Majesty, his heirs or successors, by and with the advice of his or their privy council concerning quarantine, and the prevention of infection, from the time of the departure of such ships or vessels from such infected place as aforesaid, or from the time when such persons, goods, wares, merchandise, packets, packages, baggage, wearing apparel, books, letters, or other articles shall have been received on board respectively; and that such ships, vessels, and boats as aforesaid, and all persons, (as well pilots as others,) goods, wares and merchandise, and other articles as aforesaid, whether coming or brought in such ships, vessels or boats, from such infected place as aforesaid, or going, or being put on board the same, either before or after the arrival of such ships, vessels or boats, at any port or place in Great Britain, or the islands aforesaid; and all persons, goods, wares and merchandise, and other articles as aforesaid, on board any such receiving ship, vessel, or boat as aforesaid, shall, upon their arrival at any such port or place, be obliged to perform quarantine in such place or places, for such time and in such manner as shall from time to time be directed by his Majesty, his heirs or successors, by his or their order or orders in council, notified by proclamation, or published in the London Gazette; and that until such ships, vessels, & boats, persons, goods, wares, and merchandise, and other articles as aforesaid, shall have respectively performed and shall be duly discharged from such quarantine, no such person, goods, wares or merchandise, or other articles as aforesaid, or any of them, shall, either before or after the arrival of such ships, vessels, or boats, at any port or place in Great Britain, or the islands aforesaid, come or be brought on shore, or go or be put on board any other ship, vessel, or boat, in order to come or be brought on shore, in any such port or place, although such ships or vessels so coming from such infected place as aforesaid may not be bound to any port or place in Great Britain, or the islands aforesaid, unless in such manner and in such cases, and by such license as shall be directed or permitted by such order or orders made by his Majesty, his heirs or successors, in council as aforesaid; and that all such ships, vessels, and boats, whether coming from such infected place as aforesaid, or being otherwise liable to quarantine as aforesaid, and all persons, (as well pilots as others,) goods, wares, and merchandise, and other articles as aforesaid, whether coming or brought in such ships, vessels, or boats, or going or being put on board the same, either before or after

the arrival of such ships, vessels, or boats, at any port or place in Great Britain, or the islands aforesaid, and although such ships, vessels, or boats, shall not be bound to any port or place in Great Britain, or the islands aforesaid; and that all commanders, masters, or other persons having the charge or command of any such ships, vessels, or boats, whether coming from any infected place, or being otherwise liable to quarantine, as aforesaid, shall be subject to all the provisions, rules, regulations, and restrictions contained in the said act, or in any order or orders which shall be made by his Majesty, his heirs and successors, in council as aforesaid, concerning quarantine and the prevention of infection, and to all the pains, penalties, forfeitures, and punishments contained in the said act, for any breach or disobedience thereof, or of any order or orders of his Majesty in council, made under the authority thereof.

And it is likewise enacted by the said act, That whereas certain sorts of goods and merchandise are more especially liable to retain infection, and may be brought from places infected into other countries and from thence imported into Great Britain, or the islands aforesaid, all such goods and merchandise as shall be particularly specified for that purpose in any order or orders made by his Majesty, his Heirs or Successors, in council, concerning quarantine and the prevention of infection as aforesaid, which shall be brought or imported into any port or place in Great Britain, or the islands aforesaid, from any foreign country or place, in any ship or vessel whatever, and the ships or vessels in which the same shall be brought, shall be subject and liable to such regulations and restrictions as shall be made by such order or orders of his Majesty, his Heirs or Successors, in council as aforesaid, respecting the same.

port or place in Europe without the Streights, or on the continent of America, at which there is not a regular establishment for the performance of Quarantine, which shall have been declared sufficient for that purpose by any order of his Majesty in council, notified by proclamation, or published in the London Gazette: and his Majesty is therefore pleased, by and with the advice of his privy council, to order, and it is hereby ordered,

What quaships, &c. coming from such places with clean and by ships all persons who shall have any intercourse or communication therewith.

I. That all ships and vessels, as well his Majesty's ships of war rantine to be performed by as all others, not having the plague or such other infectious disease or distemper as aforesaid, actually on board, coming from or through the Mediterranean, or from the West Barbary on the bills of health, and all ships, vessels and receiving any boats, receiving any person or persons, goods, wares, or merchanperson, goods, boats, receiving any porton person, goods, boats, receiving any person, goods, any other articles whatever, from or out of any such ship or vessel before such ship or vessel shall have performed, and shall be duly discharged from quarantine, whether such person or persons. goods, wares, or merchandise, or other articles as aforesaid, shall have come, or been brought in such shipor vessel, or such person or persons shall have gone, or articles have been put on board the same, either before or after the arrival of such ship or vessel, and whether such ship or vessel was or was not bound to any port or place in Great Britain, or the Islands aforesaid, shall, together with all persons, (as well pilots as others), goods, wares, and merchandise, and other articles as aforesaid on board thereof perform such quarantine, for such time, in such manner, and at such places as are herein-after directed : And all commanders masters, and other persons on board any such ship, vessel, or boat, so liable to quarantine as aforesaid; and all persons who shall have any intercourse or communication with them, or any of them, shall forthwith repair to such Lazaret, ship, vessel, or place, as is herein appointed, or shall hereafter be appointed in that behalf, by any order of his Majesty in council as aforesaid, or of the Lords and others of the privy council, or any three or more of them, for the performance of quarantine; and shall there perform quarantine accordingly, under and subject to all the pains penalties, fines, forfeitures, and punishments, as well pains of death as others, to which any such commander, master, or person, is or may be by law subject for any refusal or neglect to repair to such lazaret, ship, vessel, or place, as aforesaid, or for any escape, or attempt to escape therefrom, or for any other breach or disobedience of the provisions, rules, and regulations of the said herein-before recited act, or of this order, or of any orders which may hereafter be made as aforesaid.

II. And it is hereby further ordered, That all such ships and At what play vessels so coming from or through the Mediterranean, or from &c. are to the West Barbary on the Atlantic Ocean, as shall arrive with rantine. clean bills of health as aforesaid, and all such receiving ships, vessels, and boats as aforesaid, and all persons, goods, wares, and merchandise, and other articles on board the same, shall respectively perform quarantine in the places herein-after appointed, except in the cases herein-after otherwise provided for, that is to say:

All such ships or vessels, so arriving as last aforesaid, as are or shall be bound to the ports of London, Rochester, Feversham, and any creeks or places belonging to, or within any or either of the above ports, shall perform quarantine in Standgate creek.

Such of them as are or shall be bound to the ports of Leigh, Malden, Colchester, Harwich, Ipswich, Woodbridge, Aldborough, Southwold, Yarmouth, Blackney and Clay, Wells, Lynn, Wisbech, Boston, Grimsby, Hull, Bridlington, Scarborough, Whitby, Stockton, Sunderland, Newcastle, Berwick, and any creeks or places belonging to, or within any or either of the above ports, shall perform quarantine in Whitebooth Roads, between Hull and Grimsby.

Such of them as are or shall be bound to the ports of Carlisle, Whitehaven, Lancaster, Preston, Liverpool, Chester, Beaumaris, Isle of Man, and any creeks or places belonging to, or within any or either of the above ports, shall perform quarantine in Highlake, near Liverpool, at the west end of Highlake, or in Milford Haven.

Such of them as are or shall be bound to the ports of Sandwich, Deal, Dover, Rye, Newhaven, Shoreham, Arundel, Chichester, Portsmouth, Southampton, Cowes, and any creeks or places belonging to, or within any or either of the above ports, shall perform quarantine at the Motherbank, near Portsmouth.

Such of them as are or shall be bound to the ports of Poole, Weymouth, Lyme, Exeter, Dartmouth, Plymouth, Looe, Fowey, Falmouth, Gweek, Penryn, Truro, Penzance, Scilly, and any creeks or places belonging to, or within any or either of the above ports, shall perform quarantine at St. Ives Pool, within the mouth of the harbour of Falmouth.

Such of them as are or shall be bound to the ports of Bridgewater, Minehead, Bristol, Gloucester, Chepstow, Cardiff, Swansea, and any creeks or places belonging to, or within any or either of the above ports, shall perform quarantine at King Road and Portshute Pill.

Such of them as are or shall be bound to the ports of St. Ives, Padstow, Bideford, Barnstaple, Ilfracombe, Llanelly, Pembroke, Milford, Cardigan, Aberystwith, or any creeks, or places belonging to, or within any or either of the above ports, shall perform quarantine at Milford Haven aforesaid.

Such of them as are or shall be bound to the islands of Jersey, Guernsey, Sark, or Alderney, or either of them, or any part of them, or either of them, shall perform quarantine, either at the Motherbank, near Portsmouth aforesaid, or at St. Ives Pool, within the mouth of the harbour of Falmouth aforesaid; being places herein-before appointed for performance of quarantine.

Such of them as are or shall be bound to the eastern coast of Scotland, comprehending the ports of Leith, Borrowstoness, Alloa, Dunbar, Kirkaldy, Anstruther, Prestonpans, Dundee, Perth, Montrose, and Aberdeen, or to any member, creek, or other place belonging to, or within any or either of the above ports, shall perform quarantine in Inverkeithing Bay.

Such of them as are or shall be bound to the western ports of Scotland, comprehending the ports of Port Glasgow, Greenock, Irvine, Campbeltoun, Oban, Rothsay, Fort William, Ayr, Port Patrick, Stranraer, and Wigtoun, or to any member, creek, or other place belonging to, or within any or either of the above ports. shall perform quarantine at Holy Loch in the Firth of Clyde.

Such of them as are or shall be bound to the northern ports of Scotland, comprehending the ports of Inverness, Zetland, Orkney, Caithness, and Stornaway, or to any member, creek, or other place belonging to, or within any or either of the above ports, shall perform quarantine in Cromarty Bay, in the Murray Firth.

Such of them as are or shall be bound to the south west ports of Scotland, comprehending the ports of Dumfries, and Kirkcudbright, or to any member, creek, or other place belonging to, or within either of the above ports, shall perform quarantine at Carlsthorn, at the mouth of the river Nith.

And lastly-Such of them as are or shall be bound to any place on the coasts of England or Scotland, not within any of the ports or limits herein-before mentioned or described, shall perform quarantine at such place herein-before appointed for performance of quarantine, as shall be nearest to the port or place to which such ships or vessels respectively shall be so bound.

III. And it is hereby further ordered, That all goods, wares, in such ships and merchandises imported in any such ships or vessels as aforesaid, shall be opened and aired at the several places herein before

And it is hereby further ordered, That all merchant ships At what plaand vessels, and all other ships and vessels not having the plague coming withor such other infectious disease or distemper as aforesaid actu-of health are ally on board, (except any ship of war, transport, or other ship quarantine. in the actual service of government, under the command of a commissioned officer of his Majesty's navy,) coming from or through the Mediterranean, or from the West Barbary on the Atlantic ocean, which shall not be furnished with clean bills of health, shall perform quarantine in Standgate creek, and no where else: And in case any such merchant or other ship or vessel as aforesaid, coming from any of the places before described, and not furnished with a clean bill of health, shall come or attempt to enter into any of the out ports of Great Britain, or any of the islands aforesaid, the principal and other officers of the customs at such port, or in such islands, or the governor or chief magistrate thereof, shall cause such ship or vessel to depart from thence immediately, and proceed to Standgate creek to perform quarantine; and all ships of war, transports, and other ships in the actual service of government, under the command of commissioned officers of his Majesty's navy, coming from any of the said places, and not being furnished with clean bills of health, shall perform quarantine at the Motherbank, in a separate and distinct place, to be appointed and marked out with yellow buoys for that purpose, in the centre of which place a floating lazaret, moored with chains, shall be stationed, with a yellow flag constantly flying at the mast head; and all ships, vessels, and boats receiving any person, goods, wares, or merchandise, packets, packages, baggage, wearing apparel, books, letters, or any other articles whatever, from or out of any ships or vessels so coming from any of the said places without clean bills of health as aforesaid, shall perform the like quarantine at Standgate Creek or at the Motherbank respectively, in the same manner as if such receiving ships, vessels, or boats, had come from any of the said places without clean bills of health.

V. the satisfaction of the superintendant of quarantine or his assistant, or of the principal or other officer of the customs authorized to act in that behalf;) and that the commanders and masters of all such ships and vessels, by whom and with respect to which such satisfactory proof shall have been made as aforesaid, shall be examined by such superintendant or his assistant, or the principal or other officer of the customs, and shall give true answers upon oath to the preliminary quarantine questions herein after directed to be put to the commanders and masters of all ships and vessels liable to perform quarantine, and shall likewise strictly conform, in all respects, to all such directions as they shall receive from such superintendant or his assistant, or the principal or other officer of the customs as aforesaid, as well with respect to their stay or continuance at such port, and their departure from thence, and repairing to any other port or place for that purpose, as also with respect to all other orders, regulations and restrictions touching or concerning quarantine, and in default of making such satisfactory proof, or giving true answers to such questions, or of obeying and complying with such directions, orders, regulations, and restrictions as aforesaid, the said commanders, masters, or other persons having the charge of such ships or vessels shall be compelled forthwith to proceed to sea with such ships and vessels; and the said superintendant or his assistant, or the principal or other officer of the customs shall use all necessary means for that purpose, calling to his aid the commanders or other officers of any of his Majesty's ships of war, if their assistance shall appear to be necessary.

VIII. All bales of raw silk, silk stracee (or refuse,) and silk thrown, shall be opened on one side from end to end, the cords loosened, and way made, by removing a number of skins, for the porters to handle the interior of the bales; and at the expiration of twenty days, that side of the bale which has been opened being reserved, the other side shall be ripped open, and the contents handled and aired in the like manner till the thirty-fifth day, when the bales shall be put in order for delivery.

All packages of cotton, of yarn, of thread, of silk stuffs, of cotton stuffs, or burdetts, of camblets, and of linen, shall be opened, and the piece goods piled in rows, lattice-fashion, or in pyramids, turned every four days, and completely spread out and suspended on cords for several days.

Cases of paper, books, parchment, cases of sponges, and silk and thread stockings, shall be entirely unpacked, and the smaller parcels separated from each other, and so disposed as to admit of thorough airing.

Feathers, straw hats, artificial flowers, coral beads in string, brushes, shall be spread out in the same manner.

Carpets, furs, hides and skins, shall be unbailed, and each piece shall be spread and suspended on cords, sometimes in the open air, and frequently turned.

All goods packed in or with straw, cotton, or any other article enumerated in the said first class, or considered as susceptible, shall be entirely taken out of, or separated from the same, and carefully aired.

All goods enumerated in the said first class, concerning the expurgation of which no particular directions have been hereinbefore given, shall be unpacked, opened, aired, and handled in like manner, so far as may be, as is herein-before directed with regard to goods of a similar description.

XXXV. And it is hereby further ordered, That of the goods, wares, and merchandises which shall be imported in any ship or vessel arriving as above mentioned, and not furnished with clean bills of health, the articles herein-after enumerated in class the second shall in like manner be carried to a floating lazaret, or to the lazaret at Chetney Hill, there to be unpacked, opened, or treated according to the nature thereof, and aired for the space of thirty days; viz.

the port where any such goods were originally taken on board, or copies thereof attested by a notary public; and if the ship or vessel having on board such goods, wares, and merchandises, shall be other than that in which they were imported into any port or place in Europe without the Streights, or on the continent of America, at which there is not a regular establishment for the performance of quarantine, declared sufficient by his Majesty in council as aforesaid, the master, or other person having the charge of such ship or vessel, is hereby required to bring with him a declaration made and attested in like manner as the declaration before-mentioned, in which it shall be stated whether the said enumerated goods, wares, and merchandises were imported into the ports of the countries last mentioned in a ship or vessel with or without a clean bill of health; and such master or other person having the charge of any such ship or vessel, if the same shall be bound to the port of London, or to the river of Thames or Medway, shall forthwith produce such declaration or declarations (as the case may be,) to the superintendant of quarantine or his assistant at Standgate Creek; or if the same shall be bound to any of the out-ports or islands aforesaid, to the superintendant of quarantine or his assistant, or to the principal or other officer of the customs authorized to act in that behalf at such out-port or place; and if it shall appear that none of the said enumerated goods, wares, or merchandises on board such ship or vessel, are of the growth, produce, or manufacture of Turkey, or of any place in Africa within the Streights of Gibraltar, or in the West Barbary on the Atlantic Ocean, such ship or vessel importing the same shall not be obliged to perform quarantine, but shall, on production of such declaration to the superintendant or his assistant, or to the principal or other officer of the customs as aforesaid, be admitted to an entry in the usual and legal manner, but if it shall appear that such enumerated goods, wares, or merchandises, or any part thereof, are of the growth, produce, or manufacture of any of the countries last mentioned, or if no such declaration shall be produced by the master, or other person having the charge of such ship or vessel as aforesaid, then the superintendant of quarantine, or his assistant, or the principal or other officer of the customs authorized to act in that behalf as aforesaid, at the port or place at which such ship or vessel shall arrive, as the case may be, shall take care that every such ship or vessel as well as the officers, crew, passengers, and the entire cargo on board the same, shall perform quarantine, according to the nature of the case, at such and the same places as

are herein-before appointed for the performance of quarantine, for the same time, and in the same manner, as ships and vessels, their officers, crews, passengers and cargoes coming from or through the Mediterranean, or from the West Barbary on the Atlantic ocean, with clean bills of health, are herein-before respectively required to perform quarantine.

XLIII. And it is hereby further ordered, That all ships and vessels arriving in the ports of Great Britain, or the islands of rantine in the Guernsey, Jersey, Alderney, Sark, or Man, having come from or through the Mediterranean, or from the West Barbary on the Atlantic ocean, which, with their officers, crews, passengers and cargoes, shall have previously performed quarantine in the lazaret of Malta, Ancona, Venice, Messina, Leghorn, Genoa, or Marseilles, shall, upon their arrival, be put under quarantine in some of the ports or places herein-before appointed for the performance of quarantine, until the commander, master, or other person having the charge of such ship or vessel, shall have produced to the superintendant of quarantine, or his assistant, or to the principal or other officer of the customs authorized to act in that behalf, the proper documents to prove that such ship or vessel, and the officers, crew, passengers, and cargo on board the same have duly performed quarantine in one of the lazarets last mentioned; and upon so producing such documents the said ship or vessel shall not be obliged to perform quarantine, but shall be forthwith admitted to report; and all goods, wares, and merchandises on board thereof, not herein-before enumerated in the first class before stated, shall be admitted to an entry; but all goods, wares, and merchandises on board any such ship and vessel, which are enumerated in the first class before stated, shall, in such case, perform a further quarantine of fifteen days, at some one of the ports or places herein-before appointed for that purpose, in such manner as has been heretofore practised.
