PORTRAIT OF DR. STEWART.



It must be observed that the following Tables are calculated for those that are hard to operate upon; therefore the patient must begin at a number which he finds will best suit. Indeed some will not be able to take more than half the number; for instance, in Table No. 1, many will have to begin at 16, 14, or even 12, etc. etc. and reduce to 3 of No. 1, one night, and 3 of No. 2, the next. Should the patient be very hard to operate they ought to begin at 20 or 25.

### No. 1.

For Costive and Bilious Habits, the following are my directions :  
Take

18	of	No. 1	the 1st night,
5	of	No. 2	2d do.
16	of	No. 1	3d do.
6	of	No. 2	4th do.
14	of	No. 1	5th do.
7	of	No. 2	6th do.
12	of	No. 1	7th do.

10	of	No. 2	12th do.

Then take eight of No. 1, one night, and eight of No. 2, the next; so continue increasing or decreasing, as the patient may think it necessary, for the space of three weeks more or less; when he may gradually decrease to one. Price \$1 a Box.

### No. 2.

For Dyspepsia, Jaundice, and Liver Complaint, my practice is, begin with

Then take eight of No. 2 one night, and eight of No. 1 the next, for the next three weeks; when the patient may decrease at pleasure. As the Liver Complaint, with a difficulty in laying on the left side, is generally hard to subdue, I therefore advise the patient to continue the No. 2, in small doses, after the three weeks, until all symptoms are removed. ## No. 3.

With severe cases of Rheumatism or Gout, my practice has been (and with success,) the following:—Take

Then take eight of No. 1 one night, and six of No. 5 the second ; so continue for the next three weeks. Should the above fail to give relief, (which sometimes has taken place,) recourse must be had to my Rheumatic or Gout Drops, which, in no instance, when duly persisted in, have failed. The dose is, begin with twelve in the forenoon and twelve in the afternoon, (dropped on a little loaf sugar or sweetened water,) increasing one or two drops each dose until they produce a little nausea at the stomach, or slight purgative ; then lessen one or two drops, and persist in that until the effects are produced. For Consumption in its first, second, and third stages. First stage, my practice has been to begin with\*



Then take eight of No. 2 the first night, and five of No. 4 the second, for the next twelve days, when the patient may reduce, if necessary, to six of No. 2, one night, and three of No. 4 the next, or less. Price \$1 per Box. Sometimes this direful complaint is removed very quickly ; at others, it is very tedious and difficult ;

therefore the patient must persevere with the medicine, until it produces the effect. If the cough and tightness of the breast are troublesome, I recommend to the patient my Pulmonary Cough Mixture, taken as per directions, mixt with flax seed tea, a paper-spoonful to half a cup, and about two table-spoonsful with the tea through the day. Then food ought to be light, consisting of shell fish, such as oysters or clams. Price \$1 per Bottle.

N. B. When it is found that the above medicine does not produce the desired effect, it may be reasonably supposed the lungs are affected. When that is the case, my practice has been, for some time past, to cause the patient to inhale a peculiar vapor, combined with a certain gas, which may be used in his bed room, two or three times per day. With this I have produced wonderful effects, where the patient had been given over by all, and was not expected to live but a few hours; all of which can be attested by those who have been restored to health; also, by those who are now under its operation.  This Gas, with the directions, is prepared and sold by myself only.

### No. 5.

For Asthma, &c. &c. To persons of a robust constitution, I recommend beginning with

12 of No. 6, the first night, and 12 of No. 1, the next, and my Asthmatic Mixture as per directions on Bottle. Then I recommend the patient to take the Asthmatic Pill, No. 6, as per directions, and persist in them until he is relieved. Should the body become costive, while taking these Pills, I recommend a dose or two of No. 1 and No. 3, as directed. Price 1\$ per Box.

Patients who have been subject to this complaint, will do well to take, occasionally, my Asthmatic Mixture, as a preventive.

### No. 6.

For Scrofula, Erysipelas, Salt Rheum, Leprosy, Ulcers, Abscesses, and all cutaneous humors, whether internal or external, my practice is, to begin with strong purgative and aperient. I gener-



ally begin with No. 1 and No. 2, alternately. If the patient be hard to purge, take

Then take six of No. 2 one night, and six of No. 1 the next, alternately, for three weeks, if the occasion requires. Price \$1 per Box. This is to prepare the system for No. 8, formerly given under the name of 100. This Pill, when duly persisted in, according to directions, has never failed to produce the effect, in the most desperate case, even when the patient had become a complete nuisance to himself. The only restrictions are, the patient, while taking the Pills, should be moderate in both eating and drinking; likewise, be as careful as possible of catching cold; which is a rule every one ought to observe, even while in perfect health. They may be given with safety to both old and young, and at all times. My practice is to begin with three at night, and two at eleven o'clock, A. M., the first week; then take four at night, and three at eleven o'clock, A. M., the second week; and continue at that, until he feels a little griping in the bowels, when he may decrease one Pill at night, and persevere in that, till the effects are produced; which may take a longer or shorter time, according to the nature of the disease. The only thing necessary for patients having Ulcers or Abscesses is, to dress them daily with a mild ointment, to keep the air from them, and to absorb the matter which may be discharged from them.

N. B. It will likewise be necessary to state, that my No. 7, and No. 7 A, are seldom given, except in cases of Venereal, as per directions.

Then take 8 of No. 3 one night, and 8 of No. 1 the next, and so continue, increasing or decreasing as the patient may find it necessary, for at least seven weeks.

Many persons have wondered why I give the pills in such large doses. The reason is very obvious, for in most cases it is necessary to remove the morbid, or opposing matter, thoroughly from the stomach and bowels, and to keep it off by increasing the one kind of pill and decreasing the other, till such time as nature begins to act for herself. And 2nd, as my pills contain from four to five different ingredients, by leaving out any one and substituting a stronger purgative in its place, their virtue would be completely lost; or were I to make them double the size they now are, they would not suit every patient, as they would be too long in dissolving in the stomach.

### 1. *Strong Cathartic or Purgative Pills.*

They are necessary in almost every complaint, and are perfectly safe in all conditions of ill-health, when it is necessary to clear the primæ viæ, or stomach and bowels of their superfluous matter, and to prepare the patient for the use of the other Pills, as recommended for his complaint. They are a certain and immediate remedy for the Teneia or Worms, and all sudden attacks of Bilious and Colic complaints. The dose for children under eight years, is from four to eight pills every evening; for adults, double the quantity. In obstinate cases, increase the dose. These Pills do not interfere with the ordinary occupations of the patient. For Worms, for children under six years, pulverize six, and take them in the morning, fasting, in sugar, mucilage, jelly or molasses. If they are the small Pin Worms, the patient must take a dose of Castor Oil, half an hour previous to taking the pills every other day, until they are completely expelled. Price \$1 per Box.

Almost without exception, these Pills are pleasant in operation. The time or number required should not discourage the patient. Nor should he be alarmed if new symptoms or some unpleasant effects are observed. Experience teaches that the case should be in some way made worse before it can be better.

### 2. *Mild Cathartic and Aperient Pills.*

These Pills are recommended, in most cases, after a few doses of the No. 1. They are a certain remedy for Indigestion, Dyspepsia, Jaundice, Liver Complaint, and all Bilious Affections, Loss of Appetite, Headache and Piles. The dose of these Pills is from five to ten every evening, as occasion may require; for it is not necessary to procure more than three stools per day, unless the patient is liable to be costive; in such cases, I recommend a dose or two per week of No. 1, as above. They require no slops or drink to be



taken with them, and no more care while under them, than is necessary in health. Price \$1 per Box.

Free use of nourishing and fresh food is desirable while taking any of my Vegetable Pills. Avoid salt meats and fish; but salt may be taken as usual in health. Avoid spiritous liquors and wine. Coffee is preferable to tea or shells. An infusion of Stewart's Powders is very useful and agreeable, and very cooling when fever is present, or thirst great. In general, patients complain that the Pills take away their appetite for a few days; but it soon returns, and increases daily.

No family ought to be without No. 1 and No. 2, as they may be given with perfect safety at all times of the day or night.

### 3. *Mild Aperient, Deobstruent or Female Pills.*

These are recommended in almost all complaints to which females are subject; such as obstructions of customary evacuations, and all Nervous Affections, Sick Headache, Pains and Palpitation of the Heart and Breast, Weakness, Debility, Dyspepsia, Flatulency, Costiveness, Inflammations, Stranguary, and, indeed, all complaints incident to the female frame. They are perfectly harmless, and may be taken in all cases and in all stages. They will neither hinder business or amusement; and will, if persisted in, prevent and carry off numerous complaints, which are daily sending many of the fairest and worthiest of creation to an untimely grave. The dose is from four to ten every night.

They generally produce all the effect for which they were intended; but as there are some patients which they do not altogether agree with, I recommend to such, occasionally, a dose of No. 2, as they are a mild and cooling laxative; and to all patients, whether male or female, who are subject to the Hemorrhoids or Piles, Fistulas, or other diseases of the anus, such patients, by persisting in No. 2, in doses sufficient to produce two or three stools per day, and by using Stewart's Pile Ointment,\* will very soon find relief from this distressing complaint—which many hundreds, who have tried it, can at this moment attest. Price \$1 per Box.

In seasons and places where that fatal disease, the Malignant Cholera, spreads terror, dismay and death, no one, who, with a well grounded trust in God, will resolutely observe a few simple rules, need be alarmed, viz: Avoid ardent spirits and fermented liquors, unripe fruit, all vegetation that has not come to, or is past a state of perfection, damp night air; and keep the body moderately open by means of No. 1 or 2 Pills, as the habits of the body require. For, as the Malignant Cholera "has been thought to reside in the absence of biliary secretions and excretions," by attending to the above rules, it may be prevented. It is obvious that, when the body is allowed to be costive, the blood, juices of the body, and the whole viscera is affected and predisposed to every prevailing disease. Every one, as he values health, should observe these rules. The foregoing remarks may be applied to the Fever and Ague, and other Epidemics.

These Pills are designed for Consumptive complaints in all their different stages, and may be taken with perfect safety; they act altogether as an alterative. The Pills are pure vegetable, and act very powerfully on the system, without producing any dangerous or disagreeable effects. In consumption alone, the dose is, begin with three at night, and increase one every night, begin with No. 2 and take alternate doses. If accompanied with other diseases, as Herpes, Exedens, and Phagadænic Ulcers or Erysipelas, Scrofula and Callous Eating Ulcers, see Table No. 6. Price \$1 per Box.

In a great many cases of Rheumatism, Gout, Swellings, Pains and Ulcerations, violent Headache from flow of blood, and diseases of the Eyes, recourse must be had to surgery, such as dry and wet cupping, scarifying by artificial leeches, and there is often occasion to draw off matter from Ulcers, Abscesses, and long seated Chronic diseases, which, along with the Pills as directed, assist in performing the cure. All of which operations are performed by A. STEWART.

#### 5. *Rheumatic Pills.*

These operate by stool, urine, perspiration, and as a general alterative. Rheumatism is often accompanied with pains in various parts of the body, and other diseases, such as Scrofula, Scurvy, White Swelling, Gout, Syphilis. It is impossible to lay down positive rules for the patient. Where nothing is supposed to be present but Gout and Rheumatism, they are an infallible remedy, by taking them in doses of from five to twelve every evening. Should the patient be costive, I advise a dose, two or three times a week, of Pill No. 1. Should the Pills in the course of two or three weeks fail to produce any beneficial effect, there will be reason to suspect some other disease lurking in the system. See Directions. Price \$1 a box.

#### 6. *Asthmatic Pills.*

An infallible remedy for Coughs, Colds, Catarrh, Shortness of Breath, with a wheezing noise in the throat, &c., Whooping Cough, Asthma, and Dropsical complaints; they are expectorant and slightly purgative. To produce a beneficial effect they must be taken in doses, beginning with three, night and morning; also, eleven o'clock in the forenoon and four o'clock in the afternoon. ¶ Let an additional Pill be taken every night only till they produce a slight nausea, or degree of sickness, and cause a plentiful expectoration, which to a certainty they will do in a very short time, when the patient may decrease, as occasion may require. It is sometimes necessary, in costive habits, to accompany these with No. 1. See Directions. Price \$1 per Box.



*Dropsical Complaints, with Swelling of the Limbs.* When the patient is young and vigorous, there is very little trouble in performing a cure; but in old age, and when it has been long seated, it is very difficult to remove, and sometimes impossible; but generally I have been very successful. My practice with patients of middle age, and of costive habits, (which is most always the case,) is, to begin with twenty of No. 1, the first night, and reduce one pill every night, for ten or twelve days; then change to No. 2—thus proceed as the patient may think it proper. To females, who are not hard to operate upon, I recommend No. 3, instead of No. 1. The patient must avoid all slops, and drink of any kind, as much as possible. Price \$1 per Box.

Should the swelling of the limbs not give way to this medicine, while taking it, then recourse must be had to my Cupping and Scarificator, to draw away the superfluous matter there stagnated.

N. B. By this practice, I have been able to reduce very large swellings, where the patients were confined to the chair, and could not be moved without assistance; and, in the course of a few weeks, they have been able to attend to their business. For proof of this, many can be referred to, who have been relieved.

### 7. *Syphilis or Anti-Venereal, Chemical Pills.*

All my Pills, with the exception of these, are compounded from the vegetable kingdom alone; but as there are a great many complicated diseases, frequently accompanying Rheumatism, Scrofula, Gout, Pains in the Head and Joints, which are generally worse when the patient is in bed, such of these as do not give way to some of the foregoing Vegetable Pills, (as there may be some remains of Viris, in its confirmed state, lurking in the system, or, in other words, mingled with the juices of the body, whether from a hereditary taint, or by some imprudences in youth, and, as it is well known, or ought to be known, that there is but one certain cure for this complaint, whatever pretenders and quacks may tell you—thousands are annually carried off by this direful disease;) to such patients, I recommend beginning with two pills, night and morning, till their effects are perceived, which will be in the course of a few weeks. These Pills combine the Alterative, and what is commonly known as the Lisbon Diet Drink. See Directions. Price \$1,50 per Box.

*No. 7, A. Pills.* The dose is—begin with four at night and three in the morning, until the gums are slightly affected. This must be kept up by regulating the number of pills, until the disease is subdued; or, as my grandfather, Dr. Buchan, of Edinburgh, used to tell his patients, to run a *quarantine* of forty days, to insure them against a relapse. N. B. If a mild case, No. 7, A, will be sufficient; if a more severe case, No. 7 must be used. These Pills must be duly persisted in, to produce the effect, viz. soreness of the gums. While

under the operation of these Pills, the patients will find it to their advantage to use the Sarsaparilla for drink, combined with Guaiacum, and Mezereon root.

### *Pill No. 8.*

This Pill, formerly given by me as No. 100, is seldom given until the patient has gone through a course of the purgative, perhaps for twelve or fourteen days, according to the nature of his complaint. In all cases of Scrofulous Humors, Abscesses, Tumors, Ulcers, Salt Rheum, Erysipelas, St. Anthony's Fire, diseases of the Periosteum and Bone, Hip Complaint, Rheumatic White Swellings of the Joints, and, in fact, all diseases accompanied by humors. Price \$1.50 per Box.

N. B. These Pills, when duly persisted in, have never failed, in my practice, of producing the desired effect. The directions for the above pill will be found under table No. 6.

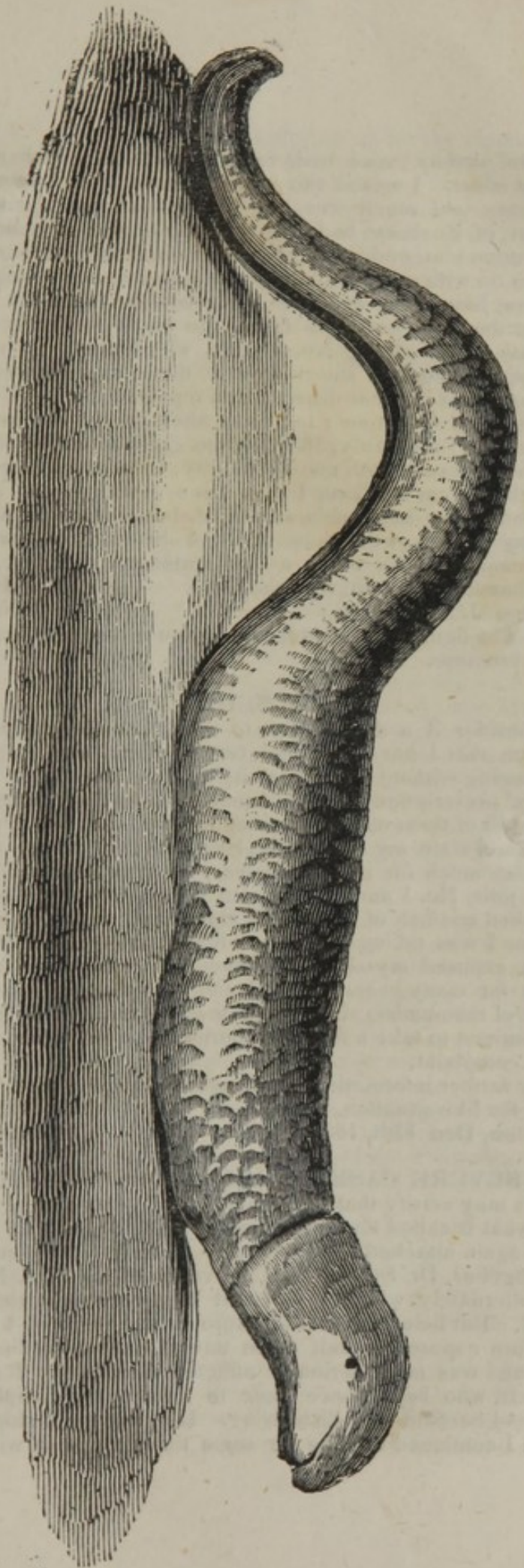
