

# Faculty of Physicians and Surgeons.



### CHAPTER I.

## OF THE FACULTY AND COMMON SEAL.

- 1. The business of the Faculty shall be managed by the Fellows, except so far as it is provided by Cap. X., that two members of the Council shall be elected by the Licentiates.
- 2. The Common Seal (of which a representation is given above) shall be in the custody of the Secretary, and shall be by him affixed to such documents as the Faculty, President, or Council may instruct.

#### CHAPTER II.

#### OF FELLOWS.

## SECTION I .- EDUCATION.

For Candidates not previously qualified.

- (A) Candidates not possessing a recognized qualification, as defined hereafter by (C) 1, in Medicine and in Surgery shall be admissible to the First Professional Examination for the Fellowship on producing the following certificates:—
  - 1. Of registration as a student by the General Medical Council;
  - 2. Of having studied Anatomy during two winter sessions and Practical Anatomy for eighteen months at a recognized school or schools;
  - 3. Of having studied Physiology for a winter session and Practical Physiology for three months at a recognized school or schools;
  - 4. Of having studied Chemistry for a winter session and Practical Chemistry for three months at a recognized school or schools.
- (B) Candidates not possessing a recognized qualification in Medicine and Surgery, having passed the First Professional Examination, shall

be admissible for the Second Professional Examination for the Fellowship on the production of the following certificates:—

- 1. Of having been engaged for six years (or in the case of graduates in Arts or Science of a recognized university five years) in acquiring professional knowledge at recognized schools and hospitals;
- 2. Of having attended lectures on Surgery for six months, and a course of Practical Surgery, involving the performance of operations on the dead body, for three months, at a recognized school or schools;
- 3. Of having attended at a recognized school or schools one course of lectures on each of the following subjects:—

Medicine, six months;
Materia Medica, three months;
Midwifery, three months;
Medical Jurisprudence, three months;
Pathology, three months;
Practical Pathology, three months;

- 4. Of having been instructed in Practical Midwifery, and having personally attended six cases;
- 5. Of having been instructed in Practical Pharmacy for three months;
- 6. Of having been instructed in Vaccination by a Public Vaccinator under the regulations of the Local Government Board;

- 7. Of having attended the Medical and Surgical practice of a recognized hospital for a period of twenty-four months;
- 8. Of having attended Clinical Lectures on Surgery for twelve months in a recognized hospital;
- 9. Of having attended Clinical Lectures on Medicine for a period of twelve months in a recognized hospital.

## For Candidates previously qualified.

- (C) 1. Graduates in Medicine or Surgery of recognized Universities, Licentiates of the Faculty or of any of the Colleges of Physicians or Surgeons of the United Kingdom, qualified in Medicine and in Surgery, are admissible to the First Professional Examination.
- 2. Candidates so qualified, having passed the First Professional Examination, shall be admissible to the Second Professional Examination on producing satisfactory evidence of having been engaged for not less than six years (or in the case of Graduates in Arts or Science of a recognized University five years) in the study and practice of the profession.

#### SECTION II.—EXAMINATIONS.

1. The subjects of the First Examination special to the Fellowship are Anatomy and Physiology. The Candidate shall also be examined in Chemistry, unless he has passed in that subject at an Examination for a Medical Degree or Licence.

- 2. (a) The examination in Anatomy shall comprise (1) written questions, (2) dissections, (3) oral questions on recent dissections, preparations, and models. The Candidate will be expected to show a thorough acquaintance with the anatomy of the brain and organs of sense, with the development of the different organs and the process of ossification. A knowledge of the best modes of preparing and displaying the different regions of the body will also be expected. The Candidate may be examined on such points in Comparative Anatomy as have a direct bearing on normal structures in the human body.
  - (b) In examining in Histology and Embryology which are common to Anatomy and Physiology, the Examiners on both subjects may examine together. For the examination in Histology the Candidates will be expected to have a satisfactory knowledge of the best methods of preparing and mounting microscopic specimens of normal tissues, and will be required to prepare such specimens in the course of the examination. They will also be required to identify mounted specimens under the microscope.
  - (c) The examination in Embryology shall include the development of the ovum, up to (and including) the formation of the

- several layers of the blastoderm. It shall also include the development of the brain and spinal cord, and the circulatory and osseous systems.
- (d) In Physiology proper the Candidate shall be required to show a sound knowledge of the subject, and also a practical acquaintance with the apparatus employed in physiological physics, and a knowledge of the practical chemical examination of blood, urine, milk, and bile.
- 3. The subjects of the Second Examination special to the Fellowship are Pathology and Surgery, or (as an alternative to Surgery) Medicine. Unless previously qualified, the Candidate shall be also examined in Materia Medica, Midwifery, Medical Jurisprudence, and in Medicine or Surgery, according as he has selected Surgery or Medicine, of the subjects before-named as special to the Fellowship.
  - 4. (a) In Pathology and Morbid Anatomy the examination shall be written and oral, and the Candidate will be required to recognize morbid specimens both macroscopic and microscopic.
    - (b) In Surgery, the Candidates will be examined in (1) Systematic Surgery, including Surgical Anatomy and Surgical Pathology; (2) Operative Surgery, involving the performance of operations

- on the dead body, and embracing surgical instruments; and (3) Clinical Surgery, involving the examination of patients and the use and application of surgical apparatus.
- (c) In Medicine, in cases in which that subject is taken as an alternative to Surgery, the Candidate shall be examined in (1) Systematic Medicine, including Medical Pathology and Therapeutics; (2) and in Clinical Medicine, involving the examination of patients.
- 5. The two examinations shall be passed in their order first and second; but a Candidate may enter for or may pass in only one of the subjects special to the Fellowship, either at the First or the Second Examination; and he shall not be required to pass again in any of those subjects in which he has formerly passed.
- 6. Fellows admitted under the above Regulations shall be qualified to hold offices and appointments.
- 7. A Candidate qualified in Medicine and Surgery, whose diplomas have been received not less than ten years previously from the Faculty, or from any of the Universities or Colleges of Physicians or Surgeons of the United Kingdom, may be admitted to an Examination embracing two subjects—(1) Surgery, or, as an alternative, Medicine; and (2) one of the subjects to be

selected by the Candidate from the list of eight subjects hereto subjoined, viz. :—

- (a) Human Anatomy.
- (b) Comparative Anatomy.
- (c) Physiology.
- (d) Pathology.
- (e) Midwifery and Diseases of Women.
- (f) Medical Jurisprudence.
- (g) State Medicine.
- (h) Psychological Medicine.
- 8. Fellows admitted under the above clause (7) shall be qualified to hold offices and appointments if they have paid the full fee (Section IV., 4).

#### SECTION III.—ELECTION.

1. There may be admitted yearly to the Fellowship without examination, should the Faculty see fit, not more than two legally qualified medical practitioners, who have been at least ten years qualified, and who shall have highly distinguished themselves by original investigations. Candidates under this section must be proposed in writing by not less than six Fellows of the Faculty, and the proposal must be submitted at an ordinary meeting of the Faculty. The proposal must be intimated on the billets calling the next three ordinary meetings of the Faculty, and at the third meeting the election shall be determined by ballot. Before the ballot is taken the Council shall report whether in their opinion the applicant has so distinguished himself as to

render him admissible under this section. For the election, two-thirds of those voting must be in favour of admission.

2. Fellows admitted under the above clause (1) shall be qualified to hold offices and appointments if they have paid the full fee (Section IV., 5).

Section IV.—Fees, and Qualification to hold Office.

1. The fees in the case of a Candidate not previously qualified are as follows:—

First Professional Examination, . 8 guineas. Second Professional Examination, 12 guineas.

2. The fees in the case of a Candidate, a Licentiate of the Faculty or a Graduate in Medicine of a recognized University, admitted under Section II., 1-5, are:—

First Professional Examination, 6 guineas. Second Professional Examination, 9 guineas.

3. The fees in the case of a previously-qualified Candidate, not a Licentiate of the Faculty, nor a Graduate in Medicine of a University, admitted under Section II., 1-5, are :—

First Examination, . . . . 8 guineas. Second Examination, . . . . . 12 guineas.

4. The fees in the case of a Candidate admitted under Section II., 7, shall be :—

At Entry for Examination, . . £10

Before admission:

 In the case of a Fellow not qualified to hold office. £15

5. The fees in the case of a Candidate admitted under Section III. are :-

For a Fellow qualified to hold office, . £50 For a Fellow not qualified to hold office, £25

6. Fellows whose ordinary place of residence is within five miles of the Faculty Hall, shall be qualified to hold office, under whatever regulations they have been admitted, and for this purpose shall pay the full fee. Fellows residing beyond that distance may or may not so qualify themselves; but should they at any time subsequent to admission change their ordinary place of residence to within five miles of the Faculty Hall, they shall continue to be disqualified to hold office till they have paid the balance of the full fee.

#### SECTION V.—PERIODS OF EXAMINATION.

There shall be two periods of examination for the Fellowship in each year, the first beginning in the second week of April, and the second in the third week of October.\* Candidates shall give notice to the Secretary not later than the fourth Monday of March and the first Monday of October that they intend to appear for examination. Not later than one week prior to the Examination they shall also submit to the Secretary the Certificates required under the Regulations, and at the same time pay the entry fee.

<sup>\*</sup> The days for the various parts of the Examination at each period may be learned on application to the Secretary.

#### SECTION VI.—ADMISSION.

- 1. A Candidate, though he may have passed all the necessary examinations, shall not be admitted to the Fellowship till he has attained the age of twenty-four years.
- 2. A Fellow may be admitted at any ordinary meeting of the Faculty, or of the Council thereof, after it has been reported to the Faculty by the Board of Examiners that he has passed the necessary examinations, and has produced to the Secretary evidence that he has attained the requisite age.
- 3. A Fellow elected under Section III. may be admitted at any ordinary meeting of the Faculty subsequent to his election.
- 4. Previous to admission the Candidate shall subscribe the following Declaration:—
- "I, A. B., do solemnly and sincerely declare that I shall be a faithful Fellow of this Faculty, promote its interest, and be obedient to all lawful Acts made, and to be made by the Faculty, for the good of the lieges and of this Faculty, and shall not willingly do prejudice to any person by my application or advice. And I make this solemn Declaration by virtue of the provisions of an Act passed in the sixth year of the reign of his late Majesty King William the Fourth, entituled, An Act to repeal an Act of the present session of Parliament, entituled, an Act for the more effectual abolition of Oaths and Affirmations taken and made in various Definition of the State, and to substitute Declarations in lieu thereof, and for the more entire suppression of voluntary and extra-judicial Oaths and Affidavits, and to make other profit visions for the abolition of unnecessary Oaths."
  - 5. A Candidate who has passed the necessary

examinations, or who has been elected under Section III., may be permitted by a vote of two-thirds of the Fellows voting at a meeting of the Faculty to be enrolled in absence, provided he transmits to the Clerk, and there is laid before the meeting a copy of the above Declaration duly signed by him in the presence of a Justice of the Peace, by whom the signature shall be attested.

### CHAPTER III.

#### OF LICENTIATES.

- 1. The curriculum of study and the regulations relating to the Examinations of Candidates for the single Licence, shall, subject to the provisions of next clause (2), from time to time be laid down by the Council, and revised by them as they may see fit.
- 2. The Licence of the Faculty shall be granted singly only to the following classes of persons, that is to say, to Graduates in Medicine of one of the Universities of the United Kingdom, or to Licentiates in Medicine of one of the Colleges of Physicians of the United Kingdom.
- 3. The Licence of the Faculty may also be granted in conjunction with the Licences of the Royal College of Physicians of Edinburgh, and of the Royal College of Surgeons of Edinburgh,

in accordance with the provisions of an Agreement between these three bodies, which was sanctioned by the General Medical Council on 31st March, 1884, and came into force on 1st October, 1884.

- 4. Licentiates of the Faculty shall, previous to their admission, subscribe the following declaration:—
- "I do solemnly and sincerely declare that I will exercise the "several parts of my profession to the best of my knowledge and ability, for the good, safety, and welfare of all persons committing themselves or committed to my care: that I will not advertise or publish any matter prejudicial to the interest or derogatory to the honour of the Faculty or disgraceful to the medical profession: and that I will loyally obey all byelaws of the Faculty, made or to be made, for the regulation of Licentiates of the Faculty."
- 5. Admission to the Licentiateship of the Faculty shall be open to women equally with men.

#### CHAPTER IV.

OF PROFESSIONAL CONDUCT AND OF FORFEITURE OF THE FELLOWSHIP OR LICENCE.

- 1. No Fellow of the Faculty shall keep an open shop for the sale of drugs or other merchandise, or be a proprietor or have any proprietary interest in a secret remedy.
- 2. Any Fellow or Licentiate of Faculty whose name may be erased from the Medical Register by direction of the General Council of Medical

Education and Registration of the United Kingdom, shall, *ipso facto*, cease to be a Fellow or Licentiate of Faculty, and his name shall thereupon be struck off the Register of Fellows or Licentiates.

- 3. Any Fellow or Licentiate who, in the opinion of the Faculty, has been guilty of any crime or public offence, or of conduct infamous in a professional respect, may be censured, suspended, expelled, or deprived by the Faculty of his Fellowship or Licence and all the rights and privileges thereto pertaining, and on deprivation his name shall be struck off the Register of Fellows or Licentiates.
- 4. For the censure or suspension of a Fellow, the mode of procedure shall be as follows, viz.:-(1) A motion that a Fellow or Licentiate be censured or suspended for an offence, to be distinctly stated in the motion, must be submitted in writing at an Ordinary Meeting of the Faculty, and be authenticated by the signatures of the mover and seconder thereof. (2) The Clerk shall immediately after said Meeting transmit a copy of the motion to the accused Fellow or Licentiate, by post, to his address in the Faculty books, or in the latest issue of the Medical Register. (3) At the next Ordinary Meeting of the Faculty the said motion, with any reply which may have been received to the communication made by the Clerk, shall be considered by the Faculty, who shall either negative the motion or remit it to the Council for investigation and report. (4) The report of the

Council, which, when advising suspension, shall specify the term for which they consider it should endure, shall not be disposed of by the Meeting of Faculty at which it is submitted, but shall be determined upon either at the next Ordinary Meeting or at a Meeting of the Faculty specially convened, of either of which Meetings ten days' clear notice shall be sent to the accused Fellow or Licentiate; and it shall be competent for him to plead personally or by a representative at the said Meeting. (5) The motion to censure or suspend shall not be carried unless two-thirds of the votes given be in its favour.

5. The mode of procedure for the expulsion or deprivation of a Fellow or Licentiate shall be as follows:—(1) A motion that a Fellow or Licentiate be expelled or deprived of his Fellowship or Licence for an offence, to be distinctly stated in the motion, must be duly submitted in writing at an Ordinary Meeting of the Faculty, and be authenticated by the signatures of the mover and seconder thereof. (2) The Clerk shall, within seven days after said meeting, transmit a copy of the motion to the accused Fellow or Licentiate by post, to his address in the Faculty Books, or in the latest issue of the Medical Register. (3) It shall at the next Ordinary Meeting of the Faculty be remitted to the Council to consider and report to the Faculty whether, in their opinion, the motion ought or ought not to be entertained. (4) The Faculty, at the next Ordinary Meeting after that at which the Report of the Council

shall have been given in, shall determine, by a majority of two-thirds of the votes given, whether the motion shall be proceeded with. (5) If it be determined that the motion shall be proceeded with, said motion shall be decided upon at a meeting of the Faculty specially convened for the purpose, after an interval of not less than one month nor more than three months from the date of the meeting at which it was determined that said motion should be proceeded with. (6) Not less than ten days' notice of said Special Meeting shall be sent to the accused Fellow or Licentiate, and it shall be competent for him to plead by himself, or by a representative at the said meeting. (7) The motion shall not be carried unless twothirds of the votes given be in its favour.

#### CHAPTER V.

#### OF HONORARY FELLOWS.

- 1. The Faculty may confer on any gentleman distinguished in the profession the rank of Honorary Fellow. A proposal to admit to the Honorary Fellowship must be signed by six Fellows, and lie upon the table for two months, when the election shall proceed in the ordinary manner.
  - 2. For the Election of an Honorary Fellow

two-thirds of the votes given must be in favour of his admission.

- 3. Honorary Fellows do not require to make or sign any Declaration, and no Fee is payable.
- 4. Honorary Fellows, when in Glasgow, shall be entitled to the use of the Library, under the same regulations as other Fellows, but they shall have no right to vote in meetings of the Faculty, or in any way to interfere in its affairs.

#### CHAPTER VI.

#### OF LICENTIATES IN DENTAL SURGERY.

- 1. The curriculum of study and the regulations relating to the Examinations for the Licence in Dental Surgery shall from time to time be laid down by the Council, and revised by them as they see fit.
- 2. Licentiates in Dental Surgery shall, on admission, sign the following Declaration:—
- "I do solemnly and sincerely declare that I will exercise the "several parts of my profession to the best of my knowledge and ability, for the good, safety, and welfare of all persons committing themselves or committed to my care: and I hereby promise as a Licentiate in Dental Surgery that I will not advertise or employ any other unprofessional modes of attracting business, nor will I allow my name to be connected with any one who does so: and that I will loyally obey all bye-laws of the Faculty, made or to be made, for the regulation of Licentiates in Dental Surgery."

Any Licentiate who may be proved to the satisfaction of the Council to have violated the obligation in the foregoing Declaration shall, if the Council so decide, render himself liable to the forfeiture of his diploma, and to his name being erased from the list of Dental Licentiates.

- 3. The mode of procedure for the deprivation of a Dental Licentiate of his Licence shall be the same as that prescribed in Chapter IV., 4, in respect to Fellows and Licentiates.
- 4. Any Licentiate of the Faculty, whose name may be erased from the Dentists' Register, by direction of the General Council of Medical Education and Registration of the United Kingdom, shall *ipso facto* cease to be a Licentiate in Dental Surgery of the Faculty, and his name shall thereupon be struck off the Register of Licentiates in Dental Surgery.

#### CHAPTER VII.

#### OF THE CERTIFICATE IN PUBLIC HEALTH.

The Faculty shall, after due examination on the different subjects embraced in State Medicine or Public Hygiene, as prescribed from time to time in the syllabus of the Faculty, grant to a Candidate who passes the Examination, and is registered under the Medical Act, a Certificate of his competency to discharge the duties of Medical Officer of Health.

## CHAPTER VIII.

#### OF MEETINGS AND ORDER OF PROCEDURE.

- 1. An Ordinary Meeting of the Faculty shall be held in the Faculty Hall on the first Monday of every month, at Four o'clock. The Ordinary Meeting in October shall be distinguished as the Annual Meeting.
- 2. A Special Meeting shall be convened when judged expedient by the President, or when he shall receive a requisition to that effect, signed by not less than Six Resident Fellows, setting forth the particular purpose of such Meeting.
- 3. All Meetings of the Faculty shall be convened by circular, delivered by the Officer, or sent by post to the Fellows residing in Scotland, at least one lawful day before the date of Meeting, intimating the business to be brought forward.
- 4. Twelve Fellows, duly convened, shall constitute a Quorum of the Faculty, and shall have full power to transact all business regularly brought forward at any Meeting. In the absence of both the President and the Visitor, the Meeting shall appoint a Chairman, who, at that meeting, shall be vested with the powers of the President.
- 5. At Ordinary Meetings the Minutes of the preceding Meeting or Meetings having been read and confirmed, the business intimated in the

billet, and thereafter any business the President may introduce, shall be considered before any other subject is taken up: After which questions may be put, and motions tabled for consideration at next Meeting.

- 6. All Motions and Amendments shall be submitted in writing, with the names of the Movers and Seconders.
- 7. No Motion shall be finally disposed of by the Meeting at which it is tabled, unless in the case provided in the clause immediately following. But when any matter requires immediate decision, the Faculty may, by agreement of two-thirds of the Fellows present, remit it to the Council, with full powers to take the necessary action thereon.
- 8. Any proposal originating with or recommended by the Council may be decided at the Meeting at which it is submitted to the Faculty, provided notice of such proposal has been given in the billet calling the Meeting—such notice also to include express intimation that the proposal will be decided at that Meeting; but no proposal for a grant of money or an alteration in the Regulations shall be disposed of by the Meeting at which it is introduced.
- 9. When any alteration of, or addition to, the Regulations is proposed, it shall, if thought proper by the Faculty, be remitted to the Council, with or without the addition of the Mover and Seconder, or to a Committee; and the report of the Council or Committee in reference thereto shall not be

decided upon at the same Meeting of the Faculty at which it is brought up.

- 10. All questions shall be determined by a majority of votes, if not otherwise provided for by these Regulations; and upon the request of any three Fellows present the voting shall be by Ballot.
- 11. The mode of voting shall be as follows:— If an Amendment be proposed on a Motion, the Amendment shall be disposed of, as against the original Motion, before any other Amendments shall be moved. Such Amendment shall be put first to the vote; if negatived, a second Amendment may be moved, and shall be disposed of in the same way as the first Amendment, and so on till no further Amendment shall be proposed. Should every Amendment be negatived, the original Motion shall then be put to the vote. any Amendment be carried as against the original Motion, which is thus lost, it shall be put as a substantive Motion, and treated as to further Amendments, and the right of speaking on it, as an original Motion.

#### CHAPTER IX.

OF THE ELECTION OF OFFICE-BEARERS.

1. The Faculty shall from time to time elect the following Office-Bearers:—a President, a Visitor, and Six Councillors—four by the Fellows, and

X.,—who, together with the Treasurer and the Faculty's Representative in the General Medical Council, shall constitute the Council of the Faculty; a Board of Examiners for the Fellowship; a Board of Examiners for the Licence; a Dental Board; Examiners in Arts and Examiners in Public Health, all as constituted in Chap. XI.; a Treasurer, an Honorary Librarian, and a Vaccinator. There shall likewise be elected a Finance Committee, to consist of the Treasurer, President, and Five elected Members; and a Library Committee, to consist of the Honorary Librarian and Six elected Members.

- 2. The President, the Visitor, the Treasurer, the Honorary Librarian, and the Vaccinator shall be elected at the Annual Meeting; when the President and the Visitor shall each nominate an Inspector of Drugs.
- 3. At the Annual Meeting there shall be elected One Councillor, who shall continue in office for four years; Examiners for the Fellowship and Examiners for the Licence (for the special subjects as vacancies occur), who shall continue in office for four years; One Member of the Finance Committee, who shall continue in office for five years; and Two Members of the Library Committee, who shall continue in office for three years.
- 4. For election to the offices of President, Visitor, Councillors, and Examiners, nomination of

Candidates shall be required before the day of election, as herein provided for; that is to say, such nomination may be made verbally by two Fellows at the Ordinary Meeting of the Faculty immediately preceding the Annual Meeting; or it may be made in writing in the form hereto annexed,\* provided the nomination paper be lodged with the Secretary not later than four o'clock of the Monday preceding the Annual Meeting.

- 5. The names of Candidates duly nominated orally or in writing for the various offices shall be intimated in the Circular calling the Annual Meeting at which the election is to take place. Should it be found that no Candidate has been nominated for any office, then (but only in that case) shall it be competent for any Fellow to propose a person for the office without previous nomination.
- 6. Candidates nominated for any of these offices shall not personally canvass the Fellows in promotion of their Candidature.
- 7. At the Annual Meeting Twelve Fellows, including the President, Visitor, and Treasurer,

shall be appointed as Representatives of the Faculty at Meetings of the Proprietors of the Glasgow Royal Botanic Institution.

- 8. From time to time the Faculty shall elect, for a term not exceeding five years, a Member of the General Council of Medical Education and Registration of the United Kingdom, as provided for by the "Medical Act, 1858."
- 9. In the event of a Fellow holding more than one office, in respect of which he is ex officio a Member of the Council of Faculty, the Faculty shall elect another Fellow to be a Member of Council, so as to secure that the number of that body shall be maintained at ten.
- 10. The Faculty shall annually, or as otherwise herein provided for, elect Three Managers of the Glasgow Royal Infirmary, Two Managers of the Western Infirmary, One Director of the Glasgow Asylum for the Blind, Two Directors of the Glasgow Lying-in Hospital and Dispensary, Three Directors of Stirling's Library, Two Directors of the Glasgow Royal Lunatic Asylum, One Governor of Haldane's Academy of the Fine Arts, Two Directors of the Glasgow Lock Hospital, and One Director of the Convalescent Home, Two Members of the Committee of Management under the Conjoint Scheme; also, Trustees or Managers of the Dr. John Macarthur, John Gibson, and Scott Bursary Funds, in accordance with the provisions of these Trusts respectively. These ap-

pointments shall be made at the Ordinary Meetings of the Faculty at the following periods, viz.:—

11. In the event of the President (who is ex officio a Manager of the Glasgow Royal Infirmary) being Professor of Medicine or Professor of Anatomy in the University, the Faculty shall, as provided by the Charter of the Infirmary, appoint another Fellow to be a Manager in his stead.

- 12. At the Annual Meeting there shall also be elected Two Members of the Dental Board, one a Fellow of the Faculty, and the other a Registered Dentist, to continue in office for three years; One Examiner in Public Health, to continue in office for four years; and Two Examiners in Arts to conduct the Preliminary Examination, to continue in office for one year. The Examiners in Arts shall be empowered to call in such aid as they may deem necessary.
- 13. Fellows qualified to hold office (under Chap. II., Sec. II., 6, 8, and Chap. III., 2), that is to say—Fellows admitted after full examination, Fellows residing within five miles of the Faculty Hall, and Fellows who, though residing beyond that distance, have paid the full fee—shall alone be eligible to any of the foregoing offices or appointments, except in cases in which it is provided by these Regulations that the offices may be held by persons who are not Fellows of the Faculty.
- 14. All these elections and appointments shall be made by Ballot; and when two or more fall to be chosen to the same office at the same time, the Ballot shall be taken separately for each.
- 15. Should three or more persons be proposed for the same office, and none of them after ballot has obtained an absolute majority of the votes tendered, then the name of the person having the smallest number of votes shall be omitted, and a second ballot taken; and so on until a candidate has obtained a majority of the votes tendered.

16. When from any cause a vacancy occurs in any office at other than the regular time of election, it shall be supplied at the first Ordinary Meeting thereafter, provided notice that such election is to take place has been given in the circular calling said Meeting; and the Fellow elected to any office in such circumstances shall hold the same for the remaining portion of the term for which his predecessor was elected.

#### CHAPTER X.

# OF THE ELECTION OF COUNCILLORS BY THE LICENTIATES.

A Meeting of Licentiates of the Faculty shall be held in the Faculty Hall on the second Monday in September of 1886, at Four o'clock p.m., and on the same day and hour every fourth year thereafter, for the purpose of electing Two Fellows of the Faculty for the office of Councillor. The Meeting shall be called by public advertisement signed by the Secretary, and the President of Faculty for the time being, if present, shall be Chairman of the Meeting. In the absence of the President the Licentiates present at said Meeting shall elect their own Chairman; fifteen Licentiates shall constitute a quorum. Any Fellow of Faculty qualified to hold office may be elected; and the two Fellows having the

highest number of votes at the Meeting shall, unless a poll be demanded, be declared duly elected. But it shall be competent for the proposer and seconder of any Candidate other than the two having the highest number of votes to demand a poll. In the event of a poll being demanded, and intimation to that effect being made in writing to the Secretary by the Chairman of the Meeting, the Secretary shall, not later than the Monday preceding the Annual Meeting, send by post a voting paper to every Licentiate resident in the United Kingdom, whose name appears in the Medical Register, containing the names of all the Fellows duly proposed and seconded at the Meeting, with the instruction that he shall mark the name of the two Candidates whom he approves, and the voting papers so marked shall be returned to the Secretary not later than the Friday preceding the Annual The Two Fellows who have the Meeting. highest number of votes shall be reported to the Faculty at the Annual Meeting as duly elected Members of the Council for four years. In the event of the Fellows so elected, or either of them, dying or resigning during the currency of his term of office, or if from any cause there should be no election of Councillors by the Licentiates as herein provided for, the vacancy in the office of Councillors shall be filled up by the Faculty at an Ordinary Monthly Meeting.

## CHAPTER XI.

# OF OFFICE-BEARERS AND THEIR SPECIAL DUTIES.

- 1. The President shall have power to convene The President. all Meetings of the Faculty, of the Council, and of the Examining Board, and when present he shall preside. Besides having a deliberative vote, he shall in all cases of equality have a casting vote.
  - 2. He, or in his absence the chairman of the Meeting, shall take the Declaration of Candidates to be admitted to the Fellowship of the Faculty, and formally admit them.
  - 3. He shall intimate the death of any Fellow that may have been reported to him on sufficient authority at the first Ordinary Meeting of the Faculty thereafter, and the same, with the date thereof, shall be entered in the Minutes.
  - 4. In all important matters he shall consult the Council, and follow their advice until the Faculty shall otherwise instruct.
- 5. The Visitor shall exercise all the powers and The Visitor. privileges of the President, when from any cause the President is absent or unable to discharge the duties of his office.
- 6. The Council shall be a consultative and The Council. executive body, to consider matters remitted to

them for that purpose by the Faculty, to watch over the interests of the Faculty, and when they consider necessary to make recommendations in respect to the business of the Faculty; to carry into effect all resolutions of the Faculty involving executive action; and in the intervals between Meetings of the Faculty to act in all matters requiring immediate attention.

- 7. They shall meet at such times as the President may deem fit. Four shall be a quorum. In the absence of both the President and the Visitor, the Meeting shall appoint a Chairman.
- 8. They shall appoint one of their number, or the Secretary of the Faculty, as Secretary, who shall keep Minutes of their proceedings, which shall be laid on the table at the Ordinary Meetings of the Faculty.
- 9. The Honorary Librarian, or other Office-Bearer, shall, when requested by the President, attend Meetings of the Council, but shall have no vote; but any Fellow added to the Council in terms of Chap. VIII., 9, shall be entitled to vote on the special matter for which he has been added to the Council.

Fellowship.

10. A special Board shall be appointed to Examining Board for the Examine for the Fellowship, consisting of three Examiners on each of the following subjects, viz. :- (a) Anatomy, (b) Physiology, (c) Pathology, (d) Surgery and Clinical Surgery, (e) Medicine and Clinical Medicine, (f) Comparative Anatomy, (g) Midwifery and Diseases of Women,

- (h) Medical Jurisprudence, (i) State Medicine, (j) Psychological Medicine.
- 11. No one shall be disqualified from holding office as an Examiner for the Fellowship by his being an Examiner for the Licence, the Dental Licence, or the Certificate in Public Health, and vice versa.
- 12. The Examinerships in Anatomy and Comparative Anatomy may be held by the same person.
- 13. The Examining Board for the Licence shall Examining Board for the consist of Examiners to be appointed for the Licence.

- 14. No person shall be eligible for appointment as Examiner in Clinical Medicine or Clinical Surgery, unless a Fellow of the Faculty holding the appointment of Physician or Surgeon (as the case may be) to the Royal Infirmary or the Western Infirmary.
  - 15. No person shall be held as disqualified for

appointment as Examiner in Clinical Medicine or Clinical Surgery by reason of his being an Examiner on another subject, and vice versa. But with this exception, it shall not be competent for an Examiner in any subject (other than Arts' subjects) required for the Licence to hold the office of Examiner on another subject required for the Licence.

- 16. The Faculty may at any time, should they see fit, elect as Examiners in Chemistry persons who are not Fellows of the Faculty, nor members of the Medical profession.
- 17. In the event of any Examiner being unable to attend an Examination, it shall be obligatory on him to provide in his place one of the other Examiners on the same subject; failing whom, of another Member of the Examining Board.
- 18. A meeting of the whole Examining Board shall be convened by the President in January each year, at which questions affecting the manner of conducting the Examinations may be discussed. Other meetings of the Board may be convened at the discretion of the President.

Dental Board. 19. The Dental Board shall conduct the Examinations for the Licence in Dental Surgery.

20. The Board shall consist of Six Members, three of whom shall be Fellows of the Faculty, and the other three Registered Dentists, who may or may not be Fellows of the Faculty. The

President of the Faculty shall be Convener of the Board.

- 21. The Examiners in Public Health shall con-Examiners duct the Examination for the Certificate in Public in Public Health. Health. The Board shall consist of Four Members, three of whom shall be Fellows of the Faculty, and the fourth a Teacher of Chemistry, or an Analytical Chemist, who may or may not be a Fellow of Faculty.
- 22. The term of office of Members of the Board shall be four years, one to retire annually by rotation.
- 23. One of the Members of the Board shall be appointed to Examine in Chemistry, another in Physics as regards its Sanitary applications, and in Meteorology. The two remaining members shall be appointed to Examine in Medicine in its relation to Sanitary Science, or Practical Sanitation, in Sanitary Law and in Vital Statistics.
- 24. The Examiners in Arts shall conduct the Examiners Preliminary Examination of intending Candidates in Arts. for the Diploma, in such manner as the Faculty or the Council may direct. All written Examinations shall take place in the presence of at least one of the Examiners in Arts, or of the Secretary of the Faculty. The Faculty may, should they at any time see fit, elect as Examiners in Arts persons who are not members of the Medical Profession.

Committee of Management under Conjoint Scheme.

- 25. The Faculty shall elect two Members of the Committee of Management under the Scheme of Conjoint Examination conducted by the Royal College of Physicians of Edinburgh, the Royal College of Surgeons of Edinburgh, and the Faculty, in accordance with the provisions of the Agreement between the said three Authorities. Members shall continue in office for two years; one Member shall retire annually, but shall be eligible for re-election.
  - \*\*\* In accordance with the provisions of the Scheme, members are disqualified from being Examiners under the Scheme.

Treasurer.

- 26. The Treasurer shall receive all monies due to, and pay all accounts due by the Faculty; but he shall not take any security for debts due to the Faculty without the authority of the Finance Committee.
- 27. He shall lodge all money he receives on account of the Faculty in one of the Banks in Glasgow in name of the Faculty, and the funds in the Bank shall be uplifted only by cheques signed by at least one Member of the Finance Committee, or the Secretary of the Faculty, along with the Treasurer. He may, however, retain in his hands a sum not exceeding £20 to meet occasional demands.
- 28. He shall keep a Cash Book, and such other books as, in the judgment of the Finance Committee, shall be necessary or convenient.
  - 29. He shall balance his Accounts yearly, to

the Monday immediately preceding the Annual Meeting, and lay before said meeting a Report, subscribed by at least three Members of the Finance Committee, containing his charge and discharge of the monies belonging to the Faculty, with a statement made in such form and embracing such particulars as may be directed by the Committee.

- 30. He shall be Chairman of the Finance Committee, and convene all Meetings thereof, and at their Quarterly Meetings he shall lay before them his whole business books and accounts.
- 31. The whole Property and Funds of the Finance Faculty (exclusive of the Library) shall be under the superintendence of the Finance Committee; but all investments of Funds belonging to or under the control of the Faculty shall be made in name of, and discharged or assigned by the President, Visitor, Treasurer, and Clerk for the time being.
- 32. The Committee shall examine Quarterly the Treasurer's cash transactions, and authorize payment of accounts, other than ordinary expenditure, due by the Faculty.
- 33. They shall meet in the Hall on the Wednesday immediately preceding the first Monday of January, April, July, and October, annually, and at such other times as may be required. Three shall be a quorum. In the absence of the Treasurer, the Committee shall appoint a Chairman.

- 34. They shall appoint one of their number, or the Secretary of the Faculty, as Secretary, by whom Minutes of their proceedings shall be kept.
- 35. They may appoint a Factor for the management of the Heritable Property of the Faculty, or any part thereof, with such instructions, and on such terms as they may deem expedient.

Custodiers of the Safe.

- 36. The President and the Treasurer shall each keep one of the keys of the Safe, in which are deposited the Minute Books, Title Deeds, and other important documents belonging to the Faculty. They shall, within one month after their election, meet to examine the contents of the Safe, compare them with the Inventory, and shall report thereon to the next Ordinary Meeting of the Faculty.
- 37. An Inventory of the whole Books, Titles, and Documents in the Safe shall be kept, and nothing shall be removed from the Safe without a receipt being granted by the person receiving it, in a book kept for that purpose. The Clerk of Faculty shall keep in his possession a certified copy of the said Inventory, which shall be at all times patent to the Fellows of the Faculty.

Honorary Librarian. 38. The Honorary Librarian shall have a general superintendence of the Library, and exercise a supervision over the Librarian. He shall, previous to the Annual Meeting, see that the Books are in good preservation, and that those lent out have been returned in terms of Chap. XII., 8.

He shall, at the Annual Meeting, give in a Report on the Library, including such statistics as the Library Committee may instruct.

- 39. He shall be Chairman and Convener of the Library Committee.
- 40. The Library Committee shall meet in the Library Committee. Hall quarterly, or more frequently if required. Three Members shall be a quorum.
- 41. They shall appoint one of their number, or the Secretary of the Faculty, as Secretary, by whom Minutes shall be kept of their proceedings.
- 42. They shall consider the merits of all publications laid before them, or recommended by any Fellow, and direct the addition to the Library of such as may be approved; but they shall not purchase any volume the price of which exceeds £10, unless with the sanction of the Faculty.
- 43. They shall prescribe, from time to time, the conditions under which the use of the Library may be allowed to Fellows not qualified to hold office.
- 44. It shall be competent for them from time to time to frame bye-laws for carrying on the work of the Library, so as to give to readers the full advantages of the Library under equitable conditions, provided such bye-laws do not contravene the Regulations of the Faculty, as herein set forth.
- 45. When any Book or other property under the care of the Librarian or Library Committee is

lost or damaged, the Committee shall determine what reparation shall be made for the same.

46. The Librarian shall report to the Library Committee the names of the Fellows infringing the Library Regulations, and the fines they have incurred, and these shall be entered in the Minutes of the Committee. And if any Fine remains unpaid One Month after being applied for, the Committee shall have power to instruct the refusal of Books to the Fellow so offending, and report the same to the first Ordinary Meeting of the Faculty thereafter.

The Vac-

47. The Vaccinator shall attend in the Hall every Monday, at twelve o'clock, to vaccinate gratuitously.

Inspectors of Drugs.

48. The Inspectors of Drugs shall from time to time, of their own accord, or when directed by the Faculty, visit and inspect all shops and other places in Glasgow where drugs are sold, agreeably to the powers contained in the Faculty's Charter.

The Clerk.

- 49. At the Annual Meeting, the Faculty shall appoint a Clerk, who shall attend and keep the Minutes of all Meetings of the Faculty; when requested, he shall also attend Meetings of the Council and of the Finance Committee.
- 50. The Clerk shall be the legal adviser of the Faculty, and shall take due care that their business is conducted with the proper formality, by

calling attention thereto, when there is a departure from the order provided by the Regulations or established usage of the Faculty.

- 51. He shall keep a Register of the Fellows of the Faculty, distinguishing them as Physicians and Surgeons, and whether qualified or not qualified to hold office.
- Annual Meeting in each year, place in the Reading-Room a tabular statement of the Office-Bearers and Representatives of the Faculty, showing the offices which have been held during the current year by each of them, with a mark placed opposite the names of those whose term of office then expires; and a complete list of the Fellows shall be sent to each Fellow before the Annual Meeting. He shall give notice of Offices falling to be filled at other times.
- 53. When any matter is remitted to the Council or to a Committee, he shall transmit a copy of the remit to the President or the Secretary of the Faculty, or the Convener of the Committee, as the case may be.
- 54. In regard to other duties, incidental to his office, he shall observe the regulations provided, and when no special regulations apply, he shall be guided by the instructions of the Faculty or of the Council.
- 55. At the Annual Meeting, a Secretary and The Secretary Librarian shall be appointed, who shall give his and Librarian.

whole time to the business of the Faculty. He shall attend at the Hall every lawful day, during such hours as the Faculty or the Council may determine.

- 56. In his capacity of Secretary, he shall act under the supervision of the President.
- 57. He shall receive the applications of Candidates for the Diploma of the Faculty and communicate to them all needful information. He shall examine and compare the relative Certificates with the Schedules delivered to him by Candidates, and when these are in conformity with the Regulations, admit the Candidates to Examination.
- 58. He shall keep Books showing the names of all who are admitted to the several Examinations, with the result in each case.
- 59. He shall keep the Common Seal of the Faculty, to be impressed only as herein and by the Faculty directed, and he shall prepare for each Fellow and Licentiate when admitted a Diploma, which, when duly attested by the proper Office-Bearers, he shall seal with the Corporate Seal, and deliver to the person therein named.
- 60. He shall transmit, as often as may be required by the "Medical Council," to the Registrars appointed under the "Medical Act, 1858," the names of all new Fellows and Licentiates of the Faculty, with such particulars as may be required. He shall also make up and cause to be printed, as often as the President

or the Council may instruct, Lists of the Fellows and Licentiates of the Faculty.

- 61. He shall receive and account to the Treasurer for all Fees exigible from Students and Candidates for the Diploma, and not returned to them in conformity with the Regulations of the Faculty. He shall find security for his intromissions, for such amount as the Council may instruct.
- 62. He shall give such assistance to the President, Treasurer, Council, Library and Finance Committees as may from time to time be prescribed or determined by the Council or Faculty.
- 63. In his capacity of Librarian, he shall act under the supervision of the Honorary Librarian.
- 64. He shall have the general charge of the Library, and shall see that all Books, Pamphlets, and Periodicals ordered by the Library Committee are forthwith entered in the Library Register, in the Alphabetical Catalogue, and in the Classified Index of Subjects. He shall also take care that all Books, Periodicals, etc., are properly bound. He shall see that the Regulations in Chap. XII. for the Library and Reading-Room are fully carried into effect, and report any infringement thereof to the first meeting of the Library Committee.
- 65. An Officer shall be appointed by the officer. Council, who shall give his whole time to the business of the Faculty. He shall reside in the Hall, and attend to the proper cleaning, heating,

and ventilating of the various apartments, and generally perform such duties connected with the business of the Faculty as President, Council, or Secretary may instruct. The tenure of his office shall be such as the Council may determine.

### CHAPTER XII.

#### OF THE LIBRARY AND READING-ROOM.

- 1. The Library shall be open for the giving out and return of Books every lawful day, from Ten o'clock a.m. till Two p.m., and from Three p.m. till Six p.m. The Reading-Room shall be open from Ten o'clock a.m. till Six p.m.
- 2. All Books and Pamphlets, before being lent out from the Library, shall be placed in the Reading-Room for one week. Periodicals shall not be lent out during the period of their currency.
- 3. During the time New Publications and Periodicals are placed in the Reading-Room, any Fellow may procure one, after Six o'clock p.m., on the condition that it be returned next day not later than Ten o'clock a.m., under a penalty of One Shilling, and an additional Shilling for every day it is kept out of the Reading-Room after Ten o'clock.
- 4. All Books, Pamphlets, and Serial Publications shall be held as New till they have been in the Library for Six Months. New Pamphlets,

when lent out, shall not be kept by any Fellow longer than Two Days, and New Books and Periodicals not longer than One Week, under a penalty of One Shilling for every week, or part of a week, they are so kept, after being formally called in by the Librarian. Other Books may be retained for One Month, after which any Fellow not returning them within Two Days after their being called in, shall be subject to the foregoing penalty.

- 5. Valuable Books of Plates, and such other Works as the Library Committee may reserve for reference only, shall not be lent out without the special sanction of the Committee.
- 6. No Book or other Publication shall be taken from the Library or Reading-Room without the consent of the Librarian, under a penalty of half a guinea.
- 7. When a Book, which has been retained by any Fellow for the full period allowed by the Regulations, is wanted by another Fellow, the Librarian shall make an entry thereof in the Book kept for that purpose, and call it in; and in the event of more than one Fellow applying for the same Book, they shall obtain it in the order of their application.
- 8. All Books and other Publications shall be returned to the Library before the 20th of September in each year, from which date till the Annual Meeting of Faculty, the Library shall be closed for the purpose of the Annual Inspection thereof;

and any Fellow not making the necessary returns shall be liable to a fine of One Shilling per week, or part of a week, for each Volume, Pamphlet, or Serial Publication retained after the day above appointed. In the event of any Fellow being unable to find any Faculty Book, borrowed by him from the Library, he may replace it to the satisfaction of the Library Committee, or may make such arrangement with them as they may deem proper to prevent the accumulation of fines.

- 9. Fellows qualified to hold office may have ten Volumes at one time from the Library.
- 10. Medical Officers of the Army and Navy on duty in or near Glasgow, and Medical Men from a distance who may be temporarily resident in Glasgow, introduced by a Fellow to the Librarian, on entering their names in a book kept for that purpose, may have the use of the Reading-Room, and access to the Library by way of reference. But no Books shall be lent out from the Library, except to Fellows of the Faculty.
- 11. A Book shall be kept in the Reading-Room, in which Fellows may enter the Titles and other particulars of any Books they may recommend as additions to the Library.
- 12. The Library shall be open for Consultation to all Registered Practitioners of Medicine and to all Registered Licentiates in Dental Surgery of the Faculty.

### CHAPTER XIII.

#### OF SCHOOLS OF MEDICINE.

- 1. Every Candidate for the Diploma of the Faculty must have followed his Course of Study in an Established School of Medicine, as defined in next section; or in a Provincial School specially recognized by the Faculty or by the Colleges of Physicians and Surgeons of that division of the United Kingdom in which it is situate, or under a Teacher recognized by the Faculty.
- 2. Under the title Established School of Medicine, are comprehended the Medical Schools of those cities of Great Britain and Ireland in which Diplomas in Medicine or Surgery are granted, and such Colonial and Foreign Schools as may be recognized by the Council of the Faculty.

#### CHAPTER XIV.

## OF QUALIFICATIONS AND RECOGNITION OF TEACHERS.

1. The following classes of persons shall be entitled to give Lectures which may be attended as part of the Course of Study:—1st, In the Universities of Great Britain and Ireland, the Professors of those Institutions. 2nd, In Scotland (a) in Glasgow, Fellows of the Faculty of Physicians and Surgeons of Glasgow whose Lectures have

been recognized by the Faculty; (b) in Edinburgh, Fellows of the Royal Colleges of Physicians and Surgeons of Edinburgh, whose lectures have been recognized by their respective Colleges; (c) elsewhere in Scotland, Fellows of the Faculty of Physicians and Surgeons of Glasgow, Fellows of the Royal College of Physicians of Edinburgh, and Fellows of the Royal College of Surgeons of Edinburgh, whose Lectures have been sanctioned by the College or Body to which the Lecturer respectively belongs. 3rd, In England, Fellows and Licentiates of the Royal College of Physicians of London, and Fellows and Members of the Royal College of Surgeons of England, whose status as Teachers has been admitted by those Colleges respectively. 4th, In Ireland, Fellows and Licentiates of King's and Queen's College of Physicians in Ireland, and Fellows of the Royal College of Surgeons in Ireland, whose status as Teachers has been admitted by those Colleges respectively.\*

- 2. In regard to the Dental Licence, Lectures and Courses of Instruction, common to the Medical and the Dental Curriculum, shall be recognized on the same conditions as those laid down for the ordinary Licence of the Faculty.
- 3. Lectures or Courses of Instruction on subjects special to Dentistry shall be recognized:—
  - (A) In Glasgow, if the Lecturer has been specially recognized by the Faculty.

<sup>\*</sup> The only Lecturers excepted from this Law are those on Chemistry who may be persons non-medical, if recognized by the Faculty.

- (B) In Edinburgh, if recognized by the Royal College of Surgeons of Edinburgh.
- (c) In England or Ireland, if recognized respectively by the Royal College of Surgeons of these divisions of the kingdom.
- 4. Applicants in Glasgow for recognition as teachers of subjects special to Dentistry must be either:—
  - (1) Qualified under the Medical Act; or
  - (2) Licentiates in Dentistry of one or other of the Bodies authorized to grant qualifications in Dentistry.
- 5. A Fellow or other person proposing to deliver any Course of Lectures in Glasgow, for which he desires the sanction of the Faculty, must make application to that effect by letter to the President, to be laid before the Faculty. On the application being tabled, it shall be remitted to the Council to inquire in any way they may think proper into his competency to conduct the proposed course of instruction efficiently, and to ascertain that he possesses all the requisite apparatus and conveniences. The application may be disposed of at the meeting at which the Report of the Council thereon is submitted.
- 6. Except as after mentioned in next clause (7), the Faculty will not sanction or recognize any Course of Lectures delivered by a Professor or Teacher who lectures upon more than one of the branches of instruction included in the Curriculum.

7. The same Professor or Teacher may give instruction in Anatomy and Practical Anatomy; Physiology and Practical Physiology; Chemistry and Practical Chemistry; and, further, Clinical Medicine or Clinical Surgery may, notwithstanding the foregoing regulations, be taught simultaneously with any one of the other courses of education prescribed in the Curriculum, by a Physician or Surgeon qualified according to the Regulations of the Faculty, and attached to a recognized Public Hospital.
