





TO THE HONOURABLE THE PRECEPTOR AND THE DIRECTORS OF THE TOWN'S HOSPITAL.

GENTLEMEN,

I beg leave most respectfully to offer myself a Candidate for the Surgeoncy of the Town's Hospital, and to present to you the accompanying Certificates as to character, abilities, and fitness for the office. For the sake of arrangement I have classified these Testimonials under THREE DIVISIONS,—the FIRST of which refers to moral worth and literary attainments,—the Second to professional qualifications,—while the Third contains opinions regarding my conduct from the non-professional Gentlemen under whose immediate superintendence I discharged my public duties. Referring you then to these Certificates for general information regarding me, I may be allowed to say for myself that I have been in practice in this City for more than twelve years, during nearly nine of which I have been engaged in the duties of the District Surgeoncy -duties which I declare I have always performed* in person, and not by delegation, as has been falsely insinuated, and that, conscious of having endeavoured, honestly and faithfully, to perform all that was required of me, I respectfully refer you to what I have done in the past as an earnest of what I am likely to do in the future.

He calls upon the Directors to examine Elders, Paupers, and his Students, of the latter of whom there are three still in Glasgow—all of them of undoubted veracity—one of them the Gentleman appointed by the "Glasgow Missionary Society in connection with the Church of Scotland," to superintend the operations of that Society in Caffraria, whither he proceeds in July, so that his evidence, at least, ought to be taken before that time.

them in opinion, that the firm but respectful expression of that difference will prove any obstacle to his success, provided he be found to be legally, morally, and professionally qualified. Besides, with the opinions which my letter contained, all the District Surgeons identified themselves; for though, indeed, none of them saw that document until it appeared in public, still so fully did they think that it embodied their opinions, that, at their unanimous request, and at their expense, was it reprinted from the newspaper and circulated among the Directors.
