TO THE MANAGERS OF THE WESTERN INFIRMARY.

GENTLEMEN,

I beg to submit my application for the vacant post of Physician to the Western Infirmary.

I have been connected with the Glasgow School of Medicine throughout the whole of my professional life. I studied here, taking the degree of B.Sc. in 1887, and those of M.B., C.M. in 1889, when, as first of my year, I obtained the Brunton Memorial Prize. I was thereafter for six months House Physician in the wards of Dr. M'Call Anderson at the Western Infirmary, and I subsequently studied for two years upon the Continent, visiting the hospitals of Berlin, Vienna, and Paris.

I returned to Glasgow in 1892, after which I was for two Summer Sessions engaged as Junior Assistant to the Professor of Physiology in the University. In May, 1894, I was appointed Assistant Physician to the Glasgow Hospital for Skin Diseases, a post which I held to the statutory limit of three years. In October, 1894, I was appointed Assistant to Dr. (afterwards Sir Thomas) M'Call Anderson, then Professor of Clinical Medicine, and I continued to assist him in the teaching of his Clinical Class at the Western Infirmary until his death in the early spring of 1908. In November, 1894, I took the degree of M.D. of the University of Glasgow, obtaining honours for my thesis "On the Analysis of




Voluntary Muscular Movements," an abstract of which appeared in the *Proceedings of the Royal Society*, vol. 57, and which in 1896 gained the Dill Prize for the best thesis of the last three years.

In 1897, after passing the required examinations, I was admitted a Fellow of the Faculty of Physicians and Surgeons of Glasgow. In 1899 I published a translation of Pollack's *Methods of Staining the Nervous System*, which was favourably received by the medical reviews. In 1900, when Sir Thomas M'Call Anderson was appointed Professor of Practice of Medicine, I became his Assistant at the University, as well as at the Infirmary, holding both offices until his death, after which the conduct of the class of Practice of Medicine devolved upon me until the appointment of his successor. I was thus in entire charge of the class during the remainder of the Winter Session, and throughout the Summer Session ; and in the summer of that year I acted in his stead as Examiner in Medicine at the Final Professional Examination.

In 1903 I published a revised and enlarged edition of Wheeler's *Medicine and Therapeutics*, a small text-book, which met with very favourable notices. It proved so successful that in 1908 a third edition was called for. This edition, which had undergone further revision and extension, has met with a gratifying success, and still commands a steady sale.

I have had a long connection with the Western Infirmary. At the beginning of the year 1895, I was appointed Extra Dispensary Physician, and three years later became full Physician to the Dispensary, an office which I vacated in December, 1904, at the end of the term attached to it of seven years' service. At that time I was Senior Dispensary Physician. After the expiry of my term of office I continued to teach in the Infirmary as Assistant to Sir Thomas M'Call Anderson, and in 1907 I was appointed to the post of Assistant Physician, which I now hold. I have thus been on the Staff of the Institution for a period of thirteen years, and I was engaged in



clinical teaching from 1894 to 1908. I can, therefore, claim considerable familiarity with the methods of clinical teaching, and, in addition, I have had eight years' experience in the teaching of a Systematic Class. I have also on many occasions been temporarily in charge of Wards, both under Sir Thomas M'Call Anderson and since my appointment as Assistant Physician. During the past two years, after a month's work in the laboratory of Sir Almroth Wright, I have been giving special attention to the subject of vaccine therapy, on which I have published a couple of papers.

From the beginning of my professional career, therefore, the greater part of my time has been devoted to hospital work and to the work of teaching, and to qualifying myself for such a position as that for which I now apply.

I append a list of my medical publications, and some testimonials in support of my candidature.


Should I have the honour to be elected to the vacant post, I shall endeavour to discharge its duties to the best of my ability.




