

SCHOOL OF MEDICINE FOR WOMEN.

In February, 1892, the Universities Commissioners issued an Ordinance (No. 18), empowering the Scottish University Courts to make provision within the Universities for the instruction of women, either by admitting them to the ordinary classes, or by instituting separate classes for their instruction. The Council of Queen Margaret College having considered the provisions of this Ordinance, came to the conclusion that the purpose for which the College had been instituted would be best served by making over their work to the University of Glasgow. They, accordingly, with the concurrence of Mrs. Elder, the proprietrix of the buildings and grounds hitherto occupied by the College, offered to transfer to the University Court these buildings and grounds, and the endowments (present and prospective), on condition that these should be devoted to the establishment and maintenance of University Classes for women The University Court having resolved to exercise the power conferred by Ordinance No. 18, and to provide University instruction for women mainly by the institution of separate classes, agreed to accept the offer made by Queen Margaret College, and remitted to a Committee to take the necessary steps for completing the transfer. In virtue of this arrangement the teachers in Queen Margaret College were appointed by the University Court, and the students were admitted matriculated students of the University.

MATRICULATION AND ENROLMENT IN CLASSES.

Attendance upon the Classes in Medicine qualifies for the Degrees in Medicine of the University of Glasgow.

By Ordinances No. 3 and No. 22 of the Commissioners under the Universities Act of 1858, every student is required at the beginning of each Session to matriculate by enrolling her name in the University album before joining any class. The office of the Hon. Secretary of Queen Margaret College will be open for the purpose of matriculation on and after Monday, 2nd October. The Matriculation Fee is £1 for the Academical year; for the Summer Session alone, 10s. Matriculation ends on 14th November.

Students entering on a Course of Medical Study should note that they must have previously passed the Preliminary Examination, and be registered in the books of the General Medical Council as Medical Students (see footnote, p. 26).

Students are entitled, after matriculation, to the privilege of admission to the University Library, to the use of the Reading Room in Queen Margaret College, and, under certain conditions, to admission to the Hunterian Museum; they are also entitled to vote for the Lord Rector of the University.

Medical students have access, for the usual attendance in the wards and on the Clinical Lectures, to the Royal Infirmary, the Royal Hospital for Sick Children, the Royal Asylum, Gartnavel, the City of Glasgow Fever Hospital, Belvidere, and the Eye Hospital, Charlotte Street; they also have facilities for Dispensary work at the Royal Infirmary and Royal Hospital for Sick Children.

The Winter Session of the Medical Classes begins on 19th October and ends on 23rd March, and the Summer Session of these Classes begins on 23rd April and ends early in July.

Class Tickets will be obtained and Fees paid at Queen Margaret College, Kelvinside, Glasgow. All Fees must be paid on enrolment.

The Secretary's office at Queen Margaret College will be open during the Winter Session from 10.30 a.m. till 5.30 p.m. except on Saturdays, when it will not be open after 1 p.m. During the Summer Session the office hours are from 11 a.m. till 5 p.m., except on Saturdays, when the office will be closed.

Syllabus of Lectures.

NATURAL PHILOSOPHY (PHYSICS).

This Class will meet daily at 3 p.m., except Saturdays; also, for practical work, on Saturdays, 10 to 12. The Course will include—

- (1) Experimental Physics (Properties of Matter, Sound, Heat, Light, Magnetism, Static Electricity, Voltaic Electricity, Electro Magnetism), Mondays, Wednesdays, and Fridays. The lectures will be fully illustrated by experiment.
- (2) Theoretical Mechanics (Elementary Kinematics, Elementary Dynamics), Tuesdays and Thursdays.
- (3) Practical Physics, Saturdays, 10 to 12. The students will work practically in the Laboratory, and will be taught the construction and use of physical apparatus generally, and will also be required to employ the various instruments, so as to verify natural laws and obtain numerical results.

Students intending to take a Degree in Arts must take the whole course. The requirements of students preparing for a Medical Degree or qualification will be met by the first division of the course, and by attending three days weekly, viz., Mondays, Wednesdays, and Fridays.

BOTANY.

This Class will meet in the Summer Session daily, 4 to 5. The Professional Examination in October and thereafter until further notice will embrace the following subjects:—
I. Angiosperms—(a) External Morphology; (b) Histology.
II. Gymnosperms and Cryptogams—Physiology.

ZOOLOGY.

This Class will meet on Mondays, Tuesdays, and Fridays at 2 p.m.

The Professional Examinations in October, 1893, will have special reference to the Aves, Insecta, and Annelida; and in April, 1894, to the Lamellibranchiata, Gasteropoda, Arachnida, and Reptilia.

Text-Books—Rolleston's Forms of Animal Life, ed. H. Jackson; Claus' Zoology, Sedgwick's Translation; Huxley's Vertebrates and Invertebrates. For practical work, besides Rolleston, may be mentioned the works of Huxley and Martin, of Marshall and Hurst, and of T. Jeffery Parker.

CHEMISTRY.

This Class will meet daily, 12 to 1, for systematic lectures. These will include the General Principles of Chemistry, Inorganic Chemistry, and the Elements of Organic Chemistry.

The Laboratory is open daily for Practical Chemistry from 10 till 1.

ANATOMY.

WINTER SESSION.

I. Lectures for Junior Students.

The structure of the human body will be studied systematically, in the following order:—

- 1. The Bones.
- 2. The Joints and Ligaments.
- 3. The Muscles and the Fasciæ.
- 4. Histology of Elementary Tissues.
- 5. General Sketch of the Vascular and Nervous Systems.

The Course will be illustrated by preparations and dissections brought into the lecture room.

II. Lectures for Senior Students in Regional Anatomy. Five days weekly, 3 to 4 p.m.

This Course will take the form of a series of Demonstrations on recent dissections. Special attention will be given to the Anatomy—Macroscopic and Microscopic—of the Thoracic and Abdominal Viscera, and lectures will be given on the Brain, Spinal Cord, and Cranial Nerves.

The bearings of Anatomy on Surgery and Medicine will be specially emphasised.

Text-Books—Quain's Anatomy. For practical work, Professor Cleland's Guide to Dissection; Ellis' Demonstrations of Anatomy, or Heath's Practical Anatomy.

SUMMER SESSION.

During the Summer Session a tutorial class on Osteology for Students entering on the Study of Anatomy will be conducted, and Lectures on Embryology and Morphology will also be given, open to the members of the Senior Class.

PRACTICAL ANATOMY.

The Laboratory will be open from 9 a.m. till 4 p.m.—on Saturdays 9 a.m. till 12 noon—under the personal superintendence of the Lecturer and Demonstrator.

PHYSIOLOGY.

The Class will meet five days weekly, at 2 p.m.

In Winter, instruction in the main facts and principles of human physiology and the methods of physiological research is given in a systematic course of one hundred meetings of the Class. This Course will include two main divisions :-

I. The Physiology of Nutrition, comprising the functions of nutrition proper, assimilation and absorption, circulation of the blood, respiration, secretion and excretion. As a preliminary to this part, some time will be devoted to the general physiology of the tissues, including their histology and chemistry, instruction in the latter being carried on in the practical class, the students being supplied with apparatus and chemical re-agents. The practical instruction will enable the student to become familiarised with the chief methods of analysing the principal fluids of the body, and with the apparatus and methods of observing and recording physiological phenomena.

II. The Physiology of Innervation, of the Senses, and of Reproduction. In this part the histology and chemistry of nervous tissue and of the central nervous organs and the sense organs will be included.

Written and Oral Examinations are held during the Session.

In the Summer Session practical instruction will be given in the Laboratory, on the same days of the week and at the same hour as in Winter, chiefly on the use of the microscope and the methods of preparing the various tissues and organs of the body for microscopical examinations. Each student will be supplied with a microscope and all the necessary material for carrying on such work, and will have the opportunity of making a complete collection of mounted specimens of the various tissues and organs.

MATERIA MEDICA AND THERAPEUTICS.

The Class will meet five days weekly, at 12 noon.

The Winter Course will be mainly occupied by the dis-

cussion of the Physiological actions and Therapeutic uses of the various drugs used in the treatment of disease. The employment of heat, cold, electricity, etc., for Therapeutic purposes, will also be considered; and there will be systematic demonstrations of the various articles of the Materia Medica.

PRACTICAL PHARMACY.

During the Summer Session lectures will be given on the official Galenical preparations, and students will be practically instructed in the compounding and dispensing of medicines.

Students are recommended to attend the Practical Class in the summer preceding their attendance upon the Winter Course.

PATHOLOGY.

The Class meets in the Pathological Department of the Royal Infirmary five days weekly, at 8 a.m.

The Class of Pathology comprises a combined course of Systematic Lectures and of Practical Laboratory Work. The Systematic Lectures are delivered during the Winter Session, and the Practical Class meets in Summer. The student may begin Pathological study with either class.

The Systematic Lectures and Demonstrations embrace a consideration of General and Special Pathology according to the following synopsis, viz.:—

- 1. Derangements of the Circulation of the Blood, and the resulting Lesions.
- 2. The Pathology of Inflammation.
- 3. The causes and varieties of Infiltrations and Degenerations.
- 4. The general principles of Tumour-formation, with an outline of the classification of Neoplasms.

- 5. The Pathology of Parasitic Diseases, including a general discussion of the Influence of Pathogenic Micro-organisms in the production of disease, and of the more common diseases caused by Bacteria.
- 6. Special Pathology of individual Organs and Tissues. This part of the course is varied from session to session according to the time at the disposal of the Lecturer.

During the Winter Session regular Class Demonstrations are given on specimens obtained in the *post-mortem* room, and the lectures are illustrated by specimens from the Museums and by diagrams.

In the Summer Session instruction in Practical Pathology is given in the *post-mortem* room and Pathological Laboratory of the Royal Infirmary, and is embraced under the following headings:—

- 1. The performance of post-mortem Examinations, and the study of the naked eye appearances of diseased parts.
- 2. The selection and preparation of Morbid Tissues for Section-cutting.
- 3. Section-cutting and Staining of Microscopic Sections.
- 4. The examination and collection of a series of Pathological Sections.

Written and Practical Class Examinations are held during the Winter and Summer Sessions.

Systematic Text-Book—A Manual of Pathology, by Joseph Coats, M.D., 2nd edition.

Practical Text-Book—Practical Pathology, an introduction to the practical study of Morbid Anatomy and Histology, by John Lindsay Steven, M.D.

SURGERY.

The Class will meet five days weekly; lectures will be given in the College 4 to 5 p.m., and clinical work and lectures 9 to 10.30 a.m. in the Royal Infirmary.

Text-Books—Walsham's Practice of Surgery (Churchill), and An American Text-Book of Surgery.

A course of Operative Surgery will be given in summer.

PRACTICE OF MEDICINE.

The Class will meet five days weekly; the lectures will be given in the College from 11 a.m. to 12, and clinical instruction from 9 to 10.30 a.m. in the Royal Infirmary.

During the ensuing Winter Session the work of the Class will be arranged according to the following plan, viz.:—

The Nature and Causes of Disease. Constitutional Diseases; followed by a brief reference to the Febrile State and the specific Fevers. Diseases of the various Systems, beginning with those of the Nervous System.

Text-Book-Taylor's Practice of Medicine.

MIDWIFERY AND GYNÆCOLOGY.

This Class will meet five days weekly, 12 to 1 p.m.

Midwifery. The Pelvis. Menstruation and Conception. Development of the Ovum, Embryo and Fœtus. Signs and duration of Pregnancy. Extra-uterine Pregnancy. Abnormal Development. Diseases of Pregnancy. Labour and its Phenomena. Management of Natural Labour. The Mechanism of Labour. Face Presentations. Pelvic Presentations. Transverse and complicated Presentations. Premature Expulsion of the Ovum. Hæmorrhage. Inversion of the Uterus. Rupture of the Uterus. Deformities of the Pelvis. Forceps, etc. Turning. Embryotomy. Cæsarean Section, etc. Induction of Premature Labour. Obstructed Labour. Uterine Inertia. The Puerperal State. Lactation. The Newly-born Child.

Phlegmasia Dolens. Puerperal Insanity. Eclampsia. Puerperal Fever, etc.

Diseases of Women. Physical Diagnosis. Malformations. Displacements. Diseases of Uterus and Ovaries. Diseases of Fallopian Tubes, Uterine Ligaments, and adjacent Peritoneum and Cellular Tissue. Diseases of the Vagina and Vulva. Functional and Symptomatic Disorders.

Practical Midwifery. Students can attend cases in connection with the Maternity Hospital.

MEDICAL JURISPRUDENCE.

This Class will meet five days weekly, 11 to 12, during the first half of the session.

The lectures on Forensic Medicine are intended to elucidate the application of Medical Science to judicial proceedings, whether civil or criminal.

The first part of the course is occupied with Medical Evidence as bearing on personal injuries, including Poisoning. This is followed by lectures on Hygiene, on questions connected with the Sexual Functions, and on those relating to Bodily and Mental Soundness.

In addition to oral examinations, subjects are prescribed for written exercises; and in the department of Toxicology facilities are afforded for students desirous of becoming practically acquainted with the tests for poisonous substances, and the processes for separating these from organic mixtures.

INSANITY.

A course of Lectures is given on Wednesdays, at 12 noon, during the Summer Session, and Clinical Instruction at the Asylum, Gartnavel, on Wednesdays, at 3 p.m.

DISEASES OF THE EYE.

A course of Lectures is given in the College on Tuesdays and Fridays, 4 to 5 p.m., during the Summer Session, and Clinical Instruction at the Eye Hospital, Charlotte Street, Mondays and Wednesdays, 1 to 3-30 p.m.

INFECTIOUS DISEASES.

A course of Clinical Instruction extending over six weeks is given at the City of Glasgow Fever Hospital, Belvidere.

HOSPITAL INSTRUCTION.

ROYAL INFIRMARY.

This Hospital contains 584 beds for medical and surgical patients, of which 110 are appropriated to the Clinical Instruction of women students only. There is also a largely attended out-patient department, besides special cliniques for ear, throat, eye, etc.

Students of this School have exceptional facilities for clinical study in wards set apart for their instruction. Dr. Wallace Anderson, the Lecturer on Medicine, has fifty beds under his charge, which provide ample material for clinical medical tuition. A number of clinical clerks are selected from among the senior students, who observe and report on special cases. At the daily visit the students are familiarised with all the cases which present themselves, and in addition Dr. Anderson gives two special clinical Lectures every week. Tutorial classes are also conducted by Dr. Scott Macgregor.

On the surgical side, Dr. Fleming has under his care sixty

beds, which afford ample opportunities of Dressing to a large number of students. The Dressers assist at all the numerous operations performed in a theatre attached to the wards and reserved for them alone. In this theatre also are given the clinical Lectures. Dr. H. Rutherfurd, Clinical Assistant, and the House-Surgeon conduct classes of bandaging and minor surgery.

The splendid pathological museum of the Hospital, under the direction of the curator, Dr. Lindsay Steven, is largely drawn upon for illustration, and is open to the students for purposes of study.

GRADUATION IN MEDICINE AND SURGERY.

The Degrees in Medicine and Surgery conferred by this University are all recognised by the Medical Acts as qualifying for practice throughout the British dominions, and for admission to the Army,

Navy, and Public Medical Service.

Every student who began his medical studies previous to 1st January, 1892, is entitled to graduate under the system in force before or after that date, according as he shall comply with the regulations in force in the University before or after that date. All others must fulfil the requirements of the new Ordinance—(Ordinance No. 14, Glasgow No. 1, Regulations for Degrees in Medicine)—the principal provisions of which are as follows:—

I. Four degrees in Medicine and Surgery are conferred by the University of Glasgow, viz., Bachelor of Medicine (M.B.), Bachelor of Surgery

(Ch.B.), Doctor of Medicine (M.D.), and Master of Surgery (Ch.M.). The degree of Bachelor of Surgery shall not be conferred on any person who does not at the same time obtain the degree of Bachelor of Medicine, and the degree of Bachelor of Medicine shall not be conferred on any person who does not at the same time obtain the degree of Bachelor of Surgery.

II. Subject to regulations to be made from time to time by the University Court, the University may also confer diplomas in Special Branches of Medical and Surgical Practice on graduates of the University

in Medicine and Surgery.

III. Before commencing his medical studies, each student must pass a preliminary examination in (1) English, (2) Latin, (3) Elementary Mathematics, and (4) Greek or French or German: provided always that, in the case of a candidate whose native language is not English, an examination in the native language of the candidate may be substituted for one in either French or German, and an examination in any other classical language for one in Latin or Greek.2

IV. The extent and standard of the preliminary examination shall be determined by the Joint Board of Examiners constituted under Ordinance, General, No. 8-[Regulations as to Examinations]—in accordance

with the terms of that Ordinance.

Under this Section the Joint Board have determined that for the Medical Preliminary Examination in October, 1893, the papers set in Latin, Greek, and Mathematics, shall be the same as those set on the lower standard in these subjects in the Arts Preliminary Examination; and that the papers set in English, French, and German, shall be of a lower standard than those set in these subjects in the Preliminary Examination in Arts. A candidate for the Medical Preliminary may take the papers set on the higher standard for the Arts Preliminary in any of the subjects, and if he obtains a satisfactory percentage of marks, he shall be held to have passed the Medical Preliminary in these

V. The preliminary examination is conducted in accordance with the provisions of Ordinance, General, No. 8—[Regulations as to Examinations] - and, subject to the provisions of the immediately succeeding section hereof, the entire examination must be passed at one and the

VI. A degree in Arts, or in Science (not being a degree honoris causa tantum), in any of the Universities of the United Kingdom, or in any

A Local Centre in connection with this Examination has been established in the University College of North Wales, Bangor. Candidates who prefer to sit for examination there must intimate their desire when returning schedule of entry to Glasgow. Such Candidates are required, on taking their seats at Bangor, to pay to the College Authorities there a special fee of 5s. This is in addition to the ordinary fee, payable at Glasgow, as mentioned at page 124 of University Calendar.

examinations are held simultaneously in Bangor and Glasgow.

The candidate for the Degrees of Bachelor of Medicine and Bachelor of Surgery must have been registered in the books of the General Medical Council at least five years prior to the date of his graduation. In order to be so registered he must transmit to James Robertson, Esq., the Scottish Branch Registrar, 1 George Square, Edinburgh, together with a printed form of application, which may be obtained from the Assistant-Clerk (Matriculation Office), a certificate of having passed the Preliminary Examination.

Colonial or Foreign University specially recognised for the purpose by the University Court, shall exempt from the preliminary examination; and the Joint Board of Examiners appointed under the provisions of Ordinance, General, No. 8—[Regulations as to Examinations]—shall have power to determine what examinations, other than those for the degrees hereinbefore mentioned, shall be accepted, either in whole or in

part, in place of the preliminary examination.

Under this Section the Joint Board have determined:—(a) to accept such Certificates as may have been obtained previous to October, 1892, as equivalent to the Preliminary Examination in Medicine for October, 1893, provided that such Certificates would have been accepted for this purpose under the regulations in force at this University in October, 1892; (b) to accept the Leaving Certificates of the Scotch Education Department in any Grade, whether obtained this year or at an earlier date as equivalent to the Preliminary Examination in Medicine in October, 1893; and (c) to accept the Examinations of certain Universities and Colleges as equivalent to the Preliminary Examination in Medicine in October, 1893, and thereafter, provided always that the regulations of the General Medical Council regarding the registration of students of Medicine be complied with. A list of these Examinations will be found in Appendix, page 40.

PROFESSIONAL EDUCATION.

VII. Candidates shall be admitted to the degree of Bachelor of Medicine and Bachelor of Surgery only after they have fulfilled the following conditions:—

- The candidate must have been engaged in medical study for at least five years.
- 2. In each of the first four years the candidate must have attended at least two courses of instruction, in one or more of the subjects of study specified in Sub-section 4 hereof—each course extending over a session of not less than five months, either continuous or divided into two terms; or, alternatively, one such course, along with two courses, each extending over a session of not less than two and a half months.
- 3. During the fifth or final year the candidate shall be engaged in clinical study for at least nine months at one or more of such public hospitals or dispensaries, British or Foreign, as may be recognised for the purpose by the University Court.
- 4. The candidate must, during his curriculum, have attended a course or courses of instruction in each of the following subjects of study, including such examinations as may be prescribed in the various classes, viz.:—
- 1. Anatomy, - - { During a course of not less than five months. }

Provided always, in so far as regards the University of Glasgow, that -

(a) It shall be the duty of the Senatus to determine from time to time the number of meetings of which such courses shall consist, and in what cases two half courses shall be deemed equivalent to a full course; and to report the determination to the University Court for its approval.

(b) It shall be the duty of the Professors and Lecturers to submit to the Senatus annually at the end of the winter session a scheme specifying what proportion of the courses shall be devoted to lectures, practical demonstrations, examinations, and tutorial work respectively. The Senatus shall transmit such scheme, with such observations as it may think fit to make thereon, to the University Court for its approval.

(c) The University Court shall not grant or continue recognition to any institutions or teachers unless it shall be satisfied that their courses of instruction are equivalent to the courses sanctioned in the Universities of Scotland.

5. The candidate must have attended for at least three years the Medical and Surgical Practice of a General Hospital at Glasgow or elsewhere, which accommodates not fewer than eighty patients, and possesses a distinct staff of physicians and surgeons, and is recognised for the purpose by the University Court.¹

1 On 7th October, 1892, the University Court recognised every General Hospital in the United Kingdom which accommodates not fewer than eighty patients, and possesses a distinct staff of physicians and surgeons.

6. The candidate must have attended Clinical Surgery during a course or courses extending over not less than nine months. These courses may be conducted by the Professor of Clinical Surgery, or by Professors or Lecturers appointed for the purpose by the University Court, or by the ordinary surgeons of a general hospital defined and recognised as hereinbefore provided, and shall consist of regular instruction at the bedside, along with Clinical Lectures.

7. The candidate must have attended Clinical Medicine during a course or courses extending over not less than nine months. These courses may be conducted by the Professor of Clinical Medicine or by Professors or Lecturers appointed for the purpose by the University Court, or by the ordinary physicians of a general hospital defined and recognised as hereinbefore provided, and shall consist of regular instruction at the bedside, along with Clinical Lectures.

8. The candidate must have attended a course of instruction in Mental Diseases of such duration, and so apportioned between lectures, demonstrations, and clinical instruction, as the Senatus, with the approval of the University Court, may from time to time determine.

9. The candidate must have attended a course of twenty-five meetings on Practical Pharmacy in a University or recognised School of Medicine, or have dispensed drugs for a period of three months in an hospital or dispensary, or in an establishment recognised by

the Pharmaceutical Society.

10. The candidate must have attended, for at least six months, by apprenticeship or otherwise, the out-practice of an hospital, or the practice of a dispensary, or of a physician or surgeon, or of a member of the London or Dublin Society of Apothecaries. He must have acted as clerk in the medical and dresser in the surgical wards of a public hospital; and must also have availed himself, to such an extent as may be required by the Senatus, with the approval of the University Court, of opportunities of studying, at an hospital or dispensary, Post-mortem Examinations, Fevers, Diseases of Children, Ophthalmology, or such other special departments as may from time to time be determined.

11. The candidate must have attended, under the superintendence of a registered medical practitioner, twelve cases of labour, or such additional number as the Senatus, with the sanction of the University Court, may from time to time determine; or have attended for three months the practice of a lying-in hospital, or of the maternity department of a general hospital or other public charitable institution, and have conducted personally six, or such an additional number of cases of labour as the Senatus, with the approval of the University Court, may from time to time deter-

mine

12. The candidate must have been properly instructed in Vaccination at a Public Vaccination Station, by a Public Vaccinator, authorised by the proper Government Authority to grant Certificates of Proficiency in Vaccination. 1

1 The recognized Vaccine Departments in Glasgow are--Western Infirmary, Royal Infirmary, and Faculty of Physicians and Surgeons.

13. No candidate for a degree shall be deemed to have attended a class as part of the Curriculum necessary for that degree who does not present a certificate bearing not only that he has given regular attendance, but also that he has duly performed the work of the class.

VIII. With respect to the Places and Institutions at which the studies of the Candidate may be prosecuted, the following Regulations shall have effect:—

1. Two of the five years of medical study must be spent in the University of Glasgow, each year of study including always the

attendances specified in Section VII., Sub-section 2.

The remaining three years may be spent in any University of the United Kingdom, or in any Indian, Colonial, or Foreign University recognised for the purpose by the University Court, or in such Medical Schools or under such Teachers as may be recognised for the purpose by the University Court, each year of study during the first four years including always the attendances speci-

fied in Section VII., Sub-section 2.

3. Of the subjects of study specified in Section VII., Sub-section 4, not less than eight must be taken in the University of Glasgow, or (subject always to the provisions as to attendance contained in the immediately preceding sub-sections) in some other University of the United Kingdom, or in some Foreign or Colonial University entitled to confer the Degree of Doctor of Medicine recognised for the purpose by the University Court, or in a College incorporated with, or affiliated to a University entitled to confer the Degree of Doctor of Medicine recognised for the purpose by the University Court: Provided always that where in any of said subjects of study two or more courses are required, the taking of one of those courses shall constitute a taking of the subject for the purpose of this sub-section.

4. The remainder of such subjects of study may (subject always as aforesaid) be taken in such Medical Schools or under such Teachers as may be recognised for the purpose by the University

Court

5. All Candidates, not Matriculated Students of the University, availing themselves of the permission to attend the Lectures of Extra-Academical Teachers in Glasgow, must, at the commencement of each year of such attendance, enrol their names in a book to be kept in the University for that purpose, paying a Fee of the same amount as the Matriculation Fee paid by Students of the University, and having, in respect of such payment, a right to the use of the Library of the University.

6. The Fee for attendance, for purposes of graduation, on the courses of instruction of recognised Extra-Academical Teachers in Glasgow, shall be not less than the amount exigible for the

corresponding courses in the University.

7. The University Court shall not recognise as qualifying for examination in any of the subjects specified in Section VII., Subsection 4, the class of any teacher who is at the time a teacher of more than one of the said subjects, except in those cases where

Professors in the University are at liberty to teach two subjects:

—Provided always that a Professor or other teacher in any endowed public College or Institution, who by the terms of his appointment is required to teach more than one subject of Medical Study therein, may be recognised under sub-section 2 of this section, as a teacher of any one of the subjects which he teaches.

8. A teacher, attendance on whose course of instruction shall, before the date of the approval of this Ordinance by Her Majesty in Council, have been recognised for the purposes of graduation in the University, shall not require to obtain a new recognition from the University Court; and attendance on the course of instruction of every such teacher may continue to be recognised as heretofore.

9. It shall be in the power of the University Court, if it shall see cause, at any time to withdraw or suspend any recognition which

it may have granted.

IX. In the University of Glasgow it shall be the duty of the Professors of the subjects specified in Section VII., Sub-section 4 hereof (except Practical Anatomy and such other subjects as the Senatus, with the approval of the University Court, may from time to time determine), so to conduct the courses that Students may receive instruction sufficient for graduation in any one of the said subjects by attendance on one course of tive or six months, or of two and a half or three months, as the case may be.

X. If any candidate shall, before presenting himself for his Preliminary Examination, have attended in any University of the United Kingdom, or in any University or Institution specially approved, or under any Teacher specially recognised for the purpose by the University Court, a course or courses of instruction in Physics, Chemistry, Botany, or Zoology, equivalent in the judgment of the Senatus to the qualifying course in the same subject in the University of Glasgow, such attendance shall (notwithstanding anything hereinbefore ordained) be held as entitling him to be examined in these subjects; and if the candidate shall have attended such course or courses in each of the said subjects, he shall be held to have completed his first year of Medical Study: Provided always that the evidence of such attendance at such equivalent course or courses shall be presented to the Senatus at the time when the candidate presents himself for his Preliminary Examination; and the Senatus shall, if satisfied, grant a certificate to that effect.

PROFESSIONAL EXAMINATION FOR THE DEGREES OF BACHELOR OF MEDICINE AND BACHELOR OF SURGERY.¹

XI. Each candidate shall be examined both in writing and orally, and also clinically where the nature of the subject admits, in the following divisors, viz.:—First, in Botany, Zoology, Physics, and Chemistry; Second, in Anatomy, Physiology, and Materia Medica and Therapeutics; Third, in Pathology and Medical Jurisprudence and Public Health;

Fourth, in Surgery and Clinical Surgery, Practice of Medicine and Clinical Medicine, and Midwifery.

In subjects which admit of practical instruction, the examination shall be such as to test the practical acquirements of the candidate.

Provided always that if a candidate have obtained in a University of the United Kingdom, or other University specially recognised for the purpose by the University Court, a Degree in Science or in Arts, granted in either case after a course of study and an examination in Botany, Zoology, Physics, and Chemistry, he shall be held to have passed his examinations in the said subjects.

XII. Candidates who profess themselves ready to submit to an examination in the subjects comprised in the first division, viz.:—Botany, Zoology, Physics, and Chemistry, may be admitted to examination in all or any two of these subjects at any examination held after they have attended a full course in each of the subjects professed.

XIII. Candidates who have passed their examinations in the subjects comprised in the first division may be admitted to examination in the second division at the end of the third winter session.

Provided that candidates who so desire may postpone their examination in Materia Medica and Therapeutics until the close of the summer session following.

XIV. Candidates who have passed their examinations in the subjects comprised in the first and second divisions may be admitted to examination in the third division at the end of the fourth winter session.

Provided that candidates who so desire may postpone their examination in Medical Jurisprudence and Public Health until the close of the summer session following.

XV. Candidates who have passed their examinations in the subjects comprised in the first, second, and third divisions may be admitted to examination in the fourth or final division, when they have completed

XVI. If any candidate at these examinations be found unqualified in one or more subjects he shall not again be admitted to examination unless he has pursued his medical studies for such time, and subject to such conditions, as the Faculty of Medicine may prescribe.

XVII. If any candidate at these examinations be found to have passed in one or more subjects with sufficient merit, he shall not be liable to re-examination in such subject or subjects, although he may have been found unqualified in a subject or subjects comprised in the same division as hereinbefore specified.

XVIII. Every candidate must deliver, on or before such day as the Senatus may from time to time determine, to the Dean of the Faculty of Medicine, a declaration, in his own handwriting, that he has completed his twenty-first year, or that he will have completed it on or before the day of graduation, and that he will not be, on the day of graduation, under articles of apprenticeship to any surgeon or other master.

XIX. After the candidate has satisfied the Examiners, the Dean of the Faculty of Medicine shall lay the proceedings before the Senatus, by whose authority the candidate shall be admitted, on such day as the Senatus may from time to time appoint, to the Degrees of Bachelor of Medicine and Bachelor of Surgery, on payment of the required fees.¹

XX. Candidates for graduation shall produce evidence of their having conformed to the Regulations which were in force at the time they commenced their Medical Studies, except in so far as is provided in Section XXV. hereof (see *University Calendar*).

PROFESSIONAL EXAMINATION FOR THE DEGREE OF DOCTOR OF MEDICINE.

XXI. 1. Subject to the conditions hereinafter specified, the Degree of Doctor of Medicine shall be conferred on any candidate who has obtained the Degrees of Bachelor of Medicine and Bachelor of Surgery of the University of Glasgow, and is of the age of twenty-four years or upwards, and has produced a certificate of having been engaged subsequently to having received the Degrees of Bachelor of Medicine and Bachelor of Surgery for at least one year in attendance in the Medical Wards of an Hospital, or in scientific work bearing directly on his profession, such as is conducted in the Research Laboratories of the University, or in the Military or Naval Medical Services, or for at least two years in Practice other than Practice restricted to Surgery.

2. Each candidate for the Degree of Doctor of Medicine shall be required to pass an examination in Clinical Medicine and in such of its special departments as the Senatus, with the approval of the University Court, by Regulations framed from time to time, shall determine; and he may present himself for examination in Clinical Medicine at any period of examination subsequent to one year after he has received the Degrees of Bachelor of Medicine

and Bachelor of Surgery.

3. Each candidate for the Degree of Doctor of Medicine shall submit for the approval of the Faculty of Medicine a Thesis on any branch of knowledge comprised in the second, third, or fourth examinations for the Degrees of Bachelor of Medicine and Bachelor of Surgery, which he may have made a subject of study after having received those Degrees, excepting subjects which are exclusively Surgical; and the Thesis, accompanied by a declaration signed by the candidate, that the work has been done and the Thesis composed by himself, shall be lodged with the Dean of the Faculty of Medicine on or before a date to be fixed by the Senatus.

4. A Bachelor of Medicine and Bachelor of Surgery, who produces to the Senatus satisfactory evidence of his intention of entering within twelve months after obtaining such degrees on the practice of his profession in a British Possession or Colony, or in a foreign Country, may, under Regulations to be framed by the Senatus, be admitted to the examination in Clinical Medicine at any period of examination after he has received such Degrees; but the Degree of Doctor of Medicine shall not be conferred on him unless he shall produce a certificate that, subsequently to having received the Degrees of Bachelor of Medicine and Bachelor of Surgery, he has been engaged for at least one year in

attendance in the Medical Wards of an Hospital, or in scientific work bearing directly on his profession, such as is conducted in the Research Laboratories of the University, or in the Naval or Military Medical Services, or for at least two years in Practice which has not been exclusively surgical, and unless his Thesis in the judgment of the Faculty of Medicine is of exceptional merit.

PROFESSIONAL EXAMINATION FOR DEGREE OF MASTER OF SURGERY.

XXII. 1. Subject to the conditions hereinafter specified the Degree of Master of Surgery shall be conferred on any candidate who has obtained the Degrees of Bachelor of Medicine and Bachelor of Surgery of the University of Glasgow, and is of the age of twenty-four years or upwards, and has produced a certificate of having been engaged, subsequently to his having received the Degrees of Bachelor of Medicine and Bachelor of Surgery, for at least one year in attendance in the Surgical Wards of an Hospital, or in scientific work bearing directly on his profession, such as is conducted in the Research Laboratories of the University, or in the Military or Naval Medical Services, or for at least two years in practice other than practice restricted to Medicine.

2. Each candidate for the Degree of Master of Surgery shall be required to pass an examination in the following subjects:— Surgical Anatomy, Operations upon the dead body, and Clinical Surgery, and in such of the special departments of Clinical Surgery as the Senatus, with the approval of the University Court, by Regulations framed from time to time, may determine; and he may present himself for examination in these subjects at any period of examination subsequent to one year after he has received the Degrees of Bachelor of Medicine and Bachelor of

Surgery.

3. Each candidate for the Degree of Master of Surgery shall submit, for the approval of the Faculty of Medicine, a Thesis on any branch of knowledge comprised in the second, third, or fourth Examinations for the Degrees of Bachelor of Medicine and Bachelor of Surgery, which he may have made a subject of study after having received those Degrees, excepting subjects that are exclusively medical; and the Thesis, accompanied by a declaration signed by the candidate that the work has been done and the Thesis composed by himself, shall be lodged with the Dean of the Faculty of Medicine on or before a date to be fixed by the Senatus.

4. A Bachelor of Medicine and Bachelor of Surgery who produces to the Senatus satisfactory evidence of his intention of entering, within twelve months after obtaining such degrees, on the practice of his profession in a British Possession or Colony, or in a foreign Country, may, under Regulations to be framed by the Senatus, be admitted to examination in the subjects specified in Sub-section 2 of this Section, at any period of examination after he has received such Degrees; but the Degree of Master of Surgery shall not be conferred on him unless he shall produce a certificate that, subsequently to having received the Degrees of

Bachelor of Medicine and Bachelor of Surgery, he has been engaged for at least one year in attendance in the Surgical Wards of an Hospital, or in scientific work bearing directly on his profession, such as is conducted in the Research Laboratories of the University, or in the Naval or Military Medical Services, or for at least two years in practice which has not been exclusively medical, and unless his Thesis in the judgment of the Faculty of Medicine is of exceptional merit.

FEES.

XXIII. The fee to be paid for the Degrees of Bachelor of Medicine and Bachelor of Surgery shall be twenty-two guineas, and the proportion of this sum to be paid by a candidate at each division of the examination shall be regulated from time to time by the University Court. The fee to be paid for the Degree of Doctor of Medicine shall be ten guineas, exclusive of any stamp duty which for the time may be exigible. The fee to be paid for the Degree of Master of Surgery shall be ten guineas.

EXAMINERS.

XXIV. The Examiners for graduation in Medicine in the University of Glasgow shall be the Professors in that University, together with such Lecturers in the University and such additional Examiners, to be appointed by the University Court, as the University Court shall deem necessary. Provided that the Court shall make such provisions as will ensure that every candidate shall be examined in each subject by at least two Examiners, of whom one shall not be a Professor or Lecturer in the University. The examinations shall be conducted in writing and orally and also clinically, when the nature of the subject admits, under regulations framed by the Senatus subject to the approval of the University Court.

APPENDIX.

NEW REGULATIONS FOR PRELIMINARY EXAMINATION FOR DEGREES IN MEDICINE AND REGISTRATION OF MEDICAL STUDENTS BY THE GENERAL COUNCIL.

No person shall be allowed to be registered as a Medical Student unless he or she shall have previously passed a Preliminary Examination in the subjects of General Education as hereafter specified:—

PRELIMINARY EXAMINATION FOR DEGREES IN MEDICINE.

In pursuance of resolutions passed by the Joint Board of Examiners created by Ordinance No. 13, General No. 8, of the Commissioners under the Universities (Scotland) Act, 1889, the following arrangements have been made for the Examinations in September—October, 1893.

SUBJECTS OF EXAMINATION.

- 1. English, including Grammar, Composition, Literature, Geography, and History.
 - (A) Grammar will include Analysis, Parsing, Derivation, and Correction of Sentences.
 - (B) Composition will include an Essay and Paraphrasing.
 - (c) Literature will include a general knowledge of the life and works of the greater writers, and a more special knowledge of Shakespeare's "Macbeth" and "As You Like It," and Scott's "Antiquary" and "Old Mortality." 1

¹ For April and October, 1894, the special subjects will be Shakespeare's "Merchant of Venice" and Scott's "Kenilworth."

- (D) Geography will include a general knowledge of the Geography of the World, and a special knowledge of the Geography of the British Empire.
- (E) History will include a knowledge of the Outlines of the History of both England and Scotland to the Accession of James VI.¹
- N.B.—The papers set in English will be of a lower standard than those set in the Arts Preliminary Examination.
- 2. Latin, comprising Grammatical Questions, Translation into English from Latin Authors not previously prescribed, and Translation of plain passages or easy sentences from English into Latin.
- N.B.—The papers set in Latin will be the same as those set on the Lower Standard in the Arts Preliminary Examination.
- 3. Mathematics, comprising (1) Arithmetic, including Vulgar and Decimal Fractions, Proportion, Percentage, Square Root, Simple Interest; (2) Algebra, including Fractions, Factors, Square Root, Equations of the First Degree, Simultaneous Equations of the First Degree, Easy Quadratic Equations, Problems leading to the above Equations; (3) Geometry—Euclid, Books I., II., and III. (or their equivalents), with easy deductions. Demonstrations other than Euclid's will be accepted if they assume no propositions which in Euclid's order are subsequent to the proposition under consideration.
- N.B.—The papers set in Mathematics will be the same as those set on the Lower Standard in the Arts Preliminary Examination.
 - 4. One of the following Subjects :-
 - (A) Greek, comprising Grammatical Questions, Translation into English from Greek Authors not previously prescribed, and Translation of plain passages or easy sentences from English into Greek.
- N.B.—The papers set in Greek will be the same as those set on the Lower Standard in the Arts Preliminary Examination.

¹ For April and October, 1894—From the accession of James VI. to the union of the kingdoms.

- (B) French, comprising Questions in Grammar, Translations, a piece of English for translation, and some short sentences.
- N.B.—The papers set in French will be of a lower standard than those set in the Arts Preliminary Examination.
 - (c) German, comprising Questions in Grammar, Translations, a piece of English for translation, and some short sentences.
- N.B.—The papers set in German will be of a lower standard than those set in the Arts Preliminary Examination.

It will be in the option of any Candidate for the Medical Preliminary to take the papers set on the higher standard for the Arts Preliminary in any of the subjects.

Excellence in one or more subjects will be permitted to compensate in some measure for deficiency in any of the other subjects. Such excellence may be shown either by attaining a high percentage of marks on the lower standard, or by passing on the higher standard.

Candidates who, having taken English, Latin, Greek, Mathematics, or a modern language, on the higher standard, as prescribed by the Arts Ordinance for the Arts Preliminary, have obtained a satisfactory percentage of marks, shall be held to have passed the Medical Preliminary in these subjects.

Candidates are requested specially to note-

- (1) THAT THE ENTIRE EXAMINATION MUST BE PASSED AT ONE AND THE SAME TIME.
- (2) THAT THE EXAMINATIONS IN LATIN, GREEK, FRENCH, AND GERMAN, WILL BE WHOLLY ON "UNSEEN" BOOKS, NO SPECIAL AUTHORS HAVING BEEN PRESCRIBED BY THE JOINT BOARD.

The Examinations will take place as follows:-

SATURDAY, 30th SEPTEMBER.

Latin (1st paper), - - - 10 a.m. to 12 noon.

Latin (2nd paper), - - - 1 to 3 p.m.

Latin (3rd paper), - - - 3.30 to 4.30 p.m.

Monday, 2nd October.

Mathematics, - - - 10 a.m. to 1 p.m.

TUESDAY, 3rd OCTOBER.

English (1st paper), - - - 10 a.m. to 12 noon.

English (2nd paper), - - - 1 to 3 p.m.

French, - - - - 3 to 6 p.m.

WEDNESDAY, 4th OCTOBER.

Greek (1st paper), - - - 10 a.m. to 12 noon. Greek (2nd paper), - - - 12.30 to 2.30 p.m.

THURSDAY, 5th OCTOBER.

German, - - - - 12 noon to 3 p.m.

The Fee for the Examination is 10s. 6d., payable on each occasion of entering. Forms of Application for admission to the Examinations may be had, after 1st September, from Mr. W. Innes Addison, Assistant Clerk, Matriculation Office, or from Miss Galloway, Hon. Secretary, Queen Margaret College. The Last day for Receiving Names is 14th September, 1893.

The results will not be known till, at earliest, 15th October.

For the Examination in September—October, 1893, the following Examinations will be accepted, provided that the entire subjects required have been passed at one and the same time:—

Oxford.—Responsions; Moderations.

Cambridge.—Previous Examination; Oxford and Cambridge Schools' Examinations.

London. —Matriculation Examination of the University of London.

Dublin, Trinity College.—Public Entrance Examination.

ROYAL UNIVERSITY OF IRELAND.—Entrance Examination.

VICTORIA UNIVERSITY.—The Preliminary Examination; the Entrance Examination in Arts.

Under the same proviso, the Examinations of Indian, Colonial, and Foreign Universities and Colleges accepted by the General Medical Council will also be accepted.

By Section VI. of the Medical Ordinance, it is provided that a degree in Arts, or in Science (not being a degree honoris causa tantum), in any of the Universities of the United Kingdom, or in any Colonial or Foreign University specially recognised for the purpose by the University Court, shall exempt from the Preliminary Examination.

OLD REGULATIONS.

Students who were registered in the Books of the General Medical Council prior to 1st January, 1892, as well as Medical Graduates, who have still to pass in an Optional subject, will be examined under the Old Regulations. The following are the subjects:—

- 1. Greek.—Xenophon, *Anabasis*, Book IV., and the Gospel according to St. Luke. Translation of passages from works not prescribed, and of English passages into Greek—the principal Greek words being supplied. Questions on Grammar.
- 2. French.—Racine's Athalie (Hachette's French Classics). Translation and exercises as in Greek.
- 3. German.—Schiller's Jungfrau von Orleans. Translation and exercises as in the other languages.
- 4. Higher Mathematics.—Euclid, Books I. to VI.; Algebra, including Quadratic Equations, and the Rudiments of Trigonometry.
- 5. NATURAL PHILOSOPHY.—Everett's Elementary Text-Book of Physics (Chapters on Sound and Heat), or Part II. of Todhunter's Natural Philosophy for Beginners, viz., Sound and Heat, omitting chapters xii. xiii. in Sound, and in Heat from sec. 732 to 746.
- 6. Logic.—Jevons' Elementary Lessons on Logic.
- 7. Moral Philosophy.—Herbert Spencer's Data of Ethics.

The dates for these Examinations under Old Regulations will be afterwards announced.

By the regulations of the General Medical Council no period of study taken more than fifteen days before registration can be recognised. The Registrar for Scotland is—Mr. James Robertson, Solicitor, 1 George Square, Edinburgh.

A student who wishes to prepare for the degrees of the University of London, or the Royal University of Ireland, must pass the Matriculation Examination of the University she selects; or, of Victoria University the Entrance Examination in Arts. The regulations for these Examinations may be had, for London, from the

Registrar, University of London, Burlington Gardens, London, W.; Examination Fee, £2; dates of Examination, January and June; for the Victoria University, from the Registrar, Victoria University, Manchester; Examination Fee, £1; date of Examination, June and September; for the Royal University of Ireland, at 25 Upper Merrion St., Dublin; Examination Fee, 10s.; date of Examination, October; for the Triple Qualification of the Scottish Corporations, Alex. Duncan, B.A., Faculty Hall, 242 St. Vincent St., Glasgow; Fee, 10s.; dates of Examination, March and July; in Edinburgh, January, March, July, October.
