


I HAVE known Dr. JAMES HUNTER since he was a lad, and have the highest opinion of him professionally, morally, and socially.


I may mention that the pauper lunacy of these parishes has been returned to me as General Superintendent of Poor at the large number of forty-seven.


I HAVE much pleasure in strongly recommending Dr. James Hunter for the appointment of Deputy Commissioner in Lunacy.
