## A List of Symptoms which arise from a disordered State of the Nerves, but not Gouty.

W IND in the flomach and inteffines, heart-burning, four belchings, fqueamifhnefs, and vomiting of watery fluff; tough phlegm, or a black liquor like the grounds of coffee; want of appetite and uncommon craving for food, and indigeftion or debility; faintnefs and fenfe of great emptinefs about the flomach when hungry; a flrong defire for rare and uncommon forts of food, or for things that can afford no nourifhment; a vifible fwelling or inflammation of the flomach, efpecially after eating; fometimes with cramps in that vifcus; an opprefion about the præcordia; an uneafy tho' not painful fenfation about the flomach; attended with low fpirits, anxiety and fcmetimes great timidity;

timidity; ftrong pulfations within the belly; fpafms in the bowels and diffensions of feveral portions of them; violent colic pains; a rumbling noife from wind paffing through the inteffines; the body fometimes too lax, oftner bound; pains in the back and belly, refembling those of the nephiritic kind; a fenfe of irritation and heat in the neck of the bladder and urethra, with a frequent defire to make water; a great discharge of limpid urine, at other times a frequent fpitting. Sudden flushes of heat over the whole body; fhiverings, a sense of cold in certain parts, as if water was poured on them; at other times an unufual glow; flying pains in the arms and limbs; a troublefome pain in the back and between the fhoulders ; pains, attended with hot fenfation, fhifting, often from the fides or back to the interior parts of the abdomen; cramps, or convulfive motions of the muscles, or of a few of their fibres; fudden startings of the legs and arms; almost constant involuntary motions of the muscles of the neck and head, or arms and legs; a general convultion, affecting at once the ftomach, bowels, throat, legs, arms, and indeed almost the whole members of the body, in which the patient ftruggles as in a violent epileptic fit; long faintings, in fome cafes following one another after flort intervals; palpitations or trembling of the heart; the pulfe very variable, frequently natural; fometimes uncommonly flow, at other times quick; oftener fmall than full, and on certain occafions irregular and intermitting; a dry cough, with difficulty of breathing with a conftriction of the lungs, fometimes returning periodically, yawning, the hiccup, frequent fighings and a fenfe of fuffocation as if from a ball or lump in the throat; fits of crying and convulfive laughing ; although in the day time the patients are more generally pretty cool, and the

the pulle fometimes flower than natural, yet in the night, efpecially in the time of fleep, hot flufhings often fpread over the whole body; the pulle becomes quicker and ftronger, and a faintnefs or fome degree of ficknefs at the ftomach is felt.

A giddinefs, especially after rifing up haftily; pains in the head fometimes returning periodically; a violent pain in a fmall part of the head, not larger than a shilling, as if a nail was driven into it; finging in the ears; a dimnefs of fight and appearance of a thick mift, without any visible fault of the eyes. Objects are fometimes feen double, and unufual fmells are perceived; obftinate watchings, attended fometimes with uneafinefs which is not to be defcribed. but which is leffened by getting out of bed; diffurbed fleep; frightful dreams; the night-mare; fometimes drowfinels and too great inclination to fleep, fear, peevifhnels, fadnels, defpair; at other times high fpirits; wandering thoughts, impaired' memory, ridiculous fancies; ftrange perfusions of their labouring under difeafes of which they are quite free, and imagining their complaints to be as dangerous as they find them tronblefome; they are often angry with those who would convince them of their mistake.

Patients, after having been long afflicted with many of these symptoms (for all of them never happened to any one perfon) fometimes fall into melancholly, madness, the black jaundice, a dropfy, tympany, confumption, palfy, apoplexy, or fome other fatal diftemper.

## Symptoms imputed to irregular and wandering Gout.

Flying pains, spafmodic contraction, and fudden fenfations of heat and cold, in the muscles and exteriour parts of the body. A want of appetite and two great craving ving and faintness: a nausea or vomiting, flatulent swellings, rumbling in the bowels, watching, low fpirits, cramps, convultions, and violent pains in the ftomach and bowels. An increased secretion of falvia, from an irritation of the veffels of the falivary glands; a ball of wind in the throat; a spasmodic asthma in the lungs; palpitations and irregular motions in the heart; an exceffive flow of pale urine, or fometimes nephritic pains in the kidneys; a hemicrania or pain in one half of the head; the calvus hystericus, or shooting pains in the head. Befides these, I have seen many other symptoms occasioned by an imperfect or an irregular gout; fuch as delirium or mania; an inflammation in one of the tonfils of the throat; a troublesome dyfuria, or frequent defire to make water; a violent itching between the toes ; a fevere pain about the cartilago enfiformis, or breaft bone, returning twice or thrice a day, especially upon any ftrong affection of the mind or effort of the body, and fometimes attended with a painful fenfation in the middle of each arm; a fenfe of burning heat over the furface of the body, except the legs, while in the mean time the fkin was fcarcely fenfibly hotter than in a ftate of health, and the pulfe was under eighty in a miuute. In one patient I met with a flight, but frequent returning gonorrhæa, from a gouty humour falling in the veffels of the urethra; and in an other, an uneafy itching of the fcrotum. I have feen three cafes of a fharp pain in the tefficles, from the fame caufe. In one of these there was a confiderable fwelling along with the pain, both which went off upon the gout coming into both the feet.

All this is confirmed by obferving that perfons, who have been but little troubled before with these fymptoms, commonly called nervous, upon the rheumatic, or rather gouty gouty pains, leaving their feet, hands or loins, have been feized with an irregular intermitting pulfe, giddinefs, faintnefs, difficulty in breathing, naufea, vomiting, flatulency in the flomach and bowels, depression of spirits, and other fymptoms of the like kind.

Such complaints, if the patient has been subject to the gout, or has gouty relations, are justly imputed to the gouty matter leaving the extremities, and fixing on the head, or viscera of the breast or belly.
