

HELP US TO CARE FOR LONDON

Thousands of trained British Red Cross volunteers working through The London Branch's 47 permanent Centres support the statutory services in times of emergency and bring day-to-day help and comfort to people in their local communities.

The cost of maintaining these services is high; some £3 million of new money every year.

The Branch receives no subsidies for its work in London, and depends entirely upon the generosity of friends and wellwishers.

THE DEED OF COVENANT

Covenanted contributions (annual payments over four years or more) enable a Charity to recover Basic Rate Income Tax already paid on the sums covenanted so that the Charity receives a substantially greater amount than actually paid out of the donor's pocket. Thus, with tax at 25%, every £100 covenanted grosses £133.34 in British Red Cross funds, while any Higher-Rate tax can be reclaimed by the donors themselves.

To effect a covenant simply complete the form overleaf and send it (together with the accompanying Banker's Order, please) to the Appeals office at London Branch Headquarters.

LARGER GIFTS

Larger one-off gifts (£250 or more) qualify under the Gift Aid Scheme for tax recovery exactly as if they were covenanted.

BEQUESTS

Another way of helping British Red Cross is by remembering us in your Will.

The Society publishes a guide to Wills and Legacies, *The Most Precious Gift of All*, which contains a great deal of general advice and useful information on the subject, and this is obtainable free of charge from the Assistant Branch Director (Appeals) at London Branch Headquarters.

In the next column are forms of words which

would be appropriate to various types of Bequest. You may wish to discuss these with your Solicitor when making or updating your Will.

SUGGESTED FORM OF BEQUEST

"I bequeath to The London Branch of the British Red Cross Society of 28 Worple Road, Wimbledon, London SW19 4EE, the sum of £...... free of duty for the general purposes of the Branch, and I declare that the receipt of the Finance Director for the time being of the said Branch shall be a sufficient discharge for the same."

SUGGESTED FORM OF RESIDUARY BEQUEST

"I devise and bequeath all my real and personal property not otherwise disposed of by this my Will or any Codicil thereto subjects to and after payment of my debts and funeral and testamentary expenses to The London Branch of the British Red Cross Society of 28 Worple Road, Wimbledon, London SW19 4EE, for the general purposes of the said Branch, and I declare that the receipt of the Finance Director for the time being of the said Branch shall be a sufficient discharge for the same."

SUGGESTED FORM OF CODICIL

- (1) I bequeath to The London Branch of the British Red Cross Society of 28 Worple Road, Wimbledon, London SW19 4EE, the sum of £...... free of duty for the general purposes of the Branch, and I declare that the receipt of the Finance Director for the time being of the said Branch shall be a sufficient discharge for the same.
