GAYS AGAINST GENOCIDE

GAYS AGAINST GENOCIDE (GAG) are gay men living with HIV/AIDS and their friends, dedicated to the overthrow of individuals and organisations who have jeopardised our lives by suppressing facts about **WELLCOME's** failed drug **AZT**, for financial benefits and career advancement. **TERRENCE HIGGINS TRUST (THT)**, in its financial and political links with **WELLCOME** by acting as its marketing and PR company, betrayed people with HIV/AIDS who trusted information put out by THT and THT's **HELPLINE** to be impartial, not realising THT were pimping AZT for **WELLCOME**. THT is guilty of putting profits before people, thereby causing avoidable illness and death in people on AZT, especially in the light of the widely publicised failure of AZT in the **CONCORDE TRIAL**, and its abandonment by UK's leading doctors and the dumping of **WELLCOME** shares by the stock market.

The joint publication of four booklets by THT and **WELLCOME** was a shameless promotion of AZT to recently diagnosed people, in order to seduce them into taking AZT. A serious complaint was lodged with the **COMMITTEE ON SAFETY OF MEDICINES OF THE DEPT. OF HEALTH**, stating: *"We are particularly concerned about four claims and one omission in Wellcome's literature about AZT. These matters are very serious indeed, as we believe that Wellcome's 'Positive Benefits' brochure, and leaflets produced together with the Terrence Higgins Trust, should be withdrawn immediately whilst these matters are being investigated"*. The result was the arrogant refusal to THT to comply.

WELLCOME is now responsible for **ALL** medical data put out by THT, as stated in THT's March 1993 Newsletter: *"THT, along with the Wellcome Foundation, is about to begin producing an important new medical information series. THT are providing a series of medical updates for all staff and volunteers...Costs will be met by the Wellcome Foundation's Positive Action Initiative, which also funds our series of general booklets."*

THT HAVE PUBLICLY DECLARED THEMSELVES AS A MARKETING COMPANY FOR **WELLCOME**, PUSHING AZT IN RETURN FOR MONEY AND CAREER BENEFITS. THIS THREATENS OUR LIVES AS THEY HAVE SACRIFICED US AND LIED TO US ABOUT AZT THROUGHOUT, BY DENYING US ACCESS TO DATA PUBLISHED BY SCIENTISTS WORLDWIDE STATING: *"AZT IS AIDS BY PRESCRIPTION" (Prof Duesberg), "AZT IS INCOMPATIBLE WITH LIFE" (Dr Sonnabend), "I'm horrified by the use of AZT. Not just because it is toxic, but because the claims of efficacy are false. I can't see how this drug can be doing anything else other than making people very sick" (Dr Bialy, editor BIOTECHNOLOGY), "THE DECISION TO USE AZT IS AN ACCEPTANCE OF DEATH" (Dr Sonnabend), "IN AZT WE DO NOT HAVE THE RIGHT TOOL" (Dr Weller, UK Chief CONCORDE TRIAL), "AZT IS AIDS BY PRESCRIPTION" (Prof Duesberg).*

THT refused to reveal the reporting of **WELLCOME** to the **DEPT. OF HEALTH** in 1992 for *"breach of the Medicines Act 1968 by making false and misleading claims about the uses and effects of AZT"* by **CHANNEL 4's DISPATCHES "AZT: CAUSE FOR CONCERN"** TV documentary makers, or that in March 1993 *An Urgent Appeal For Action* was presented to **THE UN COMMISSION ON HUMAN RIGHTS** by **PROJECT AIDS INTERNATIONAL (US)** demanding the UN *"ban the use of AZT, DDI, and DDC, which have been falsely identified as 'antivirals', in treating HIV-positive persons who otherwise show no signs of clinical illness."* The major fraud reported to the UN is the recent disclosure that *"AZT IS 1000 TIMES MORE TOXIC TO HUMAN CELLS THAN WAS ORIGINALLY CLAIMED BY WELLCOME"*, and that *"IF ACTION IS NOT TAKEN IMMEDIATELY AGAINST THOSE WHO ARE DIRECTLY OR INDIRECTLY RESPONSIBLE FOR THESE CRIMES AGAINST HUMANITY (the promotion of AZT, DDI, AND DDC) THROUGH THE PRACTICE OF PROFIT OVER LIFE, THE DRUG-INDUCED AIDS DEATHS WILL, MOST CERTAINLY, REACH PROPORTIONS UNPARALLELED BY ANY NATURAL CATASTROPHE IN HUMAN HISTORY."*

SACK NICK THE SICK NOW

NICK PARTRIDGE, known within THT as 'Nick the Sick', is the man guilty of bringing THT into disrepute, forcing people with HIV/AIDS to demonstrate outside THT's offices to demand his immediate resignation and the resignation of all collaborators in THT's promotion of WELLCOME and AZT. His sickening Big Brother approach to people with HIV/AIDS and arselicking of WELLCOME finally resulted in his obtaining his goal of being THT's *CHIEF EXECUTIVE*. As CHAIRMAN of the AIDS BIBLE, NATIONAL AIDS MANUAL (NAM), and by the placement of pet THT employees/volunteers as employees of NAM and NAM TREATMENTS & TRIALS DIRECTORY, he extended his promotion of the interests of drug companies over that of people with HIV/AIDS. His links with THT workers EDWARD KING and PETER SCOTT, editors of NAM T&T Directory and NAM respectively, resulted in these directories being reduced to being advertising and promotional fanzines for drug companies to push their wares in, by the non-publication of data this Aids Mafia wanted suppressed.

GAG MAKE THE FOLLOWING DEMANDS:

- 1: ALL THT DIRECTORS, STAFF, AND VOLUNTEERS IMPLICATED IN RECEIVING BENEFITS IN CASH OR KIND FROM WELLCOME IN ORDER TO PROMOTE AZT BE REMOVED FROM THT IMMEDIATELY.**
- 2: PUBLICATIONS ENDORSING WELLCOME & AZT BE IMMEDIATELY RECALLED, REMOVED AND PULPED.**
- 3: THT GUARANTEES NEVER TO ACCEPT PATRONAGE FROM DRUG COMPANIES, AS THIS IS SEEN AS PROMOTING AND ENDORSING THEIR PRODUCTS.**
- 4: AN INDEPENDENT PUBLIC ENQUIRY, TO INCLUDE PEOPLE LIVING WITH HIV/AIDS, BE SET UP TO INVESTIGATE THT AND PARTRIDGE'S LINKS WITH WELLCOME, AND THE ROLE OF THT DIRECTORS, STAFF, AND VOLUNTEERS IN COMPLICITY IN HIS MALADMINISTRATION OF THT.**
