

An increasing number of children are growing up facing the reality of HIV and AIDS. As they get older they begin to ask questions, and want to be more involved. How can children be helped to participate when HIV continues to be surrounded by stigma and secrecy? This conference aims to help professionals to involve children in making decisions about their lives.

This event will also launch the new National Forum on AIDS and Children report on *Children's Rights and HIV*. All delegates will receive a complimentary copy.

## Children's Participation: Needs, Rights and Cultural Diversity

## 30 November 1995, The Oval, Kennington, London SE11

This year's annual World AIDS Day Conference will explore some practice-based solutions to the increasing challenges facing all those working with children affected by HIV and AIDS. It aims to give those attending the opportunity to assess how children's participation can be actively facilitated within different services. It examines the cultural, legal and professional factors which can either favour or inhibit the recognition of children's rights and needs.

The conference is in keeping with this year's general World AIDS Day theme of 'Shared rights, shared responsibilities'.

## **KEY DISCUSSION POINTS:**

**Health:** How can children be helped to make practical and informed decisions about clinical treatments and trials? What is good practice in informing consent to medical treatment?

Family placements: How can children be more involved in planning for their future? How can they be prepared for potential changes in family circumstances? Cultural diversity: How do different cultural and community perceptions of children's needs and rights affect their levels of involvement and allow for the promotion of these rights?

Dr Eric Chevallier, Divisional Director of Programmes on Children and HIV/AIDS, Centre Internationale de l'Enfance, will be presenting the keynote address, drawing on his extensive international experience to discuss child and family-centred approaches in HIV work. He is currently involved in establishing UNAIDS, the new Joint United Nations Programme on AIDS.

Directors and managers of social services and health authorities, GP's, health visitors, nurses, training officers, child care and youth workers, child psychologists and paediatricians, social workers, HIV workers, voluntary groups and all those involved with the care and provision of services for children and families affected by HIV/AIDS.
