CWAC

(Children With AIDS Charity)



CWAC has been set up to help the youngest of those infected and affected by HIV and AIDS. It is a new national charity with the simple aim of helping children and their families lead as near normal a life as possible.

Why is HIV/AIDS unique?

Often children infected with HIV have mums, dads or other family members who are also infected and they may all be very sick at the same time.

Families are affected by other people's attitudes and, sadly, society rarely looks kindly upon those with HIV or AIDS. Very often a child cannot even talk about what is wrong with them, or their brother or sister.

The number of infected children is rising and will continue to rise. The problem won't go away.



What can CWAC do?

- We want to provide cash for family activities or respite care and to provide essential household items such as a refrigerator or telephone.
- We want to help break down the public's prejudice by promoting awareness and sponsoring educational material, aimed in particular at young people.
- We want to support family clinics so that families won't waste what little time they have left by having to attend different clinics on different days.

What can I do?

CWAC is a young charity that needs your help, both practical and financial, to establish itself. Please spread the word about CWAC.

Funds are urgently needed to help these children live happier lives so please give generously - your cheque should be made payable to Children With AIDS Charity. Attached are details of other ways to give money.

Gifts and Donations

In some form or another every charity depends on gifts and donations in cash. It is also well known that there are certain tax advantages to making such gifts. The most common are deeds of covenant, but these are being substantially supplemented by single gifts of a size which qualify for tax relief under the Gift Aid provisions.

Since the March 1993 Budget a single gift can qualify for special tax treatment as long as it is £250 or more. If you would like to help CWAC, without commitment to future donations, please let us have your cheque for this, or any greater, sum, made payable to Children With AIDS Charity (or simply CWAC). We will arrange to send you an Inland Revenue form on which you can certify that you have made the gift and on which you also can give certain details to enable the Inland Revenue to verify your tax status. We can then reclaim tax as though the sum you give is net of tax.

Gift Aid is a simple and convenient method of making those special gifts count for more.

Deeds of Covenant

Most people will be familiar with the deed of covenant method of giving to charities under which you commit to make level payments for a minimum of four years (usually) and the charity can then reclaim tax as each receipt comes in. The advantage to the charity is to gain some measure of guaranteed repeat income; and the benefit to you, the donor, is that you can spread your giving carefully and maintain your involvement with the charity of your choice.
