PHARMACOLOGY

VITAMIN C. Recent research has clearly demonstrated that Vitamin C (Ascorbic Acid) in high concentration stimulates the natural defence mechanisms of the body against invading micro-organisms, and increases its resistance to toxins, both exogenous and endogenous.

Vitamin C increases the resistance of the body by stimulating the leucopoietic functions of the reticulo-endothelial system, by increasing the opsonin and precipitin concentrations of the blood and by increasing the protective mechanisms of the suprarenal cortex.

Thus, apart from the usual therapeutic indications for Vitamin C, it follows that the inclusion of Vitamin C in the treatment of Influenza, the Common Cold, Coryza and allied conditions is a therapeutic necessity.

QUININE. This has a marked deleterious effect on invading micro-organisms, and a strong anti-pyretic effect.

These effects, which have been recognised for years, are achieved by the production of a leucocytosis at a time when, because of illness, a leucopoenia would otherwise exist.
