GENERAL PROVISION OF HEALTH SERVICES FOR THE AREA :-

The Public Officers are :-

Medical Officer of Health - Part-time Officer.

Chief Sanitary Inspector & Building Surveyor - Whole-time Officer. He holds the Certificate of the Royal Sanitary Institute and is an Associate Member of the Institute of British Engineers.

Additional Sanitary Inspector & Assistant Building Surveyor - Whole-time Officer. Engaged part-time on Housing Survey.

Additional Sanitary Inspector and Assistant Building Surveyor - Appointed, but not yet released from H.M. Forces. Will be whole-time Officer.

SANITARY CIRCUMSTANCES OF THE AREA.

Water. The Parishes of Four Marks, Medstead and Ropley are almost wholly supplied by underground rainwater storage tanks, owing to their elevation and the depth of the water-bearing strata.

The Parishes of Bentworth, Lasham and Shalden are supplied from the mains of the Herriard and Lasham Water Company.

The Parishes of Bentley, Froyle, Grayshott and Headley are, for the greater part, supplied from the mains of the Wey Valley Water Company.

Under guarantees or loan assistance from this Council, the Wey Valley Water Company have provided supplies in the Parishes of Binsted, Chawton, Farringdon, Kingsley, Selborne and Whitehill.

Terms have been agreed with the Wey Valley Water Company for the Company to provide a supply to the Parish of Newton Valence with assistance by the Council and private individuals, when necessary sanctions have been obtained. Having been approved by the County Council the matter is now in the hands of the Minister of Health.

Drainage and Sewerage.

The Parish of Bentley is sewered, the effluent being treated by broad land irrigation. Schemes for the sewerage of the Parishes of Grayshott, Headley and Whitehill are in course of revision and preparation, with a view to application being made for loan sanction.

To drain adequately the fifty Temporary Houses in course of erection at Lindford in the Parish of Whitehill, a half mile of 12 inch sewer is being laid to discharge into the Military Treatment Works at Bordon. This forms part of the general scheme for the Parish which was prepared and went to enquiry on the outbreak of War.

Rivers & Streams.

Normal routine inspections have been maintained to prevent pollution. No outstanding cases arose during the year.

Closet Accommodation.

There has been no change affecting closet accommodation throughout the District during the year.

Scavenging & Salvage.

All scavenging contracts, except that regarding nightsoil in the Parish of Grayshott, have been terminated, the Council having undertaken direct collection of night soil, wet refuse and cesspool emptying in a defined area of the Parish of Whitehill. A house-to-house collection of salvage and tins is carried out once monthly throughout the whole of the District, fortnightly in two Parishes. The collections are carried out by the Council's own vehicles and employees.

Hop-Pickers' Accommodation.

Necessary routine inspections have been maintained.

SANITARY INSPECTION OF THE AREA.

As far as circumstances have permitted, routine inspections have been maintained throughout the area. Complaints have been dealt with and abatement enforced.

Special attention has been given to drainage difficulties which naturally arose as a result of Military occupation of properties and the occupation of dwellinghouses to full capacity by civilian evacuees, which led to the overloading of drainage systems designed for a normal number of occupants. As such premises are de-requisitioned close attention is being given to the adjustment of the drainage systems.

SITES FOR MOVEABLE DWELLINGS.

Occupation of such sites has been considerably reduced throughout the year.

GOVERNMENT EVACUATION SCHEME.

The District has been used extensively for the billeting of Civilian evacuees, both under the private arrangement scheme and for the reception of organised groups from the bombed areas of London, Portsmouth and Southampton. Many families have left the District throughout the year and many houses have returned to normal use with beneficial results.

HOUSING.

Reconditioning of cottages under the Housing (Rural Workers) Acts is proceeding, although few in number.

Overcrowding occasionally occurs, principally as a result of billeting under the private arrangement scheme, but abatements have been brought about in most instances without undue delay.

HOUSING SURVEY.

A standard of fitness for rural houses was formulated for general acceptance throughout the County and the classification of houses adopted is that recommended by the Report of the Joint County Committee.

Inspections under the Survey commenced in this District on the 27th February 1945, and were continued on a part time basis until the 27th June 1945, when it had to be discontinued owing to increased duties under Civil Building Licensing. It will, however, be continued full time without interruption immediately upon release from the Services of the appointed second additional Sanitary Inspector.

MILK SUPPLY.

Inspections of Dairies and Cowsheds have been carried out. Milk production has increased throughout the District and new producers have been added to the Register, the premises having been brought up to the required standard.

MEAT AND OTHER FOODS.

In connection with condemned foodstuffs, co-operation with the Ministry of Food Salvage Officers has led to the salvage and use of foodstuffs for animal feeding or other purposes.

PREVALENCE OF AND CONTROL OVER INFECTIOUS AND OTHER DISEASES.

With the exception of a severe outbreak of measles, the year on the whole has been good.

There were 379 cases of measles.

23 cases of scarlet fever of a mild type were notified, but there was no definite outbreak.

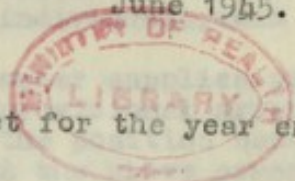

 have been proceeding.
 Necessary action is being taken to record particulars of
 progress considered with for human occupation but no demolitions
 have been carried during the year.
 Overcrowding occasionally occurs, principally as a result
 of the private arrangement scheme, but statements have
 been brought about without delay.

MILK SUPPLY.
 Inspection of dairies and cowsheds have been carried.
 Milk production has increased throughout the District and new
 producers have been added to the Register, the premises having
 been brought up to the required standard.

FEED AND OTHER FOODS.
 In connection with condensed foodstuffs, co-operation
 with the Ministry of Food Salvage Officers has led to the
 salvage and use of foodstuffs for animal feeding on other
 purposes.

MILITARY HYGIENE.
 Every opportunity has been taken to co-operate with
 the Military authorities regarding the suitability of sanitary
 arrangements in connection with the billeting of troops throughout
 the District.

PREVENTION OF AND CONTROL OVER INFECTIONS AND OTHER DISEASES.
 The year on the whole has been fairly good-there were
 no serious outbreaks.

There were 12 cases of Scarlet fever-but no diphtheria
 outbreak-and all the cases of a mild type.
 It is estimated that nearly 100% of all children in
 the schools in the District have been immunised against
 diphtheria.

555 children at school were immunised and 328 under 5 years
 there were 6 cases of diphtheria- two of them were adults
 and none of them had been immunised.
