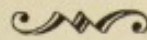

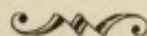

MR. CHAIRMAN AND GENTLEMEN,

I beg to submit to you the Annual Report for the year ending December 31st, 1949.

The Vital Statistics show a Crude Death Rate of 12.7 per 1000 of the population, as compared with 11.3 for 1948. The Live Birth Rate was 15.0 per 1000 of the population, as compared with 17.6 for 1948. There were 2 Still-births. The Infantile Mortality Rate was 21 per 1000 live births.

No serious outbreak of Infectious Diseases has occurred.

Housing and Overcrowding are dealt with in the Report of the Sanitary Inspector.

There has been no change in the Industrial Circumstances of your District since my last report.

## Annual Report OF THE Sanitary Inspector

For the Year 1949.

MR. CHAIRMAN AND GENTLEMEN,

I beg to submit to you in an abbreviated form my report for the Year 1949.

### Sanitary Accommodation.

The houses not provided with Water Closets are situate in an outlying part of your district which is extensively used for Fire Clay Mining. Sewer accommodation is not practicable.

### Removal of Household Refuse and Salvage Collection and Disposal.

Refuse Removal is carried out by Direct Labour. Disposal is by Tipping which has not been entirely controlled. Unauthorised deposits of inflammable material on the Tip have resulted in danger from fire. Several outbreaks caused by wilful mischief have been dealt with. A modern Horse Drawn Removal Cart with sliding covers has been purchased and is now in use. Collection is bi-weekly. Sanitary Dust Bins and Covers of Galvanized Iron are in use at all Houses with the exception of those having Pan or Earth Closets.

4 Houses have been provided with Sanitary Dust Bins for the household ashes and refuse—3 as a result of Informal Notices and 1 Statutory Notice. Up to the present no difficulty has arisen with Owners over the provision of Dust Bins.

3½ Tons of Waste Paper were collected, baled and sold. On account of the difficulty in disposing of the paper after preparation for sale collection had to be discontinued early in the year.



## Housing.

The number of Houses is now 929—a decrease of one over 1948. One house incapable of repair at a reasonable cost was demolished voluntarily by the Landlord. No new houses have been erected, neither by the Council nor by Private Enterprise. Owing to the shortage of suitable building sites a scheme for the erection of 48 flats in 3 storeys has been prepared. Negotiations for the purchase of the land did not prove successful. A Compulsory Purchase Order was therefore made which is awaiting the decision of the Minister of Health. Pending the erection of further Council Houses no licences can be issued to persons who wish to provide their own homes. The waiting list for houses contains about 130 bona-fide applications.

Selection of Tenants of Council Houses is made with the aid of a simple "Points System" which is useful in sorting out the most urgent applications.

One "unfit" house has been demolished, viz. :—No. 6 Stamford Road. Statutory Action was not necessary.

The following Houses have been dealt with. By Statutory Notices :—6 Villa Street, 38 High Street and 139 High Street. By informal notices :—25, 67, 75 Brettell Lane, 2 Vale Street, 1 Vale Street, 2 Canal Street (closed by the Owners), 20, 48, 83 Collis Street, 6 Stamford Road (demolished), 104, 124 King William Street, 18 Box Hill, 1 Dial Lane.

Repairs still present a problem both on account of the shortage of materials and the very high cost which may be disproportionate to the Rent.

Nuisances, etc. within the provisions of the Public Health Act, 1936 were dealt with at 43 Houses.

Overcrowding.—There is little overcrowding on the scale laid down in the Housing Act, 1936. The average number of persons per house is 3.3. A number of houses are occupied by two families generally related to each other. Separate accommodation for newly married couples is very difficult to obtain.



## Eradication of Bed Bugs, Etc.

No premises have been found to be infested and no complaint of infestation has been received.

## Water Supply.

With one exception all premises receive a continuous and pure supply of water for drinking and domestic purposes from the Stourbridge and District Water Board. The principal Bore Holes (at Wollaston Road and Mill Meadow) are situated in your District. Samples of Water for Chemical and Bacteriological Examination are taken at frequent intervals. The Laboratories are provided by the County Council. The Reports indicate a certain Hardness but otherwise the Water is of excellent quality for drinking. Close co-operation is maintained with the Engineer to the Board.

## Milk, Dairies and Cowsheds.

The inspection of Cowsheds passed to the Ministry of Agriculture on October 1st, 1949.

### Retailers of Milk. Milk & Dairies (Special Designations) Regulations 1949.

Very little milk is now sold loose from Retailers cans. The bulk is bottled and is retailed as delivered by the wholesalers. It consists wholly of designated milk, viz. :—Sterilised, Pasteurised and Tuberculin Tested. "Secondary" Licences have been issued as follows :—2 each in respect of Sterilised, Pasteurised and Tuberculin Tested Milk. The Principal Licences were issued by the City of Birmingham and the County Borough of Wolverhampton. 11 Shopkeepers have been licensed to retail "Sterilised" Milk all of which is sold in bottles as delivered.

## Food—Public Health (Meat) Regulations.

No Slaughter-house is used in this District. Three Retail Butchers are supplied with Meat from a Central Depot at Brierley Hill which is controlled by the Ministry of Food.

Inspections of live animals and carcasses are carried out there by qualified inspectors.

Other foods are retailed in the following shops, viz. :—Grocers 4, General 10 (part shops and part dwelling houses), Greengrocers, etc. 6 (2 lock-up shops and 4 part shops and part dwelling houses), Sweets and Tobacco 2 (part shops and part dwelling houses), Fried Fish 3 (part shops and part dwelling houses), Cafes 1.

Food poisoning outbreaks—Nil.

Unsound Food—The following food, unfit for human consumption, was surrendered and destroyed, viz. :—44 tins assorted foods ; 2 tins Dutch Brawn and 15lbs. Bacon.

### Food & Drugs Act 1938 Sec. 15.

The model Bye-Laws suggested by the Ministry of Food for securing the observance of sanitary and cleanly conditions and practices in the Handling, Wrapping and Delivery of Food sold or intended for sale for human consumption have received consideration. Subject to the approval of the Minister of Food it has been decided to adopt them.

### Ice Cream.

No Ice Cream is manufactured in your District. Licences for sale by retail have been issued as follows :—Shops 5, Cafe 1.

### Rats & Mice Destruction Act.

Disinfestation of the following premises has been undertaken, viz. :—Hospitals 1, Factories 3, Dwelling Houses 2, Refuse Tip 1. The work was carried out by an Operator employed by Brierley Hill Urban District Council by arrangement with Mr. H. J. Parker, Chief Sanitary Inspector. The assistance has been appreciated. The Sewers have not been tested. Previous tests proved conclusively that Rats were not present and that on account of the diameter and fall they could not find means of existence.

### Smoke Abatement and Atmospheric Pollution

Measures have been taken to prevent excessive emissions of smoke from the chimneys of 2 factories. One complaint was made during the year and received attention as soon as a request was made.
