



MR. CHAIRMAN AND GENTLEMEN,

I beg to submit to you the Annual Report for the year ending December 31st, 1953.

The Vital Statistics show a Crude Death Rate of 12.3 per 1000 of the population, as compared with 14.4 for 1952. The Live Birth Rate was 12.6 per 1000 of the population, as compared with 12.8 for 1952. There were 2 Still-births. The Infantile Mortality Rate was nil per 1000 live births.

Housing and Overcrowding are dealt with in the Report of the Sanitary Inspector.

There has been no change in the Industrial Circumstances of your District since my last report.

MR. CHAIRMAN AND GENTLEMEN,

I beg to submit to you my report for the Year 1953 in as concise a form as possible.

Sanitary Accommodation

The houses not provided with Water Closets are situated in an outlying part of your district where a sewer is not available and which is extensively worked for Mining of Fire Clay. They are scattered and the land adjoining is subject to subsidence.

Removal of Household Refuse

923 Houses out of 937 are provided with suitable portable receptacles for the household ashes and refuse. They are the property of either the owners or occupiers. Notices in respect of wornout Dust Bins have been complied with. Removal of Refuse is performed by Direct Labour. Collection is bi-weekly. Disposal is by tipping. As the tip is also used for commercial purposes the refuse is quickly covered. The Vehicle is "Horse-drawn." It has proved efficient and more economical than a mechanically propelled one. No necessity has arisen for the Council to consider the provision of Dust Bins. Although appeals have been made to householders not to deposit inflammable material in the Bins the quantity still remains excessive.

Salvage Collection. Salvage is not collected. Parcels are called for by arrangement with the Chief Sanitary Inspector of Brierley Hill Urban District Council.

Housing

12 only of the 48 flats have been completed ready for occupation during 1953. The remaining 36 will not satisfy the number of

applicants for houses. Land for building—excepting a few isolated plots—is not available. One house has been provided by Private Enterprise and one is in course of erection. Both are for owner-occupiers.

Demolition of Nos. 50/51 High Street is proceeding and orders have been made in respect of Nos. 95/96 High Street. They were reported as "unfit for human habitation." No. 1 Withymoor will be demolished by the owners when vacant possession is obtained. It has been rendered "unfit" by Fire Clay Mining. The number of unfit houses demolished since 1910—including Nos. 50/51 High Street is 94. The Council have provided 200 houses excluding the 48 flats. No "Repair Notices" under the Housing Acts have been issued. General Defects at the following houses have been dealt with, viz.: - Box Hill-Nos. 18 to 21; Brettell Lane-Nos. 2 & 3, 8 and 9, 15, 19, 36; Collis Street-Nos. 14, 36, 45, 88; Dial Lane No. 2; King William Street-46 and 47, 125 and 126, 142, 155. Abatement Notices-Informal and Statutory-within the provisions of the Public Health Act, 1936, were served on the owners of 43 houses. No enforcement proceedings have been necessary. The rents of most of the houses excluding those owned by the Council are controlled by the Rent Acts. As building Costs and Rates show a tendency to increase, owners of houses are reluctant to find money for repairs.

Overcrowding. There is little actual overcrowding. The average number of persons per house is 3.4. Occupation by two families, generally related, is common. The majority of applicants for houses are from married sons or daughters residing with their parents. Such arrangements are not always happy ones, particularly where there are young children. The number of separate families is estimated to be about 1100 accommodated in 937 houses.

Nomadic Caravan Dwellers

Two families took possession of sites at Mill Meadow and Bagleys Road. As there was no water supply or sanitary accommodation available the occupiers of the land were advised to give them notice to leave. They left as requested.

Eradication of Bed Bugs, Etc.

No premises have been found to be infested and no complaint of infestation has been received.

Water Supply

All premises, excepting one, receive a continuous and pure supply of water for drinking and domestic purposes from the mains of Stourbridge and District Water Board. It is pumped direct from the Bore Holes at Wollaston Road and Mill Meadow, both of which are in your area. Samples of the water for Chemical and Bacteriological Examination are submitted at frequent intervals to Laboratories provided by the County Council. They show a certain Hardness otherwise the water is of excellent quality for drinking.

Milk—Retailers—Milk (Special Designations) (Specified Areas) Order 1952

There are two producers only of Milk in your area. The Milk is taken direct to a Dairy in a neighbouring District for treatment. There is no Dairy in Amblecote. Under the provisions of the above order all Milk sold by retail in your area must be "Designated" Milk contained in bottles. Supplementary Licences to retail Milk in Amblecote have been issued to nine persons whose premises are outside the district and ten Shopkeepers within the district have each received a retailer's licence.

Food-Public Health (Meat) Regulations

No Slaughter-house is used in your District. One was in use regularly up to 1939. It is now dilapidated. There are three retail Butchers who are supplied with meat, etc., from a Central Depot at Brierley Hill which is controlled by the Ministry of Food. All the animals and carcases are inspected by qualified Inspectors. No intimation has been received from the Butchers as to their proposals when meat is decontrolled. Domestic pig feeding is not common. One complaint arising from the keeping of swine was received and dealt with. No notice to slaughter on private premises was given during 1953.

Slaughter of Animals Act, 1933. Two persons only are licensed to slaughter or stun animals in a slaughter house.

Food Distribution

Food is sold by retail in the following shops:-

Business premises only—Grocers 5; Butchers 1; Greengrocer 1. Combined Shops and dwelling houses—Grocers and General 9; Butchers 2; Greengrocers 3; Sweets and Tobacco, Etc. 2; Fried Fish 3; Cafe 1.

Worcestershire County Council have a Cooking Centre where meals are prepared and conveyed to Schools.

Eight Factories have Canteens for their employees.

One "Model" Bakery (Factory) is in operation from which Bread is distributed over a wide area.

No Ice Cream is manufactured in your area. 14 premises are registered for storage and sale thereof. They each have suitable "Conservators." The premises comprise 11 Shops, 1 Café, 1 Sports Pavilion, 1 Public House.

The model Bye-laws of the Ministry of Food for securing the observance of sanitary and cleanly conditions and practices in the Handling, Wrapping and Delivery of Food sold or intended for sale for human consumption were adopted and came into operation on 11th September, 1950. They are generally well observed.

There is no market nor stalls for street trading.

Unsound Food

The only food found to be unsound and unfit for human consumption was 15½lbs. Tinned Ham of German Origin. It was surrendered and returned to the wholesalers to be dealt with in accordance with the recommendations of the Ministry of Food.

Prevention of Damage by Pests

The following premises have been treated for infestations of Rats and Mice, viz.:—Factories 4, Hospital 1, Dwelling Houses 7, Refuse Tips 2. Regular quarterly treatment is recommended for Factories. Infestation at factories usually arises from indifferent disposal of waste food and at dwelling houses from keeping fowls. The work generally is carried out by an "Operator" employed by Brierley Hill Urban District Council by arrangement with Mr. H. J. Parker, Chief Sanitary Inspector. His assistance is appreciated. A charge to cover the cost of treatment is made in respect of premises other than Dwelling Houses. It has not been necessary to treat the Sewers. Previous tests proved definitely negative.

Smoke and Atmospheric Pollution

Excessive omissions of smoke were observed from three factory chimney stacks. At one works the trouble has been overcome by changing to electricity for power. Considerable time and thought has been given in an endeavour to permanently cure the trouble at the other two. An experiment is being made with a new type of furnace door in one instance and in the other an expert is being called in from the Ministry of Fuel and Power to advise on the means of overcoming the trouble. Both Firms are anxious to prevent the nuisance.

Pet Animals Act, 1951

One licence only has been issued. It was in respect of "Goldfish" kept for sale. An application for renewal is not anticipated.
