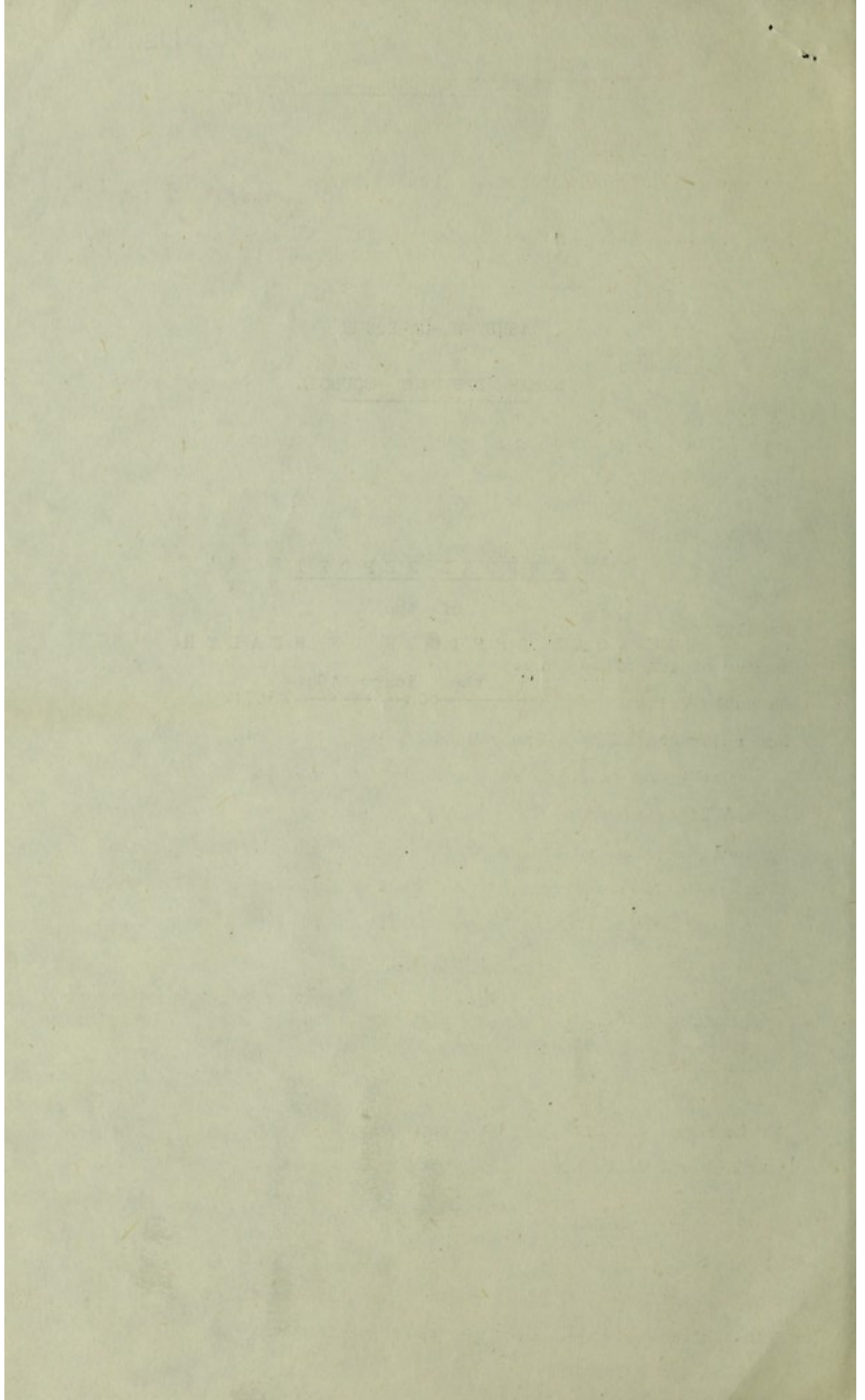

SECTION B :-

General Provision of Health Services for the Area

Hospitals

- Fever Hospitals are provided by the Leicestershire Combined Hospitals Committee. The nearest to your District is Markfield Isolation Hospital.
- Smallpox Hospitals for the treatment of Smallpox are provided by the Leicestershire County Council at Snarestone (23 beds) and Syston (15 beds).
- Tuberculosis The County Sanatorium at Markfield with 126 beds is adequate for the diagnosis and treatment of all types of Tuberculosis.
- Maternity Provision is made for cases requiring Institutional treatment in the Leicestershire Maternity Hospital, and in Leicester Royal Infirmary. Ashby Cottage Hospital Maternity Wing is much used by residents from your Area and from the surrounding Areas. Fairhaven Nursing and Maternity Home at Shellbrook, Ashby-de-la-Zouch, is also available for cases of Midwifery.
- Children Children are admitted to Leicester Royal Infirmary and Loughborough Infirmary. Ashby Cottage Hospital admit children and many cases of enlarged Tonsils and adenoids, and other major operations such as appendices were operated on by the Honorary Surgeon Mr. R. Fowick I.R.C.S.
- Other Delicate and illnourished children (3 to 5 years) are admitted to the Childrens Convalescent Home, Woodhouse Eaves.

Ambulance Facilities:-

Infectious diseases are removed in Ambulances provided by the Leicestershire Combined Isolation Hospitals Committee.

Non-Infectious diseases and Civilian Accidents. The St. Johns' Ambulance Brigade (Coalville) provides an Ambulance.

Colliery accidents are provided with Ambulances maintained by the Colliery Owners Association.

Clinics and Treatment Centres:-

These are provided by the Leicestershire County Council. An Infant Welfare Centre is held weekly in the Baptist Schoolroom, Brook Street, Ashby-de-la-Zouch. The nearest School Clinic is held at the Health Centre, Bridge Road, Coalville. An Orthopaedic Clinic is held at Bridge Road, Coalville. A Tuberculosis Dispensary is held weekly at Coalville. Venereal Diseases Clinic is held at Leicester Royal Infirmary.

Nursing in the Homes:-

The Ashby-de-la-Zouch Nursing Association provides a District Nurse. Infectious Diseases are not attended by the District Nurse. No provision is made for nursing such diseases as Measles etc., in the homes.

General Provision of Health Services for the Area

Hospital

Hospitals are provided by the Leicester County Council. The nearest to your district is the Leicester County Council Hospital.

General

Hospitals for the treatment of general cases are provided by the Leicester County Council at Leicester (25 beds) and Boston (15 beds).

Tuberculosis

The County Sanatorium at Northfield with 125 beds is adequate for the diagnosis and treatment of all types of Tuberculosis.

Maternity

Provision is made for cases requiring institutional treatment in the Leicester County Council Maternity Hospital, and in Leicester Royal Infirmary. A day hospital is also available for cases requiring treatment in the day hospital. The day hospital is situated at Northfield and is open from 9.30 am to 4.30 pm. It is also available for cases requiring treatment in the day hospital.

Children

Children are admitted to Leicester Royal Infirmary and Leicester County Council Hospital. A day hospital is also available for cases requiring treatment in the day hospital. The day hospital is situated at Northfield and is open from 9.30 am to 4.30 pm. It is also available for cases requiring treatment in the day hospital.

Other

Leicester and affiliated children (5 to 15 years) are admitted to the Children's Community Home, Woodhouse. There is also a day hospital for cases requiring treatment in the day hospital.

Isolation Hospitals:-

Infectious diseases are removed in Ambulances provided by the Leicester County Council Isolation Hospitals. There is also a day hospital for cases requiring treatment in the day hospital.

Non-infectious diseases and Civilian Accidents. The St. John's Ambulance Brigade (Civilian) provides an ambulance service for cases requiring treatment in the day hospital.

Collective accidents are provided with Ambulances maintained by the Leicester County Council.

Clinics and Treatment Centres:-

There are provided by the Leicester County Council. An Infant Welfare Centre is held weekly in the hospital. A day hospital is also available for cases requiring treatment in the day hospital. The day hospital is situated at Northfield and is open from 9.30 am to 4.30 pm. It is also available for cases requiring treatment in the day hospital.

Nurses in the Home:-

The Ambulance in-Borough Nursing Association provides a service for cases requiring treatment in the day hospital. The day hospital is situated at Northfield and is open from 9.30 am to 4.30 pm. It is also available for cases requiring treatment in the day hospital.

Sanitary Circumstances of the Area.

Water Supply

Water is supplied by the Swadlincote and Ashby Joint Water Board from the Melton Reservoir. With the exception of a few outlying properties the whole of the Urban District is supplied with water from the Public Mains.

Public Cleansing (Contd.)

Earth Closets, Privies and Cesspools are cleansed by the Council's workmen and the contents are deposited on arable land and ploughed in. Ashpits are emptied at frequent intervals.

In the Parish of Blackfordby the removal of House Refuse and the cleansing of Privies and Cesspools is carried out by Contractors under the supervision of the Council's Sanitary Inspector and the contents disposed of in a similar manner to that mentioned above.

Beyond a slight lengthening of the intervals between Refuse collection no noticeable strain has been put on the Sanitary Services by reason of evacuation or other causes.
