## 2. GENERAL PROVISIONS OF HEALTH SERVICES IN THE AREA :

### LABORATORY ARRANGEMENTS.

Bacteriological examinations are carried out by the Pathological Department of the Royal Albert Edward Infirmary, Wigan, and the arrangements are satisfactory. A report on every examination is made to the Public Health Department.

During 1954 reports were made to the authority on 38 examinations of milk, 4 of water and one of ice cream.

### AMBULANCE ARRANGEMENTS.

During the year, Non-Infectious, Infectious, Accident and Maternity Cases were dealt with adequately by the Motor Ambulances belonging to the Lancashire County Council, stationed at Hindley and Standish.

### NATIONAL ASSISTANCE ACT, 1948.

No action was taken by the Authority during the year, under Section 47 of this Act.

### 3. SANITARY CIRCUMSTANCES OF THE AREA :

#### WATER SUPPLY.

The district is supplied with water from Bolton Corporation, Wigan Rural District Council and Liverpool Corporation. The source of supply is upland surface and is found to be bacteriologically pure. During the year 4 examinations of the piped supply were made and these proved satisfactory.

All houses in the district have a piped supply of water from the main.

#### DRAINAGE AND SEWERAGE.

The combined system of drainage is in operation throughout the district. All dwellings with the exception of 18 isolated cottages and farms have a water carriage system of sanitation. The installation of a septic tank for 4 cottages was in progress at the end of the year.

#### PUBLIC CLEANSING.

Street scavenging is under control of the Engineer and Surveyor.

The collection and disposal of household refuse is under supervision of the Sanitary Inspector.

One Driver and 4 Labourers are engaged whole time on refuse collection work. All refuse is tipped at the Marsh House Tip. During the year difficulty in maintaining an adequate service was experienced and the Council purchased a 16 cubic yard S.D. Freighter of the fore and aft tipper type.

There are 2,100 dustbins, 16 pail closets and 1 privy midden within the district.

#### TENTS, VANS AND SHEDS.

#### SMOKE ABATEMENT.

There are 2 factory chimneys in the district and no action has been found necessary during the year. The emission of black smoke is allowed for a period of 2 minutes per hour.

#### SWIMMING BATHS AND POOLS.

There are none in the district.

#### VERMINOUS PREMISES.

During the year 5 houses infested with bed bugs were fumigated with 5% D.D.T. Spray and D.D.T. Fumers. This treatment has proved highly efficient.

#### RODENT CONTROL.

50 infestations of rats or mice were cleared during the year in addition to the two sewer tests and treatments. The treatment of dwelling houses is free of charge but a charge is made for treatment of business premises.

12 Licenses to store petroleum were issued during the year and 14 inspections were made for the purpose. One new 1,000 gallon storage tank was installed during the year.

### 4. HOUSING

The township consists chiefly of working class houses which are old in type and are constantly falling into disrepair.

Overcrowding exists only to a minor degree and those requiring houses are married couples having to live with parents. 35 new housing applications were received during the year.

The erection of 16 old people's bungalows made good progress during the year and 26 houses, erected by the Council's Direct Labour Department, were tenanted.

## 2. MEAT AND OTHER FOODS :

There is one small slaughter-house in the district, but the bulk of the meat supply to the district is from wholesalers in the County Borough of Wigan.

There was one successful prosecution of a butcher with unsatisfactory premises during the year.

46 animals were inspected at the slaughterhouse in the district and in 10 cases some part or organ was condemned.

Evidence of *Cysticercus bovis* was not found in any instance.

No cases of food poisoning occurred in the district during 1954.

## 6. PREVALENCE OF, AND CONTROL OVER, INFECTIOUS DISEASE.

The number of cases of Infectious Diseases notified during 1954 was one of the lowest on record, 20 cases in all being notified.

No cases of Diphtheria were notified during the year. Free immunisation against diphtheria is provided at the clinic, and during the year 83 pre school and 25 school children were immunised with two injections of Alum Precipitated Toxoid, and 118 children received reinforcing injections.

No preliminary and no post-Schick tests were undertaken.

No immunisation against the enteric group was undertaken during 1954.

No local action has been taken with regard to the use of measles serum for prophylaxis or attenuation, and there are no existing facilities for the typing of pneumococci and for the provision of appropriate type sera.

The general standard of cleanliness and habits in the district remain high and the cases of head lice dealt with at the clinic were few and were successfully treated with D.D.T. Emulsion.

#### DISINFESTATION.

Disinfestation of houses is carried out by "Sanitas Fumigators" and bedding and clothing are steam disinfected by arrangement with Hindley U.D. Council.

#### CANCER.

16 deaths (11 male and 5 females) were certified as due to cancer during the year.

Facilities for Radium treatment are available to Aspull residents at the Radium Institute, Manchester, and at Wigan Infirmary, which for this purpose is a sub-clinic of the Manchester Centre.

## TUBERCULOSIS.

The dispensary service is under control of the Regional Hospital Board and Aspull cases attend at the Chest Clinic in Millgate, Wigan.

6 cases of pulmonary tuberculosis and one case of non-pulmonary tuberculosis were notified during the year. 1 death from pulmonary tuberculosis was registered in 1954.
