SECTION. A.

Statistics and Social Conditions of the Area.

Area in acres. 50,164. 1,887. Population (estimated) 1937. 547. Number of inhabited houses. Rateable value. £ 8,848. Sum represented by a penny rate. £ 39-14-1.

Chief Industries .- The area is strictly rural with Agriculture as the main occupation. Dairy and Poultry farming are practised on a small scale. There are no towns and hardly any villages, the inhabitants being mainly scattered.

SECTION. B.

General Provision of Health Service for the Area.

- (a) Laboratory facilities .- Laboratory examinations are carried out at the Beck Laboratory, Swansea.
- (b) Ambulance facilities The Order of St. John of Jerusalem has an ambulance available at all time for all except infectious cases.
- (c) Nursing in the Home. No trained nurse or Certified Midwife resides and practises within the area either in a public or private capacity. There is an imperative need for the establishment of an efficient Nursing Service within the area.
- (d) Clinics and Treatment Centres, including Clinics solely for diagnosis or consultation. A Maternity and Child Welfare Centre meets at Brecon on the third Friday monthly.
- (e) Hospitals.- There are no hospitals situated within the area but accommodation is available for hospital cases in the County War Memorial Hospital at Brecon which is conveniently situated. Arrangements have also been made with the Brecon Borough Council for Isolation Hospital accommodation at their Hospital near Brecon. This hospital is now inadequate and it has been agreed to erect a new Isolation Hospital. A new site having now been agreed upon fresh plans are being prepared, and tenders will be invited in the near future. At the present time sporadic cases of infectious diseases are being admitted to the Mardy Isolation Hospital, Merthyr Tydfil.
- (f) Local Government Act .- Administered by the County Council.
- (g) Poor Law Medical Out Relief .- Administered by County Council through Public Assistance Officers.
- (h) Institutional Provision for the care of Mental Defectives. Administered by County Council. Female Patients are cared for at the Pantglas Hall, Carmarthenshire, and Males at Forden Institution, Montgomeryshire, and elsewhere.
- (i) Institutional Provision for Mothers or Children .- No provision for such cases is made.

- (j) Midwifery and Maternity Services. Midwives from adjoining districts attend cases within this district. Ante-Natal examinations are carried out by the Practitioners for which the County Council is responsible for the fee. No charge is made to the patients for such examinations.
- (k) Health Visiting. This work is carried out by a Whole Time Health Visitor employed by the County Council.
- (1) Children Act. 1908 .- Administered by the County Council.
- (m) Orthopaedic Treatment. The County Council has the services of a Whole Time Orthopaedic Sister and a Part Time Orthopaedic Surgeon who is attached to the Prince of Wales' Hospital, Cardiff.
- (n) Maternity and Nursing Homes .- There are no registered homes in the

SECTION. C.

Sanitary Circumstances of the Area.

(a) Water. This is mainly from wells. At a few villages there is a public supply by pipe from a spring. The Council are still comtemplating laying water on to several villages and the matter is at present being seriously discussed with a view to supplying a wholesome supply throughout their district.

The Council are now considering laying a supply of water by gravitation to the Village of Llanddew and levels have been taken

and plans prepared.

- (b) Drainage and Sewerage. At Llanddew there is waste water drainage. No other pipe drainage or sewerage exists in the area.
- (c) Rivers and Streams. No cases of pollution of streams in the area have been reported.
- (d) Closet Accommodation .- Earth Closets throughout.
- (e) Public Cleansing. Method of collecting dry house refuse and disposal of same. There is no organised scavenging. The Council are still considering making arrangements for the provision of collecting and disposing of house refuse in the whole district.


In February of this year the County Council offered immunisation free of charge to all pre-school and school age children residing in the Llanspyddid District. Many parents availed themselves of this opportunity and attended at the Llanspyddid Council School on three successive weeks. Later in the year another case occurred in a child whose parents had refused immunisation and a further opportunity was given for such children to be done. All children, who have not had Diphtheria, living in this district have been immunised with the exception of two families where the parents refused.


