

Live Births:

348 live births were registered giving an adjusted birth rate of 13.73, as compared with 14.0 for 1966 and 13.97 for 1965.

The illegitimacy rate was 54.6 per 1,000 live births as compared with 55.71 for the previous year, and a rate of 84.0 for England and Wales.

Stillbirths:

4 stillbirths were registered for 1967 as compared with 6 for 1966 and 7 for 1965.

There was one illegitimate stillbirth during the year.

Infant Mortality:

There were 5 deaths of infants under one year of age in 1967 compared with 4 for 1966 and 12 for 1965. Of these, 4 were neonatal deaths compared with 2 for 1966 and 8 for 1965.

There was an increase in Accidental Deaths in the Borough - 16 in number, as compared with 9 accidental deaths for the previous year. 6 of these deaths were in the age group 65 years and over being results of falls at their homes, chronic sick hospitals, and one fall in a shop. The other ten accidental deaths were caused by:-

(i)	Falls and injuries at work	3
(ii)	Barbiturate Poisoning	4
iii)	Motor Vehicle Accidents	3

The Home Help Service, even performing much useful work in the performance of essential duties of the household, leaves much to be accomplished in the way of other needs of the aged and chronic sick. There is still considerable scope for voluntary work in this sphere.

Deaths in the Borough exceeded births by 87. This excess of deaths over births has been the pattern for the Borough for the last ten years.

Cancer:

Cancer deaths increased from 96 in 1966 to 103 in 1967. There was an increase in deaths from Cancer of the Stomach, Cancer of the Breast and Other Malignant and Lymphatic Neoplasm. Deaths from Cancer of the Lung, Bronchus, and Uterus decreased as compared with 1966.

There were 23 male deaths due to cancer of the lungs, bronchus as compared with 28 for 1966. There were 3 female deaths due to lung cancer, as compared with 1 for the previous year.

There were 11 deaths due to cancer of the breast, 4 due to cancers of the uterus, and 17 due to cancer of the stomach.

I must remind the public that increasing knowledge has demonstrated how the risk of contracting cancerous diseases can be reduced - mainly by the elimination of or avoidance of cancerous irritants. It is hoped that films demonstrating the importance of early diagnosis and treatment of such cancers as those of the breast and uterus to womens organisations in the area will result in a reduction of mortality figures attributed to these diseases.

Diphtheria:

No cases of diphtheria were notified in the Borough during the year.

Diphtheria Immunisation:

It is pleasing to report, for the first time since 1962, a big increase in the numbers of children immunised against this disease, the total number immunised being 381. 282 of these children were in the age group 0 - 5 years as compared with 208 in 1966. No relaxation can be afforded in making young parents aware of the very great dangers and high death rate from this disease in the not so far distant past. It is my sincere hope that, not only will this level of immunisation be maintained in the Borough but, even more children will be immunised, as it is only by maintaina high level of immunisation in the population that outbreaks of diphtheria can be avoided.

Scarlet Fever:

One case, a female aged 2 years was notified during the year. There was only one case also in 1966.

Whooping Cough:

Twenty-three cases of Whooping Cough were notified in the Borough during the year - 6 males and 17 females. There were no cases notified in 1966. The number of children, under five years of age, vaccinated against Whooping Cough in the Borough totalled 284.

Measles:

Two hundred and ninety eight cases of Measles were notified during the year, one hundred and fifty four females and one hundred and forty four males. One hundred and sixteen of these cases were in the age group 5 - 9 years. There were 118 cases notified in 1966 and 98 cases in 1965.

Meningococcal Infection:

No cases were notified in the Borough during the year.

Erysipelas:

One case was notified in the Borough during the year.

Dysentery:

Eleven cases of Dysentery were notified during the year, being the same number notified for the previous year. All the cases were investigated. Faeces samples from all the notified cases and immediate contacts were sent to the Public Health Laboratory for examination. In all 22 samples were submitted for examination, the result being negative in all instances.

Food Poisoning:

No case of Food Poisoning was notified in the Borough, during the year.

Typhoid:

No cases of Typhoid were reported in the Borough during the year.

Venereal Disease:

Twenty-five persons from Carmarthenshire were treated at the Venereal Disease Clinic at Llanelli as compared with thirty-seven in 1966. These cases comprised of two of Gonorrhoea and twenty-three of other conditions.

The Clinic held at Bryntirion Hospital, Llanelli has now been closed.

Infectious Disease - Immunisation:

In contrast to last year, the immunisation figures for all children under 14 years show an increase in respect of Diphtheria, Poliomyelitis and Whooping Cough. Even so I must stress that the prevention of epidemics of these diseases depends mainly on the percentage of children in the population who have received immunisation against these diseases.

Tuberculosis:

Only two cases of Tuberculosis were notified during the year - 1 male respiratory case and 1 female non-respiratory case. In 1966 there were eleven cases notified - 8 respiratory cases (6 males and 2 females) and 3 non-respiratory cases (1 male and 2 females).

There were four deaths attributable to Tuberculosis during the year - 3 respiratory and 1 non-respiratory. This compares with 1 for last year, a non-respiratory case.

The provisional death rate for England and Wales for 1967 was 37 per million persons for Respiratory Tuberculosis, and 5 per million persons for other forms of Tuberculosis.

The treatment of Tuberculosis patients is undertaken by the Regional Hospital Boards through the Chest Physicians.

Enquiries regarding the domiciliary care of Tuberculosis patients should be addressed to the County Medical Officer of Health.

The County Council will assist in the domiciliary care of Tuberculous and other patients, by provision of beds, bedding, sickroom equipment and home help assistance.

In addition, sleeping out shelters are available for certain Tuberculous patients.

Assistance is granted in necessitous cases towards the cost of the travelling expenses of relatives visiting long stay patients in Hospitals and Sanatoria. In practice, it has been found that the great majority of applications for assistance have been by relatives of Tuberculous patients.

Assistance is granted for visits to Hospitals and Sanatoria which are not less than 40 miles from the residence of the applicant, and is subject to the following conditions:-

- (a) That there is urgent reason for the visit because of the patient's serious condition, or that the visit would, in medical opinion, do the patient good and aid response to the treatment.
- (b) That because of the length of the journey the relatives concerned are unable to afford it from their own resources without substantial hardship.

(c) That subject to (a) above, the assistance is restricted to one relative every month or two relatives every two months, unless a senior member of the Medical Staff of the Hospital certifies that more frequent visits are essential on account of the patient's serious condition.

Mass Radiography Service:

Unit "J" of the Mass Radiography Service, continued operating every Monday (apart from Bank Holidays and the holiday month of August) at the Odeon Car Park, Llanelli, but was withdrawn from service on the 31st December, 1967. In its place, the town will be included in the programme of one of the mobile units and visited once yearly and remaining in the town for a longer period of time than has been the case in the past.

A special survey unit visited two works in the Borough and also another 3 local works on the fringe of the Borough boundaries employing a large number of employees resident in the Borough.

Local Hospitals:

There are four local hospitals. The Llanelli General Hospital with 160 beds; the Bryntirion Hospital for Chronic Sick with 156 beds; the Glasfryn Maternity Hospital with 12 beds, and the Pre-convalescent Hospital at Cilymaenllwyd with 43 beds.

Distribution of Welfare Foods:

National Welfare Foods which were formerly distributed by the Ministry of Food are now distributed, under arrangement, by the Carmarthenshire County Council.

The Centre is open from Mondays to Fridays at Brynmair Clinic, Goring Road, Llanelli.

Home Nursing Equipment:

Sick-room and nursing articles and equipment required for patients at home can be obtained as follows:-

- (a) Red Cross Society, 6 West End: 6.30 p.m. 7.30 p.m. each evening.
- (b) From County Medical Officer of Health.

Equipment provided under these arrangements include air beds, air rings, bed cradles, bed pans, back rests, urinals, waterproof sheets, etc. Patients are charged according to their circumstances and the cost of the article.

Home Help Service:

The Home Help Service is organised by the Carmarthenshire County Council. The area organiser is available for interviews, etc., at 6 John Street, on Monday afternoons between 2.30 p.m. and 4.0 p.m.

Home Helps are provided during the laying-in period in maternity cases where the patient has no relative available to undertake the domestic duties of the home, and also in certain cases of sickness or needs. For those on National Assistance, domestic help on a more limited scale can be arranged, when needed, through the Ministry of Social Security.

The Health Department collaborate closely with the officials responsible for the services enumerated above.

Mental Health Service:

The Officer duly authorised to take initial proceedings under the Mental Health Act, 1961, for the provision and care and treatment of persons in the area suffering from mental illness is Mr. Dewi A. David, "Glen View", Gwendraeth Town, Kidwelly.

Mental Subnormals:

The Carmarthenshire County Council is responsible for the ascertainment, supervision and general welfare of the mentally subnormal.

Supervisory home visits are made by Mental Welfare Officers and a limited amount of home teaching of mental subnormals is also carried out.

A new and larger Junior Training Centre was opened at Heol Goffa during the year. The improved conditions and increased capacity of this centre should do much to benefit the mentally handicapped persons and their families. A small residential hostel for the use of handicapped persons in the county, living too far away for daily transportation, was opened in the same area.

Blood Transfusion Service:

There is a small Blood Bank at the Llanelli General Hospital and the services of a Pathologist with three trained technicians and four trainee technicians are available.

Blood grouping and cross matching are part of the normal laboratory routine and a twenty-four hours service is maintained for emergencies.

The Blood Transfusion Unit visited the area periodically during the year, and in all 1,384 donations were received in comparison with 1,359 donations for the previous year.

The figure of usage of blood by the Llanelli Hospitals during the year is not known.

There was an increase of 31 donations received during the year at the Llanelli Town Sessions, but a decrease of 6 donations from Other Sessions, as compared with the previous year.

The average donations per year for the last five years is 1,351 and the donations for the current year are slightly in excess of the average figure.

The Health Department collaborates very closely with the National Blood Transfusion Service when they visit the area in the displaying of posters, etc., announcing their forthcoming sessions as well as the permanent posters displayed in the town showing the great need for blood.

Most people can donate blood to the Blood Bank, and the amount of blood taken is quickly replaced from the body's reserve. This reserve is replaced in a matter of days. With the everlasting and ever increasing need for blood, I, once more, appeal that when the Blood Transfusion Unit visits the area in future even more donations will be forthcoming.

National Society for the Prevention of Cruelty to Children:

Close collaboration is maintained with the Local Inspector of the above Society, and mutual action to mitigate distress is taken in many instances.

The Local Inspector (Chief Inspector D.R. Lewis) resides at 44 Glenalla Road, Llanelli (Telephone No. 5612).

National Assistance Act, Section 57:

This section provides for removal to suitable premises of persons in need of care and attention. No formal action under this section was necessary during the year, persuasive action having been sufficient to achieve the desired ends. The availability of the powers does however aid persuasion in certain cases.

SANITARY CIRCUMSTANCES OF THE BOROUGH

Water Supply:

The Corporation's Water Undertaking was taken over by the Llanelli and District Water Board on the 1st October, 1962. Prior to the take over the Undertaking consisted of:-

- (a) The Cwmlliedi reservoir constructed in 1878, having a capacity of 200 million gallons.
- (b) The Upper Lliedi reservoir constructed in 1904, having a capacity of 200 million gallons.
- (c) The river intake of the Gwendraeth Fach which affords a supply of 3 million gallons per day.
- (d) An intake of the River Towy designed to abstract 6.1 million gallons per day, of which one million gallons per day is reserved for the Carmarthen Rural District Council, half a million gallons per day for the Llandeilo Rural District Council, and 600,000 gallons per day for the Llandelli Rural District Council.

There are two systems of mains supplying the Borough limits:-

- (i) a domestic main which delivers water treated by slow sand filters and/or chloramine, and
- (ii) trade water mains which deliver water (chlorinated only) for industrial purposes.

The water supply of the area is generally satisfactory in both its quantity and quality.

Twenty-six samples of tap water were taken, by the Health Department, for bact-eriological examination. In addition, copies of reports on samples submitted by the Llanelli and District Water Board for both chemical and bacteriological examination were received by myself, and the position can only be regarded as very satisfactory from the point of purity of the water supply.

Water Distribution in Llanelli and District Water Board Area:

The average daily consumption of filtered water for domestic purposes during the year was 5,183,000 gallons, and for trade purposes 3,410,000 gallons.

The average daily consumption per head for domestic purposes during the year was 66.1 gallons.

The total number of houses supplied with water was 24,770 for an estimated population of 78,410.

Rainfall - Llanelli Borough:

The total rainfall for 1967 was 65.63 inches as against 60.20 inches for 1966 and 54.82 for 1965.

Rain fell on 227 days and the maximum fall in 24 hours occurred on the 11th October, 1967 when 2.04 inches were recorded on the 24 hours ended at 9.0 a.m. on the 12th October, 1967.

Sewage and Sewage Disposal:

Investigations by the firm of consultants engaged by the Council to provide improved sewage disposal for the town continued during the year. It is hoped that a report which will enable the Council to deal with the problems involved, will be available in the near future.

Refuse Collection and Disposal:

All the houses in the Borough are provided with dust bins. This has proved an unqualified success not only aesthetically, but also in the reduction or elimination of nuisances, etc., caused by flies, vermin and rodents.

The refuse collected is disposed of at the Council's Refuse Tip, and controlled tipping, in accordance with the recommendation of the Ministry of Health, is being operated. This has led to considerable improvement in the conditions of the tip. Regular supervisory visits are made by my Staff. The Rodent Operator also makes regular visits, and he reports that rodent infestation is no longer a serious problem.

The estimated amount of refuse collected in the period 1st April, 1967 to 31st March, 1968, was 10,940 tons, an increase of 1.7% over that for the previous year.

Litter Act, 1958:

Litter bins are distributed on the main highways of the town and the improvement in the cleanliness of the town since these were supplied is being maintained.

River and Streams:

The River Lliedi passes through the town and is occasionally polluted by the throwing of rubbish into the bed of the river. This was guarded against as much as possible.

HOUSING

Unsatisfactory conditions in houses owned by the Corporation are investigated by the members of the Health Department. In the allocation of Council Houses, the staff of the Health Department schedule overcrowded cases and, where appropriate, make specific recommendations. Tuberculosis cases are given special consideration and priority in rehousing. Investigation of applications for housing on medical grounds is now an important added feature to the work of the Department. The investigation of applications for O.A.P. dwellings and the allocation of such dwellings is undertaken by the Department. Services to deal effectively with a small number of problem families which require intensive remedial measures cannot be regarded as adequate.

Overcrowding:

Approximately 50 families were living under overcrowded conditions in the Borough at the end of the year. This compares with 92 families at the end of the previous year.

Provision of Houses:

Up to the end of 1967, the Town Council had erected 3,185 houses, of which 793 are situated in the Llanelli Rural District area.

There is still a big demand for O.A.P. accommodation in the Borough, particularly from the single person. For the first time since the commencement of building, for the aged, a new type of accommodation - a bedsitter one person bungalow, became available for letting. At the beginning, there was some reluctance to accept these single units, but this reluctance disappeared when the first few had been occupied and furnished and the advantages of living in such easily run units became more apparent. Further applications for this type of accommodation seems to prove that it has now been accepted by the single persons. During the year, work was commenced on the 34 single flatlets, Warden Service Block, on the Old Lodge Site, together with the Warden's Flat, situated within the "Block". The "Block", a two storey block, will be gas centrally heated and will contain a communal dining hall and a communal lounge. An inter communication system and a bell warning system will also be installed. Toilet accommodation will be shared in the ratio 1:2, and bathroom accommodation in the ratio 1:3. It is hoped that this "Block" will be ready towards the end of 1968.

Inspections:

Details of inspections are contained in the report of the Chief Public Health Inspector.

Individual Unfit Houses:

During the year 15 Demolition Orders and 11 Closing Orders were made by the Town Council.

Shops, stalls, vehicles, etc. are visited regularly and particulars of condemnations are contained in the report of the Chief Public Health Inspector.

The Public Health Inspectors regularly inspect all food premises in the Borough and have and are receiving the close co-operation of the trade people of the town in their willingness to put into effect any improvements governing food premises, etc.

Regular inspections of all milk premises in the Borough were made by the Public Health Inspectors and a high standard of cleanliness has been maintained.

The results of the samples submitted showed that 4 of the samples submitted for the Methylene Blue Test had failed, with one sample declared "test void", one of the samples submitted for the Phosphatase Test had failed, and twelve of the samples submitted for the Brucella Ring Test showed positive results. One of the Guinea Pigs inoculated also showed a positive Brucella Abortus result. Investigation of the milk supply of the dairy involved in the latter results, resulted in the source of the infected milk being traced to a farm outside the Borough boundary. Appropriate action to eliminate danger of infection through milk was taken.

During the year, twenty-two samples of ice cream were submitted to the Public Health Laboratories for examination by the Methylene Blue Tests. 15 of these were pronounced to be "Satisfactory", 5 of the remainder were declared as "test void" and 2 were pronounced as "Unsatisfactory".

All the ice cream vendors are supplied with the result of the examination of samples taken from them, and copies of the results are also sent to the manufacturers in cases where the retailer is not the manufacturer.

It is the practice for a Public Health Inspector to follow up unsatisfactory samples and take subsequent samples to ensure that the standard is improved.

The improvement in the bacterial cleanliness of ice cream during the past years is due to the attention given by the Public Health Inspector to this commodity.

Atmospheric Pollution:




Volumetric recording instruments for the measure of smoke and sulphur dioxide are sited at the Public Library, Parc Howard Mansion and at the Public Mortuary. Daily recordings are taken and analysed, the results of which are sent to the Department of Scientific and Industrial Research.

The statistics and graphs show a similar pattern to those of 1963, 1964, 1965 and 1966, but with a further decrease in the average smoke and sulphur dioxide concentration for the town as a whole.

Caravan Sites and Control of Development Act, 1960:-

Three caravan sites are licensed in the Borough.

Moveable Dwellings:

Morfa Caravan Site:

This site was set up to meet the needs of 23 - 24 of the "gypsy" type caravan dwellers of the area. The conditions on the site and the behaviour of the occupants continue to show slow but steady improvement. The children from the site attend local schools.

Although the standard of living of the van dwellers generally continues to rise, it has become apparent that a section of them, usually with small children, find it extremely difficult to "make ends meet" at certain periods of the year. This retards the rate of improvement on the site as a whole and poses financial problems when considering added amenities such as individual electricity points for each caravan standing.

A number of the families originally occupying the site have left the area due to the increasing difficulty experienced in making an adequate living at some periods of the year. This reduction in numbers should increase the opportunities available to the remainder to improve their lot.

Noise Abatement Society:

The Town Council became Members of the Society in 1959.

Offensive Trades:

During the year two applications were received under Section 107 of the Public Health Act, 1936, for the renewal of the Consent to the continuation of the establishment of an offensive trade of rag and bone dealer at premises in Embankment Road and Nevill's Dock.

Both were licensed.

The Town Council during the year also renewed its consent to the establishment of a trade of Gutscraper.

Scrap Metal Dealers Act, 1964:

Thirty-nine scrap metal dealers were registered within the Borough at the end of the year.

Paddling Pools:

The four paddling pools in the Borough have become very popular, with the children, and were well patronised during the season.

Swimming Pool:

Samples of the water are taken regularly by the Health Department for examination, to ensure that high standards of cleanliness or purity are maintained.

Health Education:

During the year a poster campaign was carried out in the district. Various posters dealing with Food Hygiene, Accidents in the Home, Health Matters, Blood Transfusion Service, etc., were distributed in 'bus shelters and on public buildings. Whilst the actual results of such a campaign cannot be measured, it is hoped that the information given has alleviated and minimised some of the suffering which is brought about by ignorance and neglect of such matters.

Mr. D. H. FRANCIS, CHIEF PUBLIC HEALTH INSPECTOR

During the year 1,108 complaints were received by the Department. The complaints related to various nuisances; insanitary and overcrowded conditions in dwelling houses; unsatisfactory hygienic conditions in factories and other premises; rodent and insect infestations; unsound foods; accumulation of refuse; atmospheric pollution; moveable dwellings; water supplies, etc. Each complaint was investigated and dealt with.

A great measure of success in securing compliance with the requirements of the Notices has been due to personal contact with owners or agents of properties, whenever possible.

THE PUBLIC MORTUARY is under the supervision of the Department and subject to regular cleansing. The Department is also responsible for the maintenance of the equipment and clothing, etc., used in the post-mortem room.
