ANNUAL REPORT.

Mr Chairman and Gentlemen,

I beg to submit this curtailed report for the year 1942.

IBRABY

BIRTHS.

Livebirths. Legitimate. Males 52. Females 48. Total 100.

Stillbirths. Legitimate. Males 3. Females 4. Total 7.

Stillbirths. Legitimate. Males 4. Females 1. Total 5.

Illegitimate. Males 0. Females 0. Total 0.

Birthrate (per 1000 population) 18.32. This is higher than the rate for the whole of England and Wales.

DEATHS.

Total deaths from all causes. Males 45. Females 33. Total 78.

Deathrate (per 1000 population) 11.64. This is approximately the same as the rate for the whole of

England and Wales. Death-rate of Infants under 1 year (per 1000 live-births) 65.42. This is considerably higher than the rate for the whole of England and Wales. 57% of these deaths were due to prematurity; the remaining 43% were due to a variety of causes, all unavoidable.

INFECTIOUS DISEASE . (Notifications)

Pneumonia 2. Whooping Cough 3. Diptheria 4. Scarlet Fever 8. (Puerperal

2 of these cases of Diptheria occurred in children under (Pyrexia 1. 15 years of age, neither of whom had been immunised. There were no deaths from Diptheria.

TUBERCULOSIS.

There were 5 new cases, and 7 deaths during the year. Reports on environmental conditions have been made, as before, by your Sanitary Inspector, for the Tuberculosis After-Care Committee of the County Council.

IMMUNISATION AGAINST DIRTHERIA.

The number of children who completed the course of immunisation during the year was ;Age under 5 years. 73. Age 5 years & over, but under 15yrs.52.
This brings the estimated percentage of immunised children to 78% of children under 5 years of age, and 90% of children aged 5 to 15 years.

All work found necessary to keep houses in a reasonably fit condition for habitation was carried out by means of informal notice.
