






Tuberculosis

Sixty-eight (46 male and 22 female) cases of pulmonary tuberculosis and Eight (2 male and 6 female) of the other forms of the disease were notified during the year.

There were Twenty-eight (10 male and 18 female) deaths from the pulmonary form of the disease, and Five (3 male and 2 female) of the non-pulmonary form.

The King Edward VII Welsh National Memorial Association have an Institute at the Park Buildings, Pontypool, where Dr. A. Carveth Johnson attended on Tuesday of each week to see new cases referred to by the Medical Practitioners for examination, and old cases still requiring supervision or treatment. Visits were also made by Dr. Johnson to the homes of people too ill to attend the Institute.

No action for the compulsory removal of cases of Pulmonary Tuberculosis under Section 172 of the Public Health Act 1936 became necessary.

No cases of Tuberculosis among employees engaged in the milk trade came under my observation, therefore no action under the Public Health Prevention of Tuberculosis Regulations 1925, became necessary.

All deaths from Tuberculosis during the year had been previously notified in the district.

Venereal Disease

This complaint is dealt with by the Health Department of the County Council.

Posters have been placed in all the Public Conveniences throughout the Area, giving full particulars of the dangers attendant on the disease and directing the patient to apply to the County Medical Officer for particulars of treatment, and giving the Royal Gwent Hospital, Newport, as the Central Clinic for this purpose. Bedclothes and bedding are disinfected at the Council's Steam Disinfector.

INFECTIOUS DISEASE

203 visits were paid in connection with Infectious Disease. Terminal Disinfection was carried out in each case and all precautions taken against the further spread of the disease.

Three cases of Diphtheria were removed to hospital, of whom two were adults and the other a child who had not been immunised.

SCABIES

Ten children were removed to hospital for treatment of Scabies during the year. Nine other cases were treated at home

TUBERCULOSIS ENVIRONMENTAL ENQUIRIES

Fifty-seven enquiries were made during the year and reports submitted to the Tuberculosis Officer in Newport.

DIPHTHERIA IMMUNISATION

402 children under 5 years completed the course of injections held at monthly clinics in the area.

FARMS, DAIRIES AND COWSHEDS

129 visits were paid to Farms and Dairies during the year. Conditions on the whole were found to be good. Any small faults found were remedied without difficulty.

Regular visits were made to the Vans and Sheds in the district The number of temporary dwellings fluctuates throughout the year, the number of families at the end of the year being nine.

FOOD & DRUG ACT, 1938-Sampling

29 samples of milk, and 78 samples of other food were taken and submitted for analysis by the Public Analyst One sample of flour was found to be infested with mites. The remainder were certified as genuine samples and free from adulteration.

UNSOUND FOOD

A large proportion of unsound food is returned by the retailer to the manufacturer for salvage. The following was condemned—

SCHOOLS

All the schools in the district were examined and found to be in a satisfactory condition.

WATER SUPPLIES

The water supply to the greater part of the district is provided by the Pontypool Gas and Water Co. Sampling is regularly carried out by the Company and The Health Department of the Council. No complaints were received regarding the supply during the year.

FACTORIES

There are no outworkers in the district. One notice was received from the Factories Inspector, and the work was complied with. All bakehouses were found in a clean and satisfactory condition, and in two cases improvements were effected.

INFECTIOUS DISEASE

All cases are visited, and arrangements made for isolation, either at home or at an isolation hospital. After removal of patient, or if isolated at home, upon recovery, the house, bedding and other articles are disinfected.

ACCUMULATIONS OF REFUSE

Two accumulations of refuse were found, these were cleared, following service of notice.

ERADICATION OF BED BUGS

Two complaints were received during the year. Sulphur fumigation was carried out by the Health Department with satisfactory results.

WATER SUPPLY

The main water supply is taken from the mains of the Pontypool Company, samples are regularly taken by the Company for analysis, and no complaints were received respecting the supply from householders.

Two samples of water from a spring and well supplying houses at Varteg were examined and the report satisfactory.

FOOD & DRUGS ACT, 1934-8

Twelve samples of milk were taken under the above Acts, and submitted to the Analyst. All samples were genuine milks, and no action was necessary against the producers or vendors. 32 samples of other foods were all genuine samples.

ERADICATION OF BED BUGS

In three instances this pest has been destroyed by the use of Cimex Gas, and five by insecticide.

RATS & MICE DESTRUCTION

Number of complaints received during the year 103.

Sewers throughout the area, including river outfalls have been treated.

Five Cinemas have been treated and cleared.

Shops and Warehouses have been inspected, and where necessary baits have been laid with good results.

The number of dead rats recovered was 1,200, equivalent to 7,200 under the Ministry of Foods Formulae.

SCHOOLS

Inspection of Schools situated in my district was carried out, and no nuisances discovered.
