

# To the Chairman and Members of the Radnorshire County Council.



I have the honour to present my Annual Report on the Health Administration of the County for the year 1940. It has beeen compiled in an abridged form in accordance with instructions from the Ministry of Health.

It is with pleasure I record that the general standard of health is satisfactory. The two definite criteria which give the most reliable indication of the state of health of a Community are the Infant Mortality Rate and the incidence of Tuberculosis. In both instances the figures give cause for satisfaction. The Infant Mortality Rate being 31 per 1,000 live births as compared with 47 in 1939, and 55 for the 10 year period 1926-35. The figure for England and Wales for 1940 was 55. The number of notifications of Tuberculosis was 10. and deaths from Tuberculosis numbered 8. The numbers for 1939 were 13 and 10 respectively.

These facts should not give rise to complacency, but should be an incentive to greater efforts. Here I pay tribute to the gallant and thorough work of the Nursing Superintendent, Miss Todd, and the District Nurses. They have met the extra and onerous demands made upon them with unselfish enthusiasm.

The general Sanitary and Housing conditions existing in the Country Districts are unsatisfactory in many instances and until a uniform standard of supervision is instituted there is little hope of improvement. It is redundant to say the least that the Health Services of 20,000 inhabitants should be administered by nine separately constituted bodies.

Again it is a pleasure to acknowledge the help and advice I have received from the Chairmen and Members of the several Health Committees.

I also extend my thanks to the Staff of my Department. who, as always, have given me loyal service.

# ANNUAL REPORT.

## SECTION A.

# Statistical and Social Conditions of Area.

The Administrative County of Radnor comprises three Urban and five Rural Districts; it covers an area of 301,165 acres (Urban 8,167 acres, Rural 292,998 acres).

The Registrar-General gives the following estimates of the population for the year 1940. Urban Districts 6,460; Rural Districts 13,960; County 20,420.

The estimated population of the separate Urban and Rural Districts is as follows:—

Urban-Knighton 1759, Llandrindod Wells 3621, Presteigne 1080.

Rural—Colwyn 1,850, Knighton 3,439, New Radnor 2,296, Painscastle 1,966, Rhayader 4,409.

This does not take into account the influx of children into the County as a result of the war.

## Rateable Value.

The rateable value of the County at 1st April, 1939, was £194,814; product of a penny rate (estimated 1939-40) £811.

#### Births.

LIVE BIRTHS.—Total number of live births registered in the County during 1940 was 321, compared with 287 during 1939. There were 306 legitimate births (males 160, females 146).

STILL BIRTHS.—The total number of still births registered in the County was 14 (males 10, females 4) compared with 11 in 1939.

## Illegitimate Births.

The total number of illegitimate live births was 15 males 10, females 5).

## Death Rate.

The total number of deaths which occured in the County (after due correction for residents who died outside the County and non-residents who died in the County) was 290 compared with 281 in 1939.

Of the deaths 100 (males 46, females 54) occurred in the Urban, and 190 (males 110, females 80) in the Rural Districts.

The largest number of deaths occurred from diseases the Circulatory System followed by Cancer.

The deaths from Cancer number 42, i.e. 14.5 per cent of all deaths compared with 12.7 per cent during the five years 1931-35.

## Infantile Mortality.

The number of deaths under 1 year in the County during 1940 was 10, compared with 14 for 1939; the infantile mortality rate (number of deaths under 1 year per 1,000 births) was 31 compared with 47 in 1939; the legitimate rate was 26 per 1,000 legitimate births. Of the deaths 6 (5 male, 1 female) occurred in the Urban, and 4 (1 male, 3 females) in the Rural Districts.

There were 2 deaths of illegitimate children (2 females) in the Rural Districts, equal to a rate of 133 per 1,000 illegitimate births.

Of the 10 deaths of infants under one year of age (males 6, females 4) death occurred in 3 cases during the neo-natal period i. e. in the first month of life.

# General Provision of Health Services for the Area Laboratory Work.

The Radnorshire County Council have made arrangements with the Clinical Research Association, Ltd., Watergate House, York Buildings, London, W.C.1., for bacteriological work.

Examination of milk samples and water samples are carried out by Mr. H. J. Evans, B.Sc., F.I.C., of Liverpool, the county Analyst.

Wasserman tests for syphilis are made at the University Laboratory, Birmingham.

Advantages have been taken of the Emergency Public Health Laboratory, which has been set up under the Ministry of Health at Aberystwyth, to deal with extra work arising in connection with evacuation from vulnerable areas.

## Ambulance Services.

Two ambulances are situated at Llandrindod Wells. One at the Hospital and the other at the Town Hall. Both are available for duty in any part of the County. The ambulance garaged at the Town Hall was presented to the St. John's Ambulance Brigade by Mrs Mackenzie.

# Nursing in the Home.

Nursing in the Home is carried out by the District Nurses of whom there are 22 in the County.

Number of visits made during the year were 34,089.

# Treatment Centres and Clinics.

No change from previous report.

### Hospitals.

There is a General Voluntary Hospital of 40 beds at landrindod Wells. Hospital Wards are attached to the nighton and Rhayader Institutions which were taken over the Public Assistance Committee under the Local Governant Act, 1929.

The voluntary Hospital at Llandrindod Wells and the stitutions at Knighton and Rhayader have been included in Emergency Medical Services Hospital Scheme.

# Isolation Hospital Accommodation

The following is the Scheme at present in operation:

# THE ADMINISTRATIVE COUNTY OF RADNOR.

PUBLIC HEALTH ACT, 1936, Section 185.

Scheme for the provision of adequate Isolation Hospital accommodation for the treatment of persons suffering from Infectious Disease within the County of Radnor.

1. With a view to the provision of adequate hospital accommodation for the treatment of infectious disease other than small-pox in the County of Radnor, the County shall be divided into areas consisting of the County Districts specified in the second column of the sub-joined table and there shall be provided for each such area not less accommodation than that specified in the fourth column and placed opposite the number and description of the area.

- 2. [a] As respects the Area numbered 2, the Hospital at Rhayader provided by the Rhayader Rural District Council shall be made available for the reception of persons suffering from infectious disease other than small-pox from the Rural District of Colwyn, and an agreement shall be entered into accordingly between the Rhayader Rural District Council and the Colwyn Rural District Council.
- [b] As respects the Area numbered 3, the Rural District Councils of Painscastle and New Radnor shall provide the accommodation rendered necessary by the provisions of Clause 1 of this scheme for which purpose they shall as soon as may be initiate action and carry through any proceeding that may be necessary on their part for forming a united district pursuant to the provisions of Section 6 of the Public Health Act, 1936, or for completing agreements pursuant to the provisions of Section 181 of the Public Health Act, 1936.

Provided that the requirements of this scheme so far as relates to the area numbered 3 shall be deemed to be satisfied if accommodation comprising not less than ten beds is provided jointly for the County Districts in that Area and the Urban and Rural Districts of Hay in the County of Brecon at the Hospital provided at Hay by the Hay Urban District Council.

- [c] As respects the Area numbered 4 the requirements in Clause 1 of this Scheme shall be deemed to be satisfied if accommodation comprising not less than forty-five beds is by agreement provided jointly for the County Districts in that Area and for the Borough of Shrewsbury and the Rural District of Atcham at the hospital provided by the Shrewsbury and Atcham Joint Hospital Board.
- 3. Any agreement made in persuance of sub-clauses 2 [a] 3 [b] and 2 [c] of this Scheme may provide for the payment of a capital sum to the Council maintaining the Hospital by the Council from whose district patients are to be received into the Hospital and every such agreement shall provide for the payment of such other sums by way of annual retaining fees and weekly payments for the maintenance and treatment of patients in the Hospital as may be agreed between the parties thereto or in default of agreement on such terms as may

be determined by a single arbitrator in accordance with and subject to the provisions of the Arbitration Acts 1889 to 1934 or any statutory modifications thereto for the time being in force.

The scheme is working satisfactorily. The District Nursing Associations are anxious to help and co-operate with the County Health Department in the work.

# Hospital Provision for Mothers and Children.

Two beds are reserved in the Maternity Ward of the Llandrindod Wells Hospital for the treatment of complicated midwifery cases, or cases in which the home conditions are mastisfactory. Both the Public Assistance Institutions have sell equipped maternity wards.

## Health Visiting.

### Ante-natal Scheme.

The Scheme has been in operation since August, 1931. The total number of expectant mothers examined anteatally under the scheme during the year was 108.

### Post-natal Scheme.

The scheme was adopted by your Authority on 1st May, 4 cases were examined under the scheme.

#### Free Milk.

On May 1st, 1936, a scheme was agreed to for supplying milk to necessitous expectant and nursing mothers, and July 30th, 1937, the scheme was amended to include infants adder school age.

Under the Scheme 2771/4 gallons of milk were supplied to the end of the first half of the year. After this date ilk was supplied to expectant and nursing mothers and ildren under five in accordance with the Ministry of Food heme as laid down in the Ministry of Health Circular 53 dated 19th June, 1940.

#### Orthopædic Scheme.

The scheme established in 1927 in connection with the topshire Orthopædic Hospital. This covers children under hool age, school children and adults. Clinics are held fortably at Llandrindod Wells, and arrangements exist for tients to be seen also at Leominster, Hereford, Newtown d Craven Arms.

After care of persons who have suffered from Tuberculosis.

Section 173(2) of the Public Health Act 1936, provides that the Council of a County or County Borough may make such arrangements as they think desirable for the after care of persons who have suffered from tuberculosis.

It was decided that in this County better results would accrue if the Public Health Committee acted as the After-care Committee, and each notified case was considered on its own merits. The Public Health Committee would then be in a position to render such assistance as it might deem desirable within the wide powers conferred upon it by the provisions of this Section of the Act.


