My Lord, Ladies and Gentlemen,

I herewith beg to submit my report for the year 1948. The Birth Rate of 23.3 is well above the figure for the rest of the country (17.9). The Death Rate is slightly higher, 12.2 as against 10.8.

The infantile mortality appears a high figure of 74, but

four children only under the age of one year died.

Maternal deaths and deaths from diarrhoea under 2 years of age remain at the satisfactory figure of nil. No new cases of tuberculosis have been reported.

SECTION B.

(a) Laboratory Facilities.

By contract with Ministry of Health Emergency Public Health Laboratory, Memorial Hospital, Peterborough, at the cost of 27.10.0. per annum.

(b) Ambulance Facilities.

Since 5th. July 1948, all ambulance services were taken over by the County Council under the National Health Service.

No complaints of delay in arrival of vehicles have been received and the ambulance service appears to be very satisfactory.

- (c) Nursing in the Home.
 - The Nursing services were taken over by the County Council in July under the Health Service, all villages are now covered by a District Mursing Service. (1) General -
 - (2) Infectious Cases. No provision made by the Council.
- (d) Clinics and Treatment Centres.

(e) Hospitals - Voluntary and Public.

No hospital is situated in the District.

Acute medical and surgical cases are admitted to the Stamford and Futland Hospital.
Chronic sick are admitted to St. John's Hospital, Peterborough or St. George's Hospital, Stamford. Admission to the former hospital has been difficult owing to shortage of bed accommodation.

SECTION C. SANITARY CIRCUMSTANCES OF THE AFEA.

The District is provided with two piped (1) MATER. supplies, Barnack and Thornhaugh, owned by the Council.

The parishes of Wothorpe and St. Martin's Without are supplied by the Stamford Water Company.

Bacteriological examinations are carried out at the Peterborough Emergency Public Health Laboratory as pert of the Leberatory contract.

Wittoring is now supplied with a piped supply from the Stamford Water Works; this supply is eventually intended for the parish of Thornhaugh.

BARMACK SUPPLY - BOHR HOLE. Chlorinated at source.

Quality - The quality of water has been very satisfactory. Il samples have been taken for becteriological examination of both raw and chlorinated water.

10 samples of raw water were graded as

Class 1, one sample as Class IV. All samples of chloringted water were Class 1. No chemical tests have been made.

This supply maintains its high standard

This supply maintains its high standard of purity.

Quantity - Has been adequate.

THORNHAUGH SUPPLY - SPRINGS. Chlorinated at source.

This supply on bacteriological analysis has proved to be liable to surface pollution, the reports for the year being unsatisfactory. Il samples for bacteriological examination were taken, of these:-

From the Stamford Water Works main and it is intended to eventually extend this supply to Thornhaugh and Wansford, thus obviating the necessity of using present Thornhaugh supply.

(2) DRAINAGE AND SEVER GE.

A small sewage disposal works has been provided for the new Council Houses at Thornhaugh, Wittering, Pilsgate and Barnack.

The main sewerage scheme for the District is agreed in principle and awaiting agreement with the Peterborough Rural District Council regarding financial details before requesting the Ministry of Health to conduct a public enquiry.

Barnack has a twice weekly collection by Scavenger.

15 Informal notices were served on owners to carry out small general repairs.

2 Notices were outstanding at the end of the year.

The Rural Housing survey has now been completed in the parishes of Barnack, Southerpe and Ufford; 7 cases of overcrowding were found and 42 houses were placed in Category 5. It is estimated that to rehouse families under satisfactory conditions, a further 89 houses will be required for the above villages.

SECTION F. PREVALENCE OF AND CONTROL OVER INFECTIOUS AND OTHER DISEASES.

Patients suffering from infectious diseases are admitted to the Peterborough Isolation Hospital under the Peterborough Area Hospital Management Committee. Accommodation has been quite adequate. The incidence and severity of notifiable infectious diseases have been very low; with only 4 cases of scarlet fever, no diphtheria, 8 whooping cough and 15 measles. Only one case was admitted to the isolation hospital.

DIPHTHERIA IMMUNISATION.

Immunisation is provided by the County Council and the general practitioner service; the responsibility for records is now that of the County Council, under the National Hoalth Service.

No cases of diphtheria have been reported in the district since 1942.

BED BUGS.

No case of infestation has been reported during the year.

PEDICULOSIS.

No cases have been reported during the year.
