### NATIONAL ASSISTANCE ACT. 1948. Section 47.

The Council has built a total of 69 bungalows and 30 flats, for elderly people, of which 8 flats and 3 bungalows are to the improved Parker Morris standard

## WATER SUPPLIES.

### Re-Grouping of Water Undertakings.

After a further objection and further proceedings before a select Committee of the House of Commons, the Dorset Water Order has now been made and becomes operative on the 1st. April, 1969.

Boaminster Rural District, Bridport Rural District and Bridport Borough Councils each has one representative on the new board.

### West Dorset Water Board.

The Water Board has virtually completed the first seven phases of its Regional Scheme. During 1968 the mains from R7 (North Warren Hill reservoir) connecting Melplash to Mangerton and West Milton, were completed and brought into use and the other extension into the Waytown area should be in use by the spring of 1969. Reservoir No. 5 near Marshwood Church is about 60% complete and work is in hand laying the main from here through the Marshwood Vale. The new main from Whitchurch Canonicozum to Wootton Fitzpaine will also be complete and in use by the spring of 1969.

The West Dorset Water Board will cease to exist on March 31st. 1969 following its incorporation in the new Dorset Water Board, and it is not possible to say, therefore, what plans the new board will have for completing the West Board's original schemes. The works involved are those covered by the original phases 8 and 9 in the scheme detailed below.

### DRAINAGE AND SEWERAGE.

#### Joint Sewerage Scheme.

During the year work continued on the various parts of this scheme. The pressure pipeline from Beaminster to West Bay Road, Bridport was completed and satisfactorily tested.

In the early summer of 1968 the submarine outfall pipe was pulled into its sea bed position but unfortunately the shoreward end of the pipe did not become placed in the sea bed with sufficient coverage. The Joint Sewerage Committee, acting on the advice of their Consulting Engineers, called for the Contractors' proposals to lower the pipe into its agreed position, or otherwise to protect it in the surf zone. At the end of the year the Contractors were engaged in a variety of investigations to establish what proposals they might wish to submit to overcome the problem.

The headworks pumping station at West Bay was completed during 1968 and is ready, subject to some final testing when the outfall pipe is completed.



### Drainage and Sewerage continued.

The discharge into the River Brit of crude sewage from Beaminster through the extended storm water pumping main continued throughout the year.

### South Perrott, Mosterton and Chedington.

Agreement was reached with the Ministry of Housing and Local Government on further technical details of the scheme required by them but consent to proceed to tender was still awaited.

### Poultry Inspection.

The Ministry of Health have drawn attention to the need for frequent and regular visits to be made to all poultry processing establishments to ensure that the requirements of the Food and Drugs Act 1955, the Food Hygiene (General) Regulations 1960 and the recommendations of the Code of Practice on Poultry Dressing and Packing were being observed, and that all carcasses and viscera intended for human consumption were in a fit condition.

There are now two poultry processing premises in the district and both are under the same management; killing and plucking of the birds is carried out at one of these premises, and some eviscerating is done at the other.

About 450,000 birds mostly hens but also some turkeys and geese at Christmas time, were killed at these premises during the year. 52 visits were made and 1749 hens (0.3% of the total) were condemned.

### Food Hygiene (Markets, Stalls and Delivery Vehicles) Regulations, 1966.

The Regulations apply to covered and uncovered markets, delivery vehicles, mobile shops, stalls and trading in the open generally. They strengthen the present food hygiene requirements for these forms of trading and revoke or supersede the corresponding requirements in the Food Hygiene (General) Regulations 1960. The Regulations came into operation on 1st. January, 1967 and the Food Hygiene (General) Regulations 1960, do not apply after that date to food businesses subject to the provision of the new Regulations.

No formal action was necessary under these Regulations.

### Milk Supply.

Since 1961, the responsibility for the issue of licences for the use of special designation in connection with milk was transferred from the Council to the Dorset County Council under the Milk (Special Designations) 1960. The County Council, however, have continued to inform this Council where milk samples have failed to pass the prescribed test, and during the year notified that of 89 samples taken, 86 passed the prescribed test and 3 failed. 8 Dealers' licences to sell pre-packed milk, and 1 to sell untreated milk were issued.

### Brucellosis.

26 milk supplies were also tested for brucellosis and as a result no herds in the district were found to be infected.

No case of human infection was brought to my notice.

### Meat Inspection.

There is only one licenced slaughterhouse in the district. This is sited at Broadwindsor and is privately owned. Inspection of meat at this slaughterhouse was carried out by the Public Health Inspector from 1/1/68 - 22/10/68, and thereafter by a local Veterinary Surgeon.

129 visits were made to the slaughterhouse by the Public Health Inspector and by the Veterinary Surgeon who carried out the work of meat inspection when the Public Health Inspector was on sick leave.

#### PUBLIC CLEANSING.

There is a fortnightly kerbside collection, confined generally to public highways, for the whole of the district except Beaminster which has a weekly collection.

64 new dwellings were occupied during the year which increased the total number of domestic premises served in the area to 2884.

A 25 cubic yard capacity compression refuse collection vehicle was brought into service in May the old 12 cubic yard side loading vehicle being retained for standby duties.

It was possible to continue tipping operations in Stintford Lane, Beaminster within the terms of the lease throughout the year and the Council's own land in Stintford Lane was altered to provide accommodation under the Civic Amenities Act for householder's rubbish and to serve as an emergency tip.

Litter bins are provided by the Dorset County Council at lay-bys on classified roads and these are emptied during the normal domestic refuse collections. The number of bins increased during the year by one to a total of 24.



## Public Cleansing continued.

52 litter bins have now been provided by the Council at various sites within the district and these are emptied either weekly or fortnightly during domestic refuse collection.

## CAMPING SITES.

There is no widespread camping in the district. Licences were granted for a few single sites on which to keep a caravan.

## SCHOOLS.

The 13 schools in the area have been inspected regularly, 9 have water supplies from public mains, 3 from private estate supplies and 1 from a well. 46 water samples were taken by the County Council staff 41 were satisfactory and 5 unsatisfactory. 12 schools have water closets and 1 pail closets. All the schools except 4 are supplied with pasteurised milk.

14 samples of water were also taken from the swimming pools in three schools in the area by the County Council staff 12 were satisfactory and 2 unsatisfactory
