

REPORT OF THE MEDICAL OFFICER OF HEALTH FOR THE YEAR ENDED 31st. DECEMBER, 1956.

TO: THE CHAIRMAN AND MEMBERS OF THE BILLESDON RURAL DISTRICT COUNCIL.

Mr. Chairman, Ladies and Gentlemen,

I present to you my Annual Report on the health and sanitary circumstances of the Billesdon Rural District for the year 1956.

Again I am glad to be able to report that the health of the rural district continued to be good as is evidenced by the table on page 4. The death rate remains low, at 9.24 per 1,000 as against 11.7 for the whole Country.

Once again the maternal death rate has been 'NIL' but unfortunately, six infants under the age of one year died and there were three still births. The causes of the infant deaths can be regarded as non-preventable and the rates are well below those for the whole Country.

It is a pleasure to be able to report that there were once again no cases of Diphtheria notified during the year.

There was no serious opidemic of notifiable infectious disease during the year and the incidence was low.

LABORATORY FACILITIES.

There has been no change in the arrangements during 1956 whereby the Public Health Laboratory Service at Groby Road, Leicester undertakes the bacteriological examination of specimens submitted.

In addition to the milk, ice cream and water examinations reported upon by the Chief Public Health Inspector, the following examinations were carried out during 1956.



Mr. Chairman, Ladies and Gentlemen,

I have pleasure in submitting my Report for the year 1956. The supervision of private housing development has again had prior claim upon the time of the department and the number of plans considered during the year shows an increase on the total of the previous year. The number of occupied dwellings in the district increased from 3201 to 4037.

Apart from the preparation of a scheme for river improvement at Great Glen it has once again only been possible to attend to day to day matters and attention given to housing repairs, slum clearance, food hygiene and petroleum installations has been inadequate as was forecast in my last Annual Report.

Details are contained in the following tables of the number of planning applications which have been received and dealt with during the year. In this respect no account has been taken of re-submission of amended plans received in connection with some of the larger proposals.

7 Refusals were issued under the Plannings Acts and 3 plans rejected under the Building Byelaws. WATER.

Hopes that a supply of main water would be on its way to Hungarton and Illston-on-the-Hill during the year were dashed when credit restrictions put a severe brake on capital works.

However, the small scheme to supply Allexton did proceed and it is expected that early in 1957 water will be available in this village.

Rainfall in the period February to June was unusually light and a severe water shortage occurred in several parts of the district.

Goadby was very short of water for at least two months and a complete survey of supplies in the village was made following information that a never failing well had been closed some eighty years ago.

This well was located and found to be useless, and it was also interesting to note that whereas the wells on the eastern half of the village very rarely fail, those on the west are dry after only a short spell of limited rainfall.

FLOODING.

The residents of Great Glen were again fortunate that the River Sence did not overflow its banks on as many occasions as during 1954. However, the determination of the villagers to get something done convinced the Council that although the statut do not place any obligation on this authority to take remedial action, action must be taken,

I was accordingly astructed to prepare a scheme to alleviate flooding in this village and contributions towards the cost were promised from both the Ministry of Transport and the County Council.

Extensive surveys and investigation early confirmed my opinion that a considerable amount of work would be necessary to improve gradients and increase the depth and width of the river. Unfortunately, legal authority to proceed with the work could not be found and the scheme was forwarded to the Trent River Board together with an urgent appeal that the Board should adopt the River Sence as a "mains river" and implement the improvements at the earliest possible date.

The decision of the River Board is still awaited.

Pail closets continue to be emptied weekly and cesspools as regularly as possible with a six-weekly service as the target.

Petrol rationing towards the end of the year slightly interrupted the service but on 31st. December one cesspool emptying vehicle was removed from service and sold.

A new Karrier Yorkshire 800 gallon vehicle was placed on order.

REFUSE DISPOSAL.

×.

The growth of the population served by a regular weekly collection of refuse from 7,862 to an estimated 13,690 on 31st. December 1956 has produced many problems. New vehicles have been necessary and every care has been taken to ensure that they were not purchased and taken into use until absolutely necessary. In the last twelve months there was a population increase of about 2,490 and one new 12 cubic yard side loading refuse vehicle was acquired.

Disposal of refuse at the newly acquired Skeffington Tip was commenced. One man is engaged on digging away the soil on the tip bottom, using a Weatherill Hydraulic vehicle. Refuse is also placed in position, consolidated and covered by the use of this vehicle.

Unfortunately the weather was very bad during the first few weeks this tip was in operation and in an effort to avoid the construction of a costly access road, tipping of the refuse from the whole district reverted to Burton Overy. The consolidation and control of refuse which was possible by using the Weatherill on this old tip enabled a fire which had been burning for a number of years to be extinguished.

Although no accurate check sampling has taken place it appears quite clear that the continued increase in prepackaging almost all domestic goods, both food and otherwise, is resulting in an increase in the volume of packaging material deposited in the refuse.

Also, the introduction of more efficient heating appliances is instrumental in providing a smaller cinder content.

Seven cottages which the Council purchased in the parish of Tugby are not included in this list.
