

ANNUAL REPORT

OF THE MEDICAL OFFICER OF HEALTH FOR THE BISHOPTHORPE RURAL DISTRICT COUNCIL FOR THE YEAR 1915.

To the Chairman and Members of the Bishopthorpe Rural District Council.

Gentlemen,

I have the honour of submitting for your consideration my Report for the year 1915.

The area of the District is 5,550 acres.

The estimated population is 2,116.

BIRTH-RATE.

The births registered are 45, 21 males and 24 females; 3 females were illegitimate. The birth-rate is 21·2 per 1,000 of the population. This is an average birth-rate. In 1914 the rate was 16·6. The rate for England and Wales, less the 244 towns, is 20·7.

DEATH-RATE.

The deaths registered are 19, 9 males and 10 females, giving a death-rate of 8.9 per 1,000 of the population. Deducting the deaths of non-residents, and adding the deaths of residents who have died outside the District, we get the same rate, viz., 8.9. In 1914 the rate was 11.4. This is one of the lowest death-rates we have ever had in the District. The rate for England and Wales, less the 244 towns, is 14.8.

The infantile mortality per 1,000 births registered is 110—the highest rate we have had since 1910. In 1914 it was 84. The rate for England and Wales, less the 244 towns, is 88.

The Zymotic death-rate is 9.

CAUSES OF DEATH DURING THE YEAR 1915.

There were 19 deaths as follows:—Phthisis, 1; Cancer, 2; Rheumatic Fever, 1; Heart Disease, 2; Diarrhæa and Enteritis, 2; Premature Birth, 1; other defined diseases, 10.

CASES REPORTED UNDER THE NOTIFICATION OF INFECTIOUS DISEASES ACT.

Scarlet Fever, 13; Enteric Fever, 1; Tuberculosis, 3. No cases of Diphtheria have been reported during the year. In 1914 there were 7.

Scarlet Fever (13 cases). The first 3 cases occurred early in March in two different houses at Dringhouses, a boy aged 7 years and 2 girls aged 5 and 11 years respectively. No definite history was obtainable. The fourth case was notified from Acaster Malbis, a girl 8 years of age, she was at once removed to the Acomb Isolation Hospital. Careful enquiry proved the infection to have been imported from Leeds. The remaining 9 cases occurred between August 13th and October 31st at Bishopthorpe in seven different houses; 3 were removed to the Acomb Isolation Hospital. The School was closed for 28 days and thoroughly stoved and disinfected before being reopened. Eight of the cases were children, and I was an adult. The history showed clearly that in the first two cases the disease had been imported, and the infection spread through "contact." Along with the Inspector I made repeated visits to the village and examined all houses where suspicious cases had occurred. Every precaution was taken to check the spread of the disease. The Fever was mild in type and there were no deaths.

ENTERIC FEVER (1 case). This was of a doubtful character, and the death occurring a few days after reporting was certified as Malignant Disease of the Stomach. No nuisance was found on the premises.

Tuberculosis (3 cases). These were reported from Dringhouses. Two were children with Tubercular Glands, and were being treated at home. The third was a child who was staying for a few months in the village from Scarborough. This case was being treated at the York County Hospital. The fatal case of Phthisis shown in the death returns was that of a young man who came from York to reside with his parents at Bishopthorpe, and who died within a few days of his arrival.

PROCEDURE AS TO DISINFECTING OF INFECTED HOUSES, &c.

Where advisable, all infectious cases, apart from Tuberculosis, are removed to the Acomb Isolation Hospital as early as possible. The houses are thoroughly stoved with Formalin or Sulphur, and all infected bedding, clothing, &c., removed to the York Steam Disinfector for purification. Antitoxin is supplied by the Council free to the medical men requiring it.

CLOSURE OF SCHOOLS.

Bishopthorpe School was closed from September 24th for 28 days on account of the outbreak of Scarlet Fever.

WATER SUPPLY OF THE DISTRICT.

With the exception of Acaster Malbis the District is adequately supplied with a good and wholesome drinking water.

PUBLIC SCAVENGING.

On July 24th the Council adopted Public Scavenging for Bishopthorpe, and on August 21st it was adopted for the remainder of the District. That this will prove to be of inestimable value to the general health of the inhabitants there is no doubt.

COWSHEDS, DAIRIES, &c.

These are visited by the Inspector, and he reports them to be in a satisfactory sanitary condition.

FACTORIES AND WORKSHOPS ACT.

The two factories have been visited and the necessary regulations carried out.

REARING OF INFANTS.

The Infantile Mortality rate is 2.3, or 110 per 1,000 births registered—a very high rate.

I should strongly advise the Council to have the pamphlet, by Dr. Kaye, the County M.O.H. on the "Rearing of Infants," redistributed throughout the District. It is full of most useful information bearing on this subject.

MEDICAL INSPECTION OF SCHOOL CHILDREN.

This is carried out under the supervision of Dr. Kaye with satisfactory results.

HOUSING AND TOWN PLANNING ACT.

A number of houses at Askham Richard were inspected during the year, and improvements to ashpits, sinks, &c., and the paving of yards carried out. The whole of the District has now been examined with excellent results.

WAR TIME ARRANGEMENTS.

A number of troops are billeted at Dringhouses. Arrangements have been made with the Military Medical Officers to assist them in any sanitary or protective measures they may need. During the year the health of the troops has been excellent.

Mr. Chairman and Gentlemen,

During the past year there has been no new houses erected. The general sanitary condition of the District is good.

The Public Scavenging which has now been adopted for the whole of the District is working very satisfactorily under my supervision, and is much appreciated by the inhabitants. The Council have found no difficulty in disposing of the night soil to the farmers in the District.

The Filter Beds at the Dringhouses Sewerage Disposal Works have been found to require renewing, and the work in connection therewith is being carried out as quickly as possible.
