ANNUAL REPORT

of the

PUBLIC HEALTH INSPECTOR

for the year 1956.

To the Chairman and Members of the Bowdon Urban District Council.

Mr. Chairman, Lady and Gentlemen.

Owing to the retirement on the 9th January, 1957 of Mr. A.E. Shimmings, it is necessary for me to submit the Annual report on the sanitary administration of the Urban District for the year ending 31st December, 1956.

Water Supplies.

The whole of the district is supplied by the Manchester Corporation and a constant supply of water of excellent quality is maintained. The supply in all cases is direct to the house or premises.

The water coming from Thirlmere is neutralised with hydrated lime at the source so as to give a water with a p H value of around 7. Plumbo solvency tests in the past show that water which has stood in contact with lead service pipes overnight has a lead content very definitely less than 0.2. p.p. m.lead as Pb.

Sawerage and Sawage Disposal.

The existing sewers have been satisfactorily maintained and where necessary repaired throughout the year.

Every effort is being made to maintain the existing sewage disposal works in a reasonably satisfactory condition having regard to the inadequacy of the land irrigation method of sewage purification. The land used for irrigation has been extended and it is hoped that a slightly better effluent will result.

With the exception of 7 outlying cottages, the whole of the district is on the water borne system of sewage disposal.

Refuse Collection.

A weekly collection of refuse throughout the district has been maintained during the year. This work is carried out by one Dennis vehicle.

Controlled tipping is carried out adjoining the sewage disposal works but difficulty has been experienced in obtaining sufficient quantities of covering material to carry this out satisfactorily.

Wasto paper and salvage is also collected by the workmen and the total sales for this year amount to approximately £178.



Atmospheric Pollution.

There are no factory chimneys in the district and therefore no nuisance from this source has arisen during the year.

The Council are members of the Manchester and District Smoke Abatement Committee.

A deposit gauge recording the amount of Sulphur Dioxide in the atmosphere is installed in the Council's Yard and periodic readings are taken from this gauge. It is interesting to note that readings in Bowdon are the lowest in North Cheshire - 1.15 mgms against an average for the whole area of 2.61.

During the year inspections of the above premises have been made and where necessary attention has been drawn to the requirements of the Food Hygiene Regulations.

Inspection of Meat and Other Foods.

There are no licensed slaughterhouses in the district, meat supplies being obtained from Altrincham.

No action has been necessary during the year in respect of the provisions of the Shops Act, 1950 regarding sanitary and other arrangements in shops.

Factories Act, 1937.

No action has been necessary under this Act during the year.

Rodent Control.

The Council employs a part time Rodent Operator who carries out the destruction of rodents when necessary.

Sewer tests are taken periodically but very few takes are recorded.

The Council's refuse tip and sewage farm are treated weekly and the Council's Yard monthly. No serious infestation has been reported.
