The Public Health Inspector makes enquiries of masters of ships as to the presence of, or undue mortality among rats. He also inspects ships, quays, wharves and stores at regular intervals for signs of the presence of rats.

- (2) Arrangements for the Bacteriological or Pathological examination of rodents with special reference to rodent plague, including the number of rodents sent for examination during the year.

These examinations are carried out by the Public Health Laboratory Service, 7, Dix's Field, Exeter.

No rodents were sent for examination.

- (3) Arrangements in the District for de-ratting ships, the methods
