To the Rural District Council.

Gentlemen,

In making the Annual Report for the year 1913 the exact instructions issued to Medical Officers of Health by the Local Government Board have been followed.

A.-Nature and Social Conditions of the District-

See last year's Report.

The rainfall for the year was 26.81 inches, more than 1 inch below the average.

B.—Sanitary circumstances of the District.

a. Water Supply.

This is for the most part supplied by wells and springs.

There is a water supply at Foxham under the control of your Board, and in 1913 two extra houses have been supplied from this source. There is a semi-private supply (also under your control) for the village of East Tytherton, and a private supply for the village of Hilmarton. The District as a whole is amply supplied with good water. The water from three wells has been analysed, and in two cases the water was found to be contaminated with Sewage or other animal matter, and both these wells have been permanently closed. Fresh sources of supply are being obtained at both these places. In the other case the water of a well unused for domestic and drinking purposes was found to be of an excellent quality, and is again in use.

b Rivers and Streams.

Three cases of pollution of Streams with sewage have been found. Two have been remedied. In the case of Quemerford the best way of dealing with the sewage pollution of the Marden is still under consideration.

c. Drainage and Sewage.

There are no public drains or sewers.

d. Closet Accommodation.

The privies are mainly of the pail closet type. There are no available statistics as to the number of W.C's in the District.

e. Scavenging.

No scavenging is done by the Sanitary Authority. The privies, &c., are cleansed by the Occupiers who dispose of the sewage.

f. Sanitary Inspection of the District.

The Sanitary Inspector has done the following work— Inquired into 77 cases of Infectious Disease.

Disinfected 7 houses after Infectious Disease.

Made 48 informal notices for the removal of accumulations of offensive refuse.

Inspected 89 Dairies and Cowsheds under the Dairies and Cowsheds' Order.

The Medical Officer of Health has, with the Sanitary Inspector, made inspections at the Council's request at Compton Bassett, Quemerford and East Tytherton. He, the Medical Officer of Health, visits the homes in which Infectious cases occur, and also inspects the village schools in connection with any outbreaks of Infectious Disease.

g. Premises and Occupations which can be controlled by Byelaws and Regulations.

There is one offensive trade, no nuisance has arisen or complaint been made.

There are no cellar dwellings in the District.

Food.

a. Milk Supply.

The several Dairies which send milk into Calne for sale have been inspected and found satisfactory. The milk produced at the farms of the District is sent either to local Milk Factories or to London. All the Cowsheds and Dairies are inspected. They are kept clean and tidy.

b. Other Foods.

There are no Slaughter Houses. The Nine Bakehouses are kept clean, only one informal notice has been required this year for whitewashing.

c. Sale of Food and Drugs Acts.

No action has been required.

Housing.

In accordance with Art. XIX (14) (k) of the Local Government Board's General Orders of 13th September, 1910, and Art. V. of the Housing and Town Planning Act, the following work has been done during the year ending December 31st, 1913:—

The dwelling house for which the Local Authority did not make a Closing Order, after representation was made, has been repaired, (the defect being an unsafe bedroom floor.)

The general character of the defects found on inspection may be thus classified :—

a. EXTERNAL—faulty roofs; damp walls and foundations, due to defective spouting and drainage; faulty sanitary arrangements.

b. INTERNAL—windows which cannot be opened; no ceilings or faulty ones; faulty stairs; dirty walls.

The defects which have been found by your Inspector and for which he issued informal notices have been repaired quickly and in a proper manner, and as a consequence the cottages are greatly improved as dwelling places.

Four houses have been demolished and replaced by new and excellent cottages. Eight new cottages and one new residence have been erected during 1913. The farm and village cottages in the District are quite adequate.

One case of overcrowding has been dealt with informally and remedied.

There are no Byelaws in force for the supervision of the construction of new houses, except in the case of Quemerford. No new house is, however, allowed to be built without an adequate water supply is easily obtainable.

There is no home or outwork done in the District.

C.-Sanitary Administration of the District.

a. The Officers are Medical Officer of Health, Sanitary Inspector, and an Assistant Inspector to carry out the necessary instructions required under the Housing and Town Planning Act, 1909.

b. The Calne District Isolation Hospital is available for the reception of Scarlet Fever, Typhoid Fever and Diphtheria cases. This Hospital has a Medical Superintendent, a Caretaker, and a Matron. Nurses are obtained when necessary.

c Adoptive Acts. None are in force in the District, but regulations under the Cowsheds and Dairies' Orders are enforced.

d. The Local Authority defray the expenses of the examinations of swabs from Diphtheria cases and also for analysis of drinking water. 12 Bacteriological examinations of swabs have been required. 3 Analysts' reports on well water.

D.—Prevalence of & Control over Acute Infectious Disease.

Scarlet Fever.

Five cases at Studley, no cause was discovered for this small outbreak. Two cases were removed to the Isolation Hospital, three cases were isolated at home. No further case occurred.

Diphtheria.

Two cases in one house were notified. On investigation it was found that one of the family had been away from home in a district where there was an outbreak of Diphtheria, and when away she had a slight sore throat which did not make her ill. On her return home she slept with the two cases notified. A swab of her throat was taken which gave a positive Diphtheria result. Two more cases were notified from the same house. All five cases were removed to the Isolation Hospital and the rest of the family isolated. No further case occurred.

Measles.

There has been a wide-spread epidemic in all parts of the District, for which it has been necessary to advise the closing of 5 Schools.

The Head Teachers of the Village Schools promptly notify the Medical Officer of Health of all cases of absence from School due to infection or contagious disease.

E.-Prevalence and Control of Tuberculosis.

a. Visits to all notified cases are paid as soon as possible. Steps are taken to isolate infected persons as far as possible by day as well as by night, and advice given as to the disposal of sputum, &c.

b. No subsequent visits are paid unless asked for.

c. Whenever possible steps are taken to discover any possible contact cases.

d. In all cases the advice and assistance of the County Tuberculosis Officer is obtained, and every case is notified in addition to the County Medical Officer of Health.

e. In case of death the rooms used by the patient are thoroughly cleansed: the paper is removed and burnt; the room is whitewashed and then subjected to formation disinfection.
